DR. NELSON C. PRICE NAMED CIF, SS COUNCIL PRESIDENT

Dr. Nelson C. Price, former Principal of Azusa High School and recently appointed Assistant Superintendent of Azusa Unified School District, and a representative on the CIF, Southern Section Council for eight years, has been named President of the Council for the 1963-64 school year.

Dr. Price has served as President of both the Sierra and Tri-County Leagues in addition to having been Chairman of the CIF, SS, Blue Book Revision Committee in 1961.

Aside from his newly acquired duties as Assistant Superintendent of the Azusa Unified School District (he was principal at Azusa and Citrus High School prior to his promotion to the District position), Dr. Price is active in the Azusa Lions Club, the Community Chest and United Fund, PTA, the Coordinating Council of Azusa and the First Baptist Church of Azusa.

After attending Pasadena City College, where he received his AA Degree, and the University of Redlands, where he earned his BA Degree with honors in 1940, Dr. Price spent four and a half years in military service. He was Battalion Operations Sergeant and Sergeant Major in New Guinea and Luzon as a member of the 6th Infantry Division in 1944-45.

Upon his return to the States, Dr. Price earned his Masters Degree in History at the University of Redlands in 1946. His EdD. Degree is from the University of Southern California, class of '56.

Dr. Price is a photography "bug" and has developed 35mm color slide lectures of his travels in the Far Western United States with sound recordings from the Grand Canyon, Salt Lake City, Bryce National Park, Grand Tetons, Yellowstone National Park, and other western places of interest.

Among his many writings, Dr. Price has written several educational oriented articles including "A High School Studies Its Grading," 'Advantages and Disadvantages of the Unit Plan of School Organization," "Azusa High School Study of Student Morale," and "Financing High School Athletics."

In addition to the administrative end of education, Dr. Price has also held teaching positions at Citrus High School, Citrus College, Pepperdine College and Los Angeles State College.

In 1942 Dr. Price married Barbara Ellen Geddes. They have four children: James, 18, a student at Citrus College; Dale, 15, a sophomore at Glendora High School; Billy, 10, and Ellen, 8.

## AVIATION HS CAPTURES CIF, SS "AA" BASEBALL CROWN

Aviation HS scored six runs in the first inning and then coasted in to capture the CIF, SS "AA" baseball championship, topping Upland HS 7-2 in a game played at Galvin Park in Ontario on Friday, May 24, 1963.

Aviation, champions of the tough Pioneer League, knocked two of Upland's best pitchers out of the box in the first inning before Middleswart came on to quell the uprising. Aviation scored only one additional run during the balance of the game but the damage had been done. In the meantime Jim Lloyd, selected as the outstanding player in the small school division of the CIF, SS, was limiting the Highlanders to three hits to gain his second consecutive playoff victory.

Top-seeded in the draw, Aviation was given a bye in the first round and then defeated San Luis Obispo 4-1, and Cantwell 11-3 to qualify for the finals. Upland took the measure of Barstow 8-6, nipped Brawley 5-4, and then edged South Pasadena 3-2 to earn the right to play in the championship contest.

One of the largest crowds ever to witness a "AA" play-off baseball game was on hand at Galvin Park to see this fine championship game. They were not disappointed as both teams played outstanding ball after Upland settled down after its disastrous first inning.

#### "A" BASEBALL CHAMPIONSHIP TO HEMET HS

A new face appeared on the baseball horizon as Hemet HS of the De Anza League exploded for three runs in the fifth inning to give the Bulldogs a 3-2 win over Santa Clara and with it the "A" baseball championship of the CIF, Southern Section, in a game played at Evans Park in Riverside on Friday, May 24, 1963.

Always powerful Santa Clara appeared to be off and winging, as they scored two runs in the second inning off of starter Soliz. John Whaley then came on in relief and held the Saints hitless for six innings, striking out five and walking four.

Santa Clara, champions of the Tri-Valley League, were given a first round bye and then annihilated Thacher School 13-3, and in one of the finest games played this year, edged a great Lutheran nine 1-0, to qualify for the finals. Hemet was unseeded and in an opening-round encounter whipped Nogales, champions of the new Inland League, 5-2. They then beat Needles 3-2 and blanked Flintridge 2-0 to earn the right to play in the championship game.

Interest was high during the "A" play-offs and all games were conducted in an atmosphere of cordial and friendly relations. With our small schools spread all over Southern California a great deal of travel was involved, but the teams accepted their assignments in good spirits and we are certain that everyone enjoyed meeting and playing teams from other areas of the Southern Section.

### MINUTES OF EXECUTIVE COMMITTEE MEETING — JUNE 15, 1963

The annual June meeting of the CIF, Southern Section, Executive Committee was called to order by Chairman Keith Gunn at Newport Beach on Saturday, June 15, 1963, at 10:00 AM. Those in attendance included Messrs. Winston Nelson, Asst. Supt. of Pomona School District; John R. Taylor, Principal of Nordhoff HS; Robert J. Schilling, Asst. Supt. of La Puente School District; Robert D. Ashton, Asst. Supt. of Excelsior School District; Nelson C. Price, Asst. Supt. of the Azusa School District; Marion C. Hays, Vice Principal of Harvard School; Harold Wetzler, Principal of Hawthorne HS; Charles Ronin, Vice Principal of Redlands HS; Roland H. Ewing, Vice Principal of Atascadero HS; Harry L. Bigger, Principal of Fillmore HS; Frank O. Hopkins, Supt. of the Brea School District; and Ken Fagans, Commissioner of Athletics.

- 1. MINUTES APPROVED It was moved, seconded and carried to approve the minutes of the Executive Committee meeting held in the CIF, SS office on May 17, 1963, as published in the May, 1963, Monthly Bulletin.
- 2. GYMNASTICS COACHES COMMITTEE MEETING The Commissioner presented for consideration the minutes of the Gymnastics Coaches Committee meeting held on May 21, 1963. After a review of the minutes it was moved, seconded and unanimously carried to approve the minutes as presented. Copies of these minutes have been mailed to all gymnastics coaches and additional copies are available for anyone desiring them.
- 3. MEMBERSHIP FOR NEW SCHOOLS It was moved, seconded and carried to recommend to the Council that the following schools be admitted to membership in the CIF, Southern Section:
- a. La Quinta HS of the Garden Grove District as a regular member, effective Sept. 1, 1963.
- b. Bassett HS of the Bassett School District as a regular member, effective Sept. 1, 1964.
- c. Edgewood and Torch Jr. High Schools of the Bassett School District and Paramount and Alondra Junior High Schools of the Paramount School District as Associate members, effective Sept. 1, 1963.
- 4. SWIM COACHES MEETING—The Swim Coaches of the CIF, Southern Section, held their annual meeting at Helms Hall on Wednesday, June 5, 1963. The minutes of this meeting were presented to the Executive Committee for approval. After discussing all of the items included in the minutes, it was moved, seconded and carried to approve them as presented except for the item calling for the addition of the Class B 440-yard Freestyle as a regular event to be held in all Southern Section swim meets. This matter will be referred to the Council for consideration at its meeting scheduled for November 23, 1963.

- 5. ELECTION OF CHAIRMAN It was moved, seconded and unanimously carried to cast a unanimous ballot for the re-election of Mr. Keith Gunn, as Chairman of the Executive Committee for the 1963-64 school year.
- 6. COMMISSIONER TO ATTEND MEET-INGS—It was moved, seconded and carried to send the Commissioner, with expenses paid, as the CIF, SS representative to the Cal Poly Workshop in August, 1963; the National Federation Football Rules meeting in January, 1964; and the National Federation Annual Meeting in June, 1964. Funds are included in the coming year's budget.
- 7. TWO-MILE RUN IN ORANGE COUNTY RELAYS Tustin HS petitioned the Executive Committee to be permitted to conduct the two-mile run as a regular event in the Orange County Relays to be held on March 3, 1964. After a discussion of the matter it was moved, seconded and carried to approve the addition of the two-mile run as a special event in the Orange County Relays for the 1964 meet only. At the conclusion of the activity it will be the responsibility of the manager to submit to the Executive Committee an evaluation of this special event.
- 8. WAIVER OF ELIGIBILITY RULE Chaffey HS appealed for a waiver of the CIF, SS eligibility rule Article VI, Section 1-E, in the case of a boy who was taken seriously ill and and hospitalized, causing him to miss school so that he was unable to obtain passing grades as of the close of the second semester of the 1962-63 school year. In accordance with the authority granted the Executive Committee in cases of this nature, it was moved, seconded and carried to waive Section 1-E of Article VI of the By-Laws and declare the boy eligible for interscholastic athletics for the first semester of the 1963-64 school year, provided he is eligible in all other respects.
- 9. ADMINISTRATIVE ASSISTANT Two candidates for the position of Administrative Assistant, whose principal duties would be to handle publicity and public relations, were interviewed by the committee. Upon concluding the interviews it was moved, seconded and unanimously carried to employ Don Andersen as an Administrative Assistant at a salary of \$600.00 per month, effective August 1, 1963.
- 10. FINANCIAL REPORT AND BUDGET ADOPTION Winston Nelson, Treasurer of the CIF, Southern Section, informed the committee that although the fiscal year would not close until June 30, 1963, he was presenting a Financial Report showing estimated income and expenditures of the CIF, SS, for the 1962-63 school year as compared with the budget for that period. The report indicated that due mainly to the successful 1962 football play-offs, we will show a net gain of approximately \$12,000.00.

The treasurer then presented a proposed budget for the 1963-64 fiscal year. After discussing each item in detail and making minor changes

in the proposed budget, it was moved, seconded and carried to accept the Financial Report and adopt the revised budget for the 1963-64 fiscal year and instruct the Commissioner to prepare copies of the Financial Report and Budget for distribution to all members of the Council in September, 1963.

11. BOSCO TECH TRANSFERS — Because Bosco Tech will not field a football team, effective with the 1963 season, the Executive Committee agreed to waive the transfer rule in the case of any students at Bosco Tech who were deprived of participating in football and wished to transfer to another private school or to the public school in the high school attendance area in which their parents reside. It was moved, seconded and carried to grant eligibility only to the following boys at the school indicated, effective, September 1, 1963: John Goebel at Keppel HS; Bill Martin at Pius X HS; Dick Trier at Montebello HS; Jim Van Houten at Nogales HS; and Doug Veronda at Covina HS.

12. LOS ANGELES SECTION TRANSFER RULE - At the request of many of our private schools located in the city of Los Angeles the attention of the Los Angeles City Section of the CIF was recently called to the inequities in the present transfer eligibility rules now governing transfer students between Los Angeles City and Southern Section schools. When an athlete from a Los Angeles City high school transfers without a change of address on the part of his parents to a Southern Section school, he is ineligible for one year from the date of transfer. When an athlete from a Southern Section school transfers to a City school without a change of address on the part of his parents, he is ineligible only for a period of twenty weeks.

This situation has resulted in a great number of boys leaving Southern Section schools and transferring to City schools where they sit out their period of ineligibility and then participate in athletics without loss of athletic participation. For example, a football player completes the season in a Southern Section school, transfers to a City school in February, and the next September he is eligible for football at the City school.

After discussing the situation, the Policy Determining Committee of the Los Angeles City Schools ruled in favor of no change in their present rule. A letter from Bruce Kirkpatrick, acting chairman of the P.D.C. indicated that the feeling of their group was that they are in conformance with the State CIF rule, and there are many factors which motivate youngsters to change from private to public schools. The members of this committee feel that the matter of such transfers is a parental responsibility and privilege. The P.D.C. also indicated that they deplore proselyting as unethical and undesirable and would like information concerning any transfer of an athlete where undue influence might have been used. The Commissioner was directed to reproduce pertinent information from Mr. Kirkpatrick's letter for distribution to all of our member schools located near the city of Los Angeles.

13. FREE LANCE LEAGUES — It has been the policy of the CIF, Southern Section, for many years to encourage the formation of so-called free lance leagues in sports where all member schools of a regular league do not field teams. For example, many schools do not have swimming pools and consequently do not field swim teams. There might, however, be two teams in a given established league that do have a swim team and these two schools then make arrangements to join together with other schools from other leagues fielding swim teams for the purpose of forming a special swimming league.

Lately, problems have arisen over the administration of such free lance leagues. The question of who should be included in such leagues, who is responsible for the administration of the leagues and other questions are not defined in our By-Laws. Because of the many problems connected with this situation, it was moved, seconded and carried to authorize the Commissioner to form a committee for the purpose of studying the entire matter and preparing recommendations to be presented to the Council at the November meeting.

14. COUNCIL MEETINGS — The dates and locations for the three regular meetings of the Council for the 1963-64 school year were approved as follows:

15. FALL EXECUTIVE COMMITTEE MEETING — It was moved seconded and carried to hold the first regular meeting of the Executive Committee for the 1963-64 school year at Santa Barbara on Saturday, September 28, at 10:00 AM.

There being no further business to come before the committee, the meeting was adjourned at 4:30 PM.

#### OUTSTANDING PERFORMANCES FEATURE CHAMPIONSHIP TRACK AND FIELD MEET

The CIF, SS's great track and field program for 1963 was brought to a most successful conclusion with the holding of the championship meet before a huge crowd of 8,000 track enthusiasts at Cerritos College in Norwalk on Friday night, May 24, 1963. Beginning with the preliminary meets on May 11 and continuing through the semi-finals and championship meet, competition was exceptionally keen, which resulted in nine CIF, SS records being either tied or broken.

At the conclusion of the meet it appeared that Long Beach Poly had captured the varsity team title, as the scoreboard showed them with 21 points to only 19 for their nearest competitor,

Muir HS of Pasadena. None of the results are final, however, until a review of the official films, and when that was accomplished, many errors in placement by the judges were discovered, which caused a reshuffling of the points scored by the leading teams.

In the Class A high hurdle event the official result showed that Paul Foster of Centennial, who was picked for fourth, and Earl McCullough of LB Poly, who was given third place, should have been picked in reverse, so this change gave Centennial one additional point and took one away from the Jackrabbits. The big error occurred in the 100-yd. dash, however, when the slow motion films clearly showed that James Miles of Poly, who had been awarded third place, had in reality finished sixth.

These two changes resulted in LB Poly losing 4 points from their total of 21, which dropped them down to 17 — 2 behind Muir, whose total remained at 19. Muir's points were all solid and were highlighted by easy victories by John House in the 100 and 220-yd. dashes. Centennial, by gaining a point, accumulated 16, which gave them third place over Compton with whom they had previously been tied with 15 points.

In some respects it is unfortunate that this important meet must be decided at a later date by reviewing the slow motion pictures of the finishes. In fairness to all the athletes, however, this is necessary, because the competition in the finals is so tough that in the shorter races most of the contestants come across the finish line in a blanket finish and it is practically impossible for the judges to separate the finishers with any degree of accuracy.

Dennis Carr of Lowell HS finally got the competition he was looking for in the 880 from Larry Arnett of Pasadena and broke his week-old CIF, SS mark of 1:52.8 with a remarkable 1:52.2. Although this was phenomenal time, it was still .4 of a second slower than Ray Van Asten's national standard. Showing improvement each week, Carr went on to the State meet and smashed the national record by recording a blazing 1:50.9. Dennis Carr thus becomes the first boy in the history of interscholastic track and field championships to hold national records in the grueling 880-yd. and mile run.

Each year the CIF, SS produces a great crop of milers and this year was no exception. Tracy Smith of Arcadia HS led a brilliant field to the tape in the outstanding time of 4:12.6 to eclipse the former CIF, SS record of 4:15.1 set by Bruce Bess of La Habra in last year's finals. In shattering Bess' record, Smith bettered his previous best time by 7.8 seconds.

Carl Davis of Compton equalled a SS mark with a clocking of 14.0 in the high hurdles. In the pole vault competition in the semi-final meet at Chaffey, both Jeff Hendrix of Downey and Marc Savage of Claremont tied the CIF, SS record of 14' 54". Poor lighting for the pole vault pit at Cerritos hampered the contestants and neither boy approached this mark in the finals.

Speaking of records, one of the most noteworthy occurred in the Class C 1320-yd. run when Rick Felix of Colton HS defeated the former record-holder, George Husaruk of Montebello, in the unbelievable time of 3:05.5 to establish another SS mark. When you consider that the Class B record for this event is 3:08.1, you can gain some idea of the magnitude of this achievement.

Two other marks were established in Class C competition, as Larry Freeman of LB Poly was credited with a leap of 6' 27/8" in the high jump and Paul Wilson of Warren HS went over the bar at 13' 4" in the pole vault. The speedy relay team from Notre Dame HS was clocked at 44.0 to tie the record also held by Santa Ana HS.

Centennial HS won the Class B title with 11 points, closely followed by Santa Ana with 10½. In the Class C division, top honors went to Notre Dame, who scored 26 points to easily outdistance runner-up LB Poly, with 11.

Interest in track and field continues to increase in the SS and all seven of our meets revealed outstanding performances and record-breaking crowds. We are extremely grateful to the schools who made their fine facilities available for our meets and to the personnel at the respective schools who did such a capable job in staging these meets

The managers and locations of our 1963 meets were as follows: preliminaries were held at Huntington Beach HS with Jack Rowan as manager, at Bellflower HS with Dick Cate as manager, at Fontana HS with Austin Snyder as manager and at Valley JC where Bill Leeds of Crespi served as meet manager. Ernst Hartmann did his usual fine job of managing our semi-final meet at Compton HS, while veteran track coach Truck Lindsey turned in a fine job in managing our other semi-final at Chaffey HS.

With the championship meet being held at Cerritos College, Bellflower HS served as host and, under the direction of Ernie Jensen, saw to it that the meet ran smoothly and efficiently.
