GOING FOR TWO — Crespi tailback Russell White (left) and El Toro quarterback Bret Johnson will be the key players as their respective schools try for back-to-back CIF-SS football titles this fall. White, who rushed for 2,339 yards and 31 touchdowns as the Celts won the '86 Big-Five crown, was named section and conference MVP as a sophomore. Johnson, who guided the Chargers to a perfect 14-0 mark and the Southern Conference championship, also earned divisional MVP laurels. A total of 344 CIF-SS schools will compete for 54 league and 11 conference titles in the upcoming season, which officially opens Sept. 10.

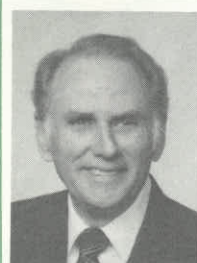
exclusivity within their product categories.

THE IMPORTANCE OF ETHICS

In this, our 75th Anniversary year, it is most important for each of our member schools to exhibit the highest level of ethics and good conduct in every athletic endeavor. It is requested that each of us - administrators, coaches, officials and student-athletes - rededicate ourselves to the principles of good sportsmanship and fair play on which this organization was founded.

As Commissioner of Athletics, I cannot emphasize too greatly the importance of our long-standing code of ethics. Every team or individual that represents a member school of the CIF Southern Section is subject to public scrutiny. Each time a team from one of our schools hosts an event or travels, its conduct is being judged by a broad segment of our many communities.

To reiterate the CIF Southern Section Code of Ethics, please remember it is the duty of all concerned with high school athletics to:

1. Emphasize the proper ideals of ethical conduct and fair play;
2. Eliminate all possibilities which tend to destroy the best values of the game;
3. Stress the values derived from playing the game fairly;
4. Show cordial courtesy to visiting teams and officials;
5. Establish a happy relationship between visitors and hosts;
6. Respect the integrity of sports officials;
7. Achieve a thorough understanding and acceptance of the rules of the game and the standards of eligibility;
8. Encourage leadership, use of initiative and good judgement by the players on a team;
9. Recognize that the purpose of athletics is to promote the physical, mental, moral, social and emotional well-being of the individual

CIF-SS EXECUTIVE COMMITTEE MINUTES

June 20, 1987

The June meeting of the California Interscholastic Federation, Southern Section Executive Committee was called to order by Chairman Pat Mauch at 8:05 a.m. on Saturday, June 20, 1987 in Laguna Beach. All members were present with the exception of Fr. Charles Motsko and Andy Patterson.

1. PRESIDENT'S UPDATE - President Pat Mauch extended his appreciation to the Executive Committee for their professional support in his first year as President. Additionally, he highlighted the CIF Southern Section Sportsmanship Awards Program and the spring championships.

2. COMMISSIONER'S UPDATE - Commissioner Stan Thomas reviewed with the Committee the Office reorganization for the 1987-88 school year; CIF Southern Section and State corporate support program; the Amateur Athletic Foundation coaching workshops; and the officials' assignment process in Orange County which will be a pilot program during the

1987-88 school year. Additionally, Commissioner Thomas updated the Committee on a recent meeting of the State Commissioners and their role and function with regard to the State Federated Council.

A question relative to concerns with reference to the number of incidents in the sports of soccer, basketball and baseball was reviewed with the Executive Committee. It was the decision of the Committee that the basic responsibility for the conduct of the athletic program lies initially with the school principal and the league. It will be the responsibility of the CIF Southern Section Office to address these concerns with league representatives in September. The focus with league representatives will be on the CIF Southern Section Code of Ethics and concerns dealing with integrity, sportsmanship, ethical conduct, fair play, and the role model that coaches must set for the student athlete.

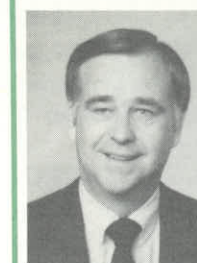

New Process in Place for Sanctioned Events

Sanctioning for interscholastic athletic events such as tournaments or contests with schools outside of the section has long been an important rule for CIF-SS member schools to abide by. Sanctioned events are covered in section 700 of the CIF-SS Blue Book.

In past years, all school correspondence concerning sanctioned events was handled exclusively by the department of one of the CIF-SS Administrators. In the new procedure, the administrator in charge of each sport will process all sanctions for his or her area: Our department will handle cross country, basketball, track & field, golf and badminton; Mr. Bill Clark will

SYNOPSIS OF 1987-88 BLUE BOOK CHANGES

The following synopsis is designed for the benefit and convenience of athletic administrators and coaches in an effort to provide a capsule summary of the changes in the State CIF Southern Section Constitution and By-laws. These changes have been enacted by the State CIF Federated Council and/or the Southern Section Council throughout the course of the 1986-87 school term.

The changes are listed initially by topic and follow in parenthesis by the Article and/or Section rule as it appeared in the 1986-87 publication. A synopsis of the change is then noted and followed by the Article and/or Section number as it appears in the current 1987-88 publication for easy reference. For example, CIF-SS 1200.1 means CIF-SS Article 12, Rule #1200, Point 1.

STATE REVISIONS

STATE CONSTITUTIONAL AMENDMENT: Amendment to State Constitution in order to be in compliance with the newly modified Brown Act (Article 5, Section 50; Article 5, Section 51; and Article 7, Section 71).

ATTENDANCE: Defines a semester of attendance. This section re-written for purposes of clarity (By-law 203).

SCHOLASTIC ELIGIBILITY: By-laws re-written to conform to recently adopted legislation dealing with the 2.0 standard for participation in athletics. This provision is now applicable to both private and public schools that are members of the CIF (By-laws 204, 205, 206, 223 and 227.)

CONTINUING ELIGIBILITY - EXPULSION: Adds to the current By-law; status of students expelled by a public school under the provisions of Article 1, Chapter 6 of Part 27, Division 4 of Title 2 (commencing with Section 48900) of the Education Code of California. Guidelines for hearing for reinstatement are spelled out (By-law 216).

STATE CHAMPIONSHIP PARTICIPATION: By-law

changed to provide each Section with representation in all state playoff activities (By-law 518).

SOUTHERN SECTION REVISIONS

FOREIGN EXCHANGE PROGRAMS: Updates approved foreign exchange programs (By-law 212).

BOARDING SCHOOL: Clarification of what constitutes a Boarding School (By-law 217).

LEGAL GUARDIAN: Adds the wording "due to hardship" to current Southern Section By-law (By-law 221.1).

SANCTIONED EVENTS: By-laws re-written (effective with the 1988-89 school year) to establish firm guidelines pertaining to the scheduling of athletic contests, especially in the sport of football. Additionally, schools may take trips for athletic competition, of over 500 miles once every three years (with the exception of Arizona and Nevada schools). This will also be effective with the 1988-89 school year (By-law 701, 702 and 713.)

to the committee that the new Athletic Director Orientation will be held on September 29 and the new Principal Orientation will follow on October 1, 1987.

3. BOYS' ATHLETIC DIRECTORS' UPDATE - Mr. Mike Moropoulos, Boys' Athletic Directors' representative, reported that the scholastic eligibility regulations are now in the hands of superintendents and that the state is just completing those areas that will affect the Blue Book.

4. GIRLS' ATHLETIC DIRECTORS' UPDATE - Ms. Sheila Burrud, Girls' Athletic Directors' representative, reviewed with the Committee the State Track and Field Championships held in Sacramento. Pomona High School was crowned Girls' champion and Hawthorne High School emerged as the Boys' champion.

5. SUPERINTENDENTS' UPDATE - Ms. Cynthia Grennan, Superintendents' Representative, reviewed with the Committee legislation dealing with the certification of coaches. A public hearing will be conducted in September by the State Department of Education prior to final implementation of the regulations governing same.

6. TREASURER'S REPORT - Mr. Bruce Keuning, treasurer, provided an update on the 1986-87 working budget and the spring playoff incomes.

7. STATE REPORT - Tony Balsamo reviewed with the Committee background information on the scholastic eligibility rules and regulations as approved by the State Executive Committee that will be forthcoming to Sections for adoption into their rules and regulations.

8. SUMMER ACTIVITIES COMMITTEE REPORT - Mr. Bob Paisola reviewed with the Committee progress of the summer athletic programs committee which met to review concerns regarding involvement in summer athletic programs. Following discussion, the Executive Committee approved for the summer of 1987 only: A. The Executive Committee's *NEW* interpretation of summertime rules 1423, 1512, 1610, 1710, 1812, 1912, 2010, 2109, 2308, 2411, 7510, 2608, 2710 and 2809 will permit member schools to use

equipment, uniforms, facilities, utilities, etc. for summer activities with the authorization of the principal. Additionally, schools, districts or booster clubs may pay entry fees for summer activities. **SPECIAL NOTE:** In the sport of football, *PROHIBITED* use of school equipment would still include air dummies, stand-up dummies, two or seven-man sleds, tackling dummies and other protective equipment (such as helmets, pads, etc.).

B. In addition, the Executive Committee authorizes the following entities to pay coaches for summer services:

- (1) District Office
 - (2) A.S.B./Principal
 - (3) Duly licensed community organization, i.e. parks and recreation
- Under *NO* circumstances will the Southern Section condone payment by individuals, special interest groups or booster clubs.

This will be discussed and forwarded to the Blue Book Committee for review and future presentation to the CIF-SS Council.

9. ALLOWABLE EXPENSES FOR PLAYOFFS - Mr. Mike Moropoulos reviewed with the Committee a recommendation from the Playoff Expense Allowance Committee relative to playoff expenses in the sports of football and basketball. Following discussion, it was moved, seconded and passed to approve the following:

FOOTBALL: The allowable travel expense in football be raised from \$1.00 per mile round trip to \$1.75 per mile. **BASKETBALL:** The allowable travel expenses in basketball be raised from \$.45 per mile round trip to \$.75 per mile round trip, and the minimum allowable amount for private automobiles would be raised from \$.15 per mile per car round trip to \$.25 per mile per car (with a limit of 3 cars).

MEALS AND LODGING FOR FOOTBALL AND BASKETBALL: The \$1.00 after-game snack provision be eliminated; raise the \$4.00 dinner allowance to \$5.00, lunch from \$2.00 to \$2.50, and breakfast at \$1.50 to remain the same (a total of \$9.00 as compared to \$8.50 previously). The authorized maximum for lodging be raised from \$4.00 to \$6.00.

It should be noted that due to the impact this would have on the recently-approved 1987-88 budget, this approval will take effect **BEGINNING WITH THE 1988-89 CYCLE**, with a provision that playoff expense allowances be reviewed every two years in conjunction with the re-leaguing and playoff grouping cycle.

10. SEASON OF SPORT COMMITTEE REPORT - Pat Mauch reviewed with the Committee results of the Season of Sport Committee meeting of May 11, 1987. Discussion was held with regard to the extension of the fall season of sport by a period of one week beginning with the 1988-89 calendar. A proposed 1988-89 calendar reflecting this additional week in the fall was reviewed by the committee.

A recommendation to consider swimming in the fall season of sport and water polo in the spring was rejected by the season of sport committee.

Additionally, Administrator Dean Crowley reviewed with the Committee the survey with regard to "R and R Week." The survey indicated that 69% of member schools were in favor of the "R and R Week" concept, while 31% were opposed; and 66% of the schools (as compared to 34%) were in favor of continuing the "R and R Week." With reference to a dead period during the summer, 62% of the schools responded "yes" and 38% responded "no".

11. SYMPOSIUM - Administrator Karen Hellyer reported that the 1987-88 CIF Southern Section Administrators' Symposium will be held on Wednesday, January 20, 1988 at the Anaheim Convention Center.

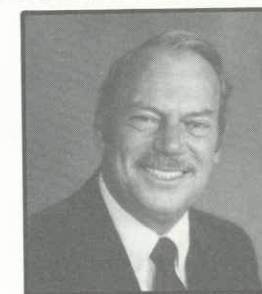
12. VOLLEYBALL REGULATIONS - Administrator Karen Hellyer reviewed with the committee a recently adopted volleyball rule which specifies that the host school have the floor standards, wall cables and referee's platform padded for safety purposes. Following discussion, it was moved, seconded and passed that schools not complying with this regulation will forfeit the contest.

13. ORANGE COUNTY OFFICIALS - Administrator Bill Clark announced that Mr. E.M. "Speed" Castillo has been hired as the new Orange

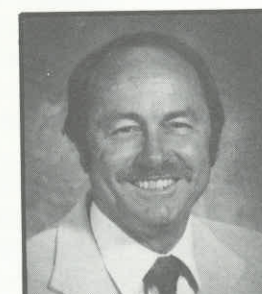

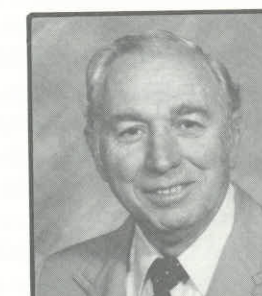

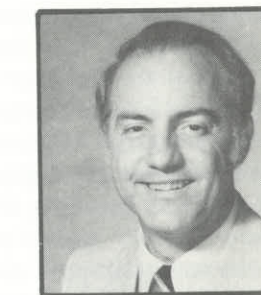

County liaison by the CIF Southern Section Office. He will be working with the various assignors in the officials' associations serving Orange County in the first year of a pilot program that allows the Orange County Officials Associations to assign officials for athletic contests.

14. PROPOSAL TO CONDUCT

BASEBALL RESEARCH - Administrator Bill Clark reviewed a proposal from Coop DeRenne, Associate Professor of Education of the University of Hawaii, to conduct research in the areas of hitting and throwing in five Southern Section high schools. Following discussion, it was moved, seconded and passed to approve the request with

the stipulation that the school principal and league approve the project.

15. ST. JOSEPH HIGH SCHOOL BASKETBALL RULE INTERPRETATION - Administrator Dean Crowley reviewed a concern of St. Joseph High School relative to elementary school basketball tournaments and the question of undue influence when a high school coach is involved with the

BUENA'S MICHAEL J. SHANAHAN JOINS EXECUTIVE COMMITTEE

The CIF Southern Section is pleased to announce the addition of Mr. Michael J. Shanahan, Principal of Buena High School in Ventura, to the CIF-SS Executive Committee. Shanahan was elected to the post by the CIF-SS Council at its May, 1987 meeting in Norwalk.

Shanahan will replace Lompoc High School Principal Bob Paisola as the Executive Committee's Northern Area Representative. The addition will allow Mr. Paisola to concentrate on his committee position of CIF-SS President-Elect.

Shanahan has had a long association with the CIF Southern Section and the administration of high school athletics. He has served as a CIF-SS Council Representative for the past three years and has held the position of Channel League President since 1982.

Prior to becoming the principal of Buena High School, Shanahan was an assistant principal at Ventura High from 1967 to 1980. Among his many responsibilities during the 13-year per-

iod was the coordination of student activities, including the athletic program. In 1976, Shanahan assumed responsibility for instruction at VHS. Before becoming an administrator, he taught speech,

English and drama at Ventura High beginning in 1954.

A 1950 graduate of the University of Nebraska, Shanahan has attended graduate schools at Cal Lutheran, UC Santa Barbara, USC, Columbia, Minnesota and Nebraska. VOLLEYBALL RULE NOTICE

The CIF-SS Executive Committee met on June 20, 1987 and reviewed the National Federation volleyball rules regarding the penalties for illegal game equipment which states:

"1. When the host school does not pad the standards, floor/wall cables and referee's platform according to Rule 3.1.3, the match shall not be played and the state association shall be notified."

It was the decision of the Executive Committee should any school not meet these required game equipment standards as outlined above, the match will not be played as specified by the National Federation and, in addition, **THE GAME WILL BE FORFEITED.**

Please review the National Federation Volleyball Rules for specific requirements regarding padding on standards, floor/wall cables and referee's platform so your school will be in compliance with all National Federation rules.

tions may not maintain the same playing and/or eligibility rules, thus requiring state and National Federation approval.

For further background, the Blue Book requires sanctioning by a host school when it invites four or more schools for competition; or when the host school invites any school from out of the state or country for a single or multi-school event; or if a school is invited to a tournament or contest hosted by a school out of the state or country. In the case where a CIF-SS school is invited to compete against a school from another CIF section, a letter from the site administrator must be filed with the CIF-SS Office.

School administrators are asked to review sanctioning guidelines that are being forwarded to member schools along with sanction forms as part of the fall school packet.

CASTILLO NAMED ORANGE COUNTY OFFICIALS' LIAISON

E.M. "Speed" Castillo, assistant principal of Gilbert High School (Anaheim Union High School District), has been appointed as the first-ever officials' liaison for the Orange County Assignment area, effective with the opening of the 1987-88 school year.

The appointment is a component of a pilot program founded exclusively for the Orange County area, which calls for the association of each sport to directly assign officials for athletic contests. Castillo's major responsibility will be to gather schedules of area schools in all sports and coordinate communications between the associations, schools and the CIF-SS Office.

Castillo has a long and highly successful background in sports officiating. He was an active member of the Arizona Interscholastic Officials' Association in football and basketball from 1954-59 and has been a member of the Southern California Football and Basketball Associations since 1960. Castillo has served as the Orange County instructional chairperson for basketball since 1977, was president of the Southern California Basketball Officials' Association for the 1981-82 season, president of the Orange County Basketball Officials' Association for the 1975-76 season and was a board member of the Southern California Football Officials' Association from 1983 through 1985.

During his officiating career, Castillo has worked eight CIF-SS basketball championships, ten Orange County All-Star basketball games, eight Orange County All-Star football games and the 1984 Shrine All-Star football game. In addition, his experience includes observing officials for the California Collegiate Athletic Association and the Pacific Coast Athletic Association.

A graduate of Arizona State University, Castillo went on to earn his master's degree at the Flagstaff campus in 1959. A veteran of the U.S. Air Force, Castillo served in Korea 1951-1953 and with the Strategic Air Command in New Mexico 1953-55.

LOOKING BACK AT THE CIF SOUTHERN SECTION

75 YEARS AGO

Page one of the CIF Southern Section archives - the first entry logged into the secretary's book - is the original constitution. The document was written by Mr. Seth F. Van Patten, who was soon to become the first CIF-SS Commissioner of Athletics.

Name - This organization shall be known as the "Southern California Interscholastic Athletic Council". (It was amended to the California Interscholastic Federation, Southern Section with the establishment of the state CIF in March of 1914.)

Object - The object of this organization shall be: 1. To promote interscholastic athletics in Southern California and to exercise a broad general supervision over the same. 2. To act as a court of appeal in any dispute involving a Southern California championship or in any dispute when appealed to by all parties concerned. 3. To provide ways and means for athletic championships which seem advisable. 4. To provide uniform eligibility rules for championship athletic contests. 5. It is understood that each league reserves the right to decide questions of eligibility within its own ranks or other questions not affecting any other league.

Members - Any high school athletic league may become a member of this organization by accepting this constitution and by-laws enacted in accordance with the same. When the organization is perfected, new members may be admitted by accepting the constitution and by-laws after having been voted in by the Council. Any high school not a member of a league may become a member in the same manner and have a voice in the Council but not a vote.

The Council - The Council shall be

composed of the Presidents of the leagues having membership in this organization. In case of any league having a student President, such league shall appoint a faculty member as its representative to the Council. The Los Angeles City League, because of the great number of students represented, shall have two delegates to the Council.

Officers - The officers shall be a President, Vice-President, and a Secretary-Treasurer. Their duties shall be such as the names imply. Their term of office shall be for one year or till their successors shall be elected.

Meetings - The annual meeting shall be during the meeting of the Southern California Teachers' Association. The President may call a meeting at any time and must do so upon request of two members of the Council.

Quorum - A majority of the Council shall constitute a quorum.

Amendments - This constitution may be amended by a two-thirds vote of the Council at the annual meeting, provided the proposed amendment had been submitted, in writing, to each member of the Council one month before the annual meeting. It may be changed or amended at any meeting by a unanimous vote.

Eligibility Rule - No one shall represent his school in any championship event or contest between any of the leagues - 1. Who is not passing in 15 hours work per week; 2. Or after the first eight semesters (four years) residence in any secondary school. Ten weeks or over or participa-

process sanctions for football, water polo, wrestling, baseball, swimming and boys' tennis; and Ms. Karen Hellyer will handle the sports of volleyball, girls' tennis, soccer, field hockey, softball and gymnastics.

Further, an addition to Article 7, ratified by the CIF-SS Executive Committee for the 1988-89 school year, concerns events scheduled prior to the official opening of the CIF-SS season of sport. The following will be added to section 700 of the CIF-SS Blue Book: (1.) *Southern Section schools traveling to a school in another state or country located over 500 miles one way for dual or triangular competition will require approval from: (1) local school board; (2) league; (3) CIF Southern Section; (4) State and National Federation, where applicable (with the exception of Arizona and Nevada Schools). Such competition may be scheduled only once every three years.*

(2.) *Two or more teams could travel together at one time (Example: foot-*

ball and cross country teams).

The initiation of this amendment is due to the increasing number of member schools requesting an early start to the football season. In the opinion of many, this creates an unfair advantage. A case in point is that of the eight-team leagues, where schools begin to participate in league games on the third week of the season. In this instance, the early start would allow the school in application an extra week of practice, causing an inequity of competition. Football is the only sport in which an early start would require scheduling of this type, and traditionally, this form of sanctioning has not been approved in any other sport.

The reason for sanctioning is relatively simple. Multiple-school events should not conflict with traditional events and the prescribed number of contests a school may participate in for each sport must be regulated. Where schools from out of the state are concerned, sanctioning is necessary because all high school athletic associa-

tion in one or more athletic contests between teams of different schools or organization shall count as a semesters residence. (Practice games shall count the same as league games).

50 YEARS AGO

When the 1938-39 school year opened, the CIF Southern Section had grown to a membership of 132 schools, 122 of which competed in 19 leagues, the other 10 designated as free lance. Excerpts of the Sept. 30, 1938 Executive Committee meeting:

Mr. Harry J. Moore, Principal of Long Beach Wilson High School, moved that the annual dues for the year 1938-39 be three cents per pupil based on the A.D.A. for 1937-38. The motion was seconded by S. Chester McIntosh, Principal of Puente High School and carried by the committee.

Commissioner Seth F. Van Patten called attention to the rule in the football code in regard to wearing a headgear. Moved by Mr. Moore, seconded by Mr. McIntosh that the

Commissioner of Athletics direct all officials working CIF Southern Section games to enforce this rule rigidly, even for the kicker in try for point after touchdown. Carried.

25 YEARS AGO

By the opening of the 1962-63 school year, the CIF Southern Section boasted 41 leagues and a school membership approaching 300. Excerpts of the Sept. 15, 1962 Executive Committee meeting:

The Executive Committee had been concerned with the matter of public relations and publicity for the CIF-SS and had directed Commissioner Ken Fagans to investigate the problem and report back. The Commissioner reported that the cost of employing a publicity director for the CIF-SS would be excessive, and he suggested that the matter be accomplished by the Commissioner with additional clerical help to relieve other facets of the Commissioner's duties. He also reported that a letter had been directed to the Los Angeles Times complaining about the

lack of prep sports coverage in that paper. A letter was read from Mr. Paul Zimmerman, editor of the Los Angeles Times, in which it was stated that a new prep sports editor had recently been employed and it was hoped that he would give more adequate coverage to prep sports in Southern California.

10 YEARS AGO

When the 1977-78 school year opened, the CIF Southern Section had a membership of 410 high schools and 45 junior highs. Mr. Tom Byrnes was beginning his third year as Commissioner. Excerpts from the June 20, 1977 Executive Committee meeting:

The Commissioner appraised the Executive Committee of the possibility of levying fines as another alternative in the penalty phase for violations of the CIF-SS rules and provided background information on current implementation in some leagues and in other state associations. Following discussion, the Chair was directed to appoint a committee to develop a recommendation for submittal to the council.
