



NEW OFFICIALS' ASSIGNMENT PROCESS

As we are aware, times and needs change constantly in the field of education. This fact pertains to the CIF Southern Section as well. Because of recent developments in the area of school finance, we are looking for ways in which to maintain stability in our current dues structure.

It was apparent that in order to offset the possible raising of dues in our Section, significant dollars must be cut in another area. After lengthy discussions with the Executive Committee and the office staff, it was approved to pilot, in Orange County, a new officials

ON THE COVER

As CIF Southern Section schools get set to kick-off the 1988 football season, one of the major questions confronting opposing coaches and defenders is: Can two-time All-CIF-SS runningback Russell White (No. 4) of Encino Crespi be stopped?

Heading into his senior year, White, who is the nephew of '87 NFL rushing champ and former Heisman Trophy winner Charles White of the L.A. Rams, has amassed 4,658 yards (11.2 per carry) and scored 69 touchdowns. With perhaps his greatest season ahead of him, White already ranks seventh on the all-time CIF-SS career rushing list.

On the defensive side, Matt Butkus of Los Angeles Loyola (No. 57, 6-3, 225) and Marcelous Elder of Long Beach Poly (No. 94, 6-5 275), are set to accept the challenge. Both Butkus, son of NFL Hall-of-Famer Dick Butkus, and Elder earned All-CIF-SS honors in the major division as juniors last fall.

A total of 356 member schools will compete for 57 league and 11 CIF-SS titles (nine 11-man and two eight man) this season, which officially gets underway the weekend of Sept. 8-10.

CIF-SS EXECUTIVE COMMITTEE MINUTES June 18, 1988

The June meeting of the California Interscholastic Federation, Southern Section, Executive Committee was called to order by Chairman Pat Mauch at 9 a.m. on Saturday, June 18, 1988, in Oxnard. All members were present with the exception of Stan Thomas, Sheri Ross and Andy Patterson.

1. PRESIDENT'S UPDATE - President Pat Mauch commended Scott Cathcart for his efforts as editor of the 75th Year Anniversary Bulletin. Additionally, President Mauch related concerns of the Executive Committee with reference to the number of issues that faced the CIF Southern Section during this year with regard to John Muir High School. It was felt that the due process form developed by the Office would be a tool that schools could use as a way of informing parents of the Southern Section of appeals procedures. Larry Zucker was commended for his article in the National Federation News reporting on the Southern Section team and academic awards program.

Executive Committee member Gary Smidderks was appointed to serve as Treasurer for the upcoming 1988-89 school year.

As his final remarks to the Committee, President Mauch felt that a goal of the Committee should be to take a look at the future role of committee members and the function that they perform with reference to establishing a strong foundation in terms of overall lines of communication and representation to the school they are representing. With this in mind, it should be noted that the Committee should develop guidelines and define roles, duties and responsibilities of those members serving on the Executive Committee.

2. COMMISSIONER'S UPDATE - Associate Commissioner Dean Crowley reviewed with the Committee meetings Commissioner Thomas has had with representatives of the Los Angeles Marathon and the Amateur Athletic Foundation, the year-end spring championships, with a strong commendation to the staff for their efforts in conducting successful championship activities, the Norwalk-La Mirada "Say No to Drugs" program, and the proposed Reebok program whereby athletes, coaches, and entertainers would be depicted on posters furnished to member schools with a strong anti-drug message. Additionally, Joe Rotcher updated the Committee on the closing of Miraleste High School and the subsequent litigation whereby an injunction has been issued temporarily forcing the district to keep the school open, with an appeal due in mid-summer. The committee was also updated with reference to the Baldwin Park appeal to the State with reference to their placement in the Sierra League.

Administrator Bill Clark reviewed with the Committee concerns relative to the excessive number of baseball incidents that occurred during this past baseball season. Following discussion, it was the feeling of the Committee that the Commissioner should review with the Council the concerns relative to the incidents in the sports of baseball, basketball and soccer, with each league representative addressing the issue at a subsequent league meeting with a plan forthcoming to the CIF Southern Section Office. Additionally, the staff will work with coaches and athletic administrators.

Eligibility Procedure For Foreign Exchange Students

The annual opening of school in the fall brings a number of questions relative to the eligibility status of foreign exchange students. Hopefully, the following points will assist administratively.

RULE 212 of the Blue Book grants automatic approval for any student under the program noted, and NO approval is necessary from the Southern Section Office.

Additionally if a student is under a foreign exchange program NOT NOTED UNDER RULE 212, then it will be necessary for the petitioning school to submit all placement papers, a brochure from the organization which provides an overview of its selection and placement process, and a phone number of the Area Director. Once received, these are reviewed with the

SYNOPSIS OF 1988-89 BLUE BOOK CHANGES

The following synopsis is designed for the benefit and convenience of athletic administrators and coaches in an effort to provide a capsule summary of the changes in the State CIF and Southern Section Constitution and By-laws. These changes have been enacted by the State CIF Federated Council and/or the Southern Section Council throughout the course of the 1987-88 school year.

The changes are listed initially by topic and follow in parenthesis by the Article and/or Section rule as it appeared in the 1987-88 publication. A synopsis of the change is then noted and followed by the Article and/or Section number as it appears in the current 1988-89 publication for easy reference. For example, CIF-SS 1200.1 means CIF-SS Article 12, Rule 1200, Point 1.

STATE REVISIONS

Article 1 - By-Law 103: Change in By-law adjusting Central Section votes from 6 to 7

Article 15 - By-Law 1501: Entire By-Law deleted by action of the State Federated Council. The State will no longer deviate from the National Federation Rules in Track and Field with regard to uniform requirements. (NF Rule 4, Section 3)

SOUTHERN SECTION REVISIONS

Accountability Rule: Rule re-written to establish guidelines for written explanation of circumstances involved when a coach is ejected from a contest or a school fails to complete a contest. The new wording also allows for better time lines for the filing of correspondence from the school Principal to the CIF-SS Office (By-Law 125.1 and 125.2)

Football Helmets - Conditioning Period: It will now be permissible to use football helmets during the pre-season conditioning period - August 22-24, 1988 (Rule 1403.3)

Adult Chain Crew - Football Playoff: It is mandatory that home schools provide and Adult chain crew for all football playoff games (Rule 1429.7)

Soccer Outside Competition Rule: Delete entire section relative to the number of players on an outside team during the school year - outside the season of sport (Rule 2712.1)

Scouting Prohibitions - Practice Session: Rule re-written prohibiting the scouting of a practice session by anyone without the written consent of the school Principal. Under this new rule, there are NO restrictions with regard to the scouting of athletic contest between schools (Rule 522)

Appeals Dealing with Interscholastic Contest: The Commissioner will have the sole authority to rule on playoff contests with reference to matters involving ineligible player(s), violation(s) of Section rules and regulations and other issues other than playing rules that might affect teams in the playoff draw (Rule 1106.2)

3. BOYS' ATHLETIC DIRECTORS' UPDATE - Mike Moropoulos, Boys' A.D. Representative, expressed his appreciation to the work being done and the leadership shown throughout the State by the Orange County Athletic Directors' Association.

4. SUPERINTENDENTS' UPDATE - Ms. Cynthia Grennan, Superintendents' Representative, updated the Committee on the coaching certification program which now is in its final stages of review by the legal staff of the State Department of Education. Currently, the date for implementation is July 1, 1988. It was the recommendation of the Executive Committee that the Southern Section Office, once the certification program is in the hands of the public school districts, forward guidelines to all private schools in order that they may address the needs of their particular institutions with regard to liability.

5. TREASURER'S UPDATE - Mr. Bruce Keuning provided an update of the 1987-88 working budget and the spring playoff income.

6. STATE REPORT -

(A) **STATE BUDGET** - The proposed State budget was passed at the April 29, 1988 meeting of the State Federated Council.

(B) **SCHOOL PROPERTIES CONTRACT** - A motion was passed empowering the Executive Committee to begin School Properties contract negotiations immediately, keeping Sections abreast of contractual terms for ratification at the October meeting.

(C) **GIRLS' GOLF** - It was moved, seconded and passed by the State Federated Council that girls playing on student golf teams return to the original rule (girls' using men's tees) for the remainder of the school year until further study can be completed.

(D) **SAN DIEGO SECTION RULE PROPOSALS** - A proposal recommending a change in the scoring in dual swimming meets and a recommendation increasing the pitching distance in girls' softball from 40 feet to 43 feet will be forwarded to the National Federation for their review and consideration.

Additionally, Bob Packer reviewed the State five-year projected calendar and asked that the Southern Section review the calendar and give consideration to setting the Southern Section Council meetings prior to the last State Federated Council meeting.

7. HALL OF FAME COMMITTEE REPORT - Mr. Bruce Kitchen reviewed a letter from the

National Federation with reference to a change in the National Federation Hall of Fame nomination procedure.

MATER DEI HIGH SCHOOL UPDATE - Associate Commissioner Dean Crowley reported on his meeting with administrative staff members James Golden, Robert Gonzalez and Becky Allec for an in-service on eligibility rules and regulations. As a result of that meeting, new procedures have been adopted by Mater Dei High School. It was assured that Mater Dei will give full cooperation and support, and the meeting was very positive and recommendations are now in place and both the Southern Section and Mater Dei High School look forward to a positive relationship.

9. FOOTBALL PLAYOFF EXPENSE COMMITTEE REPORT - Gary Smidderks reported on work being done by the Football Game Expense Committee with reference to the wide variance in game expenses reported for Southern Section football contests. The Committee gathered data and established criteria as to the differences in playoff expenses. It was the feeling of the Executive Committee that this be placed on the Council agenda for further consideration.

10. ASSIGNERS PROGRAM UPDATE - Administrator Bill Clark reported to the Committee the positive feedback received with reference to the Orange County pilot officials program and that plans are now underway to implement the program beginning next year in the following areas: Coachella Valley/Imperial Valley, Upper Desert, Inland, Long Beach/Whittier and South Bay.

11. GEOGRAPHICAL RELEAGUING UPDATE - Associate Commissioner Dean Crowley updated the Committee with regard to the Coast and San Gabriel Valley Geographical areas where the greatest number of school closures have been experienced in the last five years. The CIF-SS staff, after several meetings with league representatives and school principals, recommends disbanding the current San Gabriel Valley re-leaguings area and attaching the 21 schools to other existing areas. At the present time, several plans are being drafted which will be reviewed by league representatives and school principals of the affected areas.

12. GOLF TOURNAMENT - Gary Smidderks updated the Committee on the Southern California Golf Coaches Association Annual Golf Tournament, the funds of which will be used to assist the CIF Southern Section in conducting its

manner and assessing a fee from the officials or the association(s) to pay the assigner. This fee eliminates the line item expense to the CIF-SS Budget. During the 1987-88 school year, \$105,000 was the Section's cost for this purpose.

For the 1988-89 school year, the following areas are now committed to their own assigning: Orange County, Long Beach/Whittier, Upper Desert, South Bay, Coachella Valley/Imperial Valley and Inland.

Each of these assignment areas have agreed to begin the new process for this

golf championship program.

13. SUPERINTENDENTS' SYMPOSIUM - Associate Commissioner Dean Crowley updated the Committee on the Superintendent/Board Member Symposium, which will be held on Thursday, October 27 at the Sequoia Athletic Club in Buena Park, the theme of which will be "Know Your Southern Section CIF."

14. NEW SCHOOL MEMBERSHIPS - It was moved, seconded and passed to approve membership for Faith Baptist Christian High School (Riverside). In addition, it was moved, seconded and passed to table approval of Antelope Valley Christian (Lancaster) and Christian Center High School/Christian Center Academy (Colton). The application for membership of Delphi Academy has been withdrawn.

Following discussion, it was moved, seconded and passed not to approve the membership of Ventura School, a California Youth Authority institution.

15. ST. ANTHONY HIGH SCHOOL REQUEST - Following discussion, it was moved, seconded and passed to reinstate Mr. Tom Roanhaus, basketball coach at St. Anthony High School, effective immediately.

16. HESPERIA HIGH SCHOOL REQUEST - Following discussion, it was moved, seconded and passed to deny a waiver requesting an early start for organized team practice in the sports of girls' tennis, b/g cross country and girls' volleyball to Hesperia High School. Further, it was recommended to refer the request to the Season of Sport Committee for further study and recommendation.

17. BASKETBALL RULE 10-5 - BENCH DECORUM RULE - Following discussion, it was moved, seconded and passed to request permission from the State CIF to experiment with basketball rule 10-5, allowing coaches to stand within a 6 foot area during a basketball game for the sole purpose of coaching players.

18. LONE PINE AND MAMMOTH HIGH SCHOOL REQUEST - Following discussion, it was moved, seconded and passed to approve a football request from Lone Pine and Mammoth High Schools due to their geographical isolation.

There being no further business to come before the Committee, the meeting was adjourned at 3:20 p.m.

did. We appreciate and recognize from each of these people, the commitment in developing and maintaining the high standards of athletic competition for the CIF Southern Section. By working together, this will be accomplished over the next two years.

It is my belief that by mutual cooperation and a concerted effort by all, we are guaranteeing our students the highest standard of athletic competition for future years.

CIF-SS COUNCIL MEETING MINUTES

May 5, 1988

The May meeting of the CIF-SS Council was called to order by President Pat Mauch at 9:38 a.m. on Thursday, May 5, 1988 at the Sequoia Club in Buena Park. All leagues were present with the exception of the Christian League.

1. APPROVAL OF MINUTES - It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of March 17, 1988 as mailed to the Council; and the CIF-SS Executive Committee minutes of April 3, 1988 as mailed to the Council.

2. PRESIDENT'S UPDATE - President Pat Mauch extended his appreciation to the Council for their support during his term of office as CIF-SS President. Additionally, President Mauch commended Executive Committee members Robert Paisola, Tony Balsamo and Doug Rozelle, who will all be retiring at the end of this current school year.

3. COMMISSIONER'S UPDATE - Commissioner Stan Thomas reviewed the current all-star rule, a proposal to conduct a feasibility study to further a walk-on coach in-service program, and the draft of a due process form which is to be read, edited and returned by league representatives with suggestions which will be tabulated and reviewed with the Council at the September meeting.

In addition, Commissioner Thomas made a special presentation to John Stevenson of El Segunio High School in recognition of his 600th win in baseball, which places him among the top six in wins nationally.

4. TREASURER'S REPORT - Bruce Keuning, Treasurer, reviewed with the Council the financial report of the winter playoffs and an update of the current 1987-88 working budget.

5. STATE FEDERATED COUNCIL REPORT - Mr. Bob Paisola, representative to the State Federated Council, reviewed items from the State Federated Council meeting of April 29, 1988:

(A) School Properties - State Federated Council empowered the Executive Committee to begin contract negotiations with School Properties immediately, keeping Section abreast of contractual terms for possible ratification at the October meeting of the State Federated Council.

(B) Girl's Golf Tees - It was moved, seconded and passed that girls playing on student golf teams return to the original rule (girls using men's tees) for the remainder of the current school year until a further study and recommendation can be brought forward.

(C) Election of State Executive Committee - Dr. Robert Packer will serve on the State Federated Council Executive Committee as President-elect.

(D) San Diego Section rule proposals in swimming recommending a change in the scoring in dual swimming meets and in softball recommending an increase in the pitching distance from 40 to 43 feet were passed by the Council, while a proposal dealing with swimming relay entries was defeated. It should be noted that those items approved by the State Federated Council, will be forwarded to the National Federation Rules Committee for their consideration.

(E) All-star Competition - The Los Angeles City Section and the Southern Section proposed a change in the State Constitution and By-laws dealing with all-star competition in the sport of basketball (rules 900 and 904). It should be noted that this will be an action item at the State Federated Council meeting in October of 1988.

(F) Wrestling Advisory Committee - The Southern Section proposed that the State Office give consideration to creating a Wrestling Advisory Committee at the State level.

(G) State Cross Country Championship Team Awards - The Central Coast Section proposed that team awards (plaques) be increased from 2 to 3 in all cross country championship activities. It should be noted that this proposal will be voted on at the State Federated Council meeting of October, 1988.

6. GOLD LIFE PASS COMMITTEE REPORT - Mr. Lon Hargrave introduced recipients of Gold Life Passes for 1988 in recognition of their long-standing service to the CIF Southern Section. Recipients for the 1987-88 year were Margaret Ramondetti and Dr. Stan Oswalt.

7. SOCCER PROPOSAL - Roger Bryant presented a proposal on behalf of the Bay League relative to the tie-breaking procedure for use in CIF-SS playoff contests leading up to the championship game. This is a non-action item and will be voted upon at the September 22, 1988 Southern Section Council Meeting.

8. GIRLS HURDLES - Associate Commissioner Dean Crowley reported that the adoption of the 33-inch hurdles for girls has been pushed back to 1993 by the State CIF.

9. SUMMERTIME RULES - SUMMER PAY FOR COACHES - Commissioner Thomas reviewed the summer activities proposal that was passed in April by the Southern Section Executive Committee. This proposal will permit member schools to use equipment, uniforms, facilities, utilities, etc. for summer activities with the AUTHORIZATION OF THE SCHOOL PRINCIPAL. This would affect summertime rules 1423, 1512, 1610, 1710, 1812, 1912, 2010, 2109, 2308, 2411, 2510, 2608, 2710, and 2809. Additionally, school districts or booster clubs may pay entry fees for summer activities. SPECIAL NOTE: In the sport of football, stand-up dummies, two or seven-man sleds, tackling dummies and other protective equipment (such as helmets, pads, etc.) are prohibited for summer activity (Rule 1423). In addition, the Executive Committee authorized the following entities only to pay coaches for summer services: district office, ASB through the Principal, duly licensed community organizations (i.e. parks and recreations). Under no circumstances will the Southern Section condone payment by individuals, special interest groups or booster clubs.

When Southern Section member schools undertake summertime athletic competition, appropriate rules and procedures regulating the establishment, implementation, maintenance, monitoring and accountability of said activity should come under the governance of the appropriate school district and/or school principal.

10. OFFICIALS ASSIGNMENT PROPOSAL - Administrator Bill Clark reviewed the master plan and time line for the officials' assignment program implementation within the Southern Section.

11. CIF-SS 1988-89 BUDGET - Mr. Bruce Keuning, Treasurer, presented the 1988-89 proposed budget. Following discussion, it was moved, seconded and passed to adopt the budget as presented.


CANO, GUNN AND TRIGGS JOIN EXECUTIVE COMMITTEE

The CIF Southern Section is pleased to announce the addition of Frank Cano, Ken Gunn and Tom Triggs to the Executive Committee for the 1988-89 school year. The appointment of the trio was confirmed by the CIF-SS Council membership at its May 5, 1988 meeting in Buena Park.

Cano, who has been the principal of Alhambra High School for the past 12 years, has worked actively for the cause of high school athletics and the CIF Southern Section in many capacities. His experience includes service as a council representative for both the Pacific and Foothill Leagues, chairperson of the Foothill League Releaguings Committee, chairperson of the CIF-SS Releaguings Committee and member of the CIF-SS Playoff Committee.

Cano has been in education for 27 years, teaching at both the high school and junior high levels. His administrative tenure includes assignments as an assistant-principal for guidance, assistant-principal for business and activities and his current position of high school principal. A graduate of California State University, Los Angeles, Cano went on to receive his masters degree at the University of Southern California.

Gunn, principal of Walnut High School, follows in his father's footsteps as a member of the CIF Southern Section Executive Committee. Keith Gunn, who for many years was the principal at Victor Valley High School, served three terms on the Executive Committee (1950-51, 1956-66 and 1967-70). 
In the sports of football, boys and girls basketball and baseball, the high

In the sports of girls' volleyball and softball, the selections are made by the coaches' associations and coordinated by the CIF-SS Advisory Board for each sport.

times annually. They should receive the majority of the credit along with the hundreds of coaches, who for years have been very cooperative in providing our group with information."

The Amateur Athletic Foundation was born in 1936 through the joint efforts of the late Paul H. Helms and the late W.R. "Bill" Schroeder. Helms, the founder of a highly successful Southern California bakery, hired Schroeder to institute the Helms Athletic Foundation for the purpose of supporting worthy athletic endeavors. Since its origin, the Foundation has recognized athletes in nearly every corner of the world.

After its modest beginnings on the upper floor of the W.M. Garland Building at Ninth and Spring Streets in downtown Los Angeles, the Foundation moved into its own building - the Helms Hall - in 1948. There, for the first time, the growing collection of athletic memorabilia could be suitably displayed and shared by thousands of enthusiastic fans each year. The building was later enlarged as the athletic museum continued to expand. It also served as home to the CIF Southern Section Office from 1949-59.

In 1970, the museum was moved to the ground floor of the Citizens Savings and Loan Association office, adjacent to the Los Angeles International Airport. In September of 1981, the responsibility of sustaining the Athletic Foundation and for expanding its programs was accepted by First Interstate Bank of California.

BASKETBALL RULE CHANGES FOR 1988-89

NATIONAL FED RELAXES RULE ON INBOUNDS PASS

Beginning with the 1988-89 high school basketball season, the five-second, throw-in count will end on the release of the ball rather than when the ball is touched by a player on the court.

This rule change was one of 12 significant changes made by the National Federation Basketball Rules Committee at its March 29-30 meeting in Kansas City.

Dick Schindler, editor of the National Federation, said the change in Rule 9-3-3 was mainly an administrative one to aid officials.

"With this change, the official closest to the player throwing in the ball will know definitely when the five-second count ends," Schindler said. "Previously, it was difficult to administer for

officials when long passes were made by the out-of-bounds player. It is now an easier rule to administer."

In another change in throw-in procedures, the committee altered Rule 9-9 to allow an airborne player to jump from frontcourt to catch a throw-in pass and land in backcourt. Previously, this would have been a backcourt violation.

Schindler said that more and more throw-ins were occurring at the division line because of the alternating-possession rule. The committee believes that the implementation of this rule will help eliminate a situation which inadvertently resulted in a violation.

Although no changes were made in Rule 10-5 regarding bench decorum,

the committee agreed to allow states to experiment with the rule by allowing coaches to stand within a specified six-foot area during the game for the sole purpose of coaching players. Requests by state associations must be approved by the National Federation.

The current rule requires coaches to remain seated on the bench while the clock is running or stopped except to confer with bench personnel and players, rise and stand to signal players to request a timeout, confer with personnel at the scorer's table, attend an injured player, replace or remove a disqualified or injured player or to react spontaneously to an outstanding play.

"The committee wants to gather

BASEBALL RULE CHANGES FOR 1989

COMMITTEE MAKES METAL CLEATS LEGAL AGAIN

Effective with the 1989 high school baseball season, players will be permitted to use metal cleats.

In its June 27-28 meeting in Kansas City, the National Federation Baseball Rules Committee reinstated the use of metal cleats after a five-year absence. Since 1984, only non-metal cleats have been allowed at the high school level.

"Because of conflicting information pertaining to injuries attributed to non-metal and metal cleats, the rules committee could not judge which types of injuries were more significant," said Brad Rumble, editor of the National Federation baseball rules. "Not being medical authorities, the committee decided that both types of shoes should be allowed."

Six other rules changes were made by the committee, including a penalty for unsportsmanlike conduct by the coach that would restrict him to the dugout for the remainder of the game.

As an alternative to ejecting a coach, Rule 3-3-1 now will allow the umpire to restrict the coach to the dugout for unsportsmanlike conduct. The decision would be at an umpire's discretion and would be based on severity of the coach's conduct.

The intent of the change is to allow games to continue in those situations where the coach's conduct is not

blatant," Rumble said. "If a coach is ejected and there is not another adult sponsor or assistant coach, the game is forfeited in some states. This rule change gives the umpire an option for less severe conduct by the coach."

Rule 4-4-1-f now will allow a team that has its final player ejected to continue the game with eight players. Previously, only a team that lost its final player through injury or illness could continue play but had to forfeit the game when its final player was ejected.

Because of an increasing number of players wearing protective devices on batting helmets, the committee determined that Rule 1-1-6 no longer will require state associations to approve each particular case.

In another change involving the playing field and equipment, Rule 1-3-1 will permit a double first base by state association adoption. This alternative was instituted in softball two years ago.

"This option was enacted for safety reasons because it reduces the possibility of a fielder and runner colliding on an initial play at first base," Rumble said. "Safety is the No. 1 priority of the committee."

Two changes were made in Rule 6 involving pitching. Rule 6-1 now will

require state associations to adopt limits on the amount a pitcher can throw.

"The committee is concerned that pitchers are ruining their arms by throwing too much in a given amount of time," Rumble said. "We are asking that states adopt some type of restrictions so that adequate rest is obtained between pitching appearances."

Beginning next season, a change in Rule 6-1-3 will require pitchers to come to a complete and discernible stop in the set position. Although the rule has been the same in the past, it has been satisfied by a pitcher simply changing direction. Henceforth, the pause must be recognizable and observable.

"The committee's action this year reflected the major concerns of high school baseball - safety, participation and conduct," Rumble said. "The relatively small number of changes reflects the committee's belief that the game is thriving and popular and there's not a need to make major changes."

Baseball is the fourth-most popular sport at the high school level with 406,046 participants, trailing only football, basketball and outdoor track. It ranks third in school sponsorship with 13,615, trailing basketball and outdoor track.

organization, and in most cases, there is a time delay until all questions have been answered - the key element being whether it is possible under a program, for a student to be placed other than by random placement. If a student is not placed at random, the appeal is generally denied.

It is incumbent that the appropriate school administrator review all transcripts to determine age and completion of requirements by the student in question; - a student who has graduated from a high school and is now in the U.S. under a foreign exchange program would not be eligible for competition.

If a foreign student is under NO program, the student is not eligible as per guidelines of Rule 214. Foreign students are not eligible under our present rules and regulations unless parents (meaning the entire family) have made a bona fide move to the new school attendance area. Foreign students moving with relatives, friends of the family, etc. would not be eligible for athletics during the first year of attendance at a CIF Southern Section school. This means they are not eligible for competition at ANY level, and it would take one full year to establish eligibility.





and passed to approve the following amendments to the CIF-SS Constitution and By-laws:
RULE 522 - A. SCOUTING PROHIBITIONS
- **PRACTICE SESSION** - Scouting of any type which would include personal viewing, written notes, audio tape, motion pictures, video reproduction and/or any other type of reproduction, such as still pictures, etc. shall not be taken in any sport of a member school's practice sessions by anyone without written consent of the participating school(s).

Q and A - What is allowed with regard to scouting a contest?

There will be NO restrictions on the part of member schools regarding the filming/video taping of any contest. Home schools will maintain game management rights and responsibilities.

B. Rule 125 - ACCOUNTABILITY

125.1 - COACH EJECTION - Upon the ejection of a coach from any CIF-SS contest, it is the responsibility of the principal of said school to file a letter of explanation with the CIF Southern Section Office, which includes the circumstances surrounding the matter and what action the principal has taken to prevent a recurrence. Said correspondence is to be FILED WITHIN THREE SCHOOL DAYS OF NOTIFICATION OF THE EJECTION. After the three-day filing period has passed, the coach will not be allowed to return to his/her role at the next contest until the Office receives the required correspondence.

125.2 - FAILURE TO COMPLETE A CONTEST - When a school fails to complete a contest, due to a coach pulling his/her team from the floor, court or field, it is MANDATORY that the CIF-SS Office be notified by the Principal within 24 hours (excluding holidays and weekends). The competing schools and officials will be required to file written reports, and after review of the aforementioned material, the principal of the school involved will be required to respond to the CIF Southern Section Office concerning his/her investigation of the incident.

C. RULE 1106.2 - APPEALS DEALING WITH INTERSCHOLASTIC CONTESTS -

Any protest of a playoff contest involving an ineligible player, violation(s) of Southern Section rules and regulations which may affect teams in the playoff draw, or matters other than playing rules that might affect teams in the playoff draw, will be processed by the Commissioner, who will have the SOLE authority to rule on the contest or any contest to be played in upcoming rounds.

18. SEASON OF SPORT COMMITTEE RECOMMENDATION -

(A) Desert-Inyo League Fall Sports Practice Proposal - a proposal by the Desert Inyo League calling for ALL fall sports to begin practice on the same date as football was defeated.

(B) Sunset League R and R Week Proposal - A proposal by the Sunset League calling for a change in the R and R Week for the spring of 1989 from May 15-20 to May 8-13 was defeated.

(C) Sunset League Summer R and R Week - The Sunset League proposal calling for a summer R and R period failed to get a second.

(D) Century League Summer Proposal - The Century League summer proposal was withdrawn.

data from states that experiment as to whether this procedure will assist coaches in communicating with players without increasing sportsmanship problems," Schindler said. "This is strictly an experimental procedure which may be granted to states; the rule has not been changed."

In other rules changes for 1988-89, the committee voted to prohibit players from wearing tights or undergarments that extend below the uniform shorts, as well as prohibiting the use of any replay or television-monitoring equipment to help in making any decision relating to the game. Both of these changes were made in response to growing problems in each of those areas.

The implementation of the three-point field goal last year brought about a change this year in Rule 4-1-2 regarding the definition of "ending a try."

Beginning next season, legal touching of the ball will not end a try, Legal

touching of the ball will no longer be a part of the definition of ending a try.

"When the three-point field goal was implemented, we had a difference in the definition and interpretation of a try," Schindler said. "The rule was in conflict with the interpretation, so the 'touching' part of the rule was deleted."

The committee also authorized, by state association adoption, the use of artificial limbs for players. The limb, in the state's opinion, must not be more dangerous to players than the corresponding human limb and must not place an opponent at a disadvantage.

Two changes were made in Rule 5. Rule 5-3-3a now will allow an airborne player in possession of the ball to call a timeout. In addition, a note will be added to Rule 5-2-1 to allow each state association to determine whether the three-point field goal will be used in junior high competition.

In other rules changes, the committee deleted the part of Rule 10-6 that automatically awarded two free throws

for a blocking foul committed against an airborne shooter. Also, changes were made in Rules 7-5-1, 3 and 9-1-12 to delete all references to taking the ball to the free-throw line extended for a throw-in. In the future, the ball will be put into play closest to the spot where a violation occurs.

The word "abbreviation" was added to Rule 3-4-2 to state that one identifying name or abbreviation may be placed horizontally or vertically on either or both the front and back of the shirt.

After one year of emphasizing a new procedure for resuming play, the rules committee adopted the procedure as an official rule. If teams are not in place following a timeout or intermission after the procedure process, a violation occurs. Schindler said this procedure worked well last year and helped keep games going at the intended pace.

The committee selected three concerns for "Points of Emphasis" this year. Those areas of concern are enforcement of the principle of verticality, conduct and sportsmanship by teams and fans, and the general philosophy of rules enforcement.

Schindler said that officials are there to enforce rules, not to make decisions on which rules to enforce. Additionally, coaches should teach players to play within the rules.

BALDWIN PARK HS RELEAGUING APPEAL - Mr. Donald Vail, Principal of Baldwin Park High School, appeared before the Council to appeal the decision of the area relegating placing Baldwin Park HS in the Sierra League for the 1988-90 cycle due to the recent closure of Edgewood High School. Following discussion, it was moved, seconded and passed to deny the appeal.
