



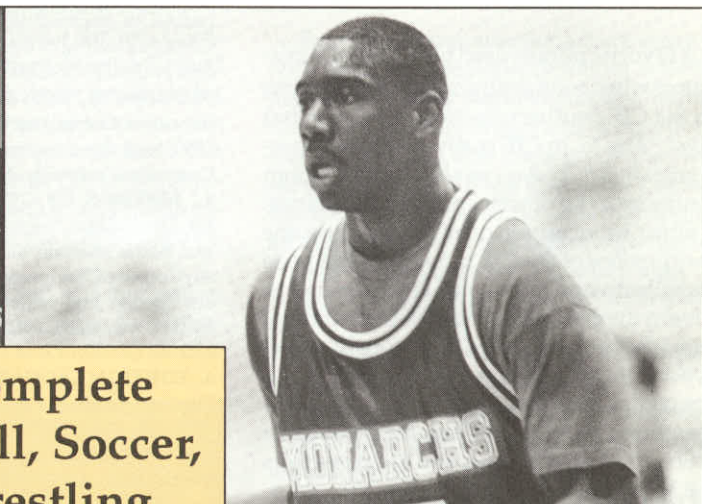
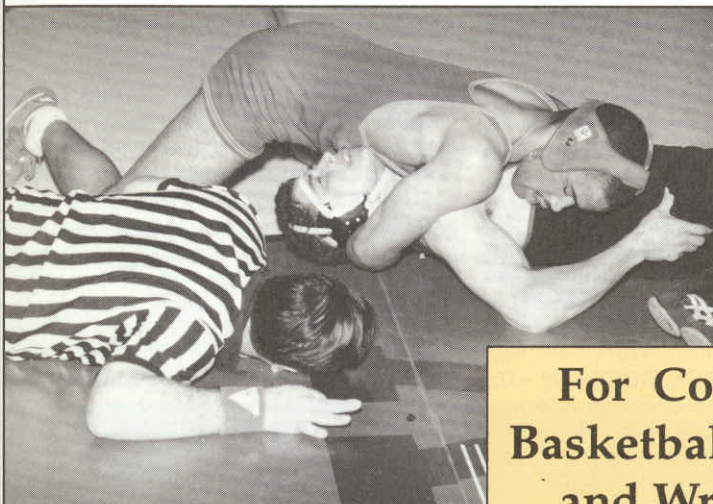

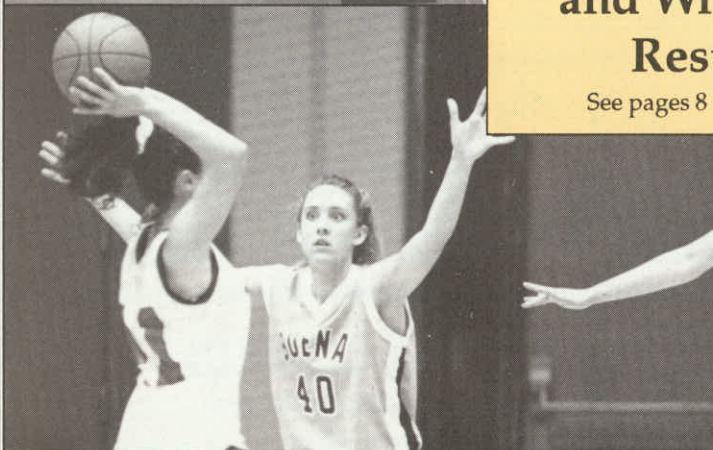

A favorite phrase used by office administrators when conducting orientation sessions on the CIF Southern Section is the one that says: "The 'C' in CIF really stands for communication." Today, as always, this axiom continues to be of tremendous importance.

Since its inception over 80 years ago, the very essence of the CIF movement has been the collective effort of voluntary members to govern themselves in the administration of interscholastic athletics. Obviously, effective communications are key in an organization composed of nearly 500 member schools spanning a geographical area from El Centro to Shandon on the coast, and as far north as Lee Vining in the Eastern Sierra.

Each year, the CIF Southern Section Office procures and/or produces hundreds of publications in massive quantities for use by its broad constituency, including member-school principals; athletic directors and coaches; district superintendents; area media outlets; officials associations; and additional groups with special interest to high school athletics. To name a few, the materials include the CIF-SS Blue Book (the Constitution and By-Laws and Directory of Member Schools), the quarterly CIF-SS Bulletin, master schedules, National Federation rule books, individual sport previews, weekly press releases, playoff handbooks, the athletic administrators' monthly update, championship game programs, council packets and specific-event memorandums and/or bulletins too numerous to count. All of these items have particular --even crucial-- importance to someone on each and every campus. Some are generic in purpose, some are highly specialized.

The CIF-SS has constantly evaluated its system of dispersement for these important materials. Regular assessments are made to determine the most effective way to forward these items, based upon weight, time factors and ultimately, cost efficiency. It would be wonderful to send everything via first class mail, but our mailing budget would soon go through the roof. Our efforts have been to

## CIF-SS COUNCIL MEETING MINUTES

January 21, 1993

The January meeting of the CIF-SS Council was called to order by Dr. Gary Smidderks at 9:00 a.m. on Thursday, January 21, 1993 at the Sequoia Athletic Club in Buena Park. All leagues were present with the exception of Arrowhead, Camino Real, Condor, Coast Valley, Del Rey, Desert Mountain, Express, Frontier, Garden Grove, High Desert, Horizon, South Coast and Sunrise.

1. **STRATEGIC PLANNING** -- The Council engaged in a State project answering questions relative to the State Strategic Planning program.  
2. **MINUTES** -- It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of September 17, 1993; the minutes of the CIF-SS Executive Committee meeting of October 21, 1992; the minutes of the CIF-SS Executive Committee meeting of September 24, 1992; and the minutes of the CIF-SS Executive Committee meeting of January 9, 1993.

3. **FRIENDS OF GOLF PRESENTATION** -- Mr. David Diltz, President of the Friends of Golf, and Eddie Merrins, Golf Professional from Bel-Air Country Club, presented stipends to 49 Southern Section high schools. The total stipend of \$30,000 was distributed in amounts ranging from \$150 to \$1,000.

4. **FOREIGN EXCHANGE PROGRAMS** -- Dr. Hanford Rants, the State CIF Foreign Exchange Program Consultant, addressed Council relative to the State CIF policy as it relates to foreign exchange students and their impact upon high school athletic programs.

5. **SOUTH COAST LEAGUE SUMMER DEAD PERIOD WATER POLO PROPOSAL** -- Don Stahl, Water Polo Coach of El Toro High School, and a member of the CIF-SS Water Polo Coaches Advisory Committee, presented a proposal seeking greater flexibility in the summer dead period for the sport of water polo. This will be an action item and will be voted on by the Council at its meeting in March.

6. **SAN GABRIEL VALLEY LEAGUE SUMMER DEAD PERIOD/GIRLS' VOLLEYBALL PROPOSAL** -- Dr. Phil Jones, San Gabriel Valley League Representative, presented a proposal recommending that the summer dead period for girls' volleyball coincide with the same regulations that currently conform to water polo and cross country. This will be an action item and will be voted on by the Council at its meeting in March.

7. **SAN GABRIEL VALLEY LEAGUE SPRING/SUMMER FOOTBALL RULE PROPOSAL** -- Dr. Phil Jones, San Gabriel Valley League Representative, presented a proposal recommending that the current summer football rules be altered so that they will be consistent with spring football rules allowing specific equipment that is now prohibited to be used at this time. This will be an action item and will be voted on by the Council at its meeting in March.

## FRIENDS OF GOLF CONTRIBUTE GENEROUSLY

Few -- if any --- annual occasions involving the CIF Southern Section are as enjoyable to report upon as the contribution to member schools made by the Friends of Golf, Inc. Once again this year, the service organization provided \$30,000 in support of golf programs at CIF-SS member schools.

In turn, the CIF Southern Section administration distributed the money to 49 member-school programs, based upon need. To determine schools that would receive a portion of the funds, the CIF-SS developed an application process requesting schools to show dollar-amount figures for specific needs. A further stipulation required each of the schools to match the F.O.G. donation with ASB or district funds in direct support of golf.

"Obviously, the CIF Southern Section is once again indebted to the Friends of Golf for their much-needed financial support of high school golf," said Stan Thomas, Commissioner of Athletics. "Golf is a sport in which our member schools can never recoup the costs of conducting competition, and in many cases, this generous support has actually kept programs afloat."

Now in its 14th year, the Friends of Golf, Inc. has hundreds of members throughout the world, who are devoted to support-

ing the game at its "grass-roots" level. The service organization lends financial assistance to junior golf, caddy programs, high school teams and intercollegiate programs. Recently, some questions have come up with regard to elementary school activities that are hosted by member schools. In these situations, the following rules will apply. It should be noted that these guidelines were set down by the CIF-SS Executive Committee, and they are the same rules that apply to all member schools within the organization.

Schools may provide the following:

1. Facility--such as gym, fields, locker rooms, etc.
2. The high school may be in charge of concessions and profits from same.
3. The high school may provide officials.

As to other areas of concern, the following would apply:

1. The Tournament Director must be a person not affiliated with the hosting member school.
2. The Agency or school entity that the host school is conducting an activity for must be either an elementary school or a youth service organization.
3. All checks must be made out to the outside agency not to the member high school.

## MINUTES OF THE EXECUTIVE COMMITTEE MEETING

January 9, 1993

The January meeting of the CIF-SS Executive Committee was called to order by President Dr. Gary Smidderks at 9:00 a.m. on Saturday, January 9, 1993 at Palm Desert High School. All members were present with the exception of Frank Cano and Ron Franklin.

1. **MINUTES**--It was moved, seconded and passed to approve the minutes of the Executive Committee meeting of November 24, 1992.

2. **PRESIDENT'S UPDATE**--Dr. Gary Smidderks reviewed with the Committee concerns surrounding the Eisenhower High School semifinal playoff site in the recently completed football playoffs. Following discussion, it was moved, seconded and passed to appoint a committee to review the play-off handbooks in football and basketball as it deals with coin flips and home sites.

3. **COMMISSIONER'S UPDATE**--Commissioner Stan Thomas reviewed with the Committee the new office lease agreement with the ABC School District; the San Marcos foreign exchange basketball situation; the Reebok Bowl; and the status of the Reebok and Pepsi contracts for 1993. It should be noted that the State has been notified that Reebok has no interest in renewing their contract which terminates at the end of the school year in June, and that Pepsi has requested a reduction in their support by 50% on a contract renewal.

Additionally, Associate Commissioner Dean Crowley reviewed with the Committee the survey sent to all constituents with reference to the basketball playoff format. It should be noted that a recommendation will be forthcoming to the Council at its meeting of January 21 to limit the number of league entries.

4. **GIRLS' ATHLETIC DIRECTOR UPDATE**--Girls' AD Representative Donna Gunstream expressed concerns with reference to Pepsi not meeting contractual obligations with member schools.

5. **BOYS' ATHLETIC DIRECTOR UPDATE**--Boys' AD Representative Donn Clickard reviewed with the Committee the suggested reorganization of the State by-laws dealing with the sport sections, which would be listed alphabetically rather than in their present format in the State and Southern Section Constitutions.

6. **TREASURER'S REPORT**--Treasurer Tom Triggs reviewed with the Committee the Division I football championships, the Reebok Bowl and the fall sport financial update. Additionally, he informed the Committee that the following schools are still delinquent in their dues for the 1992-93 year: Chaffey, Edison, LB Youth Home, Morningside, Oak Hill, Oakwood, Oxnard and Ventura County Christian High Schools. The CIF-SS Council, at its meeting of January 21, 1993 will move to drop these schools from membership.

7. **STATE REPORT**--Dr. Robert Packer, a member of the State CIF Executive Committee, discussed with the Committee the restructuring of the State legal services; the recent memo from State Commissioner Tom Byrnes relative to HIV preventative measures; female pole vault; and modification of Bylaw 1702 (b) and 1702 (c). Additionally, he gave a brief overview of the January, 1993 National Federation Winter Meeting, held in Newport Beach, where the football rules for the 1993-94 season were approved.

8. **LEGAL UPDATE**--At 12:28 p.m. it was moved,

seconded and passed to go into closed session to review pending litigation. At 2:55 p.m., it was moved, seconded and passed to go back into open session.

9. **STRATEGIC PLANNING**--Dr. Ken Gunn gave a brief overview of the progress of strategic planning at the State level.

10. **MARKETING MANAGEMENT**--Dr. Gary Smidderks gave an overview of the progress of the marketing management committee, with a selection process nearing completion for a marketing management group to represent the CIF.

11. **ORANGE COUNTY SECTION UPDATE**--Tom Triggs advised the Committee that organizational meetings are continuing relative to formation of an Orange County Section, with a target date of 1994-95. It should be noted that the Orange County leadership is working in cooperation with the State Strategic Planning process.

12. **CIF ADVISORY ALERT - HIV**--Dr. Gary Smidderks expressed concerns that each school be aware that the State CIF Office has sent a list of communicable disease precautions, as developed by the National Federation and State CIF to all school principals. It should be noted that schools and districts should take note of this and give consideration to developing plans for an awareness program among their staff.

13. **AREA REPRESENTATIVES**--Area representatives reported on relegating and area placement progress in their areas; a proposed use of specific football equipment during the summer; the R & R period for fall and winter sports; HIV concerns; geographical vs. competitive equity in playoffs; and contest safety precautions. It was also announced that the gym at Lompoc High School was recently named after former Executive Committee member Bob Paisola.

14. **NEW MEMBERSHIP**--It was moved, seconded and passed to approve membership for Santa Clarita Christian High School for free lance status.

15. **AREA PLACEMENT APPEALS**--President Dr. Gary Smidderks reviewed due process and the Committee heard the following appeals regarding area placement for the 1994-98 relegating cycle:

**CITRUS BELT AREA:** Palm Springs and Cathedral City High Schools appeared before the Committee to request placement in the Desert Area for relegating purposes. Speaking in support were Dick Williams, Principal of Palm Springs High School, and Dr. Mike Jones, Principal of Palm Desert High School. Additionally, several individuals in attendance also spoke in support of their request. Following discussion, it was moved, seconded and passed to **RECOMMEND APPROVAL OF THE APPEAL.**

**DESERT AREA:** Silver Valley HS Assistant Principal Doug DeWitt appeared before the Committee appealing the decision of the Relegating Committee denying their request for placement in the Citrus Belt Area. Alex McConahay, Principal of Banning High School, spoke in opposition to the placement of Silver Valley HS in the Citrus Belt Area, due to travel concerns. Following discussion, it was moved, seconded and passed to **RECOMMEND DENIAL OF THE APPEAL OF Silver Valley HS.** It should be noted that Silver

Valley HS may appeal this decision to the full Council at its meeting of January 21, 1993.

The Committee reviewed correspondence from Mike Gilmore, Principal of Palo Verde HS, appealing the decision of the Relegating Committee denying its request to be placed in the Citrus Belt Area. Several principals from schools in the Citrus Belt Area spoke in opposition to this request. Following discussion, it was moved, seconded and passed to **SUSTAIN THE ACTION of the Relegating Committee.** This recommendation may be appealed to the Council at its meeting of January 21, 1993.

**FREELANCE:** The Committee reviewed correspondence from Greg Reece, Assistant Principal/Athletic Director of Montclair Prep High School requesting placement in the Private Area for relegating purposes. George Giannini spoke in support of placing Montclair Prep in the Private Area. Due to the strength of the program and the difficulty of finding a football league, Clark Stephens, Principal of Liberty Christian HS, and Pat Brown of Brentwood HS, spoke in opposition to the request. Following discussion, it was moved, seconded and passed to **RECOMMEND DENIAL of Montclair Prep's request for placement in the Private Area.** This recommendation may be appealed to the Council at its meeting of January 21, 1993.

There being no further business to come before the Committee, the meeting was adjourned at 3:50 p.m.

## MINUTES OF THE EXECUTIVE COMMITTEE MEETING

February 17, 1993

The February meeting of the CIF Southern Section Executive Committee was called to order by President Dr. Gary Smidderks at 1:15 p.m. on Wednesday, February 17, 1993 at the CIF-SS Offices. All members were present with the exception of Dr. Tom Jacobson, Frank Cano, Jim Fleming, Debra Bradley, Edna Herring, Ray Monti, Dr. Robert Packer and Andy Patterson.

1. **PRESIDENT'S UPDATE**--Dr. Gary Smidderks discussed ACSA concerns relative to the direction of high school athletics in the State of California at a time when funding for public schools is forcing some schools to cut programs. Additionally, it was voted by the Executive Committee that the August meeting will be a two-day meeting, and the January meeting will be a one-day meeting, effective with the 1993-94 calendar.

2. **COMMISSIONER'S UPDATE**--Commissioner Stan Thomas announced the Executive Committee nominations (as developed by the Nominating Committee) which are as follows:

**BOYS' A.D. REP**--Donn Clickard, Atascadero HS, Jim Bashore, Carpinteria HS, Fred Peterson, West Torrance HS

**DESERT AREA REP**--Dr. Mike Jones, Principal, Palm Desert HS; Richard Tucker, Principal, Bishop HS

**PAROCHIAL AREA**--Rev. Wm. Brelsford, Principal, St. Bernard; Rev. Robt. Gallagher, Principal, St. Paul; Mary Ellen Rausch, Principal, Bell-Jeff

Additionally he discussed with the Committee regionalizing the Section to reduce costs.

3. **BOYS A.D. UPDATE**--Donn Clickard, Boys' A.D. Representative, requested that the Executive Committee give consideration to developing specific guidelines or a statement in the Blue Book concerning sportsmanship at all Southern Section athletic contests.

4. **GIRLS' A.D. UPDATE**--No report was forthcoming from Girls' AD Representative Donna Gunstream.

5. **SUPERINTENDENT'S UPDATE**--Ron Franklin discussed with the Committee relegating, blood borne disease (HIV) concerns, and the upcoming meetings to be held with various area superintendents.

6. **TREASURER'S REPORT**--Treasurer Tom Triggs reviewed with the Committee the fall playoffs, t-shirt revenue, the 1993-94 proposed State CIF budget, and the 1993-94 proposed Southern Section budget which will be introduced for first reading at the March Council meeting, with a final vote at the April meeting.

7. **STATE CIF REPORT**--Dr. Robert Packer reviewed with the Committee the following items that were acted on at the State CIF Federated Council meeting of February 5-6, 1993:

- (a) Track and field discus cage -- approved
- (b) Track and field girls' 100m low hurdles -- approved
- (c) Androgenic/Anabolic Steroids -- approved
- (d) Selection of a marketing agency -- approved
- (e) HIV Initiative -- approved
- (f) Survey Research Proposal for Strategic Planning -- approved

8. **LEGAL UPDATE**--Commissioner Stan Thomas reviewed the Campbell Hall eligibility issue which resulted in the ineligibility of one student athlete and the forfeiture of a number of contests in the sport of basketball.

9. **ORANGE COUNTY SECTION UPDATE**--Orange County Area Representative Tom Triggs reviewed with the Committee the Orange County Section initiative which is still in the planning stages.

10. **AREA REPRESENTATIVES**--Area representatives reported that the relegating process in their respective areas is moving along in a timely manner, and there were no other critical issues to be considered at this time.

11. **TRACK SANCTION REQUEST**--Associate Commissioner Dean Crowley reviewed a request for track sanctions from Walnut HS and San Luis Obispo HS which will be held in conjunction with University meets. Following discussion, it was moved, seconded and passed to approve the requests under the provisions of Rule 525.

12. **MONTCLAIR PREP ISSUE**--Representatives of Montclair Prep HS met with the Executive Committee to resolve concerns in the sport of basketball and football. Following discussion, it was moved, seconded and passed to record the violation in the sport of basketball in the official school record, and that Montclair Prep be admonished for the violation of the rule and the school be directed to follow up on all paperwork in a more expedient manner in the future. With reference to the football issue, the Executive Committee instructed the Commissioner to conduct a formal

hearing with reference to the unsportsmanlike conduct of the football team during the 1992 playoffs.

13. **1993-94 MEETING DATES**--Following a review, the proposed meeting dates for the 1993-94 school year were approved by the Committee.

14. **NEW SCHOOL MEMBERSHIP**--It was moved, seconded and passed to approve membership for the following schools:

Christian Chapel HS--Walnut, California--approved for freelance status, effective the 1992-93 school year

Fairmont HS--Anaheim, California--approved for freelance status for the 1992-93 school year.

There being no further business to come before the Committee, the meeting was adjourned at 6:15 p.m.

4. All literature pertaining to the tournament must come from the outside agency and must refer to the member high school only as a place where the games are going to be played.

5. Booster Club participation in these activities -- may assist with parking, door control, ticket takers, concession stand operators, etc., but please remember they are also considered as an extension of the high school program and in no way may sponsor or be directly in charge of the activity itself.

These policies and guidelines apply to all member schools of the CIF Southern Section. Feel free to call the CIF-SS office if you have any questions regarding these rules.

## CIF-SS CAPTURES FIVE STATE BASKETBALL TITLES

Member schools representing the Southern Section won 5 divisional titles in the CIF/Reebok State Basketball Championships, played March 19-20 at the Oakland Alameda Coliseum Arena. The CIF-SS was represented in 8 of the 10 divisional championship games.

In the boys competition, Artesia High of Lakewood held off Pleasanton Amador Valley, 68-66 in overtime, to collect its second-straight State Division II crown and third in the past four years. The win gave coach Wayne Merino's Pioneers a 29-4 record for the season. Senior forward Charles O'Bannon paced the champions with a 31-point, 12-rebound effort, while teammate Avondre Jones added 13 points and nine rebounds.

Serra High of Gardena won its first-ever State title in Division IV, rolling to an easy 67-44 win over defending state champion Salinas Palma. The Cavaliers of Coach Dwan Hurt utilized a balanced scoring attack as Michael Boyd (15), Alex Davis (11), Akeli Jackson (10), and Rod Swift (10) each finished in double figures. Serra finished the season with a 26-7 mark. In Division III, Inglewood Morningside failed in its bid for a second-straight State title, falling to a well drilled Palo Alto squad, 79-59. Coach Carl Franklin's Monarchs wrapped up the season with a 29-6 record. In Division V, Cypress Brethren Christian was overwhelmed by Emery High of Emeryville and 7-foot University of Arkansas-bound center Darnell Robinson, 74-47. The Warriors of Coach Richard Thomas completed the season with a 27-7 record.

The boys Division I title went to Crenshaw (28-2) of the Los Angeles City Section, a 73-66 win over Carmichael Jesuit in the final. Crenshaw qualified for the championship match with a thrilling 63-61 win over Santa Ana Mater Dei (33-2) of the Southern Section in the Southern Regional Finals. Additional CIF-SS boys teams to compete in the state tourney included Long Beach Jordan (21-7), Huntington Beach (29-5), and Simi Valley (25-6) in Division I; J. W. North (33-1), John Muir (28-6), and Dominguez (25-4) in Division II; Notre Dame/S.O. (25-7), South Torrance (28-4), and San Dimas (26-5) in Division III; Corona del Mar (17-13), Verbum Dei (22-6), and St.

Bernard (13-6) in Division IV; and Ambassador Christian (24-9), Chadwick (24-10), and Bel-Air Prep (21-8) in Division V.

In the girls competition, Lynwood became one of just 24 teams of all-time to complete an undefeated season, with a 65-51 win over San Francisco Balboa in the Division I final. The Lady Knights were paced by outstanding performances from Timicha Kirby (27 points, 14 rebounds) and Elana Adams (20 points). First-year coach Ellis Barfield guided Lynwood to a 31-0 season mark.

Under Coach Mark Trakh, Brea Olinda became the State's first-ever team to make 5 consecutive State-championship appearances and second of all-time to win a fourth title, defeating Bella Vista of Fair Oaks, 42-41 for the Division II title. Brea's Nicole Erickson scored a game-high 19 points, including the winning field goal with 2 seconds left to lead the Lady Cats. Brea finished the season with a 32-2 mark. In Division IV, St. Bernard High of Playa del Rey won its first-ever State championship with a 59-48 win over Grass Valley Bear River. Junior Olympia Scott tallied a game-high 24 points to lead coach Lori Pawinski's Vikings, which finished the season with a 30-4 record.

In Division III, Costa Mesa fell to Sacramento St. Francis, 50-43, in its first-ever state final appearance. Coach Lisa McNamee's Mustangs entered the campaign with a 29-5 record. St. Francis finished at 27-5.

Sacred Heart Prep of Atherton completed a perfect 37-0 season with a 59-39 route of El Cajon Christian in the Girls Division V final. Christian defeated San Luis Obispo Mission Prep (22-7, 48-46) in the Southern Regional Finals. Other Southern Section girls teams to qualify for the State tournament included Thousand Oaks, (30-2), Buena (25-4), and Capistrano Valley (24-5) in Division I; Ventura (24-5), Gahr (23-9), and Hacienda Heights Wilson (27-2) in Division II; Morningside (28-3), Rancho Alamitos (25-6), and Alemany (25-6) in Division III; Santa Ynez (27-3), Cerritos Valley Christian (28-3), and Bellermino-Jefferson (28-4) in Division IV; and Lone Pine (24-5), Pasadena Poly (26-5), and Lancaster Bethel Christian (19-6) in Division V.

### LIMITED-ENTRY FORMAT ADOPTED FOR CIF-SS/REEBOK 1993 BASKETBALL PLAYOFFS

At its meeting of January 21, the CIF-SS Council adopted policy calling for limited entry based upon regular-season performance and league standing, for the CIF/Reebok Basketball Playoffs of 1993. The new guaranteed-entry qualification standard was passed by a 42-12 vote.

As a result, each of the organization's 70 member leagues received automatic entries for its top 50 percent. In other words, automatic playoff entry went to the top two finishers in a four-team league, the top three finishers in a six-team league and the top four finishers in an eight-team league. In five-team leagues, the top three finishers advanced, in seven-team leagues, the top four qualified.

Additional teams (those finishing below the 50% cutoff in their league) were able to petition for "at-large" entry, provided they achieved a minimum of 10 wins during the regular season. For "at-large" teams to be considered for entry, there must have existed an opening in the corresponding enrollment-based divisional bracket. Where more guaranteed qualifiers existed for a specific divisional tournament bracket, "wild-card" round games were conducted to eliminate teams and provide a workable mathematical number to conduct single-elimination playoffs.

The CIF Southern Section went to an unlimited or "open" postseason tournament format in the

1989-90 season, and expanded further with the advent of a "qualifying round" in 1990-91. That year, the section hit all-time highs for post-season basketball tournament participation, pairing 367 boys and 322 girls teams in the 10 divisional tournament brackets. A year ago, the field was pared by approximately 10 percent, due to voluntary discretion by member schools and leagues.

"By placing a standard on qualification and limiting entries for the playoffs, the Council action achieved two goals," said Dean Crowley, Associate Commissioner of Athletics and CIF-SS Basketball Administrator. "It improved the overall quality of our tournament fields, while reducing the total number of contests necessary to produce champions. Because the total number of contests were reduced--many of which proved to be meaningless--the action also reduced post-season travel expenditures, a most important issue in these times of strained interscholastic athletic budgets."

The Council action followed a section-wide survey of district superintendents, principals, athletic directors and coaches, which revealed that over 67 percent of respondents expressed displeasure with playoffs based on unlimited participation. The Southern Section first adopted individual-school, enrollment-based basketball playoff groupings for the 1988-89 season, to better qualify teams and increase its number of entries in the CIF/Reebok State Championship Tournament.

### PRECAUTIONS TAKEN FOR THE PREVENTION OF COMMUNICABLE DISEASES

The CIF Federated Council has adopted an interim policy in an effort to minimize the possibility of transmission of any infectious diseases during a high school athletic team practice or contest. The CIF is implementing a precautionary statement and a sport by sport listing of rule additions effective immediately. This action is in response to numerous requests received from schools and officials to provide more specific guidance in regard to precautions against communicable diseases.

## AAF'S ZIFFREN CENTER UNVEILS INTERACTIVE VIDEO-DISC THAT WILL AID INSTRUCTION ON HIGH JUMP

From its inception in 1988, the Amateur Athletic Foundation's Paul Ziffren Sports Resource Center has been a leader in sports education. A tradition of using the latest technology in its efforts has created an interactive videodisc entitled "The High Jump Clinic."

The videodisc uses an IBM computer, a touch screen monitor for selecting different aspects of the high jump technique, and a laser disc player for instruction at four different skill levels-- novice, intermediate, advanced, and elite. It's already at work helping track and field coaches teach their athletes the rudiments of competing in the event.

The program allows the user to study the history, biomechanics and basic techniques of the high jump and permits intensive viewing of 48 different high jumps. The user can study each jump step-by-step, in slow motion or at regular speed, and get expert analysis and commentary on each.

"This is our first experience with interactive videodiscs. We're excited about the potential of this technology," said Dr. Wayne Wilson, the AAF's vice president for research and library services.

The Ziffren Center will continue to study the effectiveness of interactive videodisc technology for teaching skills in track and field and in other sports.

"The High Jump Clinic" was produced with the assistance of Interactive Arts, a Santa Monica-based multimedia developer, and is the company's first sports-related venture. Previously it has produced interactive videodiscs for the Getty Museum and the Library of Congress.

"The High Jump Clinic" is now available for loan to track and field coaches or for use by the public in the Ziffren Center. For further information about the interactive videodisc, please call the AAF at (213) 730-9696.

## "HIGHLIGHTING" COMMUNICATION IN THE CIF-SS

One area of concern that is always apparent is that of COMMUNICATION! It seems we can never do enough to promote ways to keep our communication lines open and functioning.

With literally tons of printed matter crossing our desks daily, it's no wonder some things get pushed aside and/or left behind. From the Southern Section Office alone, you have material coming in from about six different departments, and to wade through all of it takes TIME--which in most cases is in spare commodity!

One very valuable tool to help you get through the daily mail grind is the HIGHLIGHTER. Whether you have time to thoroughly read or just scan the mail, using the highlighter to mark off the "meat" of the material will prove very beneficial when you go to log, prioritize or pass along the important items. It's a lot easier for your eye to pick out one or two highlighted lines than it is to re-read the entire document! If you, as secretary, scan the mail for the administrator, you may also wish to prioritize and date the correspondence for ease in handling. And don't forget to log in anything you pass along to another department or individual. Sometimes using different colored highlighters for assorted tasks is helpful too.

The same process (highlighting) holds true when you fill out a form or request for information. If you mark the items that need filling in, chances are the form will be completed properly on the first try. This is especially helpful if the form is given to another person for completion. The CIF-SS Office spends many needless dollars each month on mail costs to return items requiring input that was overlooked or left off on the first return.

You can also use that highlighter to call attention to specifics in telephone messages, internal memos, and documents such as the CIF-SS Monthly Bulletin and the Administrative Update. Any effort you take to move along information is a boost in the communication system.

We have just finalized the winter playoff season in which communication (written and verbal) was a key element, and I am pleased to report that many of you took the extra minute to call and speak to us personally if you hit a snag or had a question. That's what we're here for, and we encourage you to continue to call us. The lines get busy, but if you are patient, we'll gladly speak to you, and many times YOU help US get new insights into specific areas.

The written communication (particularly during the playoff periods) indicates a need to THOROUGHLY READ instructions on needed paperwork so that all items are completed. Perhaps that handy highlighter needs to be used a little more in this regard!

If you are the person responsible for receiving and distributing the mail, the highlighter can be your pal again. That yellow, green, pink, etc. swash across a page will attract immediate attention and perhaps get to its destination faster.

We sincerely appreciate any and all effort made by you to keep the communication lines moving, and we hope that this little hint may assist some of you in this very important endeavor! Happy Highlighting!!

## RIM OF THE WORLD'S SCOTT CHAPMAN WINS THIRD STATE WRESTLING CHAMPIONSHIP

Senior Scott Chapman of Lake Arrowhead Rim Of The World High School became only the fifth Californian of all time to win a third state wrestling championship in a prep career at the CIF State Championship Meet in Stockton March 6.

Chapman decisioned Willie Tenner of San Bernardino Pacific High, 5-4, in the 152-pound final, to annex his third-consecutive individual state crown. In 1991, Chapman won the 140-pound championship and in 1992 the 152-pound title. Chapman finished his high school career with a sparkling 176-6 record (44-3 Fr., 44-3 So., 45-0 Jr., 43-0 Sr.) and was



last defeated in the 140-pound final of the 1991 Southern Section Masters' (state qualifying) Meet.

An outstanding student, Chapman has an overall high school grade point average of 3.75, including a perfect mark of 4.0 in his senior year. He plans on majoring in pre-med or chemical engineering as a collegian and has made recruiting visits to Purdue, Northwestern, Lehigh, Cornell and Pennsylvania. Chapman has also drawn interest from national wrestling powers Arizona State, Oklahoma State and Iowa State.

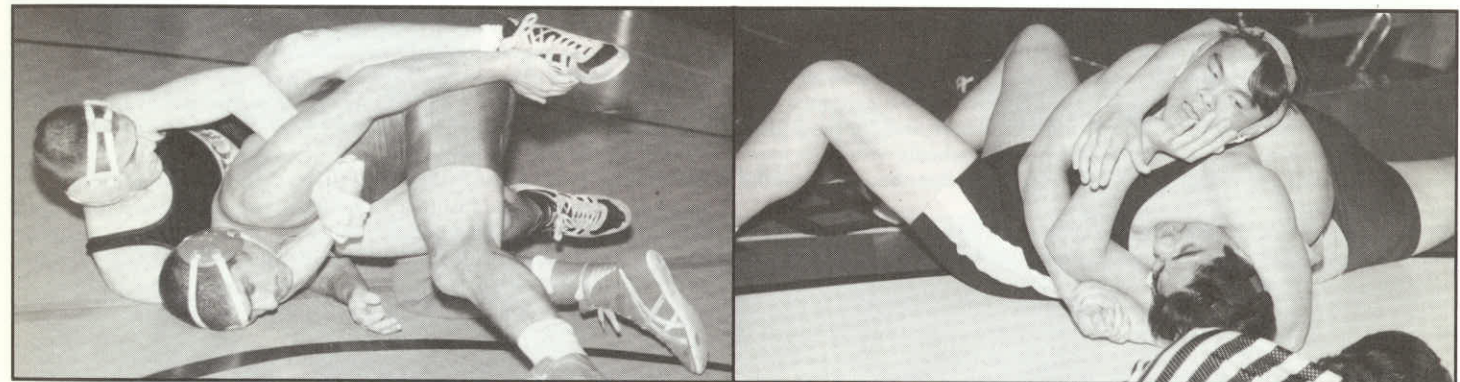

plan ahead, to mail early and use bulk rates, in order to keep the cost of our every-day operations to a minimum.

The reality is, we all remain at the mercy of the postal service and the initial mail receivers at each destination. When CIF-SS packets are received, are the contents distributed properly and in a timely manner? Does a specific document reach the hands it was intended for?

In addition to the physical process for relay of CIF-SS information and/or materials, there is a mental aspect to consider. Are the communications read carefully? Is our presentation complete, concise and understandable? Has it reached its target audience in a timely manner? Each of these factors are important to consider if our communications are to be effective. Your input with new and innovative ideas for improvement in this area is always appreciated.

As commissioner, I am disturbed tremendously when I read a newspaper quote from a coach or athletic director that states "the CIF does not communicate with us" or "we were unaware of the deadline" or "we did not know what the process was." I can honestly say this type of accusation is not from lack of effort on the part of our administrative or office staff. Certainly, we have made our share of mistakes, and freely accept the consequences of those errors. If you, as a representative of one of our member schools are unsure of an eligibility rule, contest rule or playoff qualification process, please contact our office by phone. It is the intent of the CIF Southern Section Office staff to provide member schools with a full-service operation in the management and support of interscholastic athletics.

Effective communications among member-school personnel is also critically-important to sport management. Advance information on ticket sales, uniforms, weather conditions, travel plans, contest scheduling, reporting of results and numerous additional items can enhance the smooth operation of conducting tournament, non-league or league events for CIF Southern Section schools.

Please keep in mind, the real administration of CIF Southern Section activities remains with our membership. Our member schools collectively are the strength and foundation of this organization. It may be an old and abused cliché, but communications truly are a "two-way street". When receiving materials from the CIF-SS Office, please make sure they reach their intended destination, pay close attention to their message, follow directions carefully and keep handy as a reference.

In many ways, the concept of the "C" in CIF standing for communication is an accurate appraisal. The very survival of an organization of our type begins with effective communication practices.

League Representative, presented a proposal recommending a change in the summer dead period for the sport of football. The exception, if approved, would allow football the choice of a three-week dead period from June 28 to July 18 as a dead period with principal approval, in lieu of the August dead period as is now the case for the sports of cross country and water polo.

This will be an action item and will be voted on by the Council at its meeting in March.

**9. ACADEMY LEAGUE AREA NAME CHANGE** -- Mike Grasz, Athletic Director Southeast Lutheran High School, and representing the Academy League, presented a proposal recommending that the Private Area for relegating purposes be re-named the Small Schools Area. This will be an action item and will be voted on by the Council at its meeting in March.

**10. CITRUS BELT RELEAGUING PROPOSAL** -- Dale Mitchell, Citrus Belt Area, presented a proposal recommending that the Citrus Belt Area be placed on a two-year relegating cycle, rather than the four-year cycle as passed by the Council. Following discussion, it was pointed out that under our present relegating procedures, the Relegating Committee will handle any special appeals during the cycle due to school closures, openings or other major drops in enrollment. Thus, the interpretation is that any area might meet their own needs within their area by handling readjustments within the leagues. Therefore, if an area wishes to relegate outside the four-year cycle, they may do so. (Rule 5, page 31 of the current Blue Book).

**11. ALMONT LEAGUE WINTER SEASON OF SPORT CALENDAR PROPOSAL** -- Tony Ortega, San Gabriel Valley League Representative, presented a proposal recommending that beginning with the 1993-94 school year, the allowable date for first contest in all winter sports (with the exception of wrestling) be the first Monday after Thanksgiving. This will be an action item and will be voted on by the Council at its meeting in March.

**12. BASKETBALL PLAYOFF PROPOSAL** -- Dean Crowley, Associate Commissioner, reviewed with the Council, a proposal dealing with the revision of the entry format in the sports of b/g basketball, commencing with the 1992-93 playoffs. Following discussion, it was moved, seconded and passed to reduce the number of entries in the CIF-SS basketball playoffs. The entry formulas will be as follows: 4 team leagues will be permitted two entries; 5 and 6 team leagues will be permitted 3 entries; and 7 or more team leagues will be permitted 4 entries. Additionally, schools with 10 or more wins can submit a petition for an at-large berth should there be openings in the playoff brackets.

**13. COMPETITIVE EQUITY VS. GEOGRAPHICAL PROPOSAL** -- Associate Commissioner Dean Crowley reviewed with the Council a proposal dealing with competitive equity vs. geographics when developing pairings. Following discussion, it was moved, seconded and passed that the CIF-SS stay with competitive equity when developing the brackets for playoffs.

**14. CIF-SS/L.A. CITY SECTION FOOTBALL GAME** -- Dr. Tom Jacobson, Past President of the Council, reviewed a proposal requesting approval of the post-season football game between the L.A. City Section and the Southern Section, to be televised live by KCOP for the next four years. Following discussion, it was moved, seconded and passed to authorize the proposed game for the next four years, giving the Executive Committee the authority to determine management decisions, which would include split of available funds between L.A. City and Southern Sections and the State CIF.

**15. STATE CIF PROPOSALS** -- The following items were presented to the Council for action in order to send Southern Section delegates instructed to the February 5, 1993 meeting of the State Federated Council:

(a) **NOTIFICATION OF BY-LAW 501 (SPORTS PLAY DAY)** -- Following discussion, it was moved, seconded and passed to direct the Southern Section delegates to the State Federated Council to SUPPORT this proposal.

(b) **MARKETING MANAGEMENT** -- Following discussion, it was moved, seconded and passed to send the Southern Section delegates UNINSTRUCTED regarding this initiative.

(c) **TRACK AND FIELD ADVISORY COMMITTEE PROPOSALS** -- Following discussion, it was moved, seconded and passed to direct the CIF-SS delegates to the State Federated Council to SUPPORT the girls' 100m low hurdle proposal, the discus cage proposal, and the girls' pole vault proposal.

(d) **FUNDING OF STRATEGIC PLANNING** -- Following discussion, it was moved, seconded and passed to direct the Southern Section delegates to the State Federated Council to SUPPORT this proposal.

(e) **VOLLEYBALL UNIFORM RULE** -- Following discussion, it was moved, seconded and passed to direct the Southern Section delegates to the State Federated Council to SUPPORT this proposal.

**16. AREA PLACEMENT APPEALS** -- Area Relegating Chair, George Giokaris, reviewed with the Council, area placement for the upcoming 1994-98 relegating process.

Council requesting placement in the Citrus Belt Relegating Area. Following discussion, it was moved, seconded and passed to approve the request, THUS PLACING SILVER VALLEY HS IN THE CITRUS BELT AREA FOR RELEAGUING PURPOSES. Additionally, the Council SUSTAINED THE ACTION OF THE EXECUTIVE COMMITTEE LEAVING PALO VERDE HS IN THE DESERT AREA AND MONTCLAIR PREP AS FREELANCE.

(B) A representative from the ALMONT LEAGUE requested to appeal the decision placing the San Gabriel Valley League in the Foothill Area for relegating purposes. Following discussion, a motion to set the relegating rules aside was DEFEATED, THEREFORE NO ACTION WAS TAKEN ON THIS REQUEST.

Along with this discussion, concern was voiced from the MT. SAC AREA regarding the placement of DUARTE HS in their area for relegating purposes.

With no other appeals forthcoming, it was moved, seconded and passed to ADOPT THE AREA PLACEMENT RECOMMENDATIONS AS MODIFIED.

**17. PRESIDENT'S UPDATE** -- Dr. Gary Smidderks updated the Council on the Orange County sectioning plans and announced that Administrator Bill Clark was in the hospital, and those wishing to send cards may do so at the Office or to his home. He also announced that Mr. Robert Kanaby, currently the New Jersey State Commissioner, has been appointed the new Executive Director of the National Federation, replacing Brice Durbin.

**18. COMMISSIONER'S UPDATE** -- Commissioner Stan Thomas updated the Council on the CIF-SS land lease with ABC District, the ACSA letter expressing concerns relative to the financial constraints placed on high schools and high school athletic programs, and he reviewed league reimbursement for Council meetings and the HIV alert that has been sent out by the State CIF Office, with pending rule changes in all sports for next year.

**19. TREASURER'S REPORT** -- Tom Triggs, Treasurer, reported that all dues had been paid and all fall sports have reached their income projections. Additionally, he announced that Reebok has opted not to continue corporate sponsorship next year and that Pepsi is reducing their sponsorship by 50%.

**20. STATE CIF REPORT** -- A report was given on the recently held National Federation Winter Meeting in Newport Beach, and the rule changes in football for the fall, 1993 season.

**21. STRATEGIC PLANNING** -- Dr. Ken Gunn, President-elect, and a member of the Strategic Planning Committee, reviewed recent meetings of the State CIF Strategic Planning Committee.

**22. STATEWIDE MARKETING PROGRAM** -- Dr. Gary Smidderks reviewed communications received relative to Reebok and Pepsi and the current progress being made relative to the selection of a statewide marketing firm.

There being no further business to come before the Council, the meeting was adjourned at 1:15 p.m.
