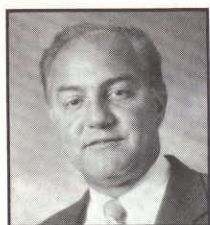

## PRESIDENT'S MESSAGE



**CIF-SS Issues  
Need  
Everyone's  
Input**

The passing this month of long time Southern Section Commissioner, Kenny Fagans, couldn't help but bring to mind a comment from Kenny recently at the Administrator Symposium in Buena Park. In that conversation, Kenny spoke supportively of Southern Section and its recent efforts within the State and Section to provide continuing leadership in athletics for the young people of our area. However, he made special note of the fact that times have changed since his days of athletic administration and that it is now a very complex process calling for the very best efforts of people at all levels to insure that the interests of young and their athletic futures are protected.

As I review the present agenda of matters that confront both Southern Section and the State CIF, the horizon is filled with a large number of very complex and important issues. Open enrollment, statewide strategic planning, state marketing and licensing, coaching education, increasing litigation, funding for athletics, all place themselves as high priorities that need to be addressed by all levels of athletic leaders within the State of California. Although in times past it might have been adequate for State leadership, Southern Section administrative staff, or even Southern Section Council to be the entities addressing these issues, today we need the very best thinking of athletic leaders at all levels.

Whether your role is a coach, an athletic administrator, principal, superintendent or board member, we need the input and assistance of all concerned parties. Unless we all address these issues with focused integrity, athletics in California will come under the jurisdiction of entities with far less expertise in making athletic decisions based on what is "best for kids."

## CIF-SS COUNCIL MEETING MINUTES January 27, 1994

The January meeting of the CIF-SS Council was called to order by Dr. Gary Smidderks at 9:10 a.m. on Thursday, January 27, 1994 at the Sequoia Athletic Club in Buena Park. All leagues were present with the exception of Arrowhead, Christian, Condor, De Anza, Express, Foothill, Golden, Metro, Mission and Pacific Coast.

**1. MINUTES** -- It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of October 21, 1993; the minutes of the November 23, 1993 CIF-SS Executive Committee meeting; and the minutes of the November 23, 1993 CIF-SS Executive Committee Closed Session.

**2. FRIENDS OF GOLF PRESENTATION** -- Mr. David Diltz, President of Friend's of Golf and Ron Polucci, board member, presented the \$30,000 grant money to the CIF-SS golf program. The grant will be distributed to the 75 requesting schools.

**3. COST CONTAINMENT RECOMMENDATION** -- Tom Triggs, Treasurer, reviewed a proposal requiring all items coming before the Council contain financial implications on member schools and the entire Southern Section. This will be an action item at the March Council meeting.

**4. OCEAN LEAGUE BOYS TENNIS PROPOSAL** -- Jason Newman, Tennis Coach and member of the Boys' Tennis Advisory Committee reviewed a proposal to change the scoring

system for playoffs in boys' tennis only. Following discussion, it was moved, seconded and passed to approve the change effective with the 1994 season.

**5. BASEBALL MERCY RULE** -- John Stevenson, Athletic Director, El Segundo High School spoke against the Southern California Baseball Officials' Association proposal calling for a ten run mercy rule in the sport of baseball. Following discussion, it was moved, seconded and passed to deny the proposal.

**6. STATE CIF PROPOSALS** -- The following items were presented to the Council for action in order to send Southern Section delegates instructed to the February 4, 1994, meeting of the State Federated Council:

(a) **HOME SCHOOL RECOMMENDATION** -- Following discussion, it was moved, seconded and passed to direct Southern Section delegates to NOT SUPPORT this proposal.

(b) **MODIFICATION OF BY-LAWS REGARDING SEXUAL ORIENTATION** -- Following discussion it was moved, seconded and passed to direct Southern Section delegates to SUPPORT this proposal.

(c) **PROPOSAL FOR MODIFICATION OF STATE RULE 1103 REGARDING ARBITRATION** -- Following discussion, it was moved, seconded and passed to direct Southern Section delegates to SUPPORT this proposal.

(d) **PROPOSAL FOR MODIFICATION OF MID-**

## COMMISSIONER'S CORNER

**Truly  
a Man for  
All Seasons**

A true giant in the growth and development of the CIF Southern Section was lost when J. Kenneth "Kenny" Fagans, Commissioner of Athletics from 1954 through 1975, died on March 26 from a heart attack. He was 84. Kenny is survived by his wife of 52 years, Norma, a resident of Balboa Island in Southern California; two sons and his sister.

During his 21-year stewardship, "Mr. Southern Section" is recognized as having brought the CIF-SS of age. His management and foresight developed a practically unknown entity into an organization of strength and respect. With Fagans as Commissioner, the CIF Southern Section expanded its membership from 218 schools to 458 and the number of sports from 11 for boys to 22 for boys and girls; initiated the interscholastic athletic program for girls; built its present office complex in Cerritos; ushered in competition in several new sports; revised the structure and responsibilities of the Executive Committee and Council; reorganized the process for the training and assignment of contest officials; and established new procedures for the seeding and pairing of championship playoff tournaments.

Fagans was born in Detroit in 1909 and moved to California with his family in 1923. He was a standout basketball player at Huntington Park High School and earned all-state honors as a senior center in 1927. Huntington Park won a Southern Section title that year.

Kenny went on to Oregon State University where he was the leading scorer on the freshman team. For the next three seasons, he played in every varsity game. Kenny was president of his senior class in 1932 at Oregon State.

After that, Fagans coached basketball at Compton from 1947 to 1953. He led his team to a pair of Southern Section titles and his teams won 53 consecutive games between 1950 and 1953.

Prior to succeeding Bill Russell as Commissioner of the Southern Section, Fagans served as assistant principal and athletic director at Centennial High School in

## MINUTES OF THE EXECUTIVE COMMITTEE MEETING November 23, 1993 - Closed Session

The Executive Committee went into closed session at 3:00 p.m. to receive the report of the Finance and Budget Committee.

It was moved and seconded that the Finance Committee, in consultation with the Acting Commissioner, be authorized to:

- (1) Approve the use of credit cards with appropriate limits.
- (2) Establish a monthly car travel stipend for three administrators and two directors.
- (3) Establish allotment limits and guidelines for business related meals with reimbursement through submitting appropriate expense receipts.
- (4) Establish a Commissioner's expense account with set limits and with reimbursement through submitting appropriate expense receipts.
- (5) Approve, when necessary, any spending which exceeds the set budgetary amounts.

The motion was passed.

It was moved and seconded that the CIF-SS utilize the guidelines established for use by State Federated Council Officers and Executive Committee members for travel and personal expense procedures. The motion carried. It was then moved and seconded that these same procedures be used for office staff, when appropriate. The motion carried.

It was moved and seconded that the President of the Council appoint, each year, a standing Finance Committee composed of Executive Com-

mittee members that will, in concert with the Commissioner and staff, (1) identify budgetary assumptions and criteria and then develop a recommended Southern Section budget, and (2) conduct a review at the conclusion of each sports season that involves the updating of income projections and actual expenditures. The motion carried.

It was moved and seconded a hiring freeze be put into effect until July 1, 1994, and that the Administrative Committee be authorized to fill any vacated positions as they deem necessary. The motion carried.

It was moved, seconded and carried to return to open session at 4:00 p.m.

It was moved, seconded and carried to go into closed session at 4:30 p.m.

It was moved and seconded to eliminate the positions of (a) Administrative Assistant/Office Manager and (b) postage delivery with the Administrative Committee given the latitude to implement the action appropriately. The motion carried.

It was moved and seconded that the health benefits cap that was established July 1, 1993 be applied to current employees and retirees. The motion carried.

It was moved and seconded that an age limit of 65 be implemented for health benefits for those

who retire after July 1, 1993. The motion carried.

It was moved and seconded that the Administrative Committee is directed to review the qualifications for retirement benefits and make appropriate recommendations to the Executive Committee. The motion carried.

It was moved and seconded that CIF-SS do everything possible to break the lease on the Xerox 5090 and obtain a more cost effective machine. The motion carried.

It was moved and seconded that the CIF-SS car be sold. The motion carried.

It was moved and seconded that Dean Crowley be appointed Acting Commissioner through June 30, 1994. At that time, the position will be reviewed pending developments regarding State restructuring and strategic planning. The motion carried.

It was moved and seconded that Acting Commissioner Dean Crowley be placed on the third step of the Commissioner's salary schedule effective October 14, 1993. The motion carried.

It was moved, seconded and carried that we return to open session at 5:30 p.m.

## RUNNING IN PAIN

A 13-year study, which looked at nearly 60,000 high school athletes in 18 sports, has determined that girls cross-country has the highest injury rate. The study was done in the Seattle area from 1979-92.

## MINUTES OF THE CIF-SS COUNCIL MEETING March 10, 1994

The March meeting of the CIF-SS Council was called to order by Dr. Gary Smidderks at 9:03 a.m., Thursday, March 10, 1994 at the Sequoia Athletic Club. All leagues were present with the exception of Desert Valleys, Express, Hi-Lo and Metro.

**1. MINUTES** -- It was moved, seconded and passed to approve the minutes of the January 27, 1994 meeting of the Council; the minutes of the January 22, 1994 Executive Committee meeting and the minutes of the February 23, 1994 meeting of the Executive Committee.

**2. LIBERTY LEAGUE PLAYOFF REVIEW PROPOSAL** -- Mr. Eric Walter, Liberty League President, reviewed a proposal dealing with playoff revenue and the distribution of net receipts. The CIF-SS Office will develop an analysis of the potential impact of this proposal for the next Council meeting.

**3. BLUE BOOK COMMITTEE PROPOSAL** -- Dr. Liza Daniel, Principal of Morningside High School and a member of the Blue Book Committee, reviewed the following recommendations from the committee:

(a) **PLAYER CONDUCT RULE (ALL SPORT SECTIONS)** -- Any player ejected for fighting or any player who leaves the confines of the bench or team area during a fight that may break out or has broken out shall be disqualified from participating in the remainder of the game and will be ineligible for the team's next contest.

(b) **COACH EJECTION (RULE 125.1 AND ALL SPORT SECTIONS)** -- Following discussion, it was moved, seconded and passed to amend this item to read: Upon ejection, the head or assistant coach shall be disqualified from participating in the remainder of the game and will be ineligible for the team's next contest.

(c) **RULES 1622/3100.2** -- In order that the CIF-SS Office may proceed smoothly during the seeding process for Boys' and Girls' Basketball, it is recommended that on the last Saturday of competition, no contest be scheduled later than 5:00 p.m.

(d) **ARTICLE 600 - COMPETITION ON AN OUTSIDE TEAM** -- The Committee is recommending that this rule be repealed. It should be noted that this is a State Rule and if approved by the Southern Section, would need to be forwarded to the State Federated Council for consideration.

(e) **CO-CHAMPIONS (FOOTBALL)** -- The Committee is proposing that, under the provisions of existing playing rules as written by the National Federation, ties can be broken in football, thus declaring a Section champion rather than a co-champion. For this reason it is recommended that for football, the tie breaker provisions in the rule book be utilized and a champion be declared, rather than co-champions.

(f) **SUMMER DEAD PERIOD (DISCUSSION ONLY)** -- It is the wish to the Committee to discuss the summer dead period to determine if there is a desire, on the part of the Council, to bring forth a recommendation regarding this item as it now exists.

These recommendations will be action items at the April 28, 1994 meeting of the Council.

**4. NOMINATING COMMITTEE PROPOSAL** -- Mr. Scott McTaggart, chairperson of the Committee, reviewed the following candidates for positions of the CIF-SS Executive Committee: President-Elect -- Tom Triggs, Principal of Buena

Park High School and Margie Godfrey, Principal of Millikan High School; Citrus Belt Area - Dale Mitchell, Principal of Centennial High School; Karen Craig, Principal of San Bernardino High School and Edna Herring (nominated from the floor), Principal of Eisenhower High School; Coast Area - Margie Godfrey, Principal of Millikan High School and Dr. Liza Daniels, Principal of Morningside High School; Foothill Area - Tony Ortega, Assistant Principal of Keppel High School and Don Duncan, Principal of Hoover High School; Small Schools - Clark Stephens, Principal of Liberty Christian High School and Tom Peters, Principal of Woodcrest Christian High School.

These recommendations will be action items at the April 28, 1994 meeting of the Council.

**5. OFFICIALS FEES PROPOSAL** -- Susana Arce, chairperson of the committee, reviewed the recommendations of the Officials Fees Committee, as follows:

(a) A two-year agreement with a \$1 across the board increase for the 1995-96 school year. For the 1994-95 school year some adjustments were made in certain sports at the varsity level.

(b) A single fee structure only, rather than a day/night schedule.

(c) Additionally, the committee addressed the concerns of the associations by adopting a set of guidelines for schools in working with officials and officiating organizations.

These recommendations will be an action item at the April 28, 1994 meeting of the Council.

**6. CIF-SS BUDGET PROPOSAL 1994-95 SCHOOL YEAR** -- Treasurer Tom Triggs reviewed the proposed 1994-95 budget which will be an action item at the April 28, 1994 meeting of the Council.

**7. STATE CIF PROPOSAL** -- Dr. Gary Smidderks, President of the Council, presented the following items which will be voted on at the Southern Section Council Meeting of April 28, 1994 in order to send our delegates instructed to the May meeting of the State Federated Council.

(a) State CIF Budget Proposal - 1994-95 school year.

(b) State CIF Executive Committee Elections.

(c) Modification of By-Law 3002 - Wrestling Weigh-Ins.

(d) Proposed 15% Option for CBED Enrollment Changes in Girls' Volleyball and Boys'/Girls' Cross Country.

(e) School Choice (Open Enrollment).

(f) Residential Eligibility for Alternative Education Students.

(g) San Diego Section Independent Study Proposal.

**8. COST CONTAINMENT PROPOSAL** -- Tom Triggs, Treasurer, reviewed a proposal pertaining to cost containment. Following discussion it was moved, seconded and passed to approve the proposal.

**9. PRESIDENT'S UPDATE** -- Dr. Gary Smidderks, President, commended the CIF-SS staff on an outstanding symposium, the continued dialogue with Orange County Representatives and the concern regarding violence in athletics. In addition, the Executive Committee has decided to set up a sportsmanship task force which will be chaired by Donn Clickard.

**10. COMMISSIONER'S UPDATE** -- Acting Commissioner Dean Crowley reviewed concerns

pertaining to the increasing number of incidents, coaches serving as poor role models and the need for identifiable school supervisors. In addition, he stressed the positive beginning of the baseball season with the officials associations and recapped the winter playoffs.

**11. TREASURER'S REPORT** -- Tom Triggs, Treasurer, gave a brief overview of the current CIF-SS working budget.

**12. STATE CIF REPORT** -- Dr. Gary Smidderks, President, reviewed the following items were acted upon by the State Federated Council at its February meeting:

(a) Home Schools Recommendation - tabled

(b) Modification of By-Laws regarding sexual orientation - passed.

(c) Arbitration - State Rule 1103 - passed.

(d) Girls' Mid-Court Line - Effective 1994-95 Season - passed.

(e) Rally Scoring in Volleyball Tournament Play - passed.

(f) Strategic Planning Goal - Adoption of Vision and Goals - passed.

**13. STATE CIF MARKETING REPORT** -- Dr. Gary Smidderks, President, reviewed the current status of State CIF Marketing.

**14. STATE CIF STRATEGIC PLANNING** -- President-Elect Dr. Ken Gunn, reviewed the progress being made at the State level with reference to the State CIF Strategic Planning.

There being no further business to come before the Council, the meeting was adjourned at 11:25 a.m.

## MINUTES OF THE EXECUTIVE COMMITTEE MEETING January 22, 1994

The January meeting of the CIF-SS Executive Committee was called to order by President Dr. Gary Smidderks at 1:00 p.m. on Saturday, January 22, 1994, at the Holiday Inn in Buelton, California. All members were present with the exception of Dr. Richard Tucker, Frank Cano and Edna Herring.

1. **MINUTES** -- It was moved, seconded and passed to approve the minutes of the CIF-SS Executive Committee meeting of November 23, 1993 and the minutes of the CIF-SS Executive Committee closed session of November 23, 1993.
2. **PRESIDENT'S UPDATE** -- Dr. Gary Smidderks commended the Southern Section Office staff on the smooth running of the recently completed fall season playoffs. In addition, Dr. Smidderks reviewed some final housekeeping items as it relates to the previous Commissioner, Mr. Stan Thomas. Also, Dr. Smidderks expressed a concern regarding the damage done by the earthquake.
3. **ACTING COMMISSIONER'S UPDATE** -- Dean Crowley, Acting Commissioner, welcomed new committee member Margie Godfrey who is replacing Maureen Sanders in the Coast Area. In addition, he reviewed with the Committee the office reorganization, the earthquake and its effect on the playoffs, the continuing visitation of league meetings by office administrators, the Dial Award winner - Tiger Woods, Western High School and the annual donation of \$30,000 by Friends of Golf.
4. **AREA REPRESENTATIVE REPORTS** -- The Executive Committee area representatives reviewed representation at divisional championship football games, concerns regarding the earthquake and travel, strategic planning and new school openings.
5. **BOY'S ATHLETIC DIRECTOR UPDATE** -- Donn Clickard reviewed the upcoming Symposium and the presentations being made by a Athletic Directors' Panel.
6. **SUPERINTENDENT'S UPDATE** -- Dr. Ron Franklin reviewed school of choice legislation

and questioned how it will affect CIF policies. Also, Dr. Fleming expressed concerns regarding the stabilization of athletic equipment, i.e., basketball backboards.

7. **TREASURER'S REPORT** -- Treasurer Tom Triggs shared with the Committee the fall sport financial report. Additionally, he reported Ventura Christian High School was delinquent in their dues for the 1993-94 school year. It was moved, seconded and passed to notify Ventura Christian HS they would be dropped from membership if their dues were not paid by the January Council meeting. Also, Mr. Triggs reviewed with the Committee the Section's financial policy guidelines and the budget development timeline. It was moved, seconded and passed to increase the mileage reimbursement to 28 cents a mile effective July 1.
8. **STATE CIF/COMMISSIONER'S MEETING UPDATE** -- Dr. Gary Smidderks shared with the committee the current status of the State CIF marketing management. Dean Crowley, Acting Commissioner, reviewed the continuing problem with Foreign Exchange Programs, open enrollment, outside competition current status, and the eight semester rule.

## SHOW OFFICIALS A LITTLE COURTESY, PLEASE

Spring has sprung.

Easter is behind us. Longer days are before us. And baseball, that grand old American game, is upon us. One hundred sixty-two regular-season games, to be specific about it.

That's a lot of strikeouts and double plays, hot dogs and Cokes, relaxed conversations and fun memories. One of the things I've always enjoyed about the game is the laid-back atmosphere that surrounds the fans in the stands. You have time to sit and tell stories together. Families can hang out and spend the whole evening doing really nothing. It's great! While all those men are out there playing a kid's game, nobody has any reason to get uptight. It's baseball, remember... nine (or more) innings of laughs and jokes, nachos and peanuts, crowd-watching and scorekeeping.

Unlike professional hockey and NBA basketball, you can take your eyes off the field for several minutes and not miss much. Who cares? Most pitchers have to jerk on their jerseys, scratch, spit, readjust their caps, and walk around the mound a time or two between pitches before slinging that thing toward home plate.

Funny thing, the ones who have more reason than anyone else to get nervous and uneasy are on the field, but they're not on a team; they're the guys in padded blue shirts, affectionately referred to as "the umps"... or stuff much worse than that.

We're awfully hard on the umpires, but I'm told that's our right, since we paid to get in. I've never quite figured out that logic. Why would buying a ticket give anyone the right to insult, curse, scream at, or ridicule a person who has the toughest job in baseball? Can you imagine how hopelessly impossible it would be to play the game without them? But you'd think they were the bad guys if you didn't know better.

The horror stories they tell never cease to sadden and sometimes shock me. If it wouldn't mean my loss of limb or life, I'd like to take some fans who delight in insults and say, "Hey, let's remember that those fellows are doing a lot better job than we could do. Show a little courtesy, please!" If you're the type who needs a verse of Scripture to verify an exhortation, how about this one? "Be kind to one another, tenderhearted, forgiving each other..." (Eph. 4:32)

I would also like to see some changes like this at Little League games, where nobody pays to get in. This is supposed to be a special setting where boys have the opportunity to learn more about the game of life than the game of baseball.

That was driven home to me recently

when I read the words of Donald Jensen, who was struck in the head by a thrown bat while umpiring a Little League game in Terre Haute, Indiana. He continued to work the game but later that evening was placed in the hospital by a physician. While being kept overnight for observation, Jensen wrote the following letter to folks like us:

*I'm an umpire. I don't do it for a living, but only on Saturdays and Sundays for fun. I've played the game, coached it and watched it. But somehow, nothing takes the place of umpiring. Maybe it's because I feel that deep down I'm providing a fair chance for all the kids to play the game without disagreements and arguments.*

*With all the fun I've had, there is still something that bothers me about my job. Some of you feel I'm there to exert authority over your son. For that reason, you often yell at me when I make a mistake, or encourage your son to say things that hurt my feelings. How many of you really understand that I try to be perfect? I try not to make mistakes. I don't want your son to feel he got a bad deal from any umpire. Yet no matter how hard I try, I can't be perfect.*

*I counted the number of calls I made in a six-inning game today. The total number of decisions, whether on balls and strikes or safes and outs, was 146. I tried my best to get them all right, but I'm sure I missed some. When I figured out my percentage on paper, I could have missed eight calls today and still gotten about 95% right. In most occupations that percentage would be considered excellent. If I were in school, that grade would receive an "A" for sure.*

*But your demands are higher than that. Let me tell you more about my game today. There was one close call that ended the game. A runner for the home team was trying to steal the plate on a passed ball. The catcher chased the ball down and threw to the pitcher covering the plate. The pitcher made the tag and I called the runner out.*

*As I was getting my equipment to leave, I overheard one of the parents comment, "It's too bad the kids have to lose games because of rotten umpires. That was one of the loudest calls I've ever seen." Later, at the concession stand, a couple of kids were telling their friends, "Boy, the umpires were lousy today. They lost the game for us." I felt terrible when I got home. Here was a group of kids who had made a lot of mistakes which had cost them a number of runs.*

*The purpose of Little League is to teach baseball skills to young men. Obviously, a team which does not play well in a given game, yet is given the opportunity to blame that loss on an umpire for one call or two, is being given the chance to take all responsibility for the loss from their shoulders. A parent or adult leader who permits the younger player to blame his failures on an umpire, regardless of the quality of the See COURTESY, PLEASE, page 19.*

## RULE REVIEW

Foreign  
Exchange  
Students

There has been a rule change this year for foreign exchange students to establish athletic eligibility. It will now require a form that must be submitted to the CIF Southern Section prior to any foreign exchange student competing in sanctioned high school athletics.

The form will aid schools in determining the eligibility of foreign exchange students and help the section in monitoring the number of exchange students competing in CIF-SS sports.

If a foreign student moves into an attendance area under an approved foreign exchange program, the student could be eligible if the student meets the scholastic and age requirements and has not graduated from the secondary school in his or her homeland.

All incoming ninth graders are residentially eligible regardless if they are foreign or domestic students.

If a foreign student moves into a Southern Section attendance area with both his or her parents with a bonafide change of address, the student has residential eligibility. If that student moves into a CIF-SS attendance area without a bonafide change of address, the student would be ineligible for one year.

The new form will be provided to each school in the packets mailed in August. The form is a checklist that verifies that the student meets all CIF eligibility requirements: That he or she had no role or choice in selecting a school to attend; that there was no contact with the student prior to home placement; that there was no contact with an exchange program or placement official by school employee or community resident prior to student placement and that the random placement of the student complies with Rule 510 of the CIF-SS Blue Book.

A school administrator must sign and submit the form to the CIF Southern Section before approval can be given.

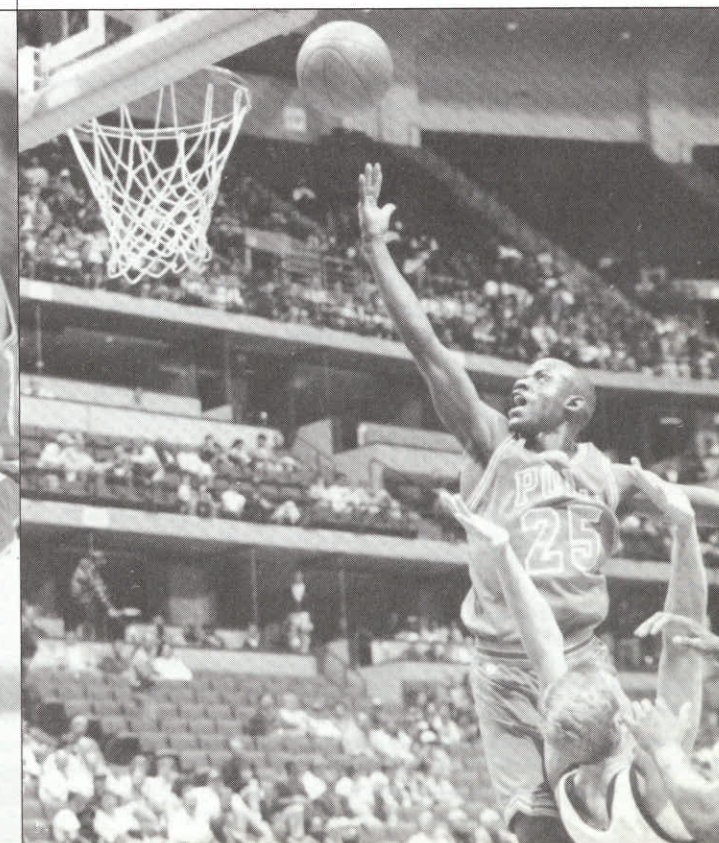
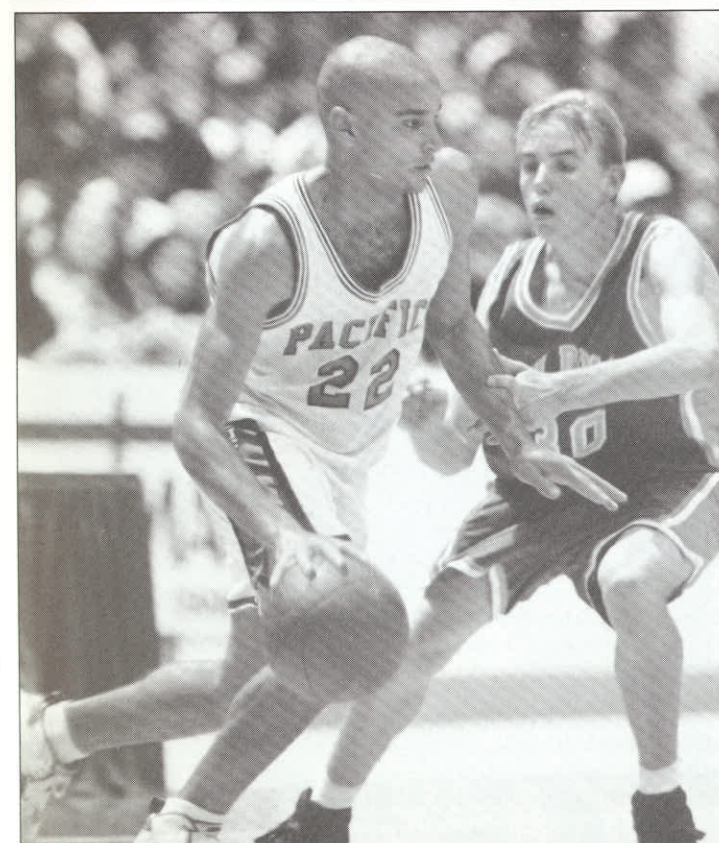

## CIF-SS CAPTURES THREE STATE BASKETBALL TITLES

Member schools representing the Southern Section won three divisional titles in the CIF State Basketball Championships, played March 18-19 at the Oakland Alameda Coliseum Arena. The CIF-SS was represented in 6 of the 10 divisional championship games.

Topping the list again was the Brea-Olinda girls team who captured their fourth straight state championship after the Ladycats defeated Archbishop Mitty of San Jose, 54-44, in the Division III final. The championship was a record-setting fifth overall for Brea and capped a perfect 33-0 season. A few days later, the Ladycats were declared the unofficial national champions by USA Today. Senior Nicole Erickson led Brea with 16 points, five steals and five assists in her final high school game.

St. Bernard of Playa del Rey won the girls Division IV championship for its second straight state title. Olympia Scott, a 6-2 forward, set a divisional record with 20 rebounds and scored 14 points to lead the Vikings over Bear River of Grass Valley, 53-43, in the final. Bear Valley led, 35-33, after three quarters, but were outscored by St. Bernard, 20-8, in the final quarter.

Other Southern Section girls teams to advance to the state championship games were Lynwood, which fell to Sacred Heart Prep of Atherton in Division I, 59-53, and Woodbridge of Irvine, which lost to El Camino of Sacramento in the Division II championship, 71-38. Lynwood, which finished the season with a record of 32-2, was led by Timicha Kirby's 18 points and 11 rebounds. Woodbridge, which finished the season with a record of 32-1, was paced by Jamie Oenning, who had 15 points and 9 rebounds.

The other girls divisional state champion was Ripon Christian in Division V. The Knights defeated Christian El Cajon, 62-46, in the title game.

In the boys competition, Pacifica High of Garden Grove advanced all the way to the Division III championship game before falling to Foothill of Sacramento, 81-61. Despite a game-high 28 points by Chris Vlasic, including four 3-pointers, the Mariners were defeated by the Mustangs in what was a record-tying margin of victory. Pacifica completed the season with a record of 30-2.

Pacific Hills of Los Angeles (formerly Bel Air Prep) advanced to the Division V boys championship before falling to Ripon Christian, 60-46. Pacific Hills, making its first appearance in a state championship game, was led by Danny Brummel who had 15 points for the Bruins.

Crenshaw High of Los Angeles City Section toppled Jesuit Carmichael for the second straight year to win the Division I title. The Cougars broke their own record of five titles and also set a record for most appearances in the finals (6). Tremaine Fowlkes and Kristaan Johnson were the big offensive weapons for Crenshaw, scoring 30 and 27 points respectively, while Tommie Davis starred on defense and had a record 14 assists.

Other boys division champions were East Bakersfield in Division II, defeating Oakmont of Roseville in the finals, 68-59, and Lincoln Prep of the San Diego Section in Division IV, knocking off Sir Francis Drake of Orland in the title game, 63-50.

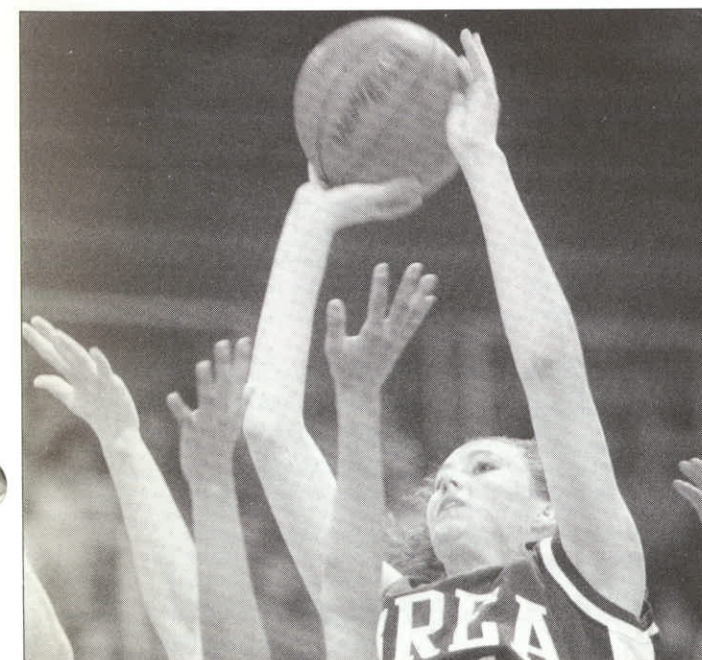

# NATIONAL FEDERATION 1994 FOOTBALL RULE REVISIONS

- 1-5-2c Gloves designed for athletic competition shall have an interior label securely attached or an interior stamp (NF/NCAA Specifications) indicating voluntary compliance with test specifications on file with the Sporting Goods Manufacturers Association as of January 1, 1994.
- 1-5-3c Allows hard materials on hand, wrist, forearm or elbow when padded as specified if directed in writing by a licensed medical physician to protect an injury
- 1-5-3k Jerseys and pants manufactured after January 1, 1996 shall have only one visible manufacturer's logo/trade name on each item and it shall not exceed 1 1/2 x 1 1/2 inches square. Rescinded prohibition on exterior washing instructions.
- 2-9-1;6-5-2.5 On a scrimmage kick, R may only fair catch beyond the neutral zone.
- 3-5-7h Officials may take a time-out when heat or humidity may create a health risk to players.
- 3-7-2 Replaced players shall leave the field immediately.
- 6-1-6 On a free kick, touching is ignored if K pushes R into contact with the ball.
- 6-5-6 Pen; Invalid fair catch signal will be penalized from the previous spot.
- 10-4-4d
- 9-5-1b Added "taunting" to the rule prohibiting baiting.
- 9-5-1c It is unsportsmanlike if a player attempts to focus attention upon himself with any delayed, excessive or prolonged act.
- 9-8-1k A substitute who enters the playing area during a fight shall be disqualified.

## WHAT IS CHILD ABUSE IN SPORTS?

(Editor's note: The following information is from a PACS -- Parent and Coaches in Sports brochure. PACS is a private, non-profit charitable organization emphasizing the importance of helping children develop their positive overall self-image through sports.)

Child abuse in sports can be defined as any action taken by an adult which results in the direct or indirect physical and/or emotional harm to children. Child abuse can be either **Active or passive**. **Active Child Abuse** in sports occurs when a child (or children) directly experiences harsh and abusive actions from parents or coaches which result in feelings of lowered self-worth, worthlessness, fear, and/or failure. **Passive Child Abuse** in sports occurs when a child (or children) observes another child (or children) being the recipient of harsh or abusive actions by parents or coaches.

### Types of Child Abuse in sports

**Verbal Abuse** is the most commonly occurring type of abuse in children's sports.

- Name calling.
- Hurtful comments regarding performance.
- Swearing at players or game officials
- Comments directed to demean a child's integrity.

**Physical Abuse** occurs when adults use any type of hurting touch, or by their actions, purposefully cause physical pain.

Examples of hurting touch:

- Slapping
- Grabbing
- Excessive exercise as a form of punishment or as a way of creating team discipline.
- Shoving
- Hitting

**Emotional Abuse** of children in sports means having unrealistic goals and expectations for children.

Examples include:

- Winning every game.
- Scoring the most points.
- Being the best player on the team.
- Playing without errors.

Emotional abuse also includes keeping children from participating in games due to limits or underdeveloped skills.

**Sexual Abuse** is any form of sexual contact or implied sexual contact between an adult and a child.

- Touching or fondling the genital, buttocks, and breast areas.
- Implicit or explicit sexual comments to boys or girls.
- Any type of sexual harassment.

*Note: These definitions are meant to serve as a guideline for increasing awareness of abuse to children in sports. Consult your state child abuse law for specific definitions and criteria.*

Compton. His background in athletic administration included 12 years as Commissioner of the California Collegiate Athletic Association and two years as Commissioner of the Pacific Coast Athletic Association (since renamed the Big West Conference). Fagans also worked for 10 years as a basketball official in the Pacific-Eight Conference (now known as the Pac-10). He officiated football, basketball and baseball for more than 30 years on the high school, junior college and collegiate levels and served as president of both the Southern California Basketball Officials (1959) and Football Officials (1960) Associations.

Fagans also was a noted Olympic Games contributor, serving on the United States Water Polo Committee from 1970-78. In 1960, he initiated the concept and was in charge of the 500-mile Olympic torch run from the Los Angeles Coliseum to Squaw Valley, California, for the opening ceremonies of the Winter Games. It was Kenny

Fagans who arranged for 500 high school track stars to carry the flame one mile each to its destination, setting a precedent for the nation-wide Olympic torch run of 1984.

Kenny was active with the CIF Southern Section in his final years. He conducted meetings of the section's Alumni Association, composed of former CIF-SS Executive Committee and Council members, and wrote a column in its newsletter. He was also president of the Retired Coaches Association of Orange County. In 1991, Fagans was inducted into the Orange County Sports Hall of Fame.

As his health began deteriorating, Fagans cut back his workload. He was unable to attend the CIF State basketball tournament in March in Oakland, his favorite event, due to illness.

Kenny Fagans was the CIF, and that is how those of us who knew him will remember him.

up Canyon Springs (Moreno Valley) with 81.5 points.

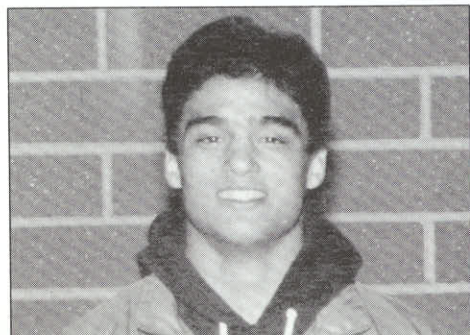

Two Canyon Springs wrestlers captured individual titles: Brothers Norman Abas (103) and Stephen Abas (112).

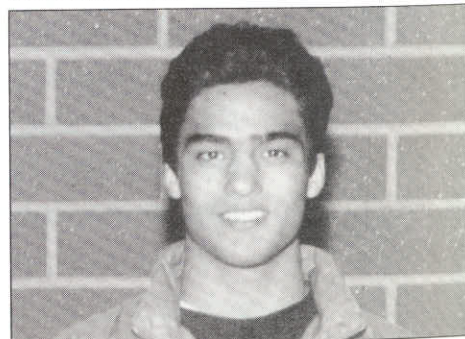
Other individual champions included Juan Alvarez of El Modena of Orange at 135;

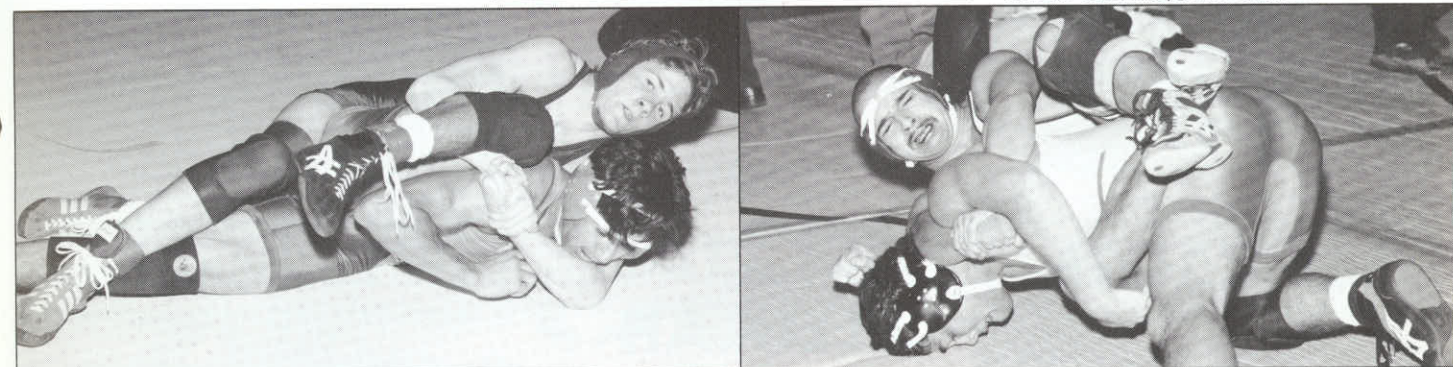

umpire, is doing the worst kind of injustice to that youngster. Rather than learning responsibility, such an attitude is fostering an improper outlook toward the ideals of the game itself. This irresponsibility is bound to carry over to future years.

As I sit here writing this letter, I am no longer as upset as I was this afternoon. I wanted to quit umpiring, but, fortunately, my wife reminded me of another situation that occurred last week.

I was umpiring behind the plate for a pitcher who pantomimed his displeasure at any call on a borderline pitch that was not in his team's favor. One could sense that he wanted the crowd to realize that he was a fine, talented player who was doing his best to get along, but that I was a blackhearted villain who was working against him. The kid continued acting like this for two innings, while at the same time yelling at his own players who dared to make a mistake. For two innings the manager watched this. When the kid returned to the dugout to bat in the top of the third, the manager called him aside. In a

voice loud enough that I was able to overhear, the lecture went like this:

"Listen, son, it is time you make a decision. You can be an umpire, an actor or a pitcher. But you can only be one at a time when you are playing for me. Right now it is your job to pitch. And, you are basically doing a lousy job. Leave the acting to actors, the umpiring to the umpires, or you won't do any pitching here. Now what is it going to be?"

Needles to say, the kid chose the pitching route and went on to win the game. When the game was over the kid followed me to my car. Fighting his hardest to keep back the tears, he apologized for his actions and thanked me for umpiring his game. He said he had learned a lesson that he would never forget.

I can't help but wonder how many more fine young men are missing their chance to develop into outstanding ball players because their parents encourage them to spend time umpiring, rather than working harder to play the game as it should be played.<sup>1</sup>

Donald Jensen speaks for a lot of us who love the game of baseball and want to keep it just that...a game. What he wrote that night in Indiana was absolutely right. Dead right. Next time you're tempted to insult or mistreat an umpire, remember Donald Jensen - the late Donald Jensen. The following morning he died of a brain concussion.
