





## PRESIDENT'S **MESSAGE**



**A Committee That Does** Something

All of us in education are fortunate! First, we get to work with students, the vast majority of whom value education and their schools. Secondly, we work side by side with some of the finest professionals in any field, teachers, coaches and administrators. Finally, on occasion, we get the opportunity to meet and work with exceptional people from the other walks of life who also value education and athletics. The common bond in these associations is "the kids." Thanks to the efforts and the vision of our commissioner. Dean Crowley, we are in the midst of a unique experience. This experience is called the CIF-SS Human Relations Committee. I know what you are thinking, "Just what education in general and CIF, in particular, needs -- ANOTHER COMMITTEE." This one truly is different.

All of us remember the incident which occurred this past football season. A football official was hit by a player in one of our Southern Section games and we were instantly the focus of national media attention. As a result of that incident and the extensive aftermath. Dean was contacted by some remarkable people. Lee Sampson, Harris Williams, Rev. Lloyd Wilkins and Dr. Fred Kennedy are all leaders in the Compton community. They wanted to become involved. More specifically, they wanted to address the racial incidents and other form of unsportsmanlike conduct that appear to be rapidly increasing in schools and in athletics. Together, these five gentlemen, Dean, Lee, Harris, Rev. Wilkins and Dr. Kennedy, formed the Human Relations Committee. The committee is composed of over thirty men and women from a variety of professions and backgrounds. An NFL Official, a small college and NBA All-Star, a senior mediator from the Department of Justice, a prominent member of the Los Angeles County Commission of Human Relations, the parent of an excellent local athletes, District and School Administrators, Athletic Directors, CIF Office Administrators, and a number of community members who care deeply about these issues, bring their numerous experiences and expertise to the group. Dr. Kennedy, a former Assistant Superintendent, was the unanimous choice to chair the committee and it is off and running. Sub committees are working on sensitivity training programs, codes of conduct for players, coaches and fans, and

### **CIF-SS COUNCIL MEETING MINUTES** January 25, 1996

The January meeting of the CIF-SS Council was called to order by Dr. Ken Gunn at 9:01 a.m. on Thursday, January 25, 1996, at the Sequoia Athletic club in Buena Park. All leagues were present with the exception of Central Coast, Delphic, Hi-Lo, Horizon, Liberty and Sunrise.

- 1. MINUTES It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of October 19, 1995 as mailed.
- 2. PUBLIC HEARING -- Mrs. Mimi Frank. parent, spoke in support of the Sunset League Girls' Water Polo proposal.
- 3. FRIENDS OF GOLF PRESENTATION --Mr. David Diltz, President of Friends of Golf presented \$35,000 grant money to the CIF-SS high school golf program. In addition, golf equipment donated by FOG will be given away to member high schools in early February.
- 4. STATE CIF FEBRUARY ACTION ITEMS -- Tom Triggs, President Elect, presented the following agenda items for the February State Federated Council in order to give our delegates
- (a) Wrestling Weight control program developed by the State CIF Wrestling Advisory Committee as recommended by the National Federation for implementation in the 1996-97 school year - Vote to support.
- (b) State Appeals Process Modification of Article II, Section 1101 which would update and improve the state appeals process - Vote to

There is a belief that discipline, respect, courage, and teamwork are some of the qualities that are learned through sports. The fact is, this does not always ring true. Although these traits are achievable through sport, they are not inherent. Coaches hold the key to student-athletes learning these life lessons.

The Amateur Athletic Foundation (AAF), an organization created to manage Southern California's endowment from the 1984 Olympic Games, has held coaching clinics in cross country, track and field, and soccer for the past 6 years. Volleyball coaches clinics are soon to be a reality. The purpose of these clinics according to Skip Stolley, AAF/CIF Coaching Program Coordinator, is to enhance the expertise of CIF coaches, in turn enchancing the athletic experience of the hundreds of Southern Section athletes they encounter.

The Southern Section has always been fortunate enough to have some of the finest coaches in the country. However, even these coaches sometimes have to take a step back and refocus on the goal at hand - the personal and physical development of a young person.

According to a 1990 survey, the quality of coaching is the most important factor on whether or not sports becomes a positive experience for the young athlete. We must encourage our coaches to focus on winning, rather than be obsessed by it. They should make it a priority, but not the top priority. After all, good coaching should not be measured by a won-loss record, but rather whether he or she has affected a young life in a positive manner.

Attending an AAF coaching clinic can give coaches the tools to go out into the field and make high school athletics a rewarding experience for the students. Not only do the AAF/CIF clinics teach the coach the proper philosophy of coaching, they have enlisted some of the top coaches in the particular sport to share the cutting edge in coaching techniques.

This past year, the CIF Southern Section encountered many incidents in which coaches have failed their athletes. They

## **JESSOP NAMED SAN DIEGO SECTION** COMMISSIONER

# MINUTES OF THE EXECUTIVE COMMITTEE MEETING February 21, 1996

The February meeting of the CIF Southern Section Executive Committee was called to order by President Dr. Ken Gunn at 1:05 p.m. at the CIF Southern Section Office. All members were present with the exception of Susana Arce, Dr. Jack Clement, Dr. David Long and Dr. Richard Tucker

1. MINUTES -- It was moved, seconded and passed to approve the minutes of the January 20, 1996, meeting of the CIF Southern Section Executive Committee.

2. STATE FEDERATED COUNCIL MAY ACTION ITEMS -- The Committee discussed State CIF action items that will be introduced to the Southern Section Council with a final vote in April.

(a) STATE CIF EXECUTIVE COMMITTEE NOMINATIONS - President-Elect Jennifer Earle (Central) and Steve Hirabayashi (San Francisco). Executive Committee (four seats): Charley Berger (Sac-Joaquin), Chuck Bononi (Northern), Joyce Eckrem (State Department of Education), Jane Grawronski (Incumbent/San Diego), Steve Hirabayashi, if not elected President-Elect (San Francisco), Jerry Laird, if Jennifer Earle is not elected President-Elect (Central), Darrell Ovid (Oakland), Gary Smidderks (CAPSO). It was moved, seconded and passed to recommend Council send the Southern Section delegates uninstructed.

(b) 1996-97 PROPOSED BUDGET - Tom Triggs, reviewed the State CIF Budget. Following discussion it was moved, seconded and passed to recommend Council support the 1996-97 State CIF budget.

(c) STATE CIF APPEALS PROCESS - Tom Triggs, reviewed the revised State appeals process. Following discussion it was moved, seconded and passed to recommend Council support the process.

(d) STATE VOLLEYBALL CHAMPIONSHIP PROPOSAL - Tom Triggs reviewed a proposal which would eliminate cross-bracketing in Division I, recognizing regional winners in each division. Following discussion, it was moved, seconded and passed to recommend Council support the process.

(e) STRATEGIC PLANNING/GEOGRAPHICAL BOUNDARIES -Tom Triggs, reviewed the current governance proposals of the State CIF Committee. This will not be an action item at the State CIF March meeting.

(f) REMAINING STRATEGIC PLANNING IMPLEMENTATION ITEMS - Tom Triggs reviewed the remaining Strategic Implementation Items. Following discussion, it was moved, seconded and passed to recommend Council support all remaining items.

(g) FINANCIAL POLICIES AND PROCE-DURES CLARIFICATION - Gary Smidderks reviewed the proposed financial policies and procedures clarifications which will be added to Article 8, Section 82 to amend previously adopted financial policies. Following discussion, it was moved seconded and passed to recommend Council support the Financial Policies Clarification.

(h) MODIFICATION OF BY-LAWS 213, 215, 218, 220 AND 221 - Tom Triggs reviewed modifications which would update the by-laws to include "caregivers". Following discussion, it was moved, seconded and passed to recommend Council support these modifications.

(i) MODIFICATION OF BY-LAW 502 - Tom Triggs reviewed the modification of By-Law 502 which would allow "outside combined teams" for a limited amount of time if approved by the league and section. Following discussion, it was moved, seconded and passed to recommend Council support the modification.

(j) MODIFICATION OF BY-LAWS 201, 202, 205 - Tom Triggs reviewed the proposed modification of By-Laws 201, 202 and 205. Following discussion, it was moved, seconded and passed to recommend Council support the modification.

(k) MODIFICATION OF BY-LAW 303 - Tom Triggs reviewed the modification of By-Law 303 which would add new language to allow for unified teams for alternative schools (necessary small schools). Following discussion, it was moved, seconded and passed to recommend Council support the modification.

(I) ADDITION OF FIFTH DIVISION IN STATE CROSS COUNTRY - Tom Triggs, reviewed the recommendation of the State CIF Cross Country/Track & Field Advisory Committee to add a fifth division in cross country to parallel the number of divisions in other state championships. Following discussion it was moved, seconded and passed to recommend Council support the addition.

(m) MODIFICATION OF BY-LAW 202 - Tom Triggs reviewed a change in language to allow foreign exchange students eligibility that have completed only the 10th and 11th grade in their country of origin. Following discussion, it was moved, seconded and passed to recommend Council support the modification.

 1996-97 CIF-SS MEETING DATES -- Following review, the proposed meeting dates for the 1996-97 school year were approved by the Executive Committee.

4. PRESIDENT'S REPORT -- Dr. Ken Gunn, President, complimented Commissioner Crowley on the new communication update process to the Executive Committee regarding critical issues and reviewed the role of the Administrative Committee.

Crowley, Commissioner reviewed the Bay and Ocean Leagues football releaguing process, Caregiver Legislation, new CIF-SS relationship with CADA, L.A. Times articles, ineligible students and playoff regionalization area meetings.

- 7. SOUTHERN SECTION 1996-97 BUDGET PROPOSAL -- Treasurer Marge Godfrey reviewed the proposed 1995-96 Southern Section Budget which will be an action item at the April 25, 1996 meeting of the CIF-SS Council.

(c) CIF Southern Section By-Law 3114.2 (Number of Team Entries into Playoffs) - The Committee recommended the following language as part of the By-Law 3114.2: In the sport of football only, if there are no .500 teams available in the draw, the next best record will be considered. This change to be used when no .500 teams are available to fill byes in the draw.

- (d) Transfer Eligibility (Article 2, Section 213.8, #2 and 222B, #2) The Committee recommended amending the wording in Article 2, Section 213.8, #2 and 222B, #2 which would restrict a student athlete that transfers at the start of the school year and after having participated in an athletic contest at the previous school.
- (e) Southern Section Council Membership (Blue Book By-Law 31) The Committee recommended the deletion of "or other authorized school administrators and/or their designees" and replaced with "and assistant principals or vice principals only".
- 9. OFFICIALS FEES COMMITTEE RECOM-MENDATION -- Susana Arce, Chairperson of the Officials' Fees Committee, reviewed recommendations of the Officials' Fees Committee for a 3 vear agreement (1996-1999) with the adjustments in wrestling, soccer, track & field, and volleyball be made the first year, the second year a \$1.00 across the board increase and the third year a \$1.00 across the board increase. In addition, the Committee recommended the adoption of 1221A as a Blue Book rule which states the host school have available someone who will handle the needs of the officials assigned to the contest. This should include but not be limited to facility orientation, locker room assignment and parking. 10. PRESIDENT'S REPORT -- Dr. Ken Gunn. President, commended the CIF-SS Office staff on the outstanding management of winter playoffs.
- 11. COMMISSIONER'S REPORT -- Dean Crowley, Commissioner, reviewed with the Committee progress of the Human Relations Committee and new CIF State open enrollment application. In addition, he complimented Assistant Commissioners, Bill Clark and Karen Hellyer on their outstanding management of the winter playoffs.
- 12. TREASURER'S REPORT -- Margie Godfrey, Treasurer, complimented the CIF-SS Office staff on their excellent management of winter playoffs and their competent fiscal management and leadership.
- 13. EXECUTIVE COMMITTEE MEMBERSHIP PROPOSED CHANGE (ARTICLE 7, SECTION 70.2) -- Dr. Ken Gunn reviewed a proposal to constitutionally amend Article 7, Section 70.2 to include a school board member and an activities director representative. This will be an actionitem at the April 25, 1996, CIF-SS Council meeting. There being no further business to come before the Council the meeting was adjourned at 11:00

## RULE REVIEW



Open Enrollment Stays the Same, For Now

There has been plenty of discussion regarding open enrollment since the State CIF proposed implementation for an open enrollment transfer deadline of May 15 of the school year preceding the transfer.

However, the State CIF has postponed implementation in favor of the current system for the 1996-97 school year. With a scheduled start date of June 1, it made more sense to put this off until next year. What it means to you, our administrators, is that you can use the same process and the same forms for next year's open enrollment transfers.

According to the proposed system for open enrollment for the 1997-98 school year, only schools/districts which takes nonathletic, non-disciplinary transfers on a completely random basis will be eligible for open enrollment and that applications must be filed before the May 15 deadline. This precludes most private and parochial schools, which may hold transfers to their own admissions requirements.

In the meantime, several options are being considered for open enrollment, including one which allows a student athlete one unrestricted transfer in his or her career. Under current rules, for a student to be residentially eligible under open enrollment, the transfer must not be a result of disciplinary action, there was no consideration given to athletics when considering the transfer, the transfer was completed during the first 15 days of the new school year, the transfer is the student's first open enrollment transfer, and the student falls under the open enrollment policy of the receiving school's board. Under those provisions, over 600 applications have been processed by the Southern Section office this year.

Details on the new process will be available at a later date. For now, open enrollment will remain status quo and open enrollment transfers will be allowed under the current stipulations listed above. Copies of the open enrollment Form 222 will be included in your school's fall packet.

### **SOUTHERN SECTION TEAMS CLAIM FIVE STATE BASKETBALL CROWNS**

Eight CIF Southern Section member schools competed for state titles in the CIF ARCO am/pm State Basketball Championships held at the ARCO Arena in Sacramento March 1 and 2. Only five came

In the Division I girls final, Mater Dei defeated Archbishop Mitty of San Jose 59-48 to earn the first girls basketball state title in the school's storied basketball history. Rhonda Gondringer scored 20 points to lead the Lady Monarchs on a 32-4 run in the first half. Gondringer also picked up 8 rebounds, while teammates Melody Peterson and Lori Hurlbut added 13 points apiece.

The Division II championship was a rematch of the 1995 final, as Woodbridge faced El Camino of Sacramento. The Lady Warriors were able to duplicate the '95 result with a 51-44 victory over the Eagles. Erin Stovall led the Warriors with 21 points and Melanie Pearson added 16.

Bishop Montgomery also took home a girls state basketball championship for the first time this past weekend as the Knights upended Bear River of Grass Valley, 46-42, for the Division III crown. Jamilah Jones and Danielle Graham each scored 11 points and Tashara Carter added 8 in the victory.

The Dominguez Dons proved that their No. 2 national ranking waswell-deserved by pulling away from Northgate of Walnut Creek and winning, 63-49 in the Division II title game. Jason Thomas scored a game-high 28 points and James Jones picked up 11 rebounds for Dominguez as they picked up their first state champi-

The Division III crown was snatched, along with a combined 27 rebounds, by twin towers Jason and Jarron Collins for the Wolverines of Harvard-Westlake. Harvard-Westlake also got 31 points from Jason and Jarron in their 62-49 triumph over Grant of Sacramento. This victory also marked the first state basketball title for the

Other Southern Section schools were in action at the state finals with Valley Christian/Cerritos falling to Campolindo of Moraga 77-60 in the Division IV girls title game, Mission Prep losing to Sacred Heart Prep of Atherton, 62-52, in the Division V girls final, and Montclair Prep was defeated by St. Elizabeth of Oakland 72-67 in the Division V Boys Championship.



### TRASH TALKING CANNOT BE TOLERATED

Whatever happened to good old-fashioned sportsmanship in interscholastic athletics? Pressure-packed contests and the desire to win have eroded the basic values competition can teach and consequently produced a style of behavior which ignores good sportsmanship altogether in too many cases. ers, coaches and fans to react in an unsportsmanlike manner.

Too often, officials allow "trash talking" to occur and do not penalize. Too often, officials will repeatedly warn players to stop verbal exchanges, but they never penalize. Official must stress in their pregame discussions with the coaches and captains that



The frequent taunting and baiting most often called "trash talking" prevents the competition from being played in a sportsmanlike atmosphere, which is a basic requirement at the high school level. Coaches and administrators must demand good sportsmanship by players, and they must be models for the players. Coaches must insist that such "trash-talking" behavior cannot and will not be tolerated.

The No. 1 priority in interscholastic athletics is good conduct and good sportsmanship. When coaches and officials allow "trash talking" to take place in interscholastic contest, sportsmanship takes a back seat. Included in taunting and baiting is players demonstrating when fouls, penalties or violations are called by officials.

Captains should be informed by the game officials that once the game starts, there should be no interchange between players that is taunting or baiting in nature. Any demonstration of showing up an official or an opponent will be penalized. If a player makes a good play and then is in the face of the opponent, pointing, hollering or chesting up, it must be penalized.

Unfortunately, there are ever-increasing types of unacceptable behavior that are tolerated as being "part of the game." The use of ridiculing motions, pointing fingers are ways in which opponents are taunted. The body language after a great play by a competition is often intended to either embarrass or intimidate the opponent. Taunting and baiting often incites opposing play-

players are to talk to teammates and coaches only and refrain from having conversations with opponents that do nothing but create ill will. Tolerating this "trash talking" behavior, or looking the other way, is not going to help solve the problem. Officials simply cannot allow taunting and baiting or "trash talking" to become an accepted part of any inter-

scholastic competition.

The coach must take a visible leadership role in this issue. Since the coach is the most influential person in teaching good sportsmanship, one of his or her fundamental responsibilities is to inspire players to conduct themselves in a manner which best represents the values of high school sports. The coach is the most influential person on the court or the sidelines, and it is reflected by the conduct and behavior of his or her players.

Coaches must stress respect for opposing players and tolerate no conduct which demeans or embarrasses. Opponents are guests and should be treated as such. A coach must get involved and act swiftly when a player taunts or baits an opponent. If a coach takes no action by reprimanding or removing the player, it sends a message that this type of behavior is acceptable. A responsible coach will simply not let it happen.

"Trash talking" an opponent is contrary to the basic concept of fair play and honorable competition. Taunting an opponent is exactly opposite of the type of conduct and behavior which participation is intended to teach. Interscholastic competition provides countless opportunities for players to show good sportsmanship as it relates to dealing with an opponent. Why have we allowed this competition to become a place where the very worst acts of disrespect toward an opponent are allowed?

While the displays of poor sportsmanship through taunting and baiting seem to be increasing at the high school level, we may point our fingers at the colleges and professionals for contributing to the problem. We cannot, however, place the responsibility on someone else. "Trash talking" simply cannot be tolerated as part of an educational program and educational experience. Officials must begin to strictly enforce the rules which prohibit such unsportsmanlike conduct. If everyone involved in interscholastic athletics does their job, these undesirable acts will no longer be part of high school competition.

From the time a youngster first gets involved in athletic contests, whether it is in school, the YMCA, Parks and Recreation Department, Little League, or boys and girls clubs, the word "sportsmanship" becomes an often-repeated term. As young men and women mature in years and ability to participate in sports activities, the challenges to portray good sportsmanship become even greater. As Knute Rockne reportedly said, "One man practicing good sportsmanship is far better than fifty others preaching it." In interscholastic athletics winning is for today, but sportsmanship and ethics are for a lifetime.

# GIRLS WATER POLO IS THE NEWEST CIF-SS SPORT

After years of lobbying, the sport of girls water polo was the latest addition to the list of CIF Southern Section approved sports. The proposal, brought forth by the Sunset League, was approved by the Southern Section Council at the March 7 meeting.

CIF-SS BULLETIN -- Spring 1996

Girls water polo was approved as a winter sport and will begin competition in the 1996-97 school year. The Southern Section joins the San Diego and North Coast Section, which already has girls water polo as an approved sport. The winter season of sport was chosen to maximize the availability of coaches, officials and the use of pool time. Also, the winter season currently has soccer and basketball as the only girls sports. The fall has four girls sports and the spring has five sports available to girls.

The sport of water polo is one of the



fastest growing sports, particularly with girls. It is one of the fastest rising sports with regard to the number of collegiate scholarships being awarded.

However, girls have been competing on water polo teams for many year. A survey of Southern Section member schools indicated that at least 59 schools already fielded girls water polo teams and many girls have competed on student teams.

With the addition of the girls team, girls will no longer be allowed to compete on the boys team, with the exception of those currently playing on their school's student team. If a school does not field girls water polo, girls would be allowed to compete on the student team. By rule, girls cannot compete with the boys team in the fall, then with the girls team in the winter.

# SOUTHERN SECTION TO REGIONALIZE PLAYOFFS

With travel costs rising and local rivalries dwindling, the CIF Southern Section Council voted, by an overwhelming margin, to regionalize the sports of baseball, softball, volleyball, basketball, soccer and tennis for the playoff cycle starting in 1996-97. The sport of football will remain in the current playoff structure stressing competitive eq-

uity rather than regionalization.

The regionalization plan, put together by a committee chaired by Temple City High School Principal Ray Plutko, calls for a format similar to that used by the NCAA for the sport of basketball, with the Southern Section seeding the top four teams in each enrollment division and placing them in four

separate regional brackets. The winners in each regional will then advance to the CIF Southern Section Final Four Championships.

Although the concept of regionalization has been approved, there are still many details to "iron out." Full plans should be available by early summer.

# SCGA HOSTS FIRST EVER GOLF RULES WORKSHOP

For the first time in CIF Southern Section history, the CIF-SS and the Southern California Golf Association (SCGA) teamed up to provide member schools a chance to learn the intricacies of the rules of golf. The Golf Rules Workshop was the idea of SCGA's Director of Rules and Competitions, Jamie Conkling to allow the CIF-SS golf coaches an opportunity to "learn about the rules of golf through the use of the USGA rulebook and casebook and be able to relay the information to their athletes."

The workshop was held at the golf training facility at Saddleback College on February 1 and numerous CIF-SS golf coaches were in attendance. The workshop covered all aspects of the rules of golf, including definitions of golf terminology. Following the classroom session, the coaches

stepped out to the practice facility and were given practical applications of the rules at three separate areas - the green, the hazards and the area known as "through the green."

Aiding Conkling with the workshop were John Alber, SCGA Assistant Director of Rules and Competitions; Bob Livingstone, SCGA Committeeman and member of the CIF-SS Golf Advisory Committee; and Angus MacKenzie, an LPGA Rules Official.

# CALVARY CHAPEL CLAIMS THIRD STATE WRESTLING TITLE

For the third time in four years, the ARCO am/pm State CIF Team Wrestling Championship plaque will be placed on a wall on the campus of Calvary Chapel High School of Santa Ana. In a thrilling victory, the Eagles edged out the only other team to have won the state title in the past four years, Independence High of San Jose.

In 1995, Independence edged out Calvary Chapel by a 113.5-106.5 margin. With

the return of several top individuals, including 1995 champion at 125 pounds Tony Gomez, Independence was seeking a second consecutive state crown. This year, the Eagles, trailing by two and a half points going into the final round, used inspired performances by Joe Calavitta at 135 and Ty Wilcox at 152 to slide past Independence and win by the narrowest margin in the state tournament's history - 102.5-102 points. In

addition to individual titles won by Calavitta and Wilcox, Matt Azevedo (third at 119), Burt Pierson (sixth at 125), and Chris Meineke (seventh at 171) also placed for the Eagles.

Calvary Chapel's third state championship is also the third for coach John Azevedo. Other than Calvary Chapel, only three other Southern Section schools have wonthe State Wrestling Championship - South Hills (1981), El Dorado (1982) and Victor Valley (1987).


