

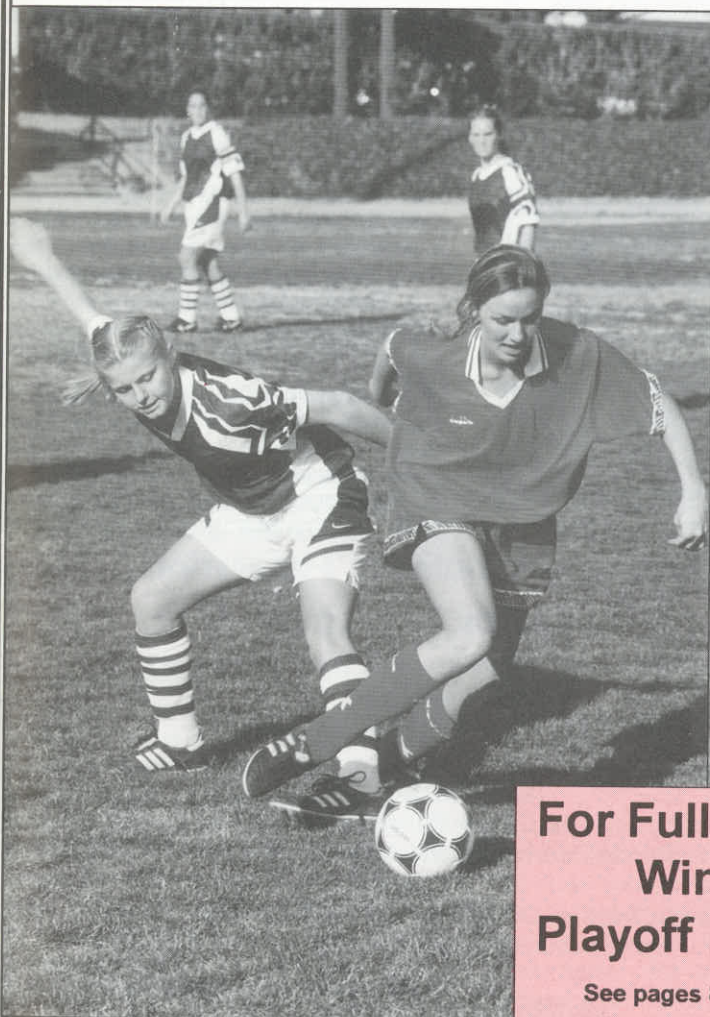

Our CIF Southern Section's continued focus and drive for growth and broadened service in great measure depends upon our many important allied organizations. Our partners include school and community groups implementing outreach programs on substance abuse prevention, sportsmanship and nonviolence as well as coaching and officiating education.

A recent notable event I would like to share with you was the approval by the CIF Southern Section Council of two new members to the Southern Section's Executive Committee effective 1996-97 school year. Namely, a designated representative from each of California School Boards Association (CSBA) and the California Association of Director of Activities (CADA).

To include the vote of CSBA is both appropriate and timely. Pursuant to Senate Bill 237, adopted by the state legislature as of July 11, 1996, CSBA is the organization responsible for all aspects of interscholastic athletics. Its representative on the Executive Committee is Dr. Hank Mercado, President of the Board of Trustees, Redlands Unified School District. Our Southern Section has taken a progressive stance in that it is the first CIF section in the state to include a school board member in its governing body.

CADA is a professional association that serves Activity Directors in California schools. Activity Directors play an important role in many aspects of the organization and operation of a school's athletic program. Their contribution is beneficial to the dialogue of the Executive Committee. CADA's representative is Ms. Barbara Johnson, Vice Principal/Activity Director, Highland High School.

Throughout this year, Dr. Mercado and Ms. Johnson have been valued members of the Executive Committee, offering from each's depth of experience, excellent insights and direction, representing their organization in an effective manner. We all anticipate that the involvement of CSBA and CADA, as well as all other valued allies, will continue to bring success to our mission of preparing quality young people.

CIF-SS COUNCIL MEETING MINUTES January 30, 1997

The January meeting of the CIF Southern Section Council was called to order by President, Tom Triggs at 9:05 a.m., Thursday, January 30, 1997 at the Sequoia Athletic Club in Buena Park. All leagues were present with the exception of the Del Rey League.

1. **MINUTES** - It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of October 24, 1996. Additionally, minutes of the CIF-SS Executive Committee meetings of November 20, 1996 and January 18, 1997 were submitted as information items.

2. **FRIENDS OF GOLF** - President, Tom Triggs introduced David Diltz, President of the Friends of Golf who reviewed the background of his organization and acknowledged the \$40,000 contribution which had been given to the Southern Section. Mr. Diltz then introduced Mr. Eddie Merrins, PGA Professional at Bel Air Country Club.

3. **SIERRA LEAGUE SPRING STARTING DATE PROPOSAL** - Ray Moore, Sierra League Coordinator, presented a proposal calling for a change in the spring season starting date from Saturday, February 22, 1997 to Monday, February 17, 1997. It was moved, seconded and passed to approve the proposal.

4. **COST SAVINGS COMMITTEE RECOMMENDATION WITH REFERENCE TO SANCTIONING NEW SPORTS** - Paul Breit, Chairperson of the Cost Savings Committee, presented a proposal calling for a moratorium on sanctioning

of any new sports through the year 2002. It was moved, seconded and passed to approve the recommendation.

5. **CIF STATE FEDERATED COUNCIL FEBRUARY ACTION ITEMS** - President-Elect, Margie Godfrey, presented the following agenda items for the February CIF State Federated Council in order to give Southern Section delegates voting direction:

A. Strategic Plan to insure quality of officiating statewide - Vote to support.

B. Shot clock for Boys' basketball:

(1) Vote to support the use of a shot clock for Boys' basketball commencing with the 1997-98 season.

(2) Use of 30 second clock - Vote to not support.

(3) Use of 35 second clock - Vote to support.

C. Revision of State CIF Constitution By-law, Article 2; Recommended procedures for operation of a State CIF Governance Structure Committee - Vote to send delegates uninstructed.

D. Revision of By-laws 3002(a) and 3002(d) - Vote to support.

E. Revision of By-law 3000(c) - Vote to not support.

F. Revision of By-law 303 - Vote to support.

G. Revision to item V1.B6, Article 3, Section 32.C, 2 & 3 - Vote to support.

STATE-WIDE MARKETING UPDATE

BIG WIN FOR FIRST CIF AND ARCO am/pm "ADOPT-A-HIGH SCHOOL" PROGRAM

The "Adopt-A-High School" CIF Title sponsor ARCO and its am/pm franchisees will launch a major local store marketing campaign designed to help neighborhood high schools support their athletic programs. The campaign, designed specifically for CIF schools, is called the CIF ARCO am/pm "Adopt-A-High School" program. The program provides am/pm retailers with an assortment of local store marketing materials and fundraising programs that can be executed in cooperation with the one or two high schools in their area.

ARCO is now in the second year of a three year sponsorship commitment to the CIF. While last year the company established its sponsorship supporting the CIF at the statewide level, the company now wants to focus more of its marketing activities at the local level. "Adopt-A-High School" will create strong relationships and fund-raising opportunities between neighborhood am/pm retailers and their customers coming from high schools located right around the corner," said Bob Seagren, CIF Marketing Director and one of the key architects of the ARCO am/pm sponsorship and "Adopt-A-High School" program. "ARCO has done an incredible job with their support of the

CIF. It's encouraging to see that they have a strong local marketing strategy to help leverage their sponsorship."

The campaign kicks-off with a special personal invitation and gift-kit from am/pm retailers to key officials at their local high schools. The gift-kit is a sample of a special CIF ARCO am/pm high school sports fundraising kit that the schools can order to generate revenue for their programs. Each gift-kit also includes a "Local Hero Card." The card invites school officials to visit the local am/pm and acknowledges them as "Local Heroes" by offering a free refill of the kits' coffee mug or sports bottle. The Local Hero mailing is scheduled to start near the end of September.

Other components of the program include CIF ARCO am/pm "Celebrating High School Sports" in-store merchandise centers and seasonal sports bottle fountain promotions. A portion of each program's proceeds will be earmarked to help support the CIF.

IRVINE'S NYBERG & SANTA BARBARA'S MAXWELL HONORED AS SCHOLAR ATHLETES OF THE YEAR

Justin Nyberg of Irvine and Annie Maxwell of Santa Barbara were honored as the Scholar Athletes of the Year in the CIF Southern Section as part of the CIF ARCO am/pm Scholar Athletes of the Year award program. Nyberg and Maxwell are part of the 16th year of this most important awards program. As the Southern Section's winners, Nyberg and Maxwell will receive a \$2,000 scholarship each.

Honored student athletes from throughout the state will receive up to \$5,000 as part of a statewide scholarship program funded by the CIF's sponsor, ARCO, and its am/pm convenience minimarkets. The 20 sectional winners each receive a \$2,000 scholarship, while the two statewide winners, Brady Beaubien of Coronado and Cathleen Sullivan of North Hollywood, will each receive \$5,000. ARCO donated more than \$50,000 in scholarships for the 1996-97 school year as part of its statewide CIF program.

Of the 22 ARCO am/pm scholarship winners, all 22 were above the 4.0 grade point average on a weighted scale. Most have been highly recruited by some of the top colleges and universities in the nation and will attend college on athletic or academic scholarships. The CIF ARCO am/

pm scholarship money can be used for other college expenses if the recipient has received a full scholarship or additional money from a college, university, or organization.

Justin Nyberg carries a 4.02 grade point average and is one of the Southern Section's top cross country runners. This past season, Nyberg finished second at the Southern Section Division I meet and eighth at the State finals. His other activities include being a yearbook photographer, Elections Commissioner for the Associated Student Body and Vice President of Irvine High School's chapter of the California Scholastic Federation. He also revived the school's long-dormant photo club, and even helped organize activities for the Irvine Youth Track Club. Nyberg will attend Princeton University in the fall and focus his studies on the humanities. He will also continue his promising track and cross country career with the Tigers.

Annie Maxwell possesses a 4.63 grade point average and was selected first team All-CIF Southern Section in the sport of volleyball. As a senior, Maxwell was also chosen as team MVP as the Dons reached the Division I IAA title match. Maxwell is also

**Officials
deserve
good
sportsmanship
as well!**

It happens all too often nowadays, players complaining to the referee after every call, a coach "working" an umpire. While some call it part of the game, all it really is is poor sportsmanship.

The great University of Notre Dame football coach Knute Rockne once said, "One man practicing good sportsmanship is far better than fifty others preaching it." While we spend many hours of "preaching" good sportsmanship towards our opponents, we often forget the need to display good sportsmanship towards our game officials. We often shake our opponents hands after a hard fought contest, but it is not often enough that we congratulate the game officials for a well called game.

Isn't the ultimate display of poor sportsmanship toward your opponent the blaming of an official for their victory - your loss. Good sportsmanship includes congratulating your opponent for a job well done. Why not include the officials in this display?

The CIF Southern Section office often gets complaints about officiating at various contests. A majority of these calls made by someone who has extensive knowledge of the rules of the game. It has been suggested that schools hold sessions to help educate their fans on the rules of the game. CIF game officials are often the best in the country at their jobs. Many of them officiate at the intercollegiate level at the same time. Some of them even officiate at the professional level. All of them are certified through their respective officials organizations.

It is clear that officials don't officiate for the money. They could find easier work for more pay, and with less abuse from fans, coaches and most disturbingly, from athletes. Which leads to the most distressing trend in interscholastic sports, the disrespect shown towards game officials by the athletes they are overseeing. Consequently we are losing many of our top officials who would rather not take the abuse.

We can easily point the finger at the professionals and the college athletes and the media coverage they receive. However, we still have the opportunity to change

MINUTES OF THE EXECUTIVE COMMITTEE MEETING January 18, 1997

The January meeting of the CIF-SS Executive Committee was called to order by President Tom Triggs at 10:10 a.m. on Saturday, January 18, 1997, at the Balboa Bay Club in Newport Beach, California. All members were present with the exception of Fr. Robert Gallagher and Dr. Ken Gunn.

1. MINUTES - It was moved, seconded and passed to approve the minutes of the CIF-SS Executive Committee meeting of November 20, 1996, as amended.

2. AREA PLACEMENT - Dean Crowley, Commissioner, reviewed the background, process and timeline for the 1998 - 2002 Area Placement Releaguings Cycle. Following discussion, it was moved, seconded and passed to approve the revised (1-16-97) Area Placement for the 1998 - 2002 Releaguings Cycle.

3. CROSS COUNTRY QUESTION - Dean Crowley, Commissioner, reviewed the background and process regarding the placement of Sultana High School in the cross country championships. Following discussion, it was moved, seconded and passed to sustain the results of the 1996-97 Cross Country Championships.

4. FOREIGN STUDENT ELIGIBILITY - Dean Crowley, Commissioner, reviewed a request for clarification regarding the eligibility of an adopted foreign student. Following discussion, it was moved, seconded and passed to approve the eligibility of the foreign student, as long as the adoption is final.

5. NEW SCHOOL MEMBERSHIP - It was moved, seconded and passed to approve membership for Oak Grove Institute/Jack Weaver School (Murrieta) for the 1997 spring season and Hillcrest Christian School (Granada Hills) for the 1997-98 school year based on their attendance

at an orientation meeting at the CIF-SS Office.

6. PRESIDENT'S REPORT - Tom Triggs, President, reviewed the implications of the Brown Act in regards to league and releguing meetings.

7. COMMISSIONER'S REPORT - Dean Crowley, Commissioner, reviewed with the Committee cost of increased Directors and Officials insurance, Museum of Tolerance visitation, the fall of 1997 CIF-SS Board Member/Superintendent Symposium, and a recommendation to reorganize releguing areas. In addition, he commended the Office staff for their outstanding management of the fall playoffs.

8. TREASURER'S REPORT - Dale Mitchell, Treasurer, reviewed with the Committee the current status of the 1996-97 budget.

9. SUPERINTENDENT'S REPORT - Dr. David Long, reviewed a memo he sent to superintendents regarding the releguing process.

10. SCHOOL BOARD REPRESENTATIVE'S REPORT - Dr. Henry Mercado, reviewed with the Committee the attendance of the Commissioner at the January 30, 1997, San Bernardino County School Board meeting, articles in a school board publication and football championships.

11. ATHLETIC DIRECTORS' REPORT - Sharen Caperton, Girls' Athletic Director, reported on CIF-SS mailings to high schools and assigning of officials. Donn Clickard, Boys' Athletic Director Representative, reported on CIF-SS championship patches and the progress of the guidelines for New Athletic Director's Handbook.

12. ACTIVITIES DIRECTOR REPORT - Barbara Johnson, Activities Director Representative, reported on the CADA Conference to be held in February in San Diego and efforts to produce an Activities Director Handbook.

13. AREA REPRESENTATIVE REPORTS - Executive Committee Area Representatives discussed Official Fees, playoffs, student eligibility, supervision, releguing, sports moratorium, Museum of Tolerance visitation, playoff regionalization, shot clock, CADA Convention, CAPSO Convention, Courtesy Cards and recent court decisions.

14. NATIONAL FEDERATION WINTER MEETING REPORT - Tom Triggs reviewed with the Committee the winter meeting process.

15. OPEN ENROLLMENT UPDATE - Dr. Gary Smidderks, reported on the progress of the State CIF Committee formed to review and clarify the confusion regarding the Open Enrollment Transfer Rule.

16. 19-YEAR OLD RULE UPDATE - Dr. Gary Smidderks reviewed a State CIF proposal which would amend By-Law 201 to read "No student whose nineteenth birthday is attained prior to June 15 shall participate or practice on any team in the following school year. A student whose nineteenth birthday is on June 14 or before, is ineligible."

There being no further business to come before the Committee, the meeting was adjourned at 3:23 p.m.

MINUTES OF THE EXECUTIVE COMMITTEE MEETING February 26, 1997

The February meeting of the CIF-SS Executive Committee was called to order by President Tom Triggs at 1:20 p.m. at the CIF Southern Section Office. All members were present with the exception of Donn Clickard, Fr. Robert Gallagher, Dr. Hank Mercado, Dr. Gary Smidderks and Dr. Richard Tucker.

1. MINUTES - It was moved, seconded and passed to approve the revised minutes of the January 18, 1997, meeting of the CIF-SS Executive Committee.

2. JOHN MUIR TRACK REQUEST - Dean Crowley, Commissioner reviewed the request for a waiver of Rule 702 to allow John Muir HS an opportunity to defend their 1600 meter relay championship at the Penn Relays. Following discussion, it was moved, seconded and passed to approve the request for waiver of Rule 702.

3. PAROCHIAL SCHOOL CONCERN - Tom Triggs, President, reviewed correspondence from Peggy Mahfood, Orange County League Representative Chairperson and Dr. Edward Sussman, Superintendent of Downey Unified School District with reference to concerns relative to parochial schools in the Southern Section. The Executive Committee directed the Commissioner to set a special meeting, asking the following individuals to serve, in order to develop a better understanding of the concerns of our constituents: Dr. Edward Sussman, Peggy Mahfood, Fr. Robert Gallagher, Dr. Jack Clement, the current president of the Catholic Athletic Association and Tom Triggs, who will serve as chairperson.

4. NEW SCHOOL MEMBERSHIP - It was moved, seconded and passed to approve membership for Northwood HS (Irvine) for the 1999-2000 school year and Wilson Creek HS (Yucaipa) for the 1997-98 school year based on their attendance at an orientation meeting at the CIF-SS Office.

5. CIF-SS MEETING DATES - Following review, the proposed meeting dates for the 1997-98 school year were approved.

6. STATE FEDERATED COUNCIL MAY ACTION ITEMS - Margie Godfrey, President-Elect, reviewed the State Federated Council action items that will be introduced at the March 13 Southern Section Council with a final vote at the May 1, 1997, Council meeting.

A. Open Enrollment Proposal - A recommendation to eliminate Rule 223 and provide for a one time transfer opportunity. Following discussion, it was moved, seconded and passed to recommend the Council send delegates uninstructed.

B. By-Law Change (New Section) - A proposal which would allow a majority vote by the State Federated Council to form new CIF Sections. Following discussion it was moved, seconded and passed to recommend the Council support the recommendation.

C. Criteria for Allied Organizations - A proposed State By-Law change which addresses criteria for allied organizations and their representation on the State Federated Council. Following discussion, it was moved, seconded and passed to recommend the Council support the recommendation.

D. Revision of Article 30 (Membership) - A proposed constitutional revision to clarify existing passages and to add a passage regarding any

representative whose status changes (i.e. retirement, change of jobs, etc.). Following discussion, it was moved, seconded and passed to recommend the Council support the recommendation.

E. State Federated Council Representation - A recommendation that sections add an under-represented minority to their state Federated Council delegation. Following discussion, it was moved, seconded and passed to recommend the Council support the recommendation.

F. Modification of By-Law 201 (19-year old Rule) - A two-part proposal. Part one is an amendment to By-Law 201 changing the date from September 1 to June 15. Part two provides for a hardship waiver if adopted by sections. Following discussion, it was moved, seconded and passed to make no recommendation on part one and to recommend the Council support part two of the proposal.

G. State CIF Executive Committee Nominations -

Executive Committee (Four Seats): Jane Gawronski (Incumbent/San Diego), Charley Berger (Incumbent/Sac-Joaquin), Gary Smidderks (Incumbent/Allied Organization - CAPSO), Chuck Bononi (Northern), Mike Henson (Central), Joyce Eckrem (Allied Organization - State Dept. Of Education), Bob Wallace (Allied Organization - ACSA Superintendent's Committee). It was moved, seconded and passed to recommend the Council send Southern Section delegates uninstructed.

H. 1997-98 State CIF Budget Proposal - Following a review, it was moved, seconded and passed to recommend the Council support the proposal.

I. Official Assignment - A recommendation of the State CIF Equity Action Team to address gender balance in officiating assignment. For girls' volleyball and basketball at the state level. Following discussion, it was moved, seconded and passed to recommend the Council support the recommendation.

J. Volleyball Rule Experiment - A four part proposal with the first three items having to do with experimental rules; 1) multiple contacts; 2) back row blocking; and 3) insignificant net contact. Part four of the proposal is the adoption of "Rally Scoring" for sub-varsity and invitationals. Following discussion, it was moved, seconded and passed to recommend the Council support the four-part recommendation.

K. Revision of By-Law 217 Expulsion - A recommendation to clarify existing practice and by-law provisions regarding expulsions and disciplinary transfers. Following discussion, it was moved, seconded and passed to recommend the Council support the recommendation.

L. Revision of By-Law 200C (Limitation) - A recommendation to compel players to play on teams of their own gender when teams are offered in the same sport for both genders. Following discussion, it was moved, seconded and passed to recommend the Council send Southern Section delegate uninstructed.

M. Cross Country C-Bed Enrollment Recommendation and a Proposal to Eliminate Move-Ups - A two-part proposal. Part I adopts new C-Bed numbers for Division V in Cross Country. Part II recommends the elimination of move-ups in enrollment categories in cross coun-

try, boys' and girls' basketball and girls' volleyball. Following discussion, it was moved, seconded and passed to recommend Council support Part I and not support Part II of the proposal.

N. Football Post-Season Bowl Games - A proposal of the Football Bowl Committee to allow the State CIF to conduct post-season bowl games in sites throughout California. Following discussion, it was moved, seconded and passed to recommend Council support the proposal.

7. TREASURERS' REPORT - Dale Mitchell, Treasurer, reviewed the proposed 1997-98 Southern Section budget which will be introduced at the March Council meeting with a final vote on May 1, 1997.

8. SUPERINTENDENT'S UPDATE - Dr. David Long reviewed the superintendent's newsletter, and the Superintendent's & School Board Symposium set for October 8, 1997.

9. ATHLETIC DIRECTORS' REPORT - Sharen Caperton, Girls' Athletic Director representative reported on concerns regarding corporate sponsors' titling on championship patches, boys' and girls' basketball playoff dates and soccer officials.

10. AREA REPRESENTATIVES REPORTS - Executive Committee Area Representatives reported on officiating concerns, the CADA Convention and senior citizen ticket prices.

There being no further business to come before the Committee, the meeting was adjourned at 6:10 p.m.

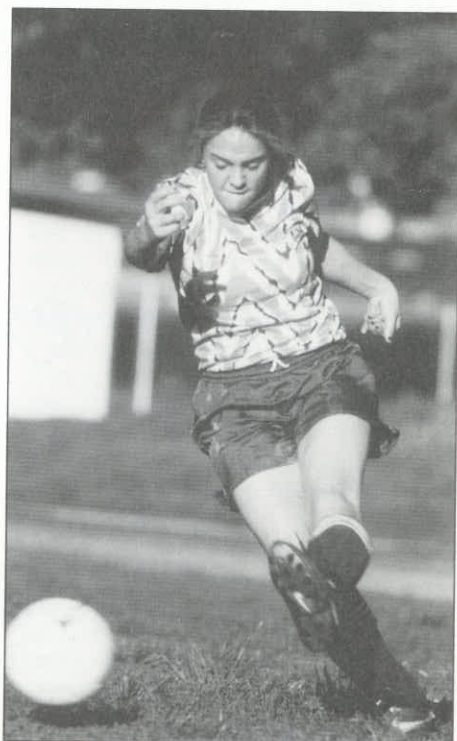

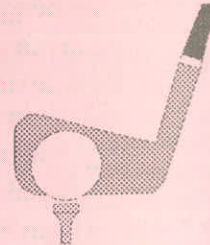

MINUTES OF THE CIF-SS COUNCIL MEETING March 13, 1997

The March meeting of the CIF-SS Council was called to order by Tom Triggs at 9:07 a.m., Thursday, March 13, 1997, at the Sequoia Athletic Club. All leagues were present with the exception of Condor, Express, Foothill, Heritage, Hi-Lo, Liberty, Prep and Victory.

1. MINUTES - It was moved, seconded and passed to approve the minutes of the Council meeting of January 30, 1997. Additionally, the minutes of the CIF-SS Executive Committee meeting of February 16, 1997, were submitted as an information item.

2. SOUTHERN SECTION NOMINATING COMMITTEE REPORT - Dr. Scott McTaggart, Nominating Committee Chairperson, reviewed recommendations for positions on the CIF Southern Section Executive Committee. This will be an action item at the May 1, 1997, meeting of the CIF-SS Council.

Activities Director Representative: Barbra Johnson, Activities Director, Highland HS

Boys' Athletic Director Representative: Donn Clickard, Boys' Athletic Director, Atascadero HS; Mike Ono, Boys' Athletic Director, Jordan HS (Long Beach)

Coast Area Representative: Dr. Liza Daniels, Director, Inglewood Unified School District

Desert Area Representative: Dr. Richard Tucker, Principal, Bishop Union HS; William Frey, Principal, Silver Valley HS

Parochial Area Representative: Fr. Robert Gallagher, Principal, St. Paul HS; Fr. Aidan Carroll, Principal, Bishop Amat HS

School Board Member Representative: Dr. Henry Mercado, Redlands Unified School District Board of Education

3. BLUE BOOK COMMITTEE REPORT - Ben Bushman, Chairperson of the Blue Book Committee, reviewed the following recommendations which will be action items at the May 1, 1997, meeting of the CIF-SS Council:

A. Coaches and Athletes Code of Ethics - The

Committee recommended adding to the Southern Section Blue Book a Coaches and Athletes Code of Ethics.

B. Multiple Offense Rules - The Committee recommended adding to all Blue Book Sport Sections multiple offense rules for coaches and athletes: First ejection - one game suspension; Second ejection - two game suspension; Third ejection - out for remainder of season.

DANIEL FREEMAN HOSPITALS' "TRAINING TO WIN" PROGRAM BECOMES HUGE SUCCESS

With a successful beginning that involved twelve high schools in the Bay and Ocean Leagues, the Training to Win Program instituted by Daniel Freeman Hospitals, along with the West Coast Sports Medicine Foundation, is now bursting at the seams. The Program now involves twenty schools with many more waiting to join the program. It is not that the Training to Win Program does not want to provide for these schools, it is just their funding has been unable to keep up with the demand.

The Training to Win Program provides participating schools with on campus athletic trainers, preseason physical examinations, injury screening clinics, injury prevention training and state of the art medical, surgical, and rehabilitation services to some 8,000 athletes. Additionally, a secondary insurance plan is offered, free of charge, to student athletes of participating high schools.

According to a 1995-96 CIF survey, participation in athletics has increased by over 21% over the past ten years. With the increase in participants comes the increase in numbers of injuries. Daniel Freeman Hospitals has concluded that in their adjacent communities, there needed to be a support system for the high school athletes. According to the Program's Mission Statement, its goal is to reduce the incidence of athletic injuries in local high schools and to treat injuries on-site in order to return the student athlete to competition. The Program strives to provide the schools educa-

tion, injury prevention and rehabilitation.

Another recent development has been the incorporation of 24 Hour Fitness Centers into the Training to Win Program. 24 Hour Fitness Centers' involvement includes opening up their clubs to participating athletes for sport specific training sessions. "Since our goal for this program is injury prevention and keeping the athlete in competition, the addition of 24 Hour Fitness as a partner is a perfect fit," says Dr. Keith Feder, the Director of Sports Medicine for Daniel Freeman Hospitals and the Training to Win Program. "It also allows kids who might not normally have easy access to weight rooms a way to improve their strength and conditioning."

"This Program is a definite win-win situation for those participating schools," according to CIF Southern Section Commissioner, Dean Crowley. Crowley then remarked, "Where else can you go to get this type of care and training at no cost? We are extremely pleased with Daniel Freeman Hospitals' and West Coast Sports Medicine Foundation's involvement with these schools and the CIF Southern Section."

Also in the works for the Training to Win Program is an educational seminar series designed to educate coaches and athletes about head injuries, their symptoms, and recommended responses.

What is a
Bona Fide
Change of
Address?

Faced with an increasingly mobile society, schools are constantly processing transfers and in turn, the CIF Southern Section is processing plenty of transfer eligibility paperwork. With regards to transfer eligibility, Rule 214 states that: "A student may have transfer eligibility provided the student is compelled to move from any school to a CIF school due to a bona fide change of residence from one school attendance area to the attendance area of the new school by the parents or legal guardian(s) or caregiver with whom the student was living with when the student established residence eligibility at the prior school."

Simplified, if you have make a bona fide change of address from one public school attendance area to another public school attendance area, your student will be athletically eligible with no paperwork required.

What constitutes a bona fide change of residence? There are two elements. First, there must be a change of address from one public school attendance area to another public school attendance area. The previous public school attendance area is used to establish the student athlete's residential eligibility. Although the public school attendance area is the criterium used, this also applies to parochial and private schools. Secondly, whomever the student athlete is living with at the school of established eligibility must also move. Whether that consists of mother and father, or mother, or father, they must move to a new public school attendance area. If a student athlete has divorced or separated parents and he or she moves from one parent's home to the other's, the parent with whom he or she was living with when he or she established his or her eligibility is where his or her residential eligibility exists. A move to the other parent's home does not make the student athlete residentially eligible.

Unless both of these two elements takes place, then the student athlete is not residentially eligible. However, he or she may be granted eligibility in one of three other ways - Open enrollment (223), Hardship Waiver (215), and sitting out from varsity

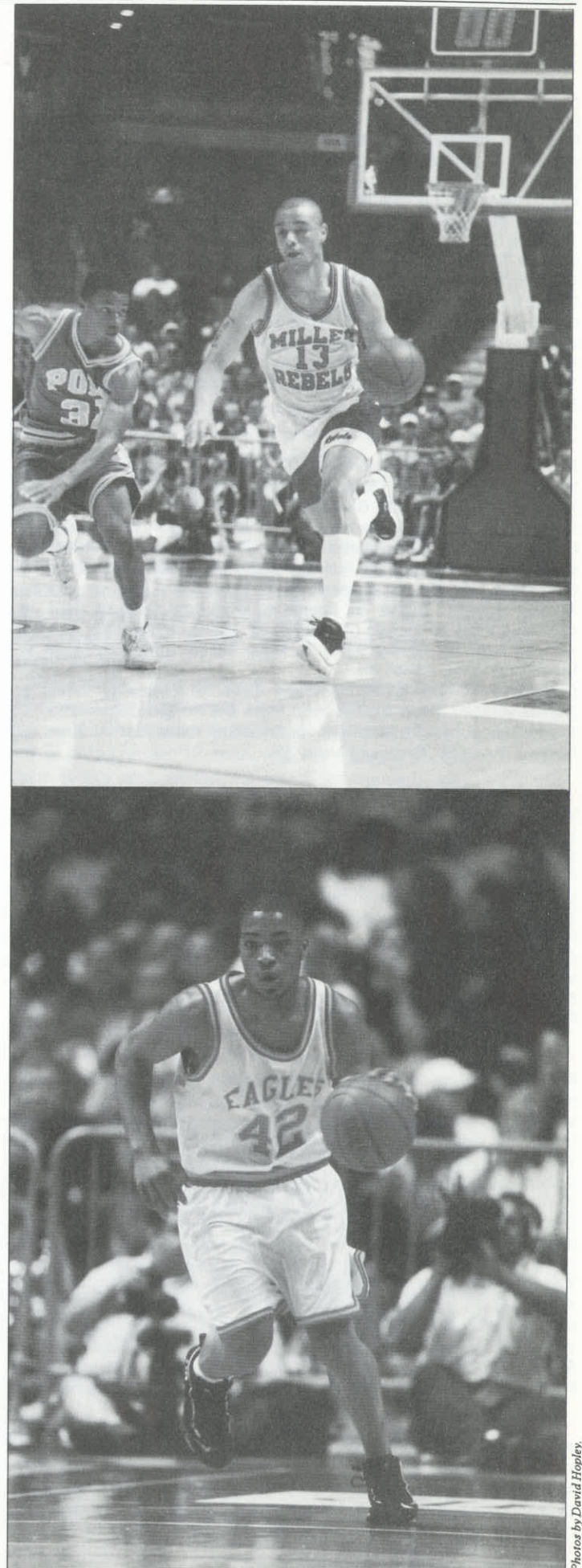

SOUTHERN SECTION TEAMS CLAIM FIVE STATE BASKETBALL CROWNS

Six CIF Southern Section member schools competed for state titles in the CIF ARCO am/pm State Basketball Championships held at the Arrowhead Pond of Anaheim this past weekend. Five came away with wins.

In the Division II girls final, Laguna Hills held off Newark Memorial, 41-40 to earn the first girls basketball state title in the school's history. Tamara Inoue scored 15 points to lead the Hawks, including four clutch free throws in the final minute. Center Tayyiba Haneef and forward Whitney Houser added 10 points apiece and each provided a crucial blocked shot in the last 23 seconds to preserve the Hawks win.

The Division III championship had Bishop Montgomery taking a 15 point lead early in the third quarter only to see Acalanes of Lafayette come back to within 3 points of the Lady Knights with 23 seconds left. Andree Verhulst sank two of four free throws in the final seconds to seal Bishop Montgomery's second consecutive State Championship. Tashara Carter led the Knights with 21 points and 17 rebounds.

In boys action, all three Southern Section teams in the finals prevailed. Dominguez won their second straight Division II title by defeating Shasta of Redding, 85-52. Dominguez forced 30 Shasta turnovers while cruising to the victory. The Dons' leading scorer was forward Jason Thomas, with 20 points, while Kenny Brunner added 16 points.

Also winning their second consecutive crown was Harvard-Westlake. The Wolverines dominated Hillsdale of San Mateo, 90-50. Jason and Jarron Collins each scored 24 points and Jason Collins pulled down 17 rebounds for Harvard-Westlake. Guard Ryan Smiley also added 12 points for Harvard-Westlake. The Wolverines are ranked No. 5 in the nation in the latest *USA Today* Super 25 Poll.

The Division IV crown went to Crossroads, also in blowout fashion. The Roadrunners defeated Encina of Sacramento, 93-57, for their second state crown and first since 1987. Led by Cash Warren's 24 points, Crossroads pulled out to a 40 point lead at one point and finished with the highest point total in state final history. LeQuan Tolbert added 21 points and 17 rebounds for the Roadrunners.

The only other Southern Section school in action at the State Championships was St. Bernard, who fell to Campolindo of Moraga, 68-54, in the girls Division IV title game. Ndidi Unaka and Tonda Williams each scored 12 points for the Vikings. The victory marked Campolindo's third straight State Championship.

Less than two weeks after he won his fourteenth CIF Southern Section boys basketball championship, Coach Lou Cvijanovich of Santa Clara High School was notified that on July 9, he will be inducted to the National High School Sports Hall of Fame.

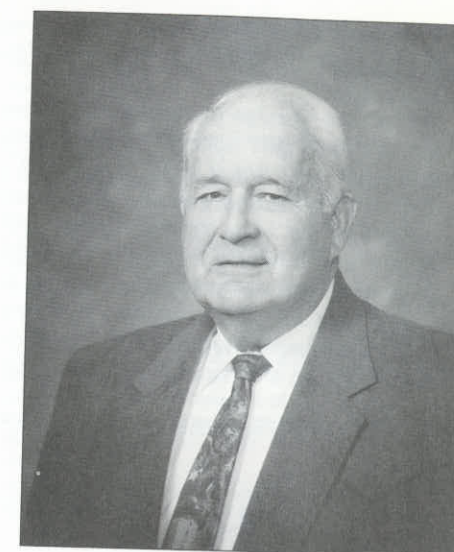
The National High School Sports Hall of Fame was started in 1982 to honor high school athletes, coaches, contest officials, and others for their extraordinary achievements and accomplishments in high school athletics. Cvijanovich is part of the Hall of Fame's 15th induction class, which boosts the total of inductees to 221.

Often referred to as "Mr. Santa Clara," Cvijanovich has been at the school for 39 years. Over that period of time, he has been a teacher, coach, and athletic director. As

a coach, he has coached nearly 1400 games (basketball, football, and baseball combined) and won 42 league championships and 17 CIF Southern Section titles (2 in football, 1 in baseball).

As a basketball coach, he has a career record of 783 wins and 243 losses (76.3%) and has won 2 State CIF titles, in addition to his 14 Southern Section crowns. His teams have qualified for playoff competition in 38 of 39 years.

Coach "C" has won numerous coach-of-the-year awards from various organizations and was awarded the John R. Wooden Award by the Los Angeles Athletic Club in 1995. A 1989 inductee into the Ventura County Sports Hall of Fame, Cvijanovich also has the original gym at Santa Clara now named after him.



LONG BEACH POLY COACH RECEIVES WOODEN-CIF COACH OF THE YEAR AWARD

Ron Palmer, the highly successful coach from Long Beach Poly was awarded the John R. Wooden-CIF Coach of the Year Award at the Wooden Awards Ceremonies held annually at the Los Angeles Athletic Club. The award is given to the coach which demonstrates extraordinary contribution to his community, in addition to a unparalleled dedication to the development of the youngsters involved in high school basketball.

Palmer is the fourth recipient of the Wooden-CIF Coach of the Year. Other winners of this prestigious award are Willie West of Crenshaw (twice) and Lou Cvijanovich of Santa Clara.

CROWLEY RECEIVES HONORARY LIFE MEMBER AWARD FROM CADA

Dean Crowley, CIF Southern Section Commissioner since 1994, received an Honorary Life Membership to the California Association of Directors of Activities (CADA). The CADA Awards were presented at the CADA State Convention on February 20 in San Diego.

The Honorary Life Member Award is given to a deserving individual at the pleasure of the CADA Board of Directors. Recipients are non CADA members who have contributed greatly to the organization.

Crowley, the Southern Section's Commissioner for the past 4 years, has been with

the CIF-SS office for over twenty years, spending most of that time as Associate Commissioner. Prior to the CIF-SS, Crowley was at Gahr High School in Cerritos, where he held several positions including coach, athletic director, counselor, and assistant principal.

Pasadena Poly was awarded seven team championships in the 1996-97 CIF Southern Section Academic Awards Program. In a newly-formed two division format, the Panthers claimed the badminton, football, girls soccer, boys swimming, boys tennis, girls volleyball, and water polo team titles in the small schools segment (1499 and below). Recipients of the individual awards must be seniors that have maintained a minimum 3.5 GPA (4.0 scale) in college-prep courses over the past three years, in addition to earning a letter in at least one varsity sport and participating in an additional extracurricular activity (music, drama, service group, etc.).

The Academic Awards program is sponsored by the Anaheim Angels, Ford Motor Company, and the Murdy Foundation. They were honored at the May 14 Anaheim Angels-Baltimore Orioles game.

CALVARY CHAPEL CLAIMS FOURTH STATE WRESTLING TITLE

For the fourth time in the past five years, Calvary Chapel of Santa Ana came home from the Spanos Center in Stockton with a State CIF ARCO am/pm Team Wrestling Championship. Last season, the won the state title with the slimmest margin of victory in the tournament's history. This year, with many key veterans back, the Eagles set the record for most points tallying 136.5 points.

So dominant was Calvary Chapel that the team it edged for the title in 1996, Independence of San Jose, finished second with a

distant 74 points. Defending individual champions Joe Calavitta and Ty Wilcox each successfully defended their titles, as Calavitta defeated Kirk Moore of Bakersfield Foothill at 140 and Wilcox defeated Telly Sanders of Clovis Buchanan at 160. The Eagles' other finalist Burt Pierson (130), was defeated by another Southern Section wrestler, Carlos Blanco of Canyon Springs. Others placing for Calvary Chapel were Louie Hernandez (5th at 145), Tino Archuleta (5th at 125), Jay McGuffin (5th at 135), and

Josh Saul (8th at 171).

Calvary Chapel's fourth state championship is also the fourth for coach John Azevedo. In state wrestling tournament history only Clovis has won more titles (6) than Calvary Chapel.

Steve Trevino of Santa Fe (112), Justin Flores of Temecula Valley (119), and Hector Torres of Rosemead (HWT.) were other Southern Section wrestlers who brought back state individual championships from Stockton.

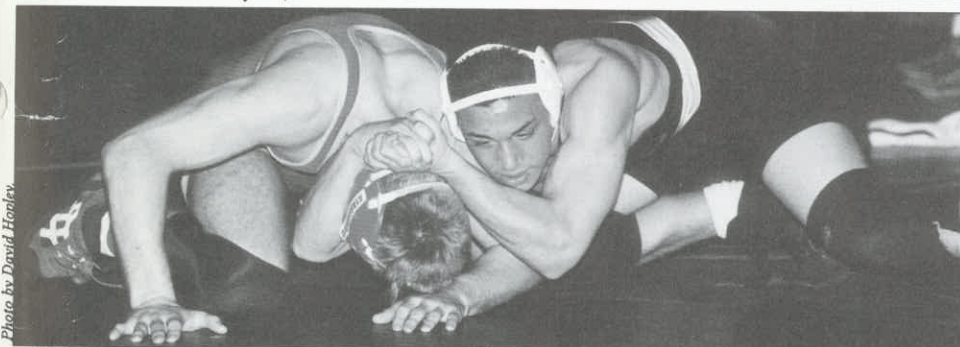
