

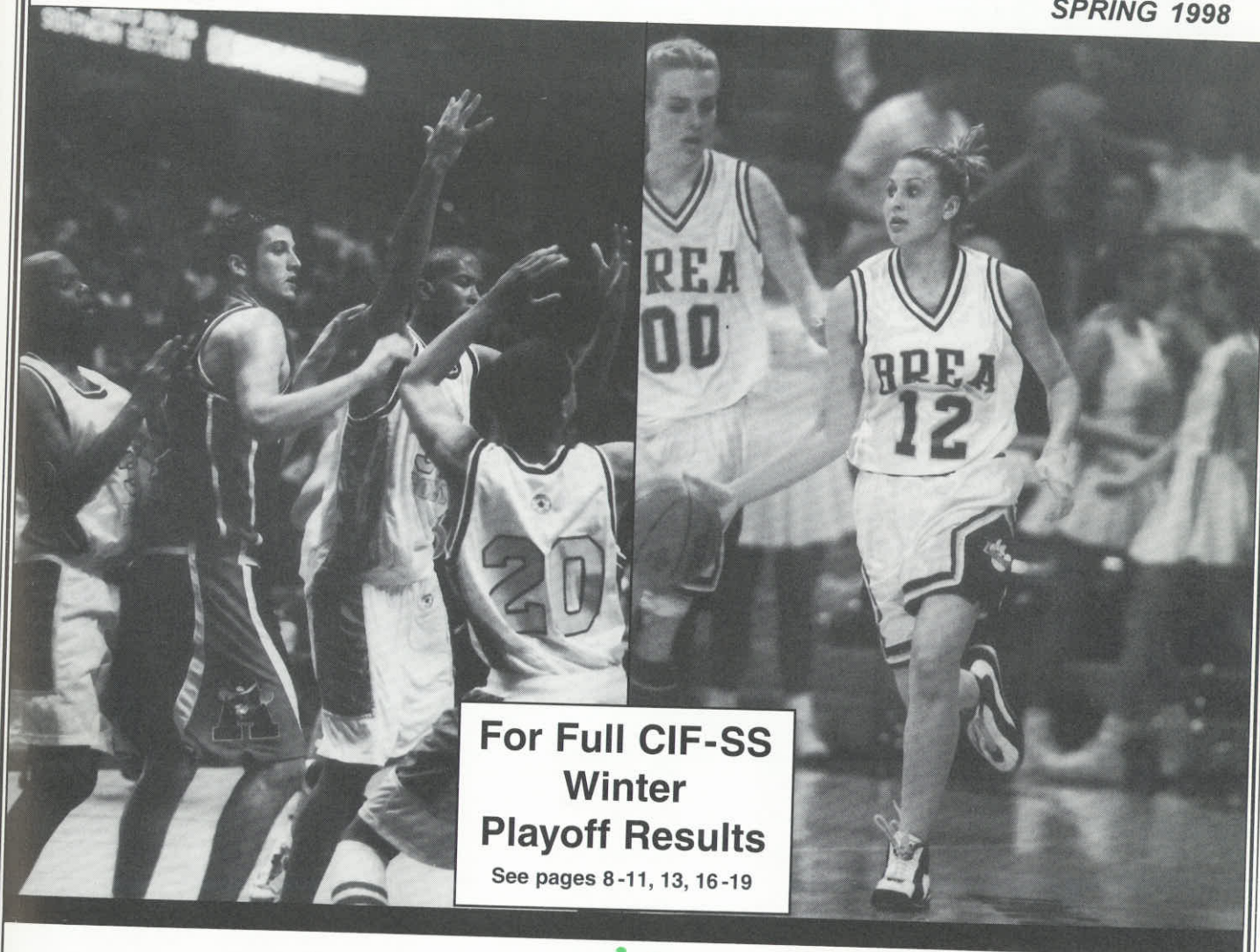

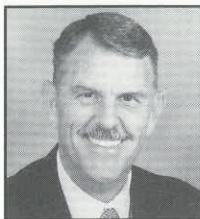

## PRESIDENT'S MESSAGE



**Competitive Anomalies... Are There Solutions?**

The fever pitch in athletic circles reaches decibels to the ninth degree from the Southern Section to the North Coast Section when areas of the state are challenged to align dominant athletic schools into leagues. In many cases, the collaborative working relationships among principals deteriorates as they posture themselves for self-serving purposes. It is believed by many that the situation is basically a private school versus public school issue. This is far from the truth. There exists the opportunity for prowess athletic programs in all types of schools. The situation is further exasperated through "Open Enrollment" in the public sector as the open flow of talent goes to schools with high profile successful teams. Thus, separation state-wide of private and public schools is not a viable course of action.

As a result of the heightened state-wide concern by school boards, superintendents, community activists, the state CIF Executive Director and Executive Committee has established a "Select State-wide Committee." The charge to the committee .....to develop recommendations to relieve those unique competitive situations whereby schools with perceived "dominant programs" find themselves in situations uncomfortable for them and other schools in the league or area where they compete. The committee held public hearings in Northern California (April 8) and Southern California (April 23) to permit the opportunity for input from various publics.

Using this information and work studies of the Committee, the following (condensed form) will be recommended to the State CIF Executive Committee:

- CIF Sections use competitive equity among school teams as the major objective in re-leaguing and create result-based criteria upon which to assess equity.

- CIF Sections create an array of scheduling options useful in mitigating travel time, i.e., double headers, later starting time, contest units, Saturday games, etc.

- CIF Sections develop strategies to address competitive anomalies such as

## CIF-SS COUNCIL MEETING MINUTES January 29, 1998

The January meeting of the CIF Southern Section Council was called to order by President, Tom Triggs at 9:14 a.m., Thursday, January 29, 1998 at the Sequoia Athletic Club in Buena Park. All leagues were present with the exception of the Agape, Citrus Belt, Condor, Foothill, Golden, Horizon, Tri-Valley and Valle Vista.

**1. FRIENDS OF GOLF** - President, Tom Triggs introduced David Diltz, President of the Friends of Golf who reviewed the background of his organization and presented a \$50,000 donation to the Southern Section high school golf program.

**2. MINUTES** - It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of October 21, 1997. Additionally, minutes of the CIF-SS Executive Committee meetings of November 19, 1997 and January 17, 1998 were submitted as information items.

**3. ORANGE COUNTY RELEAGUING** - Jim Staunton, Orange County Releaguings Chairperson, presented the Orange County proposal for the 1998-2002 cycle. Following discussion, a motion to accept the proposal was defeated by a vote of 8 yes, 1 no and 1 abstention. Comments from Dr. Diana Schmelzer, principal of University High School; Dr. Donald Martin, principal of Corona del Mar High School; Gail Richards, principal of Irvine High School; Bob Boies, principal of Newport Harbor High School and Mark Cunningham, athletic director of University High

School were heard in support of the original proposal. Following further discussion, it was moved, seconded and passed to remain status quo for one year. A motion to place Corona del Mar in the Pacific Coast League and Aliso Niguel in the Sea View League failed.

**4. PLAYOFF ENROLLMENT FORMAT** - Dean Crowley, Commissioner, reviewed the playoff enrollment format for the 1998-2002 cycle. Following discussion it was moved, seconded and passed to remain status quo for the 1998-99 cycle.

**5. FORFEITURE AMENDMENT** - Phil Haley, principal of San Geronio High School, presented the San Andreas League proposal to change Article 5, Section 500.2, "Forfeiture Status". Following discussion a motion to approve the proposal was defeated.

**6. GIRLS' TEAM GOLF** - Jim Staunton, president of the Sunset League, presented the Sunset and South Coast leagues proposal for implementation of Girls' team golf beginning in the fall of 1998. Following discussion it was moved, seconded and passed to approve the proposal.

**7. CIF STATE FEDERATED COUNCIL FEBRUARY ACTION ITEMS** - Dr. Ken Gunn, Past-President, presented the following agenda items for the February State CIF Federated Council in order to give Southern Section delegates voting direction:

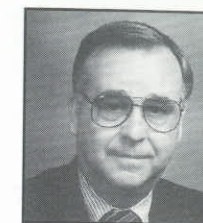

## MINUTES OF THE EXECUTIVE COMMITTEE MEETING January 17, 1998

The January meeting of the CIF-SS Executive Committee was called to order by President, Tom Triggs at 10:07 a.m. in Palm Springs. All members were present with the exception of Fr. Robert Gallagher.

**1. MINUTES** - It was moved, seconded and passed to approve the minutes of the CIF-SS Executive Committee meeting of November 19, 1997.

**2. STATE FEDERATED COUNCIL FEBRUARY ACTION ITEMS** - President-Elect, Margie Godfrey, reviewed the State Federated Council action items that will be voted on at the January 29, 1998 meeting of the CIF-SS Council.

(A) Gifts, Contributions, and Sponsorship - A recommended By-law change to develop a By-law to deal with the influence of gifts, sponsorships and contributions on teams and school programs. Following discussion, it was moved, seconded and passed to recommend the Council send delegates uninstructed.

(B) Revision of State CIF By-law 303 - A proposal to revise CIF By-law 303 as it pertains to any situation which could be defined as a "multi-campus situation". Following discussion, it was moved, seconded and passed to recommend the Council support the proposal.

(C) Girls' Regional Golf Championship - A proposal to initiate a Girls' Regional Golf Championship for 1998 in Northern California. Following discussion, it was moved, seconded and passed to recommend the Council support the recommendation.

(D) Landing Sector for Discus and Shot Put - A recommendation of the State CIF Track and Field Advisory Committee to formally experiment with a 40 degree landing area, instead of a 60 degree area, for the 1998 season. Following discussion, it was moved, seconded and passed to recommend the Council support the recommendation.

**3. BUILDING LEASE** - Assistant Commis-

sioner, Bill Clark, reviewed a five year lease agreement with the ABC Unified School District. Following discussion, it was moved, seconded and passed to approve the five year lease agreement.

**4. AREA PLACEMENT** - President, Tom Triggs, reviewed concerns with reference to the Area Placement process and Releaguings. Following discussion it was moved, seconded and passed that the Executive Committee will put forth a proposal to change the current Area Placement Procedures and configurations prior to, and no later than, April 28, 1998. If the proposal is adopted by the CIF-SS Council and if the configuration of an area is changed, the affected area will be required to releague.

**5. CIF-SS TECHNOLOGY** - Treasurer, Clark Stephens and Assistant Commissioner Bill Clark, presented the CIF-SS Technology Committee proposal to upgrade and network the office and computers, and establish a data base of CIF-SS information. Additionally, part of the proposal will be to upgrade the current telephone system. Following discussion, it was moved, seconded and passed to approve the non-budgeted uncommitted reserve expenditure, not to exceed \$85,000 for the technology improvement.

**6. NEW SCHOOL MEMBERSHIP** - It was moved, seconded and passed to approve the membership of New Roads School in Santa Monica based on their attendance at an orientation meeting at the CIF-SS Office.

**7. COMMISSIONER'S REPORT** - Commissioner, Dean Crowley, reported on open enrollment; the Friends of Golf donation of \$50,000; Finger Printing Laws; State CIF Eligibility Committee; alumni contests and the Internet.

**8. TREASURER'S REPORT** - Treasurer, Clark Stephens, reviewed the current status of the 1997-98 budget.

**9. SCHOOL BOARD REPRESENTATIVE RE-**

**PORT** - Dr. Henry Mercado reviewed the presentation of the Commissioner at the CSBA meeting in Anaheim on Friday December 5, 1997 and provided copies of a brochure entitled, "School Board Guide to the California Interscholastic Federation".

**10. ATHLETIC DIRECTOR'S REPORT** - Girls' Athletic Director Representative, Sharen Caperton, requested consideration for switching Boys and Girls water polo seasons every other year and mailing sport previews to athletic directors.

**11. ACTIVITIES DIRECTOR'S REPORT** - Activities Director Representative, Barbra Johnson, reported on the February 1998 CADA convention in Reno, Nevada.

**12. AREA REPRESENTATIVE REPORTS** - Executive Committee Area Representatives discussed the awards presentation for football championships; water polo officials; cross country culminating meeting; Girls' golf; cross country championships and the CADA Sportsmanship Conference.

**13. FALL SPORT PLAYOFF DATE** - Assistant Commissioners, Bill Clark, Karen Hellyer and Harold Cebrun reported on the fall sports championships.

There being no further business to come before the committee, the meeting was adjourned at 4:02 p.m.

## MINUTES OF THE EXECUTIVE COMMITTEE MEETING February 25, 1998

The February meeting of the CIF Southern Section Executive Committee was called to order at 10:20 a.m. by President, Tom Triggs in the CIF Southern Section Office. All members were present with the exception of Barbra Johnson, Dr. David Long and Tony Ortega.

**1. MINUTES** - It was moved, seconded and passed to approve the minutes of the January 17, 1998 meeting of the Executive Committee.

**2. REVIEW STATE FEDERATED COUNCIL MAY ACTION ITEMS** - President-Elect, Margie Godfrey, presented the following items slated for action at the May meeting of the State Federated Council.

(a) Revision of Open Enrollment By-Law (223 and 214) - It was moved, seconded and passed to recommend approval to the CIF-SS Council.

(b) Proposal to Address Criteria for the Employment of Coaches - It was moved, seconded and passed to recommend approval to the CIF-SS Council.

(c) Proposal to add Snowboarding as an approved CIF sport - It was moved, seconded and passed to recommend approval to the CIF-SS Council as an event which is part of the existing skiing competition.

(d) Proposed definition of "bonafide residence" for student athletes - It was moved, seconded and passed to recommend approval to the CIF-SS Council.

(e) Proposal for Post-Season Northern California Invitational Tennis Regional Tournament - It was moved, seconded and passed to recommend approval to the CIF-SS Council.

(f) Nominations for State Executive Committee and President-Elect - It was moved, seconded and passed to recommend that delegates be sent uninstructed by the CIF-SS Council.

(g) State CIF Budget Proposal - It was moved, seconded and passed to recommend approval to the CIF-SS Council of the working budget.

**3. AREA PLACEMENT/COMPETITIVE EQUITY** - President, Tom Triggs, presented background information with reference to area placement and concerns which have occurred as a

result of same. Previously, the Executive Committee made a decision to develop a proposal dealing with area placement in the off cycle, amending the current Area Placement Procedures. After a lengthy discussion, it was moved, seconded and passed to present a proposal to the CIF-SS Council for ratification with reference to a Constitutional Amendment adding to Article 3, Area Placement Procedures, Item 6 (a), (b), (c), (d) and (e) - Special Circumstances.

Due to special circumstances and/or school requests, effective with the 1999-2000 school year, the Executive Committee recommends that:

(1) Damien and St. Lucy's high schools be moved from the Mt. Sac Area to the Parochial Area.

(2) Rosary, Servite, Mater Dei and Santa Margarita high schools be moved from the Orange County Area to the Parochial Area.

**4. CIF-SS MEETING DATES** - The proposed meeting dates for the 1998-99 school year were presented. A motion was made, seconded and passed to approve same.

**5. PRESIDENT'S UPDATE** - Due to the lengthy agenda, the President deferred his update until the next meeting of the committee.

**6. COMMISSIONER'S UPDATE** - Commissioner, Dean Crowley, updated the committee regarding a meeting he attended at the Huntington Beach Union High School District with Executive Director, Jack Hayes regarding competitive equity, etc.; an appeal to the Orange County Releaguings being submitted to the State CIF; the CIF-SS website and the possibility of obtaining advertising on the site sometime in the spring.

**7. TREASURER'S REPORT** - Treasurer, Clark Stephens, reported on the fall sports income and expense and deferred review of the 1998-99 proposed CIF-SS Budget to the Commissioner. Commissioner Crowley reviewed the proposed budget with the committee, outlining all categories giving rationale for same.

The CIF-SS Executive Committee, at this point, adjourned to closed session.

The closed session dealt with budget review and it was the decision of the Executive Committee to recommend as part of the budget, a 3% salary increase during the 1998-99 school year for all employees to the CIF-SS Council as a non-action item at its March meeting as part of the CIF-SS Budget proposal.

**8. STATE CIF FEBRUARY MEETING** - President-Elect, Margie Godfrey, reviewed the State Federated Council Briefs from the February meeting.

**9. STATE MARKETING REPORT** - President, Tom Triggs, announced that M & FM Marketing is no longer representing the State CIF. John Tarman, formerly of the Central Coast Section, has been employed at the State CIF Office to serve as Marketing Director and is doing a tremendous job for the organization. There is some concern as to whether or not ARCO will continue as a State sponsor. Notification of their continuance will be made in March.

**10. SOUTHERN SECTION NOMINATING COMMITTEE REPORT** - The Executive Committee reviewed the slate of nominees which will be presented to the CIF-SS Council at its March meeting as a non-action item.

There being no further business to come before the Committee, the meeting was adjourned at 5:30 p.m.

## NATIONAL HIGH SCHOOL SPORTS HALL OF FAME RECIPIENTS ANNOUNCED

Swimmer Jill Sterkel and baseball coach John Stevenson are among 13 individuals selected for induction into the 1998 class of National High School Sports Hall of Fame.

The 1998 class is the 16th group to be inducted into the Hall of Fame, which was started in 1982 by the National Federation of State High School Associations (NFHS) to honor high school athletes, coaches, contest officials and others for their extraordinary achievements and accomplishments in high school athletics. This year's class increases to 234 the number of individuals who have been inducted into the Hall of Fame.

Sterkel, who won eight CIF Southern Section Individual swim titles at Wilson High School in Hacienda Heights, won an Olympic gold medal at the age of 15 at the 1976 Olympics in Montreal. She set eight national high school records and still holds the second-best time in the 50-yard freestyle. In 1988, Sterkel became the first female swimmer to qualify for four Olympic teams and won a bronze medal in the 50-meter freestyle. During her collegiate career at the University of Texas, Sterkel won 16 individual collegiate titles and led the Longhorns to AIAW national championships in 1981 and 1982.

John Stevenson, who has been the base-

ball coach at El Segundo High School since 1960, has more than 800 victories. That ranks him seventh in the nation among active coaches. He has won 25 league championships and six CIF Southern Section titles. Among the many players Stevenson has coached are former major league stars George Brett and Scott McGregor.

The 13 individuals were chosen for the National Sports High School Hall of Fame after a two-level selection process involving screening and selection committees composed of active high school administrators, coaches and officials. Nominations were made through member state high school athletic/activity associations.

## MINUTES OF THE CIF-SS COUNCIL MEETING March 24, 1998

The March meeting of the CIF-SS Council was called to order by Tom Triggs at 9:09 a.m. Tuesday, March 24, 1998, at the Sequoia Athletic Club. All leagues were present with the exception of Academy, Agape, Heritage, Imperial Valley and Liberty.

1. **MINUTES** - It was moved, seconded and passed to approve the revised minutes of the January 29, 1998, meeting of the CIF-SS Council.

2. **DELETION OF RULE 711** - It was moved, seconded and passed to defer action until the April 28, 1998, CIF-SS Council meeting.

3. **OFFICIALS' FEES COMMITTEE RECOMMENDATION** - Susana Arce, chairperson of the Officials' Fees Committee, reviewed the proposed 1998-99 Officials' Fees Committee's recommendations to add doubleheader and tournament fees. Following discussion, it was moved, seconded and passed to approve the recommendations.

4. **EXECUTIVE COMMITTEE AREA PLACEMENT RECOMMENDATIONS** - Tom Triggs, President, reviewed an Executive Committee proposal to add a constitutional amendment (Section 6) to Article 3 of the Southern Section constitution dealing with the area placement process and special circumstances. A constitutional amendment will require a two-thirds majority vote for passage by the CIF-SS Council. This will be an action item at the April 28, 1998, CIF-SS Council meeting.

5. **MOJAVE RIVER LEAGUE PROPOSAL TO DELETE RULE 310 (ASSOCIATION RULE)** - Dr. John Slatinsky, President of the Mojave River League, presented a proposal calling for the deletion of Rule 310 (Association Rule). This will be an action item at the April 28, 1998, CIF-SS Council meeting.

6. **SOUTHERN SECTION NOMINATING COMMITTEE REPORT** - Dr. Scott McTaggart, Nominating Committee chairperson, reviewed recommendations for positions on the CIF Southern Section Executive Committee. This will be an action item at the April 28, 1998, CIF-SS Council meeting.

7. **BLUE BOOK COMMITTEE REPORT** - Ben Bushman, chairperson of the Blue Book Committee, reviewed the following recommendations which will be action items at the April 28, 1998, meeting of the CIF-SS Council.

A. Water Polo Tournament Proposal - The Committee recommended an addition to Blue Book Rule 2905 to read, "A student may not participate in more than three tournaments during the season."

B. Private Football Camp Definition - The Committee recommended adding a definition for private football camps to Blue Book Rule 1922 to read, "a private football camp is defined where there are students from three or more schools in attendance and the camp is not being run by a high school coach who has students in attendance."

C. Out of State Competition Rule 702.1 - The Committee recommended adding an exemption to Rule 702.1 to read, "any team, who, in the previous year has reached the championship round and is invited to return, may petition the Southern Section Commissioner for approval."

8. **SOUTHERN SECTION 1998-99 BUDGET PROPOSAL** - Treasurer Clark Stephens reviewed the proposed 1998-99 Southern Section budget which will be an action item at the April 28, 1998, CIF-SS Council meeting.

## RULE REVIEW

What is a

Around this time of year, coaches begin to wonder what kind of student-athletes they will have coming to their respective schools from area junior high schools. By CIF rules, junior high students are allowed to enter any high school in the state, there is always the danger of certain coaches making tempting promises to gain that extra talented athlete.

California Interscholastic Federation representatives are governed under rule 510 in an attempt to regulate such "undue influence."

Some examples of what can and cannot be done under Rule 510 follow:

1. It would not be a violation by a schools athletic director to visit a junior high school campus for the purpose of informing students about his or her athletic programs, but if a coach from that same school did the same, it would then be a violation of 510.

2. Any school may conduct an open house on campus prior to the end of the school year and it would not be a violation for coaches to be present as attendance is voluntary.

3. Schools cannot access junior high students for the purposes of registering them for summer programs until the junior high school is on summer vacation. Registration of those students should not take place until the end of the school year. Additionally, school summer programs may only have those students participate that have registered for school in the fall. Therefore, school summer programs can only be run for students who will be in grades 9-12.

4. Boosters are not allowed to talk to possible students or parents about the school or program in an effort to attract students to their school.

While this is not a complete list of examples, it should provide a basic understanding and an outline of what to do and See **RULE REVIEW** page 19.

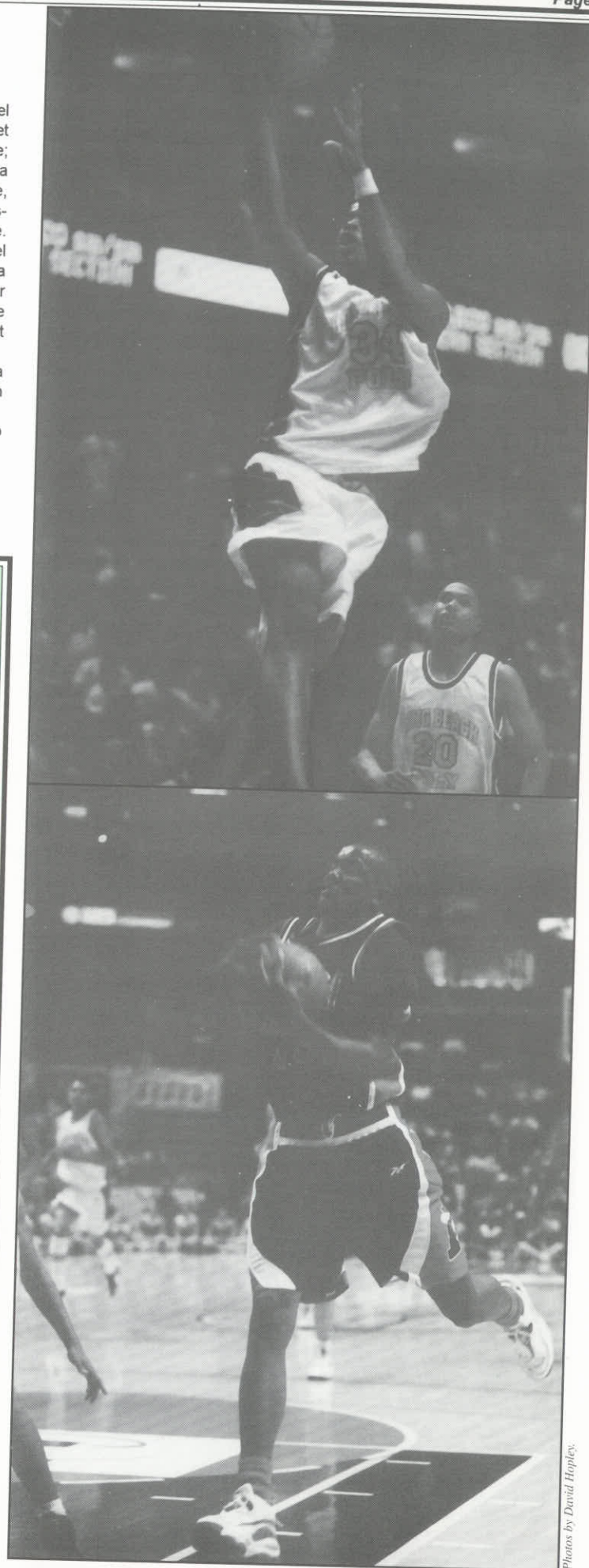

# SOUTHERN SECTION TEAMS CLAIM SIX STATE BASKETBALL CROWNS

Six CIF Southern Section member schools competed for state titles in the CIF ARCO am/pm State Basketball Championships held at the Arco Arena in Sacramento on March 20-21. Five came away with wins.

In the Division II girls final, Brea Olinda defeated Shasta of Redding, 51-32 to earn the sixth girls basketball state title (a state record) in the school's history. Kate Ides scored 16 points to lead the Ladycats. Brea Olinda finished ranked No. 11 in the final USA Today prep poll.

The Division IV championship had St. Bernard taking a 11 point lead early in the third quarter only to see Colfax come back to within 4 points of the Vikings before St. Bernard could nail down its third State Championship. Shannon Howell led the Vikings with 20 points.

In boys action, all three Southern Section teams in the finals prevailed. Santa Margarita won their first Division II title by defeating Montgomery of Santa Rosa, 61-52. Santa Margarita forced 11 Shasta turnovers while cruising to the victory. The Eagles' leading scorer was forward Dekker McKeever, with 20 points, while T.J. Williams added 17 points.

Also winning their first-ever crown was Verbum Dei. The Eagles defeated Pacific Grove, 59-50 in the Division IV final. Marlon Parmer led the Eagles with 21 points, while Delron Johnson tallied 15 rebounds for Verbum Dei. Guard Robert Watkins also added 16 points for the Eagles.

The Division V crown went to Pacific Hills, also in blowout fashion. The Bruins defeated Brookside Christian of Stockton, 69-52, for their first state crown. Led by Conrad Adamczak's 23 points, Crossroads of scored the Knights 23-8 in the third period to pull away. Ryan Abrahams added 16 points for the Bruins.

The only other Southern Section school in action at the State Championships was Alemany, who fell to Sacred Heart Cathedral of San Francisco, 67-54, in the girls Division III title game. Kate Beckler scored 20 points for the Indians. The victory marked Sacred Heart's sixth consecutive State Championship.

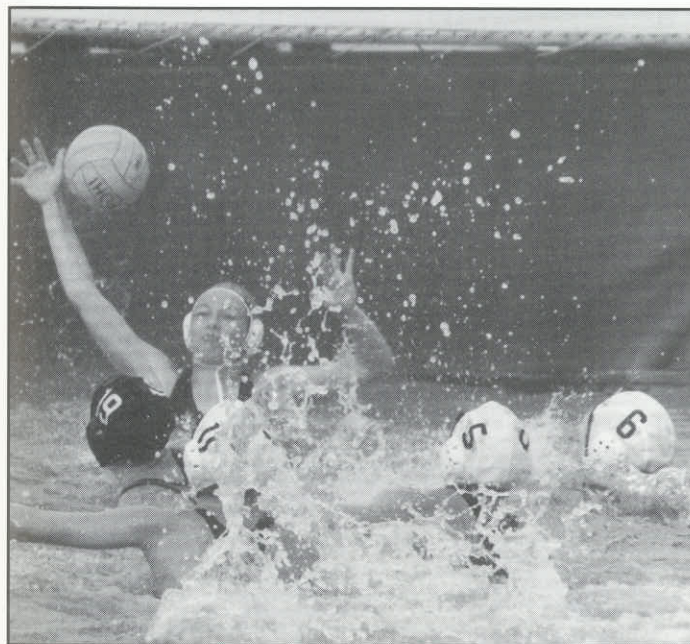

## PASADENA POLY CLAIMS NINE TEAM CHAMPIONSHIPS IN THE 1997-98 CIF-SS ACADEMIC AWARDS PROGRAM

Pasadena Poly was awarded nine team championships in the 1997-98 CIF Southern Section Academic Awards Program. In a newly-formed two division format, the Panthers claimed the badminton, football, girls soccer, boys swimming, boys tennis, baseball, softball, girls track and field and boys water polo team titles in the small schools segment (1499 and below). Long Beach Wilson claimed three team crowns in the large school division (1500 and above). The Bruins won the team awards in the sports of golf, boys swimming and boys water polo.

The team awards, granted in 22 sports, are based on cumulative grade point average. To be considered, teams must have accomplished a minimum 3.0 grade point average (4.0 scale) in college-prep courses in the first semester of the 1997-98

school year. The highest team GPA in each sport determines the champions.

Each CIF-SS member school is entitled to name boy and girl individual "Student-Athlete of the Year" winners, as well. Recipients of the individual awards must be seniors that have maintained a minimum 3.5 GPA (4.0 scale) in college-prep courses over the past three years, in addition to earning a letter in at least one varsity sport and participating in an additional extracurricular activity (music, drama, service group, etc.).

The Academic Awards program is sponsored by the Anaheim Angels, Ford Motor Company, and the Murdy Foundation. They were honored at the May 6 Anaheim Angels-Toronto Blue Jays game.

## CALVARY CHAPEL CLAIMS FIFTH STATE WRESTLING TITLE

For the fifth time in the past six years, Calvary Chapel of Santa Ana came home from the Spanos Center in Stockton with a State CIF ARCO am/pm Team Wrestling Championship. Last season, the Eagles set the record for most points tallying 136.5 points. This year, Calvary Chapel took the title by only eight points by edging out Buchanan of Fresno, 110-102.

Calvary Chapel took the team title despite

having only one wrestler finish higher than third in any weight class. Josh Saul, who finished eighth last year at 171 pounds, finished second at this years tournament at 215 pounds. The Eagles' other finalists, Adam Bones (112), Ben Nakamura (145), Arsen Aleksanyan (160), Mike Bigrigg (189) finished either third or fourth. Calvary Chapel's fifth state championship is also the fifth for coach John Azevedo. In state wrestling tournament history only Clovis has

won more titles (6) than Calvary Chapel.

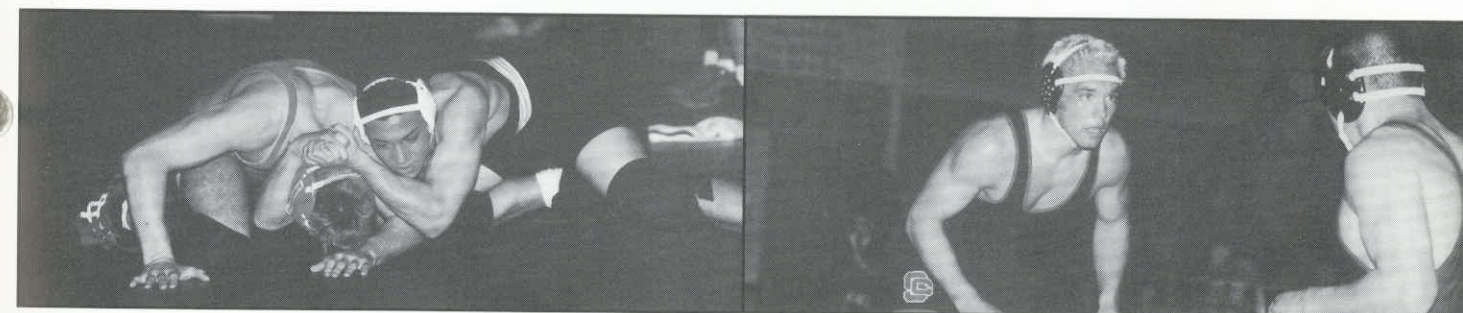
