## PRESIDENT'S MESSAGE



### RELEAGUING TASK FORCE REPORT

Last year, the annual survey the Southern Section office sends to all member schools indicated a fairly high degree of dissatisfaction with the relegating process. Of 516 responses, relegating was judged to need improvement by 22.29%, and only average satisfaction was indicated by 23.26%. As a result of this survey, a special task force was formed last summer. The task force has met six times and has identified the following as its purposes:

Facilitate the leaguing process (including are placement and relegating appeals) by grouping schools in such a way that the competitive experience is maximized for the greatest number of students.

Design a configuration for area placement that would permit a reasonable opportunity for schools to group themselves into leagues and/or conferences for competition.

Formulate a proposal to improve the relegating appeals process and procedure, probably giving more responsibility to the Executive Committee.

Develop a manual of suggested procedures for use by area relegating committees.

We believe strongly that relegating is the purview of the member schools. One of the strengths of the CIF is the philosophy that governance should remain with those closest to the student-athletes, i.e., principals and athletic administrators. With that in mind, the task force is deliberately proceeding slowly and with consideration of the potential effects of our recommendations on present governance structures. We don't want to "throw the baby out with the bath water."

One idea that has received a good deal of discussion is to create six regions of 86-90 schools. These regions would organize themselves into conferences of about 12

## CIF-SS COUNCIL MEETING MINUTES January 28, 1999

The January meeting of the CIF Southern Section Council was called to order by President, Margie Godfrey, at 9:09 a.m., Thursday, January 28, 1999, at the Sequoia Athletic Club in Buena Park. All leagues were present with the exception of the Arrowhead League.

1. **ADOPT AGENDA** - It was moved, seconded and passed to adopt the agenda.

2. **MINUTES** - It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of October 21, 1998. Additionally, the minutes of the CIF-SS Executive Committee meetings of November 4, 1998, and January 9, 1999, were submitted as informational items.

3. **FRIENDS OF GOLF** - President Margie Godfrey introduced David Diltz, President of the Friends of Golf who reviewed the background of his organization and continued contributions to Southern Section schools' golf programs in the amount of \$55,000 for this school year.

4. **ORANGE COUNTY RELEAGUING** - Jim Staunton, Orange County Releaguering Chairperson, presented the Orange County Proposal for the 1999-2002 cycle. Following discussion, a motion to accept the proposal was approved. In addition, Jim Staunton announced with unanimous approval of both leagues University High School will move from the Sea View League to the Pacific Coast League for the 1999-2002 cycle.

5. **PAROCHIAL AREA RELEAGUING** - Bill

Goodman, Parochial Releaguering Chairperson, presented the Parochial Area Proposal for the 1999-2002 cycle. A motion to accept the Parochial Area Proposal for all sports except football was passed. A motion to accept the Parochial Area Football Only Proposal was approved. An appeal from Father Anguiano, Principal of Alemany High School, David Dicker, attorney and Jim Clausen, parent, in reference to Alemany High School's placement in the Del Rey League was heard by the Council.

Speaking in opposition to the appeal and in support of the Parochial Area Football Only Proposal was Patrick Murphy, Principal, Mater Dei H.S.; Bill Goodman, Principal, St. John Bosco H.S. and Sister Cheryl Milner, President of C.A.A. Following discussion, a motion to allow the current leaguing cycle for football only to be played out to its conclusion (1998-2002) and place the Orange County parochial schools in a three-team football league for the remainder of the current leaguing cycle was defeated.

6. **LICENSED MEDICAL DOCTOR** - Dr. Ken Biermann, Pacific League Representative, reviewed the proposal which would amend CIF-SS By-law 1931.2 to read "A licensed medical doctor or the primary health provider designated by the home team as team physician or team doctor shall be in attendance at all playoff games."

## MARKETING UPDATE

### THE BETTERMENT OF INTERSCHOLASTIC ATHLETICS THROUGH CORPORATE RELATIONSHIPS

#### NIKE'S MARCH MADNESS...IT SPREAD

Recently, Danielle Reaves of the CIF Southern Section caught up with Damon Haley - NIKE's Regional Sports Marketing Manager to discuss NIKE's March Madness ad campaign. The series of ads presented a new way of looking at March Madness and its effects on fans across the country. Here is an inside look on the campaign.

SS: What was the creative inspiration behind Nike's college basketball campaign?

DH: "March Madness" has become the moniker for the fun and intensity that hits college basketball at tournament time. For its college basketball campaign, Nike and advertising agency Weiden & Kennedy decided to imagine what would happen if March Madness really was a disease. What if you actually could "catch" March Madness, and it became an actual epidemic that swept the nation?

SS: But isn't the term "March Madness" owned by the NCAA?

DH: Yes, and after reviewing Nike's concept for the ad campaign, the NCAA agreed to allow Nike to use the term in the ads.

SS: How big was the campaign? How long did it run?

DH: the epidemic continued to grow and scientists had no idea how to stop it. Ads have been running since and as March Madness grows, it is impossible to know how big it will become. Nike will continue to air the ads exposing the growth of this epidemic - and its unusual effects on basketball fans - until it has run its course.

SS: Given the criticism Nike received from PETA regarding a commercial last year, why did Nike create a new commercial featuring laboratory rats?

DH: Nike does not condone animal abuse, nor were any animals harmed in the ad. But in order for scientists to understand March Madness, they conducted research to understand what causes it. It's obvious the madness affects human beings, but could it be duplicated in other animals?

SS: Burning old shoes is bad for the environment...why would Nike show this?

DH: In order for scientists to contain the March Madness epidemic, they must determine how it is spread, and remove any items that may be contaminated. It was obvious to them that Duke University was consumed by March Madness, so they swept through and removed as many 'contaminated' items as they could. Fortunately, the scientists obtained the necessary permission to set the fire, it was closely supervised and it was extinguished quickly.

SS: Is Nike deliberately courting controversy?

DH: We created an ad campaign that gets to the core of the unique and intense love affair that college basketball fans have with their school, and with the entire intoxicating affair that is March Madness. We don't actively court controversy, but we don't shy away from it either. We love sports. We love college basketball. How we portray that love may not appeal to everyone, but we believe true college basketball fans will instantly relate to and identify with these ads.

SS: Why did Nike only focus on madness surrounding men's college basketball? Can't the followers of the women's tournament be equally susceptible to contracting the disease?

DH: There is a different advertising campaign that aired during March for women's college basketball, featuring the highly acclaimed "Championship Season" ad series that Nike first ran last year.

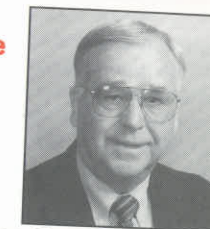

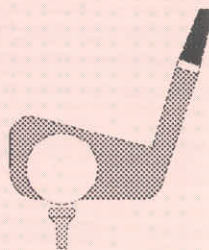

The February meeting of the CIF Southern Section Executive Committee was called to order at 1:20 p.m. by President Margie Godfrey at the CIF Southern Section Office. All members were present with the exception of Susana Arce, Dr. David Long, Hank Mercado, Bob Nero and Tony Ortega.

**1. ADOPT AGENDA** - It was moved, seconded and passed to adopt the agenda.

**2. MINUTES** - It was moved, seconded and passed to approve the minutes of the January 9, 1999, CIF-SS Executive Committee meeting.

**3. FOOTBALL EARLY START REQUEST** - Larry Carlson, Principal of Tustin High School reviewed a request to allow Tustin and Servite high schools a one week early start date for the first football game in 1999. Following discussion, a motion to support the request for one year only was approved. Additionally, a motion to allow the CIF-SS Office, in consultation with the CIF-SS President, the authority to approve any future football requests from schools in the Parochial/Orange County relegating areas was approved.

**4. STATE FEDERATED COUNCIL MAY ACTION ITEMS** - Past President, Dr. Ken Gunn, reviewed the State Federated Council action items that will be voted on at the March 25, 1999, meeting of the CIF-SS Council.

**A. Minimum Age Requirement for Varsity Football** - A proposal to eliminate the present minimum age requirement for participation in varsity football. Following discussion, it was moved, seconded and passed to recommend the Council support the proposal.

**B. Revision of By-Law 1103** - A proposal to revise the State CIF appeal procedures involving matters other than student eligibility and section playoffs. Following discussion, it was moved, seconded and passed to recommend that delegates be sent uninstructed by the Council.

**C. Revision of By-Law 1105 (CIF State Playoff Appeals Procedure)** - A proposal to clarify the appeals procedure for State Playoffs

and Championships. Following discussion it was moved, seconded and passed to recommend the Council support the proposal.

**D. Revision of CIF Constitution, Article 34 (Powers and Duties of Federated Council)** - A proposal to clarify Article 34. Following discussion, it was moved, seconded and passed to recommend the Council support the proposal.

**E. State CIF Budget for 1999-2000** - It was moved, seconded and passed to recommend that delegates be sent uninstructed.

**F. Revision of By-Law 1100 (CIF Section Student Eligibility Procedures)** - A proposal to clarify CIF Section student eligibility hearing protocols. Following discussion, it was moved, seconded and passed to recommend the Council support the proposal.

**G. Student Eligibility By-Law Proposal** - A proposal to address and discourage the increase in misinformation and fraudulent practices to obtain eligibility. Following discussion, it was moved, seconded and passed to recommend the Council support the proposal.

**H. State CIF Cross Country Entries** - A proposal to invite the CIF Southern Section to submit six entries for Division I in the State Cross Country Meet for 1999. Following discussion, it was moved, seconded and passed to recommend the Council support the proposal.

**I. Revision of State Constitution Article 7, Section 70 (Executive Committee)** - A proposal to revise Article 7, Section 70 in order to further the goal of gender equity and ethnic diversity in governance. Following discussion, it was moved, seconded and passed to recommend the Council support the proposal.

**J. Revision of By-Law 226 (Independent Study)** - A proposal to clarify the language in By-Law 226 (Independent Study). Following discussion, it was moved, seconded and passed to recommend that delegates be sent uninstructed by the CIF-SS Council.

**5. NEW SCHOOL MEMBERSHIP** - It was moved,

seconded and passed to approve membership of Death Valley Academy (Shoshone) and Desert Hot Springs high schools for the 1999-2000 school year on the condition they attend an orientation meeting at the CIF-SS Office.

**6. PRESIDENT'S REPORT** - Margie Godfrey, reported on the Relegating Task Force.

**7. COMMISSIONER'S REPORT** - Dean Crowley, Commissioner, announced his retirement effective September 1, 1999.

## CIF SOUTHERN SECTION HALL OF FAME RECEIPT ANNOUNCED

We've all heard the old cliché. If you look up a certain word in a dictionary, you will see the face of somebody who exemplifies just that word.

In the case of Jack Fernandez, there could be no more true statement.

It is because of his commitment and dedication to the sport of wrestling that Fernandez has been selected as the latest recipient of the California Interscholastic Federation Southern Section Hall of Fame Award.

Fernandez has been involved in wrestling for over 45 years, as a competitor, coach and official.

As coach at Mira Costa High School,

Fernandez's teams won five CIF-SS Masters Championships, finished 2nd three times, and captured 17 league championships.

Fernandez's teams also won 22 various tournament championships and coached a CIF record 22 individual champions. His mentoring also resulted in 49 other individuals taking 2nd, 3rd or 4th place.

Coach Fernandez has also been honored numerous times for his accomplishments coaching. In 1973 he was National High School Coach of the Year; he received honors for his "25 Years of Service" to high school wrestling; in 1984 he was a staff member of the United States Olympic Team that competed in Los Angeles; and he has

been honored numerous times as the Coach of the Year by both the Southern California Coaches Association and the South Bay Coaches Association.

Besides his time spent blowing the whistle, Fernandez has also dedicated time as President of the CIF Wrestling Association (1959-60), Executive Board Member of the Southern California Coaches and Officials Association, Executive Board Member of the South Bay Wrestling Officials Association and as a member of the National Amateur Wrestling Coaches Association.

The CIF Southern Section is pleased to honor Jack Fernandez with his induction in to the CIF-SS Hall of Fame.



# MINUTES OF THE CIF-SS COUNCIL MEETING March 25, 1999

The March meeting of the CIF-SS Council was called to order by Margie Godfrey at 9:03 a.m. Thursday, March 25, 1999, at the Sequoia Athletic Club. All leagues were present with the exception of Agape, Alpha, Arrowhead, Channel, Delphic, Desert Valley, Freedom, Heritage, Liberty, Metro and Sunbelt.

**1. ADOPT AGENDA** - It was moved, seconded and passed to adopt the agenda.

**2. MINUTES** - It was moved, seconded and passed to approve the minutes of the Council meeting January 28, 1999. Additionally, the minutes of the CIF-SS Executive Committee meeting of February 10, 1999, were submitted as an informational item.

**3. SOUTHERN CALIFORNIA PGA FOUNDATION** - Frank Talarico, Director of the Southern California PGA Foundation, presented a check to the CIF-SS for \$20,000.00 to support the Boys' and Girls' Golf Championships.

**4. BLUE BOOK COMMITTEE PROPOSAL** - Nancy Billinger, Blue Book Committee member, reviewed the following recommendations which will be action items at the April 29, 1999, meeting of the Council.

A. Travel Restrictions (Blue Book Rule 702.1) - the Committee recommended deleting all travel restrictions under Rule 702.01 (second paragraph).

B. Eligibility and Forfeitures (Rule 500.2 - Recommended Amendment - Rule 500.3) - The Committee recommends an addition to Blue Book to read, "In the case where it is determined that an ineligible player competed due to the failure of the school administration to submit the proper paper work which would have granted immediate eligibility with no restrictions, i.e., open enrollment and transfer eligibility with no restrictions, the school would only be forced to forfeit the initial game won that the student in question played in."

C. Discipline, Expulsion and Transfer for Disciplinary Reasons (Rule 217) - The Committee recommended the following wording for Rule 217.1, Expulsion Return to Previous School/Transfer to New School to read, "the eligibility of a student who is expelled and at a later date returns to the same school shall be determined by the local administration. If the student is compelled to transfer from any public or private school, that student shall have restricted eligibility in all sports and be ineligible for all levels of

competition for a period of one year following the initial transfer."

**5. FOOTBALL SCRIMMAGE** - James Christianson, President of the Frontier League, reviewed a proposal which calls for an interscholastic scrimmage in addition to a 10<sup>th</sup> game. This will be an action item at the April 29, 1999, Council meeting.

**6. FOOTBALL SPRING AND SUMMER RULES** - Dennis Rast, representing the Marmonte League, reviewed a proposal which would allow specific spring football rules to be applicable for summer time football practice. This will be an action item at the April 29, 1999, Council meeting.

**7. WATER POLO PLAYOFFS BY ENROLLMENT** - Gary Murphy, President of the Mission League, reviewed a proposal calling for boys and girls water polo playoffs be conducted by enrollment beginning with the 1999-2000 school year. This will be an action item at the April 29, 1999, Council meeting.

**8. OFFICIAL FEES COMMITTEE PROPOSAL** - Ralph Trigsted, member of the Officials' Fees Committee, reviewed the proposed 1999-2000 Officials' Fees Committee's recommendation. This will be an action item at the April 29, 1999, Council meeting.

**9. CIF-SS NOMINATING COMMITTEE REPORT** - Margie Godfrey, President, reviewed recommendations for positions on the CIF-SS Executive Committee. This will be an action item at the April 29, 1999, Council meeting.

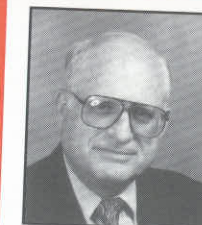

## RULE REVIEW

For many years foreign exchange students have taken part in CIF Southern Section competition. Recently, however, there have been some questions and concerns raised about the placement of foreign exchange students.

Historically, CIF-SS, has allowed foreign exchange student participation at the varsity level, only to those students that have come through CIF approved foreign exchange programs.

State CIF bases its approval of foreign exchange programs as to whether the program places the students randomly. Foreign exchange students should not have the option of picking which school they want to attend.

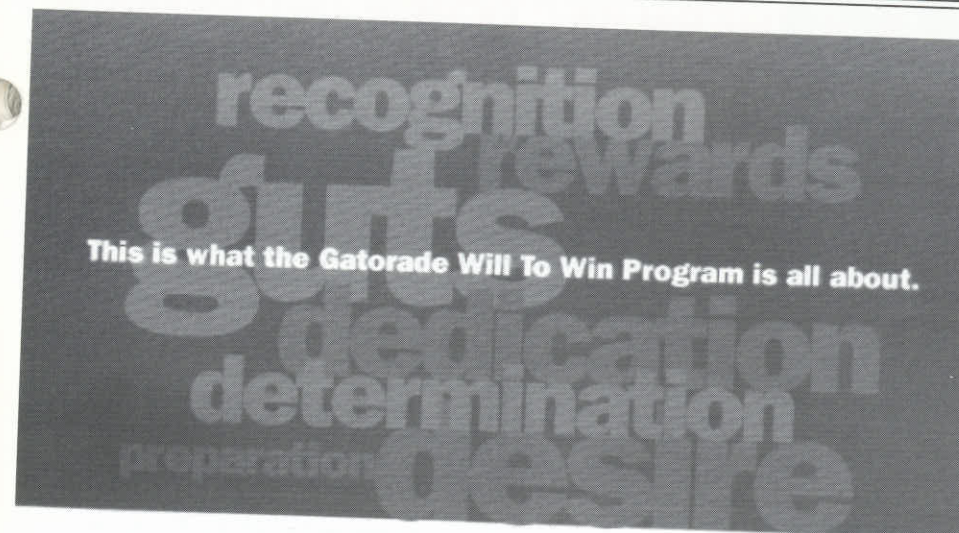
Next year the State CIF office will begin to evaluate all foreign exchange programs to better determine whether any abuses are taking place. Starting next year, paperwork must be approved by the section office prior to the student participating in any sport.

If the program is not an approved foreign exchange program, the student will be granted only restricted eligibility, which means that he/she will not be allowed to participate at the varsity level.

This policy is not retroactive but will affect all new incoming foreign exchange students, starting in the 1999-2000 school year. The appropriate forms will be available in next year's school packets.

Also, a reminder to principals and athletic directors concerning open enrollment, all students hoping to take advantage of open enrollment, must apply to the school on or before May 15.

In addition, the school must keep documentation so as to be able to prove that the students application was received on or before the May 15 deadline.

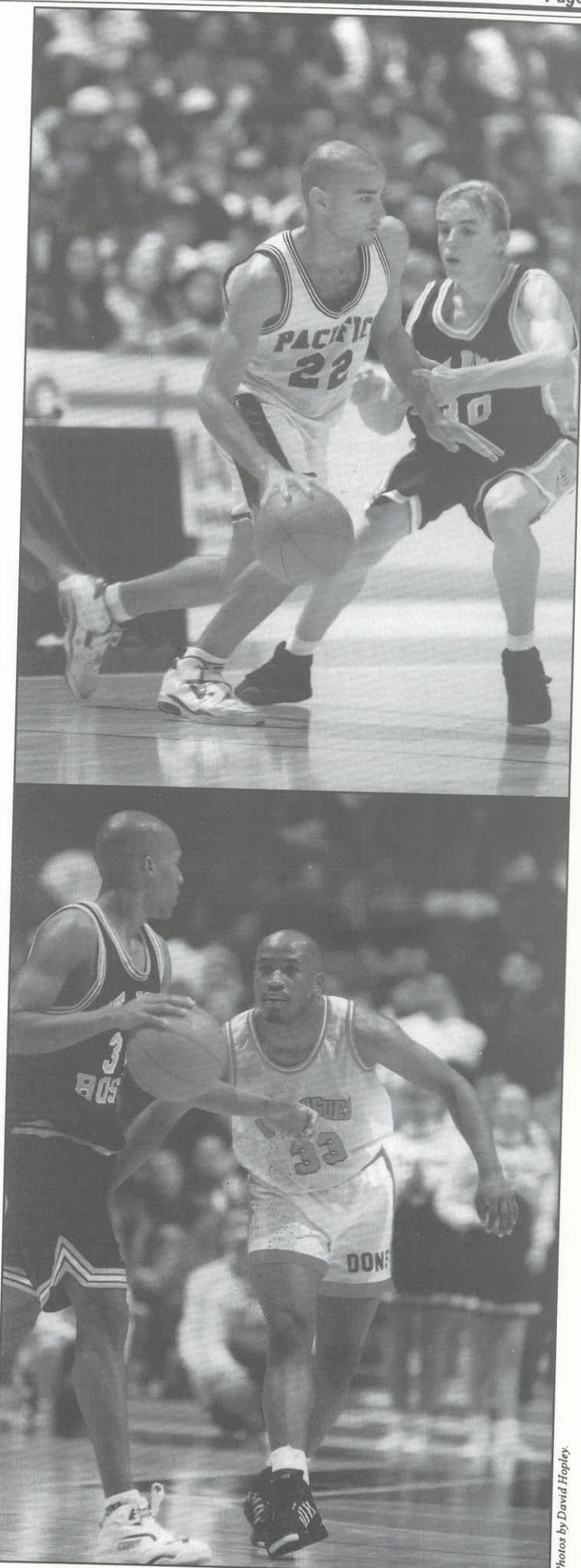

## SOUTHERN SECTION TEAMS CLAIM FOUR STATE BASKETBALL CROWNS

Eight CIF Southern Section member schools competed for state titles in the CIF State Basketball Championships held at the Arco Arena in Sacramento on March 19-20. Four came away with wins.

In the Division II girls final, Brea Olinda came back from an 11 point deficit in the fourth quarter to defeat Amador Valley of Pleasanton, 54-51 to earn the seventh girls basketball state title (a state record) in the school's history. It was also Brea Olinda's second title in a row. Lindsey Davidson and Jeri Costello scored 14 points each to lead the Ladycats. Brea Olinda (32-3) finished ranked No. 16 in the USA Today Prep Poll.

The Division III title game saw Harvard-Westlake with a four point lead with just over two minutes remaining in the game, only to be outscored 9-0 the rest of the way as Corrie Mizusawa of Lafayette Acalanes High took over the game, scoring all nine points to give Acalanes a 47-42 victory. Harvard-Westlake was led by Omelego Udeze who scored 20 points and grabbed 18 rebounds as the Wolverines (29-6) tried to hold on for the victory.

The Division IV championship saw Calvary Chapel make a last minute run after trailing by nine points late in the fourth quarter only to see Atherton Sacred Heart hold on to win its fifth state title. Cathy Joens led the Eagles with 18 points on a tough 9 of 26 shooting night.

The Division V title game saw Chadwick fall, 61-45 to Pinewood of the Northern Section. Chadwick held a one point lead entering the final quarter, but then Pinewood poured it on, outscoring Chadwick 25-8 in the final eight minutes. The Dolphins lost despite strong performances by Erin Gilliland (18 points, 14 rebounds) and Kristin Ceglar (10 points, 11 rebounds).

In boys action, three out of four Southern Section teams in the finals prevailed. In the Division I final, Mater Dei couldn't quite handle the defensive pressure of Oakland Fremont as they lost 50-45. Mater Dei committed 24 turnovers as Fremont's press prevented Mater Dei from getting much offense going. The Monarch's top scorer was Mike Bayer who totaled 12 points and added 10 rebounds.

The Dominguez Dons, ranked seventh nationally, defeated Grant of Sacramento 72-59 in the Division II championship game. For the Dons, it was their third title in four years. The Dons compensated for a sub-par performance from seven-foot center Tyson Chandler that saw him foul out with just five points, with 29 points from senior swingman Keith Kincade and 16 points from junior guard Steve Moore.

Verbum Dei won their second consecutive state title, as the Eagles needed overtime to defeat Sacramento Christian Brothers, 74-63. See **STATE BASKETBALL** page 13.

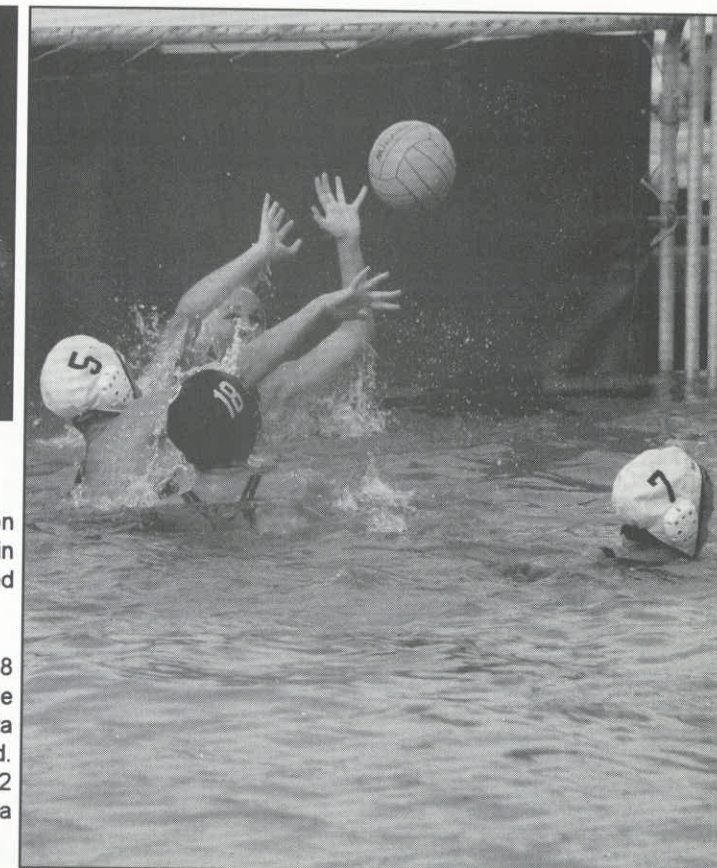

The Panthers claimed small school (1499 and below) championships in badminton, baseball, football, softball, boys swimming, girls swimming, boys tennis, boys track and field, girls track and field, girls volleyball, boys water polo and girls water polo. In the large school division (1500 and above) Dos Pueblos captured three team championships in softball, boys swimming and boys volleyball.

The team awards, granted in 22 sports, are based on cumulative

grade point average. To be considered, teams must have accomplished a minimum 3.0 grade point average (4.0 scale) in college-prep courses in the first semester of the 1998-99 school year. The highest GPA in each sport determines the champion.

Each CIF-SS member school is also entitled to name boy and girl individual "Student-Athlete of the Year Award" winners. Individual award recipients must be seniors who have maintained a minimum 3.5 GPA (4.0 scale) in college-prep courses
