MARKETING UPDATE

THANK YOU FOR YOUR SUPPORT

As we conclude a very successful 2006-07 athletic year, we would like to take a moment to review and remind our 570+ member schools of how your support is required for us all to succeed:

Year in review:

Savings for our schools: Our CIF Southern Section marketing efforts generated over \$550,000 in revenue; simple math will tell you every member school saved \$1,000 in potential dues from these efforts. This is clearly money much better used on your campus and that is why we provide the marketing efforts we do.

TV: Our new TV policy linking us all together like a college conference was a big success with over \$25,000 revenue being distributed to 35 plus schools that had regular season games broadcast on cable, over-the-air TV or the internet. We were also able to have three outstanding girls championships broadcast. For the first time in years, we saw swimming, track and baseball finals broadcast in their entirety. This first year of our new policy had a few speed bumps but brought the entire TV package a much better situation for our members.

Title Sponsor Extends: This past spring we were able to announce that the Southern California Toyota Dealers Association has agreed to a third three-year contract to be the title sponsor of our CIF Southern Section championships. This new agreement means Toyota will have invested more than \$1.5 million as our signature sponsor during this entire decade.

Reminders for the coming year:

Toyota Banners At Your Games: Every school will receive another banner. This banner is REQUIRED at all hosted playoff games and we ask you to PLEASE put these banners up 'permanently' at your football fields and gymnasiums so they display year round. The 60 Southern California Toyota Dealers are nearly all former athletes or current parents/grandparents in the Southern Section so they notice these things. It's a small act that means 'millions' to all the member schools.

TV Scheduling: A reminder that our TV policy and contracts give priority to Fox Sports, Vootage and other companies before your local cable companies. If you are contacted for ANY television opportunities, please contact Thom Simmons or John Costello in the CIFSS office to confirm. We are here to do this work and will contact you when contracts have been signed... and your school gets that revenue during the regular season. We have had to occasionally pull back unauthorized TV arrangements. Just send all inquires (other than local cable) to the CIFSS office.

Gatorade in the Playoffs: A reminder that only Gatorade or non-sponsored jugs, bottles and cups may be displayed during any playoff game. We experienced some issues with this last year when a couple of football teams had the wrong 'blue' jugs prominently on their benches. Gatorade has been a valued Partner for more than two decades and these little efforts are valuable for all of us.

CIFSS page in your programs: By July 14th we will have a one page ad that recognizes all our business partners ready for those schools able to include the page in their football and basketball programs. Your help with this is greatly appreciated and adds 'value' to our sponsorships. And please remember to then send us a copy of a program so we can forward it to the sponsors also.

Thanks for a great year, have a great summer and we look forward to the start of football, girls volleyball and all the fall sports in just a few weeks.

As we end the school year, it occurs to me that we have had quite a year. The Section witnessed a number of changes that we believe will improve the quality of our athletic management and help students reach their goals. I have selected the most significant events for review:

- **Passage of the new transfer rule (206).** The state office realized that without a significant change in our transfer policies, we would face the possibility of legislators writing rules for us. Consequently a compromise proposal was offered that allows freshmen students a one-time transfer prior to the start of the third semester. The rule takes effect on July 1, 2007 and will affect the current class of 2010.

- **New Hardship Appeal Process** – Along with the transfer policy the State Office has approved a new process for hardship appeals. Starting this fall, transfer appeals will be heard by regional hearing panels: a state coordinator will assign these panels. Panels will consist of trained hearing officers the majority of whom will come from out of the Section in which the hearing is held.

- **Approval of an officials' fees package.** Because of the hard work of the Official's Fees/Relations Committee, a proposal for a three-year increase in fees passed in Council. This package recognizes the work of our officials in improving the quality of their officiating and responding to the concerns of our schools. The Section Office will monitor our officials' units to ensure that training, recruiting and retaining officials remains a high priority.

- **The retirement of Karen Hellyer** – Karen will leave the office after 26 years of service. She will be missed. As recording secretary to Council, Karen called roll, advised the Executive Committee on protocol, acted as our historian and managed six sports. She was an advocate for our female athletes and our resident expert on Title IX.

- **The addition of a new Commissioner.** With the support of the Executive Committee and Council, the office will

MINUTES OF THE EXECUTIVE COMMITTEE MEETING

January 26, 2007

This meeting of the CIF Southern Section Executive Committee was called to order at 8:35 a.m. by President Earl Haugen in the Tahquitz Canyon meeting room at the Doral, Desert Princess Resort, Palm Springs, California. All members were present with the exception of Sue Rainey and Bill Thomason.

1. OPENING BUSINESS

E. Adopt Agenda – It was moved, seconded and approved to adopt the agenda with the removal of item 4.B.4.

F. Approval of Minutes – Minutes of the November 8, 2006 Executive Committee Meeting – It was moved, second and approved.

3. ACTION ITEMS

A. State Federated Council Action Items

1. State Wrestling Committee Proposal – After discussion, it was moved to support the proposal. The motion was seconded and approved.

2. Revision of Bylaw 205.B: Scholastic Eligibility – After discussion, it was moved to not support. The motion was seconded and approved to **not** support.

4. NON-ACTION ITEMS

A. State Federated Council Non-Action Items

The following items were discussed by the committee:

1. Bylaw 200 Revision: CIF Philosophy on Student Eligibility for Interscholastic Athletic competition

2. Bylaw 214 Revision: Transfer Eligibility

3. Bylaw 215 Revision: Hardship Waiver

4. Appeals Process Revision for Hardship Waiver – It was moved, seconded and approved that all Executive Committee Area Representatives will be present at the March 8, 2007 Council Meeting to lead study sessions for their areas to discuss the new transfer eligibility, hardship and appeal process changes and bring questions to the next meeting.

5. Bylaw 1605 Basketball Coaches Box - After discussion, it was moved, seconded and approved to support this proposal.

B. Southern Section Non-Action Items

The following items were discussed by the committee.

1. Proposal from Sea View League to amend Rule 312 Association Rule – After discussion, it was moved, seconded and approved to not support this proposal.

2. Proposal I from Mountain View League to amend the Summer Dead Period – After discussion, it was moved, seconded and approved to support this proposal with the removal of "or June 8, whichever is first."

3. Proposal II from Mountain View League to amend the Summer Dead Period – After discussion, it was moved, seconded and approved to not support this proposal.

4. Revision of Bylaw 215 – This item was removed from the agenda.

5. CIF Southern Section Preliminary Budget 2007-2008 – After discussion, it was moved, seconded and approved to support the 2007-2008 Preliminary Budget. After discussion to add administrative and support staff, it was moved seconded and approved to present two proposals to Council as follows

1. Increase sport fees. A \$20 increase to all of our schools for each sport would raise approximately \$175,400 and increase the basic fee to \$100 for small schools.

2. Change playoff percentage. By changing the playoff split from 50-25/25 to 60-20/20 we would project to increase revenue by \$235,975; enough to fund the position and provide for growth in the personnel area for several years.

5. NEW BUSINESS

A. Approval of new Appeal Hearing Officers – After discussion, it was moved to approve Dennis McReynolds, George Clemens and Dave Zirkle as Appeal Hearing Officers. The motion was seconded and approved.

6. OLD BUSINESS

A. Recommendation from Strategic Planning Committees – Two of the Strategic Planning Committees brought forth proposals.

1. The Sportsmanship Committee brought forth a proposal to add new wording to the Bylaws in each area of sport. See attached Blue Book Recommendation and form.

After discussion, it was moved to approve the Sportsmanship Committee's recommendation to add new language and a Student-Athlete Post Ejection/Return to Competition Requirement Form. This motion was seconded and approved.

The Officials Fees Committee presented their recommendations. After discussion it was moved to propose new language in the Blue Book for officials. This motion was seconded and approved. (Proposed language attached.)

The Communications Committee discussed their issues and the need to create a more visual and user-friendly website for the "casual" fan.

The Financial Viability Committee presented the concerns determined through meetings.

They determined there is a disconnect among those outside of Southern Section regarding the operations of the Section. They recommend greater education for the general public.

The Student Eligibility/Sport Offerings Committee reported a major focus will be online education. They feel this should be a statewide discussion. Another item of discussion was sport offerings and allowing each Section to determine which state approved sports will be offered.

7. REPORT SESSION

A. President's Report – Earl Haugen felt the committee was very involved with the Transfer Rule changes. The National Federation Summer meeting will begin on June 30th and the Executive Committee is invited to attend.

Earl also commended Dominguez High School. Twelve players were suspended for the remainder of the season and still won a CIF championship.

John Dahlem presented a look at CIF. He presented pictures of top athletes of the years and has compiled 27 chapters of CIF history including office staff, past Council presidents and Commissioners.

B. Treasurer's Report – Bill Dabbs stated there are still schools who have not paid their 2006-07 dues and asked Executive Committee members to contact the schools in their area.

C. Commissioner's Report – Jim Staunton reported he has received help from Bob Nero with Compton Unified School District. He asked all Executive Committee Members to attend the Alumni Luncheon on March 3, 2007 at the Honda Center.

D. Executive Committee Member Reports – Rob Wigod discussed a wrestler who became ineligible due to falsification of information. He also thanked everyone who assisted at the Football Championship games.

Paul Castillo discussed basketball playoffs. The girls will be playing at the Pyramid and boys division one, two and three will be the Honda Center and division four and five will be playing at Colony High School.

Larry Satterfield attended the East Valley Championship game. He plans to attend the Desert Mountain meeting.

Jerry Halpin attended the Kennedy/Anaheim game. The teams showed great sportsmanship.

Terry Speir attended the Santa Fe/Schurr game.

Bill Dabbs commended the office for the well run Home Depot Center games.

John Dahlem went to the 8 Man football game in Cuyama.

Janet Berardi commended one of her teachers who wrote a song that is up for an Academy Award.

Stan Ford attended the Colony/Elsinore game.

Sr. Cheryl Milner commended the well-organized state bowl championship.

There being no further business to come before the Executive Committee, the meeting adjourned at 3:40 p.m.

Division V Girls

Branson Girls Win in First Finals Showing

Rachael Bilney had 14 points, five assists and five rebounds to lead Branson of Ross past Pacific Hill of West Hollywood, 51-36, in the Division V girls' state championship.

Samantha Bilney, Rachael's twin, had 12 points and eight rebounds for the Bulls (33-3), who have now won 31 in a row.

Ariel Dale led Pacific Hills (30-6) with 11 points, and Bree Richardson, the daughter of former NBA player Pooh Richardson, had 10.

Pacific Hills took a 3-0 lead, but would make only two more baskets in the first half, and trailed 20-11 at the break. The Bulls put the game out of reach in a 19-8 third quarter, and led by as many as 22 in the final period.

The win gave Branson a sweep of the Division V titles, as the boys won earlier in the day. It was the first time since 2001 that the same school won both the boys' and girls' championships (Bishop Montgomery of Torrance).

With the victory, Branson tied a record for most combined wins by girls' and boys' teams in a single season, with 66. Ripon Christian matched that total in 1994.

Archbishop Mitty Second-Half Comeback Proves the Difference

Danielle Robinson scored 22 points and grabbed eight rebounds as Archbishop Mitty of San Jose defeated Brea-Olinda, 54-49, to win the girls' Division II championship.

Nicole Anderson had 14 points and nine rebounds for the Monarchs (31-4), who overcame a nine-point first half deficit, and Kassandra McCalister added 11.

Jeanette Pohlen, who will go to Stanford in the fall, finished with 21 points for Brea Olinda (33-2), which was ranked sixth in the nation by Sports Illustrated/Full Court Press coming into the game. The game, however, was decided early in the third quarter when a flurry of fouls was called on Brea Olinda. Pohlen, Kelsey Harris and Lauren Bell all picked up their third fouls in the first 55 seconds, and all three had four fouls with four minutes to go. Mitty outscored the Ladycats 17-5 in the third period, and held on for the win.

Robinson, a point guard who will join the Paris twins at Oklahoma next year, was nine of 18 from the field and had three assists. Lindsay Leo grabbed 12 rebounds.

The title was the third for Mitty, and its first since 1999. Brea Olinda played in its 10th championship game, and has won a record eight California crowns.

Mitty shot just nine of 34 in the first half, which helped explain the 28-22 Brea Olinda lead. During the salvo of third-quarter whistles, however, the Monarchs managed to take the lead for good, 31-30, and eventually led by as many as seven. Brea Olinda cut the lead to three with 22 seconds left, but McCalister hit two free throws to seal the win.

Mater Dei Takes the Battle of Monarchs in OT

Taylor King scored 29 points and had 15 rebounds as Mater Dei of Santa Ana overcame two years of frustration to beat Archbishop Mitty of San Jose for the boys' Division II state title, 69-64 in overtime.

David Wear added 10 points for Mater Dei (33-4), which had lost in the state championship game for the past two years.

Collin Chiverton led Mitty (29-6) with 20 points and Drew Gordon added 17. But Mitty was just 14 of 29 from the free throw line, while Mater Dei was 21 of 33,

and that proved to be the difference in the game.

Even so, Mitty had a 53-49 lead late in the fourth quarter, but went scoreless for 5:40, including the first 2:47 of overtime, to open the door for Mater Dei.

King tied the score with a free throw with 47.3 seconds left, but he missed the second -- in fact, King missed four of six free throws in the last 2:40 -- and neither team scored the rest of the way.

Mater Dei had the better of the play in the first half, and led by five, 32-27, at the break. But an 11-0 Mitty run turned the game around in the third quarter, and the two went back and forth until Mitty ran off nine unanswered points to take a 50-46 lead. But after Greg Justice hit a three-pointer with 2:53 remaining, the well went dry for Mitty, and Mater Dei took over. The Southern California champ scored the first six points of overtime and Mitty could never get closer than three.

It was Mater Dei's sixth state title, and its first since 2003.

Division IV Girls

Marlborough Uses Huge Second Half Run For First State Title

Nikki Speed scored 25 points and had five steals as Marlborough of Los Angeles overcame a 16-point second-half deficit against St. Patrick/St. Vincent of Vallejo to win the girls' Division IV state title, 67-52.

The Mustangs (27-7) outscored the Bruins 41-12 in the second half, as Speed scored 20 of her points in the final 16 minutes.

Alex Cowling led St. Patrick/St. Vincent (30-4) with 32 points, though 24 came in the first half, which the Bruins dominated. They led 40-26 at the break and scored first in the third period, but after that it was all Marlborough. The Mustangs ran off 20 straight points in slightly more than six minutes and then, spurred by Speed's scoring and steals, outscored the Bruins 13-3 early in the fourth quarter to take control of an electric, up-and-down game.

Both teams are very young, with only one senior starter and just two seniors on each roster. Both Speed and Cowling are juniors.

The title was the first for Marlborough, which was making its debut in the state championship game.

Division IV Boys

Campbell Hall Rolls to Second Crown in Three Years

Jrue Holiday scored 20 points as Campbell Hall of North Hollywood defeated Cardinal Newman of Santa Rosa, 70-34, to win its second boys' Division IV state title in the past three years.

Holiday also had seven rebounds and four assists for the Vikings (33-1), who are ranked 13th in the nation by Sports Illustrated. Justin Holiday and Robert Ford had had 15 points each and Keegan Hornbuckle added 10. Campbell Hall's only loss came at the hands of St. Andrew's of Rhode Island, by two points. The Vikings defeated St. Mary's of Berkeley in 2005 for its first state championship.

Matt Wellen led Cardinal Newman (27-8) with 10 points. This was the Cardinals' third appearance in the state championship game, but they have yet to win.

This one slipped away early, as Campbell Hall jumped out to an 11-2 lead and never looked back. It was 43-19 at the half, and never got closer. In fact, the Vikings went ahead 67-27 in the fourth quarter, which triggered the California mercy rule, which means the clock only stops for timeouts. It was the first time the mercy rule, which was instituted prior to the 2005-06 season, has been invoked in a state title game.

The CIF Southern Section Blue Book outlines a series of "Recommended School Responsibilities Relating To Game Officials" that schools might take upon themselves to do for officials. There is no mandate to perform these activities. There are no repercussions to schools who do not do these things. There is, however, a positive impact on schools who do these acts!

Officials go through formal and informal ratings. Such ratings are done by peers, coaches, athletic directors and paid Unit evaluators. Similarly, officials speak with each other about how schools treat them- a form of site evaluation.

Is the official welcome on campus? Does the school do the "little things" properly?

These discussions create an identity for your school and your District. Are you a school of choice for officials? Your answer may reflect the quality of officiating you receive. Web based assignment programs allow officials to reject specific schools for contests.

Take a minute to review the Blue Book Fee Schedule. Listed below is a sample of some of the recommended actions:

- The host school have available someone who will handle the needs of the officials assigned to the contest.....to include....locker room assignment and parking.

- The officials' locker room is open at halftime and immediately after the game.

- At the completion of the contest, the officials' locker and dressing room facilities remain secured for at least 30 minutes in football and 20 minutes in all sports.

- Coaches not approach or confront the officials at the completion of a contest.

- The participating schools should enforce the principles of Victory with Honor

Jazmine Jackson scored 25 points as Sacred Heart Cathedral of San Francisco pulled off another miracle finish to beat Bishop Amat of La Puente, 60-54 in overtime, to win the girls' Division III state championship game.

The Irish (32-2) trailed by three with time running out in regulation, and Tierra Rogers drove to the basket for a two-point layup -- but was fouled with three seconds left.

Sacred Heart had no time outs left, and had Rogers scored without being fouled, under high school rules, the clock would have run out before Bishop Amat would have had to inbound the ball. But Rogers then made the free throw to tie the game, and in overtime, the Lancers made just two of nine free throws and the Irish pulled away.

Kristen McCarthy topped Bishop Amat (27-6), the two-time defending Division III champions, with 17 points, and Ashley Adams added 11. Amanda Alvarez added 10, but the Lancers turned the ball over 30 times, and made just 15 of 30 free throws.

Ki-shawna Moore had 16 and Rogers 10 for Sacred Heart, which won the game despite getting outrebounded 54-37, and making just 19 of 29 free throws.

In the NorCal finals March 17, the Irish trailed by three with 19 seconds left in regulation, and Rogers came up with a basket, a steal and an assist to put them up one -- and Sacramento missed a seven-footer at the buzzer to give SHC the win.

Bishop Amat took charge early against SHC, which came into the game ranked 16th nationally by Sports Illustrated. The Lancers were ahead 14-4 with 20 seconds left in the first quarter before the Irish began chipping away at the lead. A Jackson 12-foot bank shot off an inbounds play game Sacred Heart its first lead at 23-22 with 2:13 left in the half, but Bishop Amat promptly scored the final seven points on the second period to take a 29-23 lead into the locker room.

The Lancers led by as many as eight in the second half, and forced three straight Irish turnovers down the stretch to build a 50-47 lead with 8.8 seconds to go. But then Rogers took the ball to the basket, drew the touch foul and sent the game into overtime.

James Harden had 24 points and topped five players in double figures as Artesia of Lakewood beat Bishop O'Dowd of Oakland, 91-64, to win its second straight Division III boys state championship.

Other double-figure scorers for the Pioneers (33-2) were Renardo Sidney (18), Malik Story (14), A.J. Gasporra (13) and Lorenzo McCloud (13), as Artesia won its fifth California state championship. The Pioneers set a Division III record for most points in a title game, and the teams' combined total was also a record. The previous records were 83 by Crossroads of Santa Monica in 1983 and 154 by Estancia (82) and Washington of Fremont (72) in 1991, respectively.

Brandon Walker had 24 points for Bishop O'Dowd (26-7), which has won one previous state championship in 1981. Shawn Lewis added 18.

Artesia took over the game early, jumping out to a 40-15 lead, but the gritty Dragons refused to buckle. Backed by an emotional crowd, O'Dowd eventually cut the lead to six in the third period, 55-49, but Artesia's talent -- the Pioneers are ranked seventh in the nation by Sports Illustrated -- was just too much for the Dragons to overcome.

Artesia shot 51.7 percent from the field, outrebounded O'Dowd 49-34 and blocked eight shots.

Alexandria Mitchell had 19 points for Berkeley (27-7), which lost to Long Beach Poly in the state finals for the second straight season. Jennifer Gross had a double-double, with 10 points and 13 rebounds.

The first quarter went back and forth, with Poly leading 17-15 after eight minutes. But after the Yellowjackets tied the score at 15, Long Beach Poly went on a 15-2 run that decided the game. Dixon had nine points in that burst and 12 in the second period. At the half, it was 35-23 Poly, and though Berkeley cut it to six in the final 30 seconds, the issue was never in doubt.

The game was the final one in Berkeley coach Gene Nakamura's 24-year career, which included two California titles, the last in 1997, and five other trips to the state championship game.

WINNERS OF THE 2006-07 CIF SOUTHERN SECTION ACADEMIC AWARDS

The winners of the annual CIF Southern Section Academic Awards program were announced at CIF-SS headquarters on April 4.

The team awards, based on a cumulative grade point average, are awarded in 22 sports.

To be considered, teams must have a minimum 3.0 GPA average (4.0 scale) in college-prep courses in the first semester of the 2006-07 school year. The highest team GPA in each sport determines the winner. Schools are divided into two enrollment categories, 1500 and above and 1499 and below. The team with

the highest GPA in each enrollment category for each sport receives the award. The first place teams receive a banner to commemorate their achievement.

All teams who participate receive Academic Award certificates for their student athletes.

Each CIF-SS member school is entitled to name a male and a female "Student-Athlete-of-the-Year" as well. Recipients of the individual awards must be seniors that have maintained a

open a new position to handle the volume of work that has increased many fold over the years. At over 565 schools next year, the office must deal with new schools, new rules and changing demands. We will make service to our Section our first priority.

The State Office reports strong revenue from the games and positive reaction from television and the press. The Section has approved a proposal to extend the experiment.

• **Dispersal of championship venues** – Many people from communities outside of Orange and Los Angeles Counties have expressed dismay at drive time attached to championship events located in the same venue year after year. The Section Office has responded by locating baseball and basketball championships in Riverside, water polo in Santa Barbara, golf in Paso Robles and wrestling in Rialto. We can find high quality sports all over our Section. It is appropriate we locate events on a more distributed basis.

It is gratifying that the Section has seen so much change and still manage to have strong championship events and great support from our leagues. Our strength is our people and the effort they put into our work. We look forward to a new year in which we implement these new and significant changes.
