CIF-SS COUNCIL MEETING MINUTES January 28, 2010

1. OPENING BUSINESS

A. Call to order by Sr. Cheryl Milner, President of the Council

B. Pledge of Allegiance

C. Roll Call

D. Adopt Agenda – Action - A motion was made to amend the agenda adding items 4-11 to the non-action session. The officials' fees proposal was also added. Item 4B5 was pulled from the agenda. It was seconded and supported unanimously.

E. Approval of Minutes

1. Council – Minutes of the October 22, 2009 Meeting – Action - It was moved, seconded and supported to accept the minutes as presented.

2. PUBLIC HEARING SESSIONS

A. Recognition of anyone wishing to address the Council. Speakers must limit their remarks to three minutes.

Tom Frekker-Representing the soccer official's association addressed the council regarding soccer official's fees. The soccer board (at the beginning of the year) negotiated a significantly lower fee for lower level soccer. Previously it was at \$59 and is now at \$33. The average fee (of all lower level officials' fees) is \$60.11. They are respectfully asking that the lower level fees be adjusted to a fair rate.

Mike Pemberthy- "VIP Cards" is a fundraiser designed to help schools create and sell a dis-

count card (related to businesses and services in local communities). They worked with Tesoro High School last year and helped raise over \$25k for their school.

B. SOUTHERN SECTION

1. Proposal from Football Advisory Committee regarding Rule 1917.1(2) – "0" Week Contests to be presented by Tony Barile – Action - It was moved, seconded and passed to support SS359.

2. Proposal from Basketball Advisory Committee regarding Rule 3200.10 to be presented by Richard Wiard – Action - It was moved by the San Andreas League to table this proposal then seconded. The motion to table the proposal was defeated. It was then moved, seconded and passed to support SS360.

4. NON-ACTION SESSION

A. STATE FEDERATED COUNCIL

1. Legal Expenses, 2004-2009 – Discuss - See supporting documentation regarding legal expenses and insurance coverage for litigation. It should be noted that the cost of litigation is not as a result of schools suing the CIF-SS, but rather individuals who bring suit against the State and local CIF governing bodies.

COMMISSIONER'S CORNER

CIF-SS SURVEY OF ATHLETIC ADMINISTRATORS

Last spring over 300 athletic directors and administrators participated in an on-line survey related to transfer rules and hardships. The results seem to be an accurate reflection of the beliefs of our administrators and help the Section Office set policy as we move ahead in a dynamic sports world.

Transfers – here are a few notable responses to questions about the transfer rule:

The administrators were asked to list the top 5 issues that concern them. They chose from a list of several frequently heard complaints. The top 5 were:

1. Club coaches who seemingly dictate where a student should attend school.
2. Schools that always receive large numbers of transfers.
3. Parents with lots of resources moves to gain eligibility.
4. Student transfers after his/her father disagrees with a coach.
5. Club sports in general.

ELIGIBILITY WORKSHOPS PLANNED

EVEN ADMINISTRATORS GET AN ATTITUDE ADJUSTMENT

LOS ALAMITOS – Like a lot of people, Rainer Wulf had the wrong idea.

When he was coaching boys' basketball at Trabuco Hills High, like many coaches and players, his world revolved around him. One thing he didn't want to do was get in trouble. He did everything in his power to make sure that his name and his school were never mentioned by the folks who comprised the CIF Southern Section office.

"If your name was mentioned," Wulf recalls, "it was like, 'Uh-oh, what did we screw up?'"

But Wulf discovered through years of involvement in coaches associations and work with various section committees that the section office wasn't looking to take people down.

Actually, it was to prop people up.

"It was just the opposite," Wulf says, sitting behind his desk in section headquarters, a converted post office in Los Alamitos. "The reality of it was that the section was there to help."

The negative perception is something the section office would like to break. Instead of being seen as the long arm of the law – and there is an element to administering justice that comes with the office – section administrators want their constituency to know that they're there to make things better.

It's a large constituency, too, of students, athletes, parents, teachers, coaches, schools, officials, administrators, friends, relatives and media who are connected to the 576 schools that fit under the Southern Section's umbrella.

Three of the section's four assistant commissioners have been on the job less than three years, Wulf, Scott Raftery and Kristine Palle. Yet they, like Commissioner James Staunton (hired in 1999) and assistant commissioner Rob Wigod (hired in 2000), want people to know that they're accessible.

How accessible? Going into basketball playoffs, which Wulf oversees, it's not unusual for him to respond to 70 emails and 20 phone calls a day, and those are just the ones that aren't handled by capable assistant Sharon Hodge, a longtime fixture in the section office. And that workload is handled by each administrator who oversees a sport.

MINUTES OF THE EXECUTIVE COMMITTEE MEETING January 16, 2010

This meeting of the CIF Southern Section Executive Committee was called to order at 8:30 a.m. by President Sr. Cheryl Milner. All members were present with the exception of Wendy Doty and Janet Berardi.

1. OPENING BUSINESS

E. Adopt Agenda – It was moved, seconded and approved to adopt the revised agenda. It was moved, second to allow the Governance Committee report to be read early in the meeting upon the arrival of Sue Kuwabara. It was approved.

F. Approval of Minutes – It was moved and seconded to approve the minutes of the November 4, 2009 Executive Committee meeting. The motion was passed.

3. ACTION ITEMS

A. State Federated Council Action Items

1. Legal Expenses, 2004-2009 – After discussion the Executive Committee suggested clarification be obtained from the State Office on items contained in this report. It was moved, seconded and approved to send members un-instructed.

2. Transfer Eligibility Data, 2007-2009 – After discussion it was moved, seconded and approved to accept the report.

3. CIF Appeal Panel Data, 2007-2009 – After discussion it was moved, seconded and approved to accept the report.

B. Southern Section Action Items

1. Proposal from Football Advisory Committee regarding Rule 1917.1(2), 0 Week Contests – After discussion, it was moved, seconded and approved.

2. Proposal from Basketball Advisory Committee regarding Rule 3200.10 – After discussion, the Executive Committee recommended the basketball proposal be revised to request an additional two-year pilot to collect time and data.

4. NON-ACTION ITEMS

A. Southern Section Non-Action Items

1. Proposal from Girls Volleyball Advisory Committee regarding Rule 2904.1, 2904.1, 2906 and 2908 – This item was discussed.

2. Proposal from the Football Advisory Committee regarding Rule 1903.2, 1903.3, 1903.4 and 1903.7 – Physical Conditioning Practice – This item was discussed.

3. 2010-11 Nominees to the Southern Section Executive Committee – This item was discussed.

4. 2010-2011 CIF Southern Section Budget – The budget was reviewed as presented. Dr. Smidderks recommended that the Finance/Audit Committee meet to discuss the long term financial goals as well as potential policies to be established for money back to member schools, commitment to the reserves, incentives for employees, etc., for the years in which Southern Section realizes a significant overage.

5. Proposal from Victory League regarding the procedure for team placements in volleyball, baseball and softball – This item was discussed.

6. Proposal from the Marmonte League regarding Rule 3214 – Number of Team Entries into Playoffs – This item was discussed.

5. NEW BUSINESS

A. Governance Committee Report – Sue Kuwabara and Gary Smidderks presented information from the last Governance Committee

meeting and will report back in April.

B. Consideration of Mission College Preparatory Catholic High School for membership in the Southern Section. After discussion it was moved, seconded and approved to allow full membership to Mission College Prep in the Northern Area.

C. Report from Re-Leaguering Area Placement Committee – Bill Dabbs reported on the recent meeting. Recommendations will be presented in the future.

D. Discussion of Divisional Placement Procedures and Recommendations from Staff – Information was distributed and the item was discussed.

6. CLOSED SESSION

A. Report on Actuarial and Medical Costs – It was recommended by the Executive Committee that Mitch Carty pursue an actuarial study on retiree costs.

B. Discussion of Sanctions against two Schools –

Chaparral High School - It was recommended by the Executive Committee that the Commissioner write a letter to Chaparral High School to institute sanctions unless the school reports on positive actions to promote sportsmanship and proper behavior.

Fairmont Prep – The Executive Committee approved actions against Fairmont Prep for misuse of courtesy cards.

7. REPORT SESSION

A. President's Report – Sr. Cheryl Milner complemented Kristine Palle on her efforts with the Student Council Committee. She also praised the staff for their hard work at the championship events.

B. Treasurer's Report – Jim Monico read the treasurer's report. He reported on the potential losses in football, volleyball and water polo and that cross country was up from the previous year. T-shirts sales were down.

C. Commissioner's Report – The Commissioner had no further reports to make.

D. Executive Committee Member Reports – The Executive Committee Members who attended championship events reported positively on their experiences and complemented staff for their hard work. Kristine Palle was complemented on her efforts with the Student Council Committee. Members also commended Mitch Carty on his preparation of the budget. There being no further business, the meeting adjourned at 3:00 p.m.

"There are 80 or 90 pieces of communication daily," Wulf says. "My goal is that if I have a message, I don't leave until I respond in some fashion. Our goal is to get back to you right away."

When the basketball playoffs finally began on Feb. 17, Wulf breathed a big sigh of relief. As a fan, there was no more talk: Just the process of finding out who was No. 1.

The playoffs continue this weekend, with boys playing on Friday, Feb. 19, and girls on Saturday, Feb. 20. A lot of effort is taken to ensure the brackets are balanced, but there are also parameters the playoff committee has to work within, such as polls and splitting teams from the same league into different quarters.

"We have a great product on the basketball side, some of the best basketball in the country," says Wulf, who grew up in Monterey Park, attended Bishop Amat High and UC Irvine. "It's an affordable ticket, it's a family event. When I was young I was fortunate enough to have parents and coaches who took me to games, and there's a whole generation who can get that same excitement out of it."

Wulf, whose first name is pronounced RY-ner, began coaching boys' basketball at Trabuco Hills in 1997, and continued until 2004. He became athletic director in 1998, a position he held until moving to the section office in 2008.

He has been on the job for 18 months. Among the biggest adjustments is "looking at things from a global perspective." When he was a coach, or an athletic director, he saw things only as they mattered to his interests. "You need to look at it from everyone's perspective," he says. "Things don't go as quickly as you'd like because you have such a diverse group of schools with their own missions doing the best that they can," but "you're taking a view from 2,000 feet up instead of just your neck of the woods."

He hasn't looked back on his decision, but he has looked back on the reaction of friends and colleagues who chided him "for going over to the dark side."

But, Wulf says, "it was a perception that was not a reality. We're doing everything we can to be accessible to our schools."

"We're here to support high school athletics in good times and tough times."

2. Transfer Eligibility Data, 2007-2009 – Discuss - See supporting documentation regarding transfer data.

3. CIF Appeal Panel Data, 2007-2009 – Discuss - See supporting documentation on hardship appeals.

4. Concussion Protocol – Discuss - Proposal for dealing with serious head injury and return to play.

5. Girls Wrestling State Invitational – Discuss - Information distributed on prospective Girls' State Wrestling Invitational. Will be presented at Federated Council for first read.

6. Revision of Bylaw 206, Residential Eligibility – Discuss - Two proposed revisions: The first clarifies that a "valid change of residence" does not trump athletically motivated moves. The second revision removes going to and from a boarding school as a valid change. Boarding school students would be handled as all other transfer eligibility situations are handled.

7. Revision of Bylaw 207: Transfer Eligibility – Discuss - Proposed revision clarifies that a valid change of residence still has to meet the condition that the transfer was not as a result of a disciplinary situation at the former school and that the pre-enrollment form is completed. This will verify that there is no evidence of the use of undue influence by anyone associated with either school. The second revision also clarifies that boarding school students will be treated like all other transfer students under this bylaw.

8. Revision of Bylaw 209: Foreign Student Eligibility – Discuss - This revision would make all Foreign Students (both on approved programs and international students) subject to limited eligibility like any other transfer student not making a valid change of residence.

9. Revision of Bylaw 1203: Student Participation – Discuss - This revision would require that all athletic activities in CIF-approved sports involving member schools be held under the rules and regulations of the participating schools' respective league, Section and the CIF, during the school year.

10. Revision of Bylaw 600.C: Competition on an Outside Team – Soccer – Discuss - This clarifies language for soccer specifically to say that during a CIF Section's established season of sport, students may not participate on an outside team. Currently portions of this bylaw are specific to the Southern Section which participates in the winter. This language change would eliminate the "winter" aspect making it applicable to all seasons. In the north, soccer is played in the fall with kids participating in both club and high school concurrently. This change really affects the other CIF Sections because we already have the rule in place.

11. Wrestling Weigh In Violation Penalty – Discuss - Proposal for penalties involving wrestling tournament weigh in violations (as specified by NFHS).

B. SOUTHERN SECTION

1. Proposal from Girls Volleyball Committee regarding Rule 2904.1, 2904.2, 2906 and 2908 to be presented by Lyndsey Mikhail - This proposal would move the start date for volleyball to allow for timely pairing as well as allow for more time to complete the extremely condensed play-off schedule. Some thought since fall is already scheduled, it would be best to begin this practice in the fall of 2011 so that coaches don't have to

adjust their already completed schedule.

2. Proposal from Football Advisory Committee regarding Bylaw 1903.2, 1903.3, 1903.4 and 1903.7 – Physical Conditioning Practice to be presented by Tim Salter – Discuss - Given that most every football program is practicing and playing over the summer, the 3 days of conditioning (when coming into the fall season) seems wasted as the student athletes have already been participating in helmets and pads. Supporting this proposal would eliminate the directive for three days of initial conditioning.

3. 2010-2011 Nominees to Southern Section Executive Committee – Discuss - Each member in attendance was asked to stand and introduce him/herself from the floor. Sharon Caperton was nominated from the floor for the at large representative position.

4. 2010-2011 CIF Southern Section Budget – Discuss - Please note the detailed budget report for the upcoming school year.

5. Proposal from Victory League regarding the procedure for team placements in volleyball, baseball and softball to be presented by Steven Avalos – Discuss - This proposal was pulled from the agenda.

6. Proposal from Marmonte League regarding Rule 3214 to be presented by Matt La Belle – Discuss - This proposal would expand the automatic entries to playoffs inserting language to account for leagues that have more than 8 teams. Leagues with 9 or more teams would receive 5 automatic entries into the playoffs. It was moved, seconded and supported that this item becomes an emergency action item. It was then moved, seconded and supported to implement SS379.

7. Proposal from Officials Fees/Relations Committee – Discuss - The three year contract would include a \$0-\$1-\$1 increase over the course of the next three years. Adjustments have been made to tournament fees that haven't been addressed in a while (wrestling, volleyball and water polo). The sport of track and field is the only sport where the starters must provide their own ammunition and a \$10 increase was proposed to account for that expectation. Concern was voiced at the lower level soccer fees with the committee being encouraged to reconvene so that the amount can be reviewed and reconsidered.

5. NEW BUSINESS

A. Governance Task Force Report by Gary Smidderks

Ray Johnson- (Public Relations and Communications Sub-Committee) - This group is working hard to craft a relationship between all the sections and the public in order to help people understand what CIF does. Utilization of our natural resources (students, athletic directors and administrators) will help put the message out there to foster the understanding of the value of high school sports. Public relations are an integral part in gaining support for the organization and the cause.

Gary Smidderks- (Governance Sub-Committee) – This group looks at how we can better deal with rules, regulations and functions that need to be reconciled among the various sections. Some items are better dealt with as a federation vs. an association. Litigation was one example of something that may be better dealt with at a

Revisiting
"Recruit, Train
and Retain"

One especially successful effort in recent years has been the focus of our schools and the Southern Section to recruit officials. It was only a few short years ago that we wrote about shortages of officials that would cause unwanted schedule changes. All indications are that a record number of new officials have joined Section affiliated officials Units in all sports. One measure of the success of recruitment efforts is that in some sports there is now a waiting list to expand membership.

This influx of new officials has a number of explanations. Recruitment efforts are more professionally done, targeting the right audience. Tough economic times have caused many to seek other sources of income. And finally, a brighter light has been shining on officials with the introduction and expansion of instant replay and stadium microphones.

The need to maintain adequate staffing for officials is vital to the continued play of high school sports. To that end, suggested actions for schools, the Section and officials Units include:

- For schools: Continue the practices that make your school a site that welcomes officials and recognizes their efforts
- For the Section: Continue to support officials Units and schools, providing recognition and guidance for officials and schools
- For officials Units: Continue training and development efforts to better the state of officiating

Great strides have been made in all of the above. The need to recruit new officials has been met. That now leads to the next steps, resulting in a future wave of officials that are aware of the needs and requirements of their trade, as well as the priorities and demands of the Section and its member schools.
