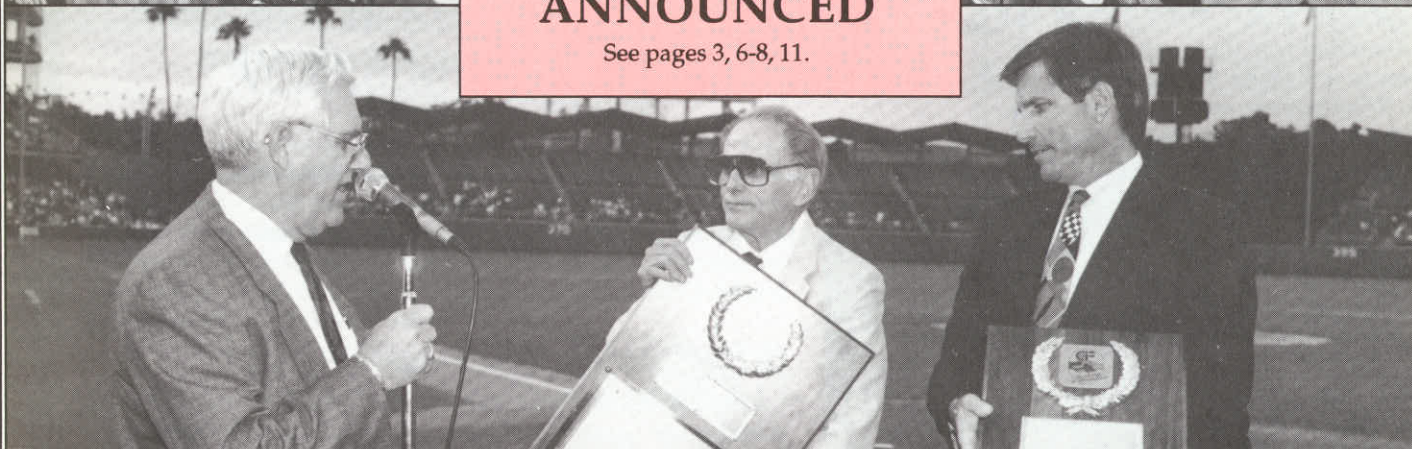

COMMISSIONER'S CORNER



It's The Competition That's Crucial

Throughout last year's presidential campaign, eventual winner Bill Clinton maintained his focus on what he and the democratic party maintained as the most important issue for the greatest percentage of the American population. The now-famous placards he kept posted in his campaign headquarters read: "It's the economy, stupid!"

In response to the current attempt at a forced break up of the CIF Southern Section membership, I am inclined to hang a sign in my office: "It's the competition, stupid!"

As this grand association winds down its 80th year of operation, its original mission seems to be increasingly set aside for peripheral concerns. Governance. Litigation. Strategic planning. Market base. Geography. Demographics. Lobby. Power. These are terms identified with the many complex issues permeating high school athletics in the 1990's. What bothers me is, they are often wielded about by people who don't know the difference between a pair of shoulder pads and a baseball bat.

I started in this business over 30 years ago as a football coach. In those days, the term governance in association with our program meant the election of team captains. A market base was where I picked up a half-gallon of milk on the way home. Strategic planning was watching the other guy's game film and the lobby was a place we met in the morning at coaching clinics. My assistants and I used the term "power" when we wanted our tackle and fullback to double team the defensive end.

In my seventh year as commissioner, I clearly understand these issues and their long-term implications. Having been a building principal and district administrator, I know what the stakes are, from a wide-angle perspective. As much or more than anyone, I respect and promote the important role interscholastic athletics and related activities play in the total educational picture. I am also aware of the political nature of the CIF Southern Section, which remains an association of volunteer members with the collective authority to govern their own activities.

Assuredly, the majority continues to rule

March 25, 1993

The March meeting of the CIF-SS Council was called to order by Dr. Gary Smidderks at 9:10 a.m. on Thursday, March 25, 1993 at the Sequoia Athletic Club. All leagues were present with the exception of Camino Real, Christian, Coast Valley, Condor, Garden Grove, Golden, Heritage, Hi-Lo, Metro and Sunrise.

1. **MINUTES** -- It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of January 21, 1993 and the minutes of the CIF-SS Executive Committee meeting of February 17, 1993.

2. **NOMINATING COMMITTEE REPORT** -- Mr. Scott MacTaggart, Chairman of the Nominating Committee, reviewed with the Council the following candidates for positions of the CIF-SS Executive Committee:

3. **MIRAMONTE LEAGUE TOURNAMENT PROPOSAL** -- Mr. Ray Plutko, Principal of Charter Oak HS and Miramonte League Representative, reviewed with the Council a proposal allowing for four contests in an 8-team tournament in the sports of baseball, basketball, field hockey, soccer, softball, volleyball and water polo. This will be an action item and will be voted on by the Council at its meeting in April.

4. **IVY LEAGUE FOOTBALL SCRIMMAGE PROPOSAL** -- Mr. Rick Stangle, representing the Ivy League, presented a proposal for the addition of one interscholastic scrimmage for football prior to the beginning of the regular season. It should be noted that currently, schools have the option of a scrimmage or a game beginning with the first regularly scheduled contest. However, this proposal would provide for a scrimmage in addition to ten games. This will be an action item and will be voted on by the Council at its meeting in April.

5. **OFFICIALS' FEES COMMITTEE PROPOSAL** -- Gary Norton, Principal of Irvine HS, and Chairman of the Officials' Fees Committee, reviewed a recommendation of the Officials' Fees Committee that no raise in officials' fees be forthcoming for the 1993-94 school year. This will be an action item and will be voted on by the Council at its meeting in April.

RULE REVIEW

Summertime Rules 1993

Once again, as in previous Summer Bulletins, I would like to review rules and regulations regarding summertime activities on the part of member schools and their coaches.

When summertime athletic activity is to be conducted by Southern Section schools, the school involved **MUST ESTABLISH** appropriate rules and procedures regulating the establishment, implementation, maintenance, monitoring and accountability of each athletic activity.

This continued interpretation will permit member schools to use equipment, uniforms, facilities, utilities etc. for summer activity

1992-93 CIF-SS/FORD/ANGELS/MURDY FOUNDATION ACADEMIC AWARD WINNERS ANNOUNCED

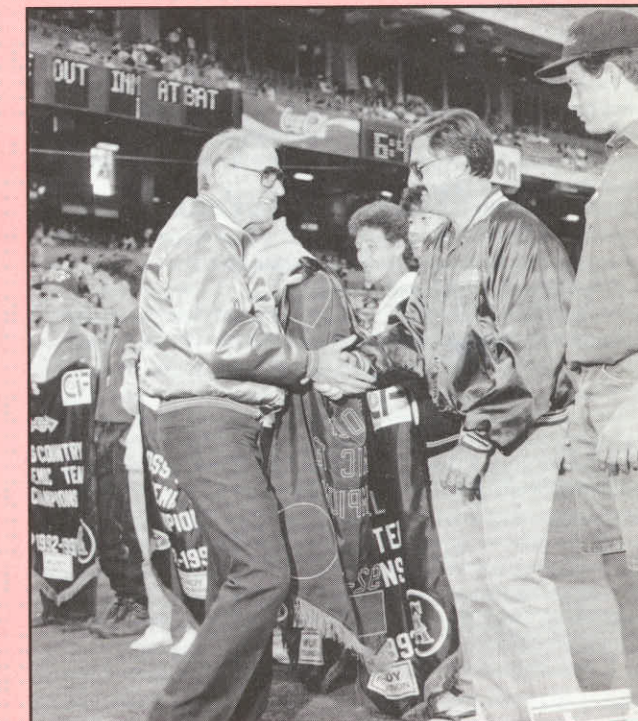
In a cooperative effort between the California Angels, Ford Motor Company and the Murdy Foundation, the CIF Southern Section recognized outstanding teams and individual student-athletes for academic achievement in the eighth annual CIF-SS California Angels/Ford Academic Awards Program. The winners were recognized in a ceremony held prior to the Angels-Cleveland Indians game at Anaheim Stadium April 21.

"On behalf of the member schools of the CIF Southern Section, our hat is off to the Angels, Ford and the Murdy Foundation for initiating and continuing this most outstanding awards program," said CIF-SS Commissioner of Athletics Stan Thomas. "Recognition for academic achievement provides positive reinforcement in the form of a worthwhile challenge for our student-athletes."

The team awards, based on cumulative team grade point averages, were awarded in 23 sports. To be considered, a CIF-SS member-school team must have accomplished a combined 3.0 average (on a 4.0 scale) in college-prep courses for the first semester of the 1992-93 school year.

An additional component of the program provides each CIF-SS member school with the opportunity to single out a boy and girl individual "Student-Athlete of the Year." Recipients must be seniors with a minimum G.P.A. of 3.5 in college-prep courses for the past three years, in addition to lettering in at least one varsity sport and participating in an additional extracurricular activity (Music, drama, service group, etc.)

Recognized college-prep courses include communications, English, literature, fine arts, foreign language, mathematics, natural sciences and social sciences. The 1992-93 team champions are shown on page 11, as well as the student-athletes of the year.

MINUTES OF THE EXECUTIVE COMMITTEE MEETING

April 20, 1993

The April meeting of the CIF-SS Executive Committee was called to order by Dr. Gary Smidderks at 1:10 p.m. on Tuesday, April 20, 1993 in the Conference Room at Anaheim Stadium. All members were present with the exception of Fr. William Brelsford, Jim Fleming, Tom Triggs, Bill McKinley and Andy Patterson.

1. PRESIDENT'S UPDATE -- Dr. Gary Smidderks reviewed with the Committee the August Executive Committee meeting, scheduled for August 6 and 7, and a recent newspaper article detailing the financial status of the ABC Unified School District. Additionally, he discussed with the committee the superintendents' survey with reference to the playoffs; AB 1375 which is currently being discussed in the State legislature; and announced the retirement of Dick Nelson, the current CIF President, who will be retiring from education in June; and the promotion to the District Office of Executive Committee member Ray Monti.

2. COMMISSIONER'S UPDATE -- Commissioner Stan Thomas discussed with the Committee, as a cost-saving measure, the concept of printing the Blue Book every two years, with pages containing rule updates being sent annually. He also announced that the CIF-SS Directory of Member Schools will be printed this year in October in order to make it a more accurate document reflecting hiring changes that occur in late summer and early September. Both items will be brought back to the Executive Committee after one year for evaluation. He also discussed the idea of regionalizing the Section for purposes of area placement, relegating and playoffs; the AAF Track and Field Coaching Clinics; the resolution of the Azusa Valley View High School football contract dispute; Orange County relegating concern; and the support of the officials with reference to no fee increase. It should be noted, however, that with no fee increase for the last two years, schools should take note of the importance of being good hosts to our officials which would include security of their property including vehicles, proper locker room facilities, etc.

3. GIRLS' ATHLETIC DIRECTOR REPRESENTATIVE UPDATE -- Girls' A.D. Representative Donna Gunstream reported on her recent attendance at the CAHPER Conference and the State AD Conference, with issues focusing on fewer high school students enrolling in physical education classes, the large number of academic teachers in current coaching positions with no physical education background, interest in athletic directors in the Los Angeles metropolitan area forming an association, and continued concerns relative to fewer women involved in coaching and administrative positions in athletics.

4. BOYS' ATHLETIC DIRECTOR REPRESENTATIVE UPDATE -- Boys' A.D. Representative Donn Clickard reviewed with the Committee an item to be published in the 1993-94 issue of the CIF-SS Blue Book with reference to sportsmanship and the role of coaches and athletes in this very important aspect of high school athletics.

5. SUPERINTENDENTS' REPRESENTATIVE UPDATE -- Ron Franklin, Superintendents' Representative, reviewed with members of the Committee his letter sent to Commissioner Thomas with reference to issues and concerns of Southern Section superintendents.

6. TREASURER'S REPORT -- In the absence of Treasurer Tom Triggs, Gary Smidderks reviewed with the Committee the winter playoff financial reports and updated the Committee on a revision in the State CIF budget proposal.

7. LEGAL UPDATE -- Executive Committee member Ray Monti, (who chaired the Committee) reported on the recent hearing involving sportsmanship issues during the football season by Montclair Prep High School. Requirements were placed on Montclair Prep for the 1993-94 season as follows:

...The athletic director of Montclair Prep will review, the Monday prior to each football game with the athletic director of the opposing school, all issues relative to game control and personnel conduct.

...A report from the opponent will be filed with the Southern Section Office as it relates to crowd and sideline control and overall game management which is to include potential taunting, ejections, jamming of quarterback signals and any unnecessary roughness that could take place. (A suggested check list was given to the school).

...Results of the above mentioned check list will be shared with the CIF Southern Section Executive Committee at its October, November and January meetings.

8. COST CONTAINMENT COMMITTEE REPORT -- Administrator

Karen Hellyer reviewed the ongoing work of the Cost Containment Subcommittee of the Executive Committee, composed of Ron Franklin, Donna Gunstream, Tom Triggs and Karen Hellyer. The Committee recommended possible cost saving measures that could be accomplished by schools, leagues and the Southern Section, with an additional point of discussion that any proposal coming to the floor of the Council be required to state the financial impact the proposal would have on the Section, league and schools. These recommendations will be reviewed further by the Executive Committee and Council.

9. GAME EXPENSE LIMITATIONS -- Associate Commissioner Dean Crowley requested the Executive Committee to give consideration to forming a committee to develop guidelines with reference to game expenses for CIF-SS playoffs in revenue sports which include football, b/g volleyball and b/g basketball. It should be noted that the Office has had an exorbitant number of calls from schools questioning expenses as noted on reports by their opponents during the playoffs. These included stadium costs, number and cost of ticket takers and sellers, security and other game personnel, such as scorers, timers, announcers, etc. It was the feeling of the Office that there

KAISER AND CIF PLAN MORE WORKSHOPS FOR ATHLETIC TRAINERS & TEAM DOCTORS

On two special dates in August, the CIF-SS will again be offering a program designed to advance the physician-acquired skills and procedures needed to become a sport team physician.

The program, entitled "Modern Practices and Procedures of the Sports Team Physician," is sponsored by the Kaiser Foundation Hospital in Fontana, California.

"It's an opportunity for schools to have their team physician, their athletic trainer, their athletic director, and student trainer attend a program that will enhance their skills in handling athletic teams," stated Karen Hellyer, CIF-SS Administrator. "It's an opportunity they really shouldn't miss."

Some of the topics of discussion will include what a doctor should bring to an athletic contest, what should be provided for him, the liability of the physician, emergency procedures related to athletic injuries and HIV, how to handle blood and other body fluids, and when an athlete can return to play.

Speakers include Jerome F. Wall, Orthopedic Surgeon; Jim Clover, Certified Athletic Trainer; Aaron Rubin, Family Physician; Bill Chamber, Athletic Trainer; and Thomas M. Mirich, Orthopedic Surgeon.

The program will be offered August 21 in Ventura and August 28 in Orange County from 7:30 until 12. Brochures were mailed to schools in early June. If you have any questions, please feel free to contact Karen Hellyer at the CIF-SS office.

CIF-SS COUNCIL MEETING MINUTES

April 29, 1993

The April meeting of the CIF-SS Council was called to order by Dr. Gary Smidderks at 9:05 a.m. on Thursday, April 29, at the Sequoia Athletic Club. All leagues were present with the exception of Golden, Heritage and Valley.

1. MINUTES -- It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of March 25 and the minutes of the CIF-SS Executive Committee meeting of April 20, 1993.

2. GOLD LIFE PASS/HALL OF FAME PRESENTATIONS -- Those receiving life passes in recognition of their long-standing service to the CIF-SS were introduced. Recipients were: Maynard Horst, Mark Keppel HS; George Scott, Pasadena Unified School District; Jim Douglas, Schurr HS; and Rich Ramirez, Coachella Valley HS. Additionally, the Hall of Fame honorees were: James Regenfuss, Leuzinger HS; Donald R. Green, Pomona Unified School District; and Dee Kohlmeier, Hoover HS.

3. SUNSET LEAGUE PLAYOFF ENTRY PROPOSAL -- Gary Ernst, Sunset League Representative, presented an addition to the bylaws dealing with the number of entries in the playoffs. If approved, 50 % of the teams in each league will be guaranteed representation in all team playoffs. Under the provisions of this proposal, four-team leagues would be guaranteed two entries; five and six team leagues would be guaranteed three entries; seven, eight and nine team leagues would be guaranteed four entries. This is an action item and will be voted on by the Council at its meeting in October, 1993.

4. SUNSET LEAGUE ASSOCIATION RULE PROPOSAL -- Gary Ernst, Sunset League Representative, presented a change in Bylaw 309.1 (association rule). Under the provisions of this proposal, coaches would be allowed one hour per school day for practice outside the season of sport during the school year. It should be noted that "school day", under the provisions of this proposal, would be defined as any day that classes are in session for that member school. This is a non-action item and will be voted on by the Council at its meeting in October.

5. EXECUTIVE COMMITTEE ELECTIONS -- Dr. Scott MacTaggart presented the report of the Nominating Committee as it relates to the CIF-SS Executive Committee. Following a vote by the Council, those elected were: Boys' A.D. Representative -- Donn Clickard, Atascadero HS; Desert Area Representative -- Richard Tucker, Principal, Bishop HS; Parochial Area Representative -- Rev. Robert Gallagher, Principal, St. Paul HS.

6. MIRAMONTE LEAGUE PROPOSAL -- Mr. Ray Plutko, Miramonte League Representative, reviewed with the Council a proposal allowing for four contests in an 8-team tournament in the sports of baseball, basketball, field hockey, soccer, softball, volleyball and water polo. Following discussion, it was moved, seconded and passed to approve the proposal.

7. IVY LEAGUE FOOTBALL SCRIMMAGE PROPOSAL -- Mr. Rick Stangle, representing the Ivy League, reviewed a proposal for the addition of an interscholastic scrimmage in the sport of football prior to the beginning of the regular season. Following discussion, a motion to support this proposal was defeated.

8. OFFICIALS' FEE PROPOSAL - 1993-94

SCHOOL YEAR -- Susana Arce, a member of the Officials' Fee Committee, reviewed a recommendation of the officials' fee committee that no raise in the officials' fees be forthcoming for the upcoming school year. Following discussion, it was moved, seconded and passed to approve the proposal.

9. SEASON OF SPORT COMMITTEE PROPOSALS -- Ron Barney, Chairman of the Season of Sport Committee, reviewed with the Council two proposals that are supported by the Committee: (a) NOVEMBER R & R ADJUSTMENT -- A recommendation to change the fall R & R (November) to run from Monday thru Friday was approved.

(b) SPRING R & R ADJUSTMENT -- A proposal deleting the spring R & R and allowing for a 15 day practice to be conducted beginning with the first Monday after the last event for the spring season, (Monday, May 16, 1994) was approved. It should be noted that all spring practice sessions must be completed with the last day of school in June.

10. BLUE BOOK COMMITTEE PROPOSALS -- Commissioner Stan Thomas reviewed the following items from the Blue Book Committee:

(a) COUNCIL MEETING -- A proposal to move the September, 1993 Council meeting to October in order to coincide with the State Federated Council meeting was approved.

(b) AREA PLACEMENT PROPOSAL -- An addition to the steps in the current Area Placement procedures was approved. This recommendation will now require that each relegating committee member, after the initial meeting, return to their respective areas and review all proposals with member school principals. A second meeting would then be held by the Relegating Committee to make recommendations to the Executive Committee, which will have the final approval.

(c) ACADEMY LEAGUE AGE ELIGIBILITY RULE -- This proposal would allow for 14-year-olds (if they weigh at least 160 pounds and have doctor's approval) to participate at the varsity level in 8-man football. Following discussion and a motion to support, the proposal died for lack of a second.

(d) SINGLE OFFICIAL FEE -- A proposal for a single official fee in the sport of basketball and soccer was defeated.

(e) MOUNTAIN VIEW LEAGUE SPORTSMANSHIP PROPOSAL -- A proposal providing for handshakes between teams at the conclusion of a football contest, followed by immediate clearing of the field was defeated. Additionally a position statement with reference to sportsmanship will be published in the 1993-94 edition of the CIF-SS Blue Book.

(f) MARMONTE LEAGUE SOFTBALL PROPOSAL -- A recommendation prohibiting softball players from practicing with an outside team during the season of sport was defeated.

11. CIF-SS BUDGET PROPOSAL -- Tom Triggs, Treasurer, presented the proposed 1993-94 budget. Following discussion, it was moved, seconded and passed to adopt the budget as presented.

12. MARMONTE LEAGUE GIRLS' BASKETBALL PROPOSAL -- Mr. Mike Botsford, representing the Marmonte League, reviewed a change in the girls' basketball playing rules which, if approved by the Southern Section Council, would be forwarded to the State CIF for the 1993-94 year.

The purpose of this proposal is to bring the girls' program more in line with National Federation rules and other levels of basketball. It would provide for the implementation of a mid-court line, as now utilized in all other organized basketball programs at the high school level. Following discussion, it was moved, seconded and passed to approve this proposal.

13. STATE FEDERATED COUNCIL PROPOSALS -- Dr. Tom Jacobson presented the following agenda items for the May State Federated Council meeting, which require action by the CIF-SS Council in order to give voting delegates direction:

(a) State Executive Committee Elections -- Vote to send delegates uninstructed

(b) State CIF Proposed Budget -- Vote to support

(c) Proposed Modification of Bylaw 203 (a) -- Vote to support

(d) Proposed Deletion of Bylaw 202 -- Vote not to support

(e) Proposed combination of Bylaw 201 (age) and Bylaw 513 (season of sport) -- Vote not to support

(f) Proposed modification of Bylaw 513 -- Vote not to support

(g) Proposed modification of Bylaw 501 -- Vote to support

(h) Proposed deletion of Bylaw 1600-1601 -- Vote to support

(i) Proposed addition of Bylaw 309 or 510 -- Vote to support

(j) Modification of Bylaw 1702 (a) -- Vote to support

14. AREA PLACEMENT APPEALS -- Area relegating chair George Giokaris, reviewed with the Council area placement and appeals for the upcoming 1994-98 relegating cycle. Mr. Ray Plutko, representing the principals of the Mt. San Antonio Relegating Area, appeared before the Council to appeal the decision of the relegating committee and the decision of the Executive Committee placing Duarte High School in the Mt. San Antonio area for the purposes of relegating. Also speaking in support of the Mt. San Antonio area appeal was Dr. Karl Major, Principal of Covina HS and Stuart Reeder, principal of La Puente HS. Gary Jensen, Duarte HS Athletic Director, Paul Castillo, representing the San Gabriel Valley League, and Don Duncan, Relegating Chairperson for the Foothill Relegating Area, spoke in support of the placement of Duarte HS in the Mt. San Antonio Relegating Area. A motion to uphold the appeal was defeated by a vote of 35-18.

15. PRESIDENT'S UPDATE -- Dr. Gary Smidderks reviewed with the Council the ongoing

GOLD LIFE PASS AWARD WINNERS HONORED

The California Interscholastic Federation, Southern Section honored four longtime contributors to the cause of high school athletics and CIF-SS activities with the prestigious Gold Life Pass Award at the April 29 Council Meeting in Buena Park.

The Gold Life Pass Award, emblematic of the highest service honor the organization can bestow upon an individual, celebrated its 41st year this spring. The award was initiated in 1952, with the first presentation going to Mr. Seth Van Patten, generally regarded as the "Father of the CIF Southern Section" and its first Commissioner of Athletics (1930-50). Including the four recipients awarded this year, a total of 137 Life Pass Awards have been presented.

Biographical sketches of the 1993 honorees, James Douglas, Maynard Otto Horst, Richard Moreno Ramirez, and George M. Scott follow.

JIM DOUGLAS

Jim Douglas, a man known for setting a positive atmosphere, served over 32 years in the Montebello Unified School District. He began his career as a business and history teacher at Montebello High for ten years and continued on as activities director for six years and assistant principal for four years.

In addition, Douglas coached swimming for one year, basketball for six, baseball for 12 and football for 13. He started the sophomore basketball team and took his baseball team to first place in the league for six years. He transferred to Schurr in 1980 as principal and remained there through 1992. In 1988, the school was named a California Distinguished School.

"Many of the better times (working in the district) came from seeing kids do well...seeing people grow and progress," said Douglas in a Schurr publication.

As principal, he was a supporter of all of Schurr's activities and tried to attend every sporting event, according to Bobbi Leggett, a co-worker of 17 years. "He is the finest most unselfish educator I have ever known," said Bobbi. "His dedication to kids was always the most important part of his job. He is truly someone you meet once in a lifetime if you are very, very lucky!"

MAYNARD HORST

Maynard Horst grew up in the city of Alhambra and graduated from Alhambra High School, where he began his athletic career. He continued his education at USC and was a standout baseball player on the 1948 national championship team. He began teaching and coaching at Mark Keppel High School in 1951. During his tenure there, Horst coached varsity baseball for 18 years and football for 15. His remaining 19 years were in administration. Under his leadership, his baseball teams reached the CIF-SS playoffs many times, reaching the semi-finals on two occasions. He retired in 1990, after 39 years at Keppel High.

Horst coached many outstanding athletes during his career, including Mike McCormick of the San Francisco Giants and Pete Mikkelsen of the New York Yankees and Los Angeles Dodgers. In addition, he worked as a CIF-SS official in both football and basketball for 25 years and, in 1962, he was president of the Basketball Officials Association.

In 1991, the Superintendent and Board of Education of the Alhambra School District officially named the baseball field of Mark Keppel High School "Maynard Horst Field."

RICH RAMIREZ

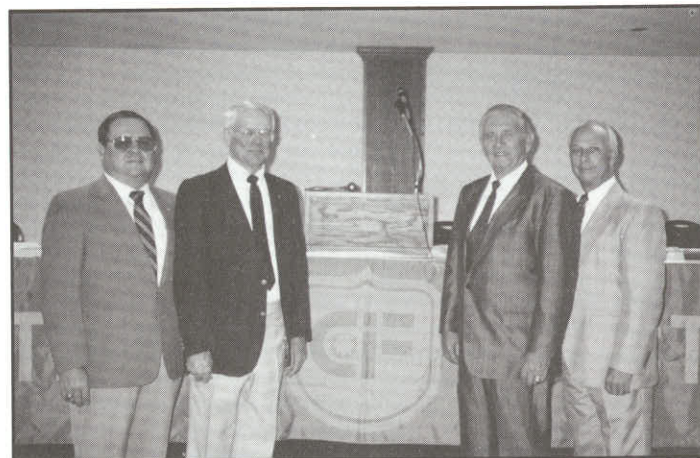
Rich Ramirez graduated from Coachella Valley High School in 1959. However, while in attendance there he played on two football and three championship baseball teams. He went on and graduated from Riverside City College where he played on two championship football teams and also played baseball two years. He then transferred to and graduated in 1964 from Long Beach State College, where he played on their first baseball championship team in 1964 and was Outstanding Rookie in 1963. In fact, he even stayed on an extra year to be assistant baseball coach to Bob Westhoff.

In 1965, Ramirez accepted a teaching position at his alma mater, Coachella Valley High, and spent 27 years in the following capacities: Dean of Students (three years), Dean of Boys and Director of Student Activities (four years), and Director of Student Activities and Athletics (17 years). In addition, he was assistant varsity football coach for six years with six league championships, head varsity football coach for two years, providing the first winning

season in ten years, head baseball coach for one year, and head softball coach for three years with one league championship.

He has also served athletics as the Desert Valleys League Representative and Coordinator to the CIF-SS for 15 years, a member of the CIF-SS Executive Committee as Boys' Athletic Representative for four years, a Citrus Belt Area Athletic Directors Association member, and a Cal State Athletic Directors Association member.

In 1992, Ramirez retired from Coachella Valley H.S. to go into private business as owner of Field of Dreams Sports Memorabilia and Collectibles in Palm Desert.

GEORGE SCOTT

George Scott was born and raised in Iowa where he graduated from high school and attended Parsons College. There he earned letters in football and baseball and a degree in education. He went on to receive a Master's from the University of Omaha and his first teaching job in Carson, Iowa in 1948, coaching boys and girls basketball and baseball. In 1951, he moved to Council Bluffs, Iowa and became athletic director. He coached a number of sports, including baseball, and won the state championship in 1952.

After moving west to Pasadena, California, he began teaching at McKinley Junior High in 1955, coaching football and basketball. He was appointed athletic director at Pasadena High in 1960. However, because the superintendent felt the need for a district level administrator, Scott took the responsibility for bringing cohesiveness between three high schools and six junior high schools, as well as acting as a liaison between the district and CIF. As District Coordinator of Athletics for the Pasadena City Schools, Scott had to coordinate both junior and senior high athletic programs, the driver education program, the earthquake preparedness and civil defense program, the school safety program, and the elementary school physical education program.

He served four years as a league rep to the CIF Council and five years on the Foothill Relegating Committee. In addition, he served several years as chairman on the CIF Eligibility Committee.

For the 24 years Scott was district athletic director, Pasadena's four high schools garnered 35 CIF championships and 19 state championships. He retired in 1990 after serving 35 years in the district and a total of 42 years in education and athletics.

CIF-SS HALL OF FAME INDUCTEES NAMED

The CIF Southern Section Hall of Fame Recognition Award will have three names added to its list of recipients this spring, with the induction of Donald R. Green, Dorance Harper Kohlmeier, and James W. Regenfuss.

The CIF-SS Hall of Fame Recognition Award was created in 1984 to bring public recognition to the numerous individuals who have contributed directly to the advancement of interscholastic athletics within the geographic boundaries of the organization.

"This special award provides a tribute to individuals who have displayed commitment, devotion and excellence in the interscholastic athletic community over an extended period of time," points out Stan Thomas, Commissioner of Athletics. "On behalf of our members schools, congratulations are in order for these most deserving recipients for their many years of outstanding service."

A biographical look at the 1993 inductees follows.

DON GREEN

Don Green enlisted in the Marines after Pearl Harbor. They let him finish his senior year at Monmouth College in Illinois, then sent him to the South Pacific Islands for two years. Upon his return, he attended USC where he received his Master's Degree.

His first teaching and coaching position was at Colton High School, coaching football, track and cross country. He was called back to the Marines in August and spent 17 months on duty. He was then appointed head track coach for the East Coast Marines.

He spent the next 18 and 1/2 years with the Pomona schools coaching football and track. He was athletic director and chairman of the physical education department and coached Bob Seagren at Pomona High, a man who later won the gold medal in the Mexican Olympics for pole vaulting.

Green went to California Lutheran College in 1970 and spent 21 years teaching golf, recreation, the psychology of coaching, and student teaching. He coached football for nine years and track and field for 21 years. In addition, he administered cross country with a graduate assistant. After giving up football, Green was athletic director and chairman of the physical education department until a permanent replacement was found.

Green not only coached many athletes, but also produced a great number of teachers and coaches while serving as a master teacher at Colton, Pomona and CLU.

He coached his two sons in high school and college, both of whom now teach high school and coach at the high school and college level. His two girls were also teachers and one is continuing in the field of education.

Green was honored at the 1992 Mt. Sac Relays after 44 years of successful coaching. He continues to support his former students by attending meets and helping out whenever possible.

DEE KOHLMEIER

After 37 years at Hoover High School, six as varsity basketball coach and the last 31 as athletic director, Dee Kohlmeier retired on June 20, 1990. A graduate and former basketball player of Milan High School in Indiana (located in the city where "Hoosiers" was filmed), he came to California with high credentials, including a letter of recommendation from then UCLA basketball coach John Wooden. Following graduation from high school, he attended Hanover College in Indiana as well as USC, where he earned a Master's in education. He also earned a Secondary Administration Credential and a California Life Teaching Credential.

In his coaching career, Kohlmeier took Hoover to the final four in the CIF semifinals in 1957 and had an overall record of 76 wins and 48 losses in six years. In addition, he coached golf 15 years and had a total of eight league champions with the Foothill and Pacific Leagues.

A member of the California State Teachers Association, Kohlmeier has also won such honors as a Pacific League Life Pass, Foothill

League Life Pass and Hoover High School Life Pass.

A man known for his values and Midwestern work ethics, Kohlmeier once turned down a job with UCLA so he and his wife, Barbara, also an educator, could stay close to home with their sons, Kirt and Kris, both of whom have followed them into teaching and coaching.

JIM REGENFUSS

Jim Regenfuss was the wrestling coach at Leuzinger High School for nearly thirty years. During the last half of his teaching career, he was a member of the physical education department. In that capacity he was instrumental in developing an outstanding instructional program in wrestling for ninth and tenth grade physical education students.

He began his pursuit of excellence in 1952 when he settled in Southern California. During Regenfuss's tenure as Leuzinger's wrestling coach, his teams were always formidable and several of his athletes won honors at the CIF-SS level. Many went on to wrestle in college and today there are a number of Regenfuss's boys in the coaching ranks.

He instructed and was the driving force in the first Wrestling Coaches and Officials Association in the South Bay, working in conjunction with Ken Fagens, former CIF-SS Commissioner. In addition, he assisted in developing the CIF-SS Blue Book wrestling interpretations. Within the South Bay, he organized the very highly successful El Camino College Wrestling Tournament. In conjunction with his own school district, he developed the Centinela Valley Invitational Wrestling Tournament. Regenfuss conducted many CIF sectional tournaments at many sites throughout the 1960s.

Upon his retirement in 1979, Regenfuss continued his activity in wrestling, organizing numerous high school, college and junior college tournaments as well as assisting in the organization of the CIF wrestling finals. Regenfuss is also a Life Time Honorary Member of the National Wrestling Coaches Association and continues to aid the national association with his expertise.

AAF/CIF CROSS COUNTRY CLINIC SCHEDULE ANNOUNCED

These are free clinics designed specifically for high school cross country coaches.

The Amateur Athletic Foundation has funded the cost of developing this program and offering it to cross country coaches at regional clinics across Southern California. The clinic curriculum and coaching manual was designed by an exceptional team of high school coaches who also serve as instructors.

Head Coaches are urged to bring their assistants and lower-level coaches. Much of the unique 2-day clinic format takes place outside the lecture room with sessions featuring instructors coaching athletes/demonstrators. The clinic dates are as follows:

"The schools receiving this award are to be commended for the direction provided by their administrative and coaching staffs, and especially for the positive actions of their student body memberships."

CALVARY CHAPEL BECOMES FOURTH CIF-SS SCHOOL TO WIN WRESTLING STATE CHAMPIONSHIP TOURNAMENT

Many CIF Southern Section member schools have experienced athletic successes during the 1992-93 school year, but perhaps the greatest accomplishment of the current term belongs to the wrestling team from Calvary Chapel of Santa Ana.

Not only did the Eagles --representing a school of less than 350 students-- capture the CIF/Reebok State Championship, its team members had a combined 3.48 grade point average (on a 4.0 scale) to win a CIF Academic Team Championship. The team grade point average was determined from college-prep courses during the first semester of the 1992-93 school year. The annual CIF-SS Academic Awards Program is co-sponsored by the California Angels, the Ford Motor Company and the Murdy Foundation (please see page 3).

On the wrestling mat, the achievement of coach John Azevedo's team, especially considering the school's size, was nothing short of spectacular. Calvary Chapel become only the fourth Southern Section school of all-time to win the 21-year old State Championship Tournament, which is conducted in a single-division format. Southern Section schools have traditionally had a tough time in the state meet, due to a rugged qualifying process, based upon individual performance. South Hills (1981), El Dorado (1982) and Victor Valley (1987) are the only others.

The Eagles scored 79 points to defeat runners-up Shingle Springs Ponderosa of the Sac-Joaquin Section (72) and perennial-power Clovis of the Central Section (65). Junior 119-pounder Dane Valdez led the team to victory by defeating Todd Wong of Sacramento Hiram Johnson, 12-7, for an individual state title. Valdez' twin-brother, Shane, took a second at 112, senior Joey Coughran finished third at 130 and sophomore Ed Mosley wound up sixth at 145 to account for the Eagles scoring. Mauricio Mora (135 pounds) and Josh Holiday (140) also qualified for the competition.

The team also won both the Southern Section Division III Team Dual-Meet and Individual Tournament Championships. Appearing in the team duals for a second-straight year, the top-seeded Eagles dispatched No. 2-seeded Irvine, 40-22 in the finals, to finish the season with a 17-1 win-loss mark. In the individual championship tournament, Calvary Chapel amassed a whopping 195.5-point total to overwhelm runner-up Ontario Chaffey at 109. Both of the Valdez brothers, Coughran, Mora, Holiday and Mosley each won individual Southern Section divisional crowns in their respective weight classifications.

work of the Cost Containment Committee which is recommending that any new proposals coming before the Council be required to state the financial impact the proposal would have on the Section, leagues and schools. He reviewed with the Council a decision made by the Executive Committee relating to a number of concerns of member schools regarding the delinquency in submitting financial reports. As of this date, after reasonable request from the Commissioner's Office, schools that continue to be delinquent with financial reports will not be permitted to play home contests in that sport in the playoffs during the upcoming season. It should be noted that this policy will now apply to all revenue producing sports.

16. COMMISSIONER'S UPDATE -- Commissioner Stan Thomas announced changes in the format of the Blue Book and Directory for purposes of cost containment for the upcoming year, and he encouraged schools and leagues to discuss areas of hosting and providing adequate security for game officials. He announced that Senate Bill 1375 is now in the State Legislature. This is the bill that gives the CIF the right to govern high school athletics in this State. He encouraged all CIF constituents to give full support of this bill.

17. TREASURER'S REPORT -- Treasurer Tom Triggs reviewed with the Council the 1992-93 working budget and an update on the final winter playoff activities.

18. STRATEGIC PLANNING -- Dr. Ken Gunn gave a brief overview of the progress of strategic planning at the State level, which in recent months has included a number of surveys that have been completed, with results forthcoming.

19. MARKETING MANAGEMENT COMMITTEE UPDATE -- Dr. Gary Smidderks gave an overview of the progress of the Marketing Management program now underway with M & FM Marketing Consultants.

There being no further business to come before the Council, the meeting was adjourned at 11:55 a.m.

with the **APPROVAL OF THE PRINCIPAL**.

Please note CIF-SS Blue Book rules 1423 (football), 1511 (track and field/cross country), 1610 (swimming and diving), 1711 (wrestling), 1812 (basketball), 1912 (softball), 2010 (water polo), 2109 (gymnastics), 2211 (volleyball), 2308 (badminton), 2411 (baseball), 2510 (field hockey), 2608 (golf), 2710 (soccer), and 2809 (tennis).

For football, the use of air dummies, stand-up dummies, two and seven-man sleds, tackling dummies and protective equipment are **ALLOWED** for summer activity (new for 1993). It should be noted that helmets and other player protective gear is prohibited.

For summer services by coaches, payment may be made by the school district office, A.S.B. through the principal, or duly-licensed community organizations such as Parks and Recreation. It must be understood that coaches may not be paid directly by special interest groups, individuals, parents or booster clubs.

A summer dead period will be in effect from Monday, August 2, 1993 until the beginning of the first official starting date for fall sports which begins on August 23, 1993. No class could be offered in a summer school program which could circumvent the rule.

During the dead period, weight lifting **ONLY** would be permitted. No running or other type of conditioning would be allowed.

Special nationally recognized programs in various sports that require a national or regional championship format, such as Bobby

An exception to this rule will allow **WATER POLO AND CROSS COUNTRY ONLY** the choice of a three-week period from June 28, 1993 to July 18, 1993 as a dead period with principal approval in lieu of the August dead period.

It should be further noted that Senate Bills 19 and 1533 direct the CIF to conduct the business of interscholastic athletics. It is not noted in this legislation that athletics are discontinued during the summer months. Therefore, we have a dilemma. It is the belief of our section officers that in order to comply with our legislative mandate, state by-laws and section rules and regulations, administrators (specifically superintendents and principals) are accountable for summer programs in their respective districts or schools.

It should be noted that schools may not start summer competitive activities until such time as school is out for the summer. The only exception to this rule would be the Watts Summer Games sponsored by the Los Angeles Junior Chamber of Commerce.

6. **SEASON OF SPORT COMMITTEE PROPOSAL** -- Mr. Ron Barney, Principal of Nordhoff HS and Chairman of the Season of Sport Committee, reviewed with the Council a proposal recommending that the winter (Nov.) R & R be brought in line with the spring (Feb.) R & R, to run Monday through Friday. Additionally, as part of the proposal, the spring R & R (May) be deleted and that spring practice be conducted by member schools beginning with the first Monday after the last event for the spring season, which would be May 16, 1993, and that schools be allowed a fifteen (15) day spring practice, before and after school, which must be concluded with the last day of school in June. This will be an action item and will be voted on by the Council at its meeting in April.

7. **BLUE BOOK COMMITTEE RPEORT** -- Mr. Allen Martens, Principal of Alta Loma HS and member of the Blue Book Committee, reviewed the following recommendations:

(a) Council Meetings -- the Committee is recommending that the first Council meeting be held in October in order to coincide with the State Federated Council meetings.

(b) Area Placement Proposal -- This proposal would add an additional step to the current area placement procedures. This recommendation will require that each relegating committee member, after the initial meeting, return to their respective areas and review all proposals with member school principals. A second meeting would be held to make recommendations to the Executive Committee.

(c) Academy League Age Eligibility Rule Proposal -- This rule, not endorsed by the Blue Book Committee, is recommending that 14-year-olds, if they weigh at least 160 lbs and have a doctor's approval, be allowed to participate at the varsity level in the 8-man division in the sport of football.

(d) Single Official Fee - Basketball and Soccer - Proposal -- This proposal, not endorsed by the Blue Book Committee, would provide for one official in the sport of basketball and soccer. It should be noted that currently, a minimum of two officials are required by National Federation Rules and Regulations in the sport of soccer.

(e) Mountain View League Sportsmanship Proposal -- This proposal is not endorsed by the Blue Book Committee, because the committee feels it is more of a local issue rather than a Section governance issue. The proposal allows for the option of exchanging handshakes on the football field at the close of a contest.

(f) Marmonte League Softball Proposal -- This recommendation is not endorsed by the Blue Book Committee. It provides for a modification of Rule 1914 prohibiting softball players from practicing with an outside team during the season of sport. Current rules allow for an athlete to practice with an outside team and prohibits competition with an outside team. It is the feeling of the Blue Book Committee that this should be a local option of the coach and not a rule of the organization.

All of the above items will be action items and voted on at the April meeting of the Council.

8. **CIF-SS BUDGET PROPOSAL** -- Treasurer Tom Triggs reviewed with the Council the proposed 1993-94 budget which will be an action item at the April meeting of the CIF-SS Council.

9. **MARMONTE LEAGUE GIRLS' BASKETBALL PROPOSAL** -- Mike Botsford, representing the Marmonte League, reviewed with the Council a proposal that if approved by the Southern Section Council, would be forwarded to the State for action by the State Federated Council. This proposal recommends that in the sport of girls' basketball, the State come into line with National Federation playing rules by providing a mid-court line as currently used in other levels of girls' basketball (i.e. 2-year and 4-year college play). If approved, this would still keep in place the 30 second shot clock. This is an action item and will be voted on at the April meeting of the CIF-SS Council. If approved, it will be forwarded to the State Federated Council, which will not take action until the 1993-94 school year.

10. **STATE CIF PROPOSALS** -- Dr. Tom Jacobson, State CIF Representative, presented the following items which will be voted on at the Southern Section Council meeting in April in order to send our delegates instructed to the May meeting of the State Federated Council:

- (a) Executive Committee elections
- (b) Proposed State CIF 1993-94 budget
- (c) Review of Bylaw 203 (a) -- definition of semester of attendance
- (d) Deletion of Bylaw 202-8 semesters
- (e) Combine Bylaw 201 (age), and Bylaw 513 (Season of Sport)
- (f) Modification of Bylaw 513 (Season of Sport)

- (g) Modification of Bylaw 501 (Play Day)
- (h) Deletion of Bylaws 1600, 1601 (Swimming)
- (i) Addition of Bylaw 309 or 510 (Donation of athletic equipment)
- (j) Wrestling recommendation

11. **SOUTH COAST LEAGUE WATER POLO PROPOSAL** -- Don Stoll, Water Polo Coach of El Toro HS and a member of the Coaches' Advisory Committee, reviewed a proposal seeking greater flexibility in the summer dead period for the sport of water polo. Following discussion, it was moved, seconded and passed to table the proposal until a later date.

12. **SAN GABRIEL VALLEY LEAGUE SUMMER DEAD PERIOD GIRLS' VOLLEYBALL PROPOSAL** -- Dr. Phil Jones, San Gabriel Valley League representative, reviewed a proposal recommending that the summer dead period for girls' volleyball coincide with the same regulations that are currently in place for water polo and cross country. Following discussion, a motion to approve the proposal was defeated by the Council.

13. **SAN GABRIEL VALLEY LEAGUE SUMMER FOOTBALL RULE PROPOSAL** -- Phil Jones, San Gabriel Valley League representative, reviewed a proposal recommending that the current summer football rules be modified so that they will be consistent with spring football rules, allowing use of specific equipment that is now prohibited during the summer. Following discussion, it was moved, seconded and passed to approve the proposal by a vote of 29-28.

14. **LOS PADRES SUMMER DEAD PERIOD FOOTBALL PROPOSAL** -- Donn Clickard, representing the Los Padres League, reviewed a proposal recommending that the summer dead period for football coincide with the same regulations that are currently in place for water polo and cross country. Following discussion, a motion to approve the proposal was defeated by the Council.

15. **ACADEMY LEAGUE NAME CHANGE** -- Michael Grasz, representing the Academy League, reviewed a proposal recommending that the Private Area for relegating purposes, be renamed the Small Schools Area. Following discussion, it was moved, seconded and passed to approve the proposal.

16. **ALMONT LEAGUE WINTER SEASON OF SPORT CALENDAR PROPOSAL** -- Tony Ortega, Almont League Representative, reviewed a proposal recommending that beginning with the 1993-94 school year, the allowable date for first contest in all winter sports (with the exception of wrestling) be the first Monday after Thanksgiving. Following discussion, it was moved, seconded and passed to approve this recommendation.

17. **PRESIDENT'S UPDATE** -- Dr. Gary Smidderks, President, commended the CIF-SS staff for the excellent manner in which the 1993 winter playoffs were conducted. Additionally, he commended the Commissioner for his work in establishing good lines of communication with the County Superintendents, and reported on strategic planning at the State level, the ACSA letter relative to financial concerns, and announced that Karen Hellyer, Ron Franklin, Donna Gunstreram and Tom Triggs are part of a committee that will meet to discuss finances and how they affect high school athletic programs. State championship winners in the sports of basketball and wrestling were commended.

18. **COMMISSIONER'S UPDATE** -- Commissioner Stan Thomas addressed sportsmanship concerns in the sport of soccer, updated the Council on the County Superintendents' meetings, and stressed that communication between principals and superintendents is very important to the success of our organization, especially during this period of financial crisis. He touched upon the regional playoff concept and noted that superintendents have been surveyed on this matter.

19. **TREASURER'S REPORT** -- Tom Triggs, treasurer, gave a brief overview of the current CIF-SS working budget.

20. **ORANGE COUNTY SECTION UPDATE** -- Tom Triggs updated the Council on the Orange County Section proposal, with plans to re-submit to the State Federated Council for the 1993-94 school year, with a section to begin functioning during the 1994-95 school year. However, strategic planning could push this date back somewhat.

21. **STATE CIF REPORT** -- Tom Triggs reviewed the following items, which were approved by the State Federated Council at their February meeting: Discus cage; 33" hurdles; Bylaw 524 (Androgenic/Anabolic Steroids) which is a recommendation only; M & FM Marketing Agency for the State; The adoption of the National Federation communicable disease precautions; The allocation of \$24,813 for two additional strategic planning surveys.

22. **STRATEGIC PLANNING** -- Dr. Ken Gunn reviewed progress being made at the State level with reference to strategic planning. As stated earlier, it should be noted this will be an ongoing process during the 1993-94 school year.

23. **STATEWIDE MARKETING PROJECT** -- Dr. Gary Smidderks reviewed the recent meetings of the statewide marketing committee and the selection of Marketing and Financial Management Enterprises (M & FM) to represent the State CIF in negotiations for statewide corporate sponsorships.

There being no further business to come before the Council, the meeting was adjourned at 11:25 a.m.

regarding issues brought to the legislative body. What is perceived to be the greatest good for the greatest number always has and always will receive my unconditional support. That's my charge.

According to documented survey of the Southern Section membership, a mandate of the Council and a sustained appeal to the State Federated Council, the secession of Orange County schools is clearly not supported by the majority it will affect. I could reiterate a long list of reasons why this potential break is not in the best interest of the Southern Section nor the Orange County schools, citing finances, services, travel and facility use. But the key issue, the real heart of the matter, is a bottom-line reflection of what we're supposed to be all about in the first place. *It's the competition, stupid!*

The reason interscholastic athletics developed wasn't to satisfy school administrators, athletic directors or even coaches. Athletics didn't become the No. 1 secondary-school activity to provide a town, a community or any single individual with an opportunity to boast. The purpose was to benefit the kids, pure and simple. Had the students themselves not exhibited a burning desire to compete with one another in tests of strength, skills and courage, it never would have happened.

The initiation of the CIF Southern Section in 1913 brought regulation, organization, ethical conduct and fairness to the games the students so wanted to play. In forging the federation, a tremendous membership enhanced the competition beyond the wildest dreams of our founders. These were the schools from the many diverse communities

of Central and Southern California, from San Luis Obispo to El Centro and the many points between: Santa Barbara, Ventura, Santa Monica, Pasadena, Long Beach, Huntington Beach, Anaheim, Santa Ana, Riverside and San Bernardino. From the desert to the sea, the organization flourished; the competition was tremendous.

If the section splits, we could be saying goodbye forever to many traditional competitive matchups. These might include football playoffs between Eisenhower and Mater Dei; baseball contests between Simi Valley and El Dorado; girls basketball games between Brea Olinda and Buena. We might also kiss-off swim meets, tennis matches, track and field events and wrestling tournaments featuring student-athletes representing the nine counties in the highest-populated portion of the state.

If one region of the Southern Section leaves, how long will it be before others follow? Will the schools of the Inland Empire be satisfied with travel across Orange County for playoff contests in Los Angeles or Ventura County or vice versa? Is further fragmentation of the state's schools in the best interest of our interscholastic athletic program? Why not take the time to ask the coaches -- or better yet -- the students.

The virtues of geographic expanse, diversity of membership and participants hailing from vastly different origins have long been the hallmark of Southern Section competition. The opportunity to compete with a school from afar -- an accomplished team you may have never seen -- is the very essence of our post-season playoff tournaments. These characteristics can be claimed by no other section

They will meet this summer, with a report to the Executive Committee in August.

10. STRATEGIC PLANNING UPDATE -- Dr. Ken Gunn gave a brief overview of the progress of Strategic Planning at the State level, which in recent months included a number of surveys to be completed and returned to the State CIF Office.

11. MARKETING MANAGEMENT COMMITTEE UPDATE -- Dr. Gary Smidderks gave an overview of the progress of the marketing management program that is now underway with M & FM Marketing consultants.

12. ORANGE COUNTY SECTION UPDATE -- Tom Jacobson reviewed with the Committee the ongoing work in Orange County with reference to the development of a new Section, with the next meeting set in Orange County for May 18 to review draft of the constitution and bylaws.

13. DIVISION I FOOTBALL GAME UPDATE -- Administrator Bill Clark announced that Chris Thomas, Director of Marketing, is continuing discussions with KCOP to televise Division I football championship game live in lieu of the LA City/Southern Section Reebok Bowl which has been discontinued.

14. SOUTHERN SECTION NATIONAL FEDERATION SUMMER MEETING REPRESENTATION -- As a cost saving measure, it was reaffirmed by the Executive Committee that there will be a reduction in the number of members attending the National Federation summer meeting. As voted on at an earlier meeting, the president, one executive committee member, the commissioner and one office administrator will be the only authorized representatives to the National Federation, in addition to the president-elect who will attend the summer prior to his/her term of office.

15. LYNWOOD HIGH SCHOOL GIRLS BASKETBALL REQUEST -- Following discussion, it was moved, seconded and passed to approve a request via the State CIF, to allow Lynwood High School to participate in an international basketball tournament in Greece. It should be noted that Lynwood HS, due to their outstanding basketball season, culminating in the State Division I Championship, has been invited by the National Federation and USA Basketball (National Amateur Governing Body for Basketball in the USA) to represent the United States in the International School Sports Federation 1993 Basketball Tournament, to be held in Athens, Greece. Lynwood will be the only girls' team from the U.S. participating in this event

and will represent the Section, the State, their community and the U.S. in this tournament. It should be noted that this is the first time that the United States has participated in this event since 1985.

16. AREA PLACEMENT APPEALS -- Ray Plutko, Principal of Charter Oak HS and representing the principals of the Mt. San Antonio Releaguement Area, appeared before the Committee to appeal the decision of the Releaguement Committee's placement of Duarte HS in the Mt. San Antonio Area for the purposes of releaguement. Gary Jensen, Duarte HS Athletic Director and Paul Castillo, speaking for the San Gabriel Valley League and the Foothill Area, spoke in support of the placement of Duarte HS in the Mt. San Antonio Releaguement Area. Following discussion, it was moved, seconded and passed (by a vote of 10-2) to sustain the action of the Releaguement Committee's placement of Duarte HS in the Mt. San Antonio Area.

17. DELINQUENT FINANCIAL REPORTS -- The administrative staff reviewed with the Committee concerns relative to the escalating number of financial reports that are long overdue in revenue producing sports. This presents a great imposition not only on the Section but on member schools involved in revenue splits from these contests. Following discussion, it was moved, seconded and passed that after a reasonable request from the Commissioner's Office, schools that continue to be delinquent with financial reports will not be allowed to play home games during the playoffs for the upcoming season of sport. It should be noted that this would apply to all revenue-producing sports. As part of this proposal, there are currently seven schools still delinquent in the sport of basketball for the current season, and if financial reports are not filed by these schools by the date of the next Council meeting (April 29), they will not be allowed to host a home game next season.

18. NEW MEMBERSHIP -- It was moved, seconded and passed to approve membership for Yucaipa Junior High School as an associate member, beginning with the 1993-94 school year. Additionally, it was moved, seconded and passed to table the membership request for Vasquez High School (Action) until more information is available.

There being no further business to come before the Committee, the meeting was adjourned at 4:25 p.m.
