



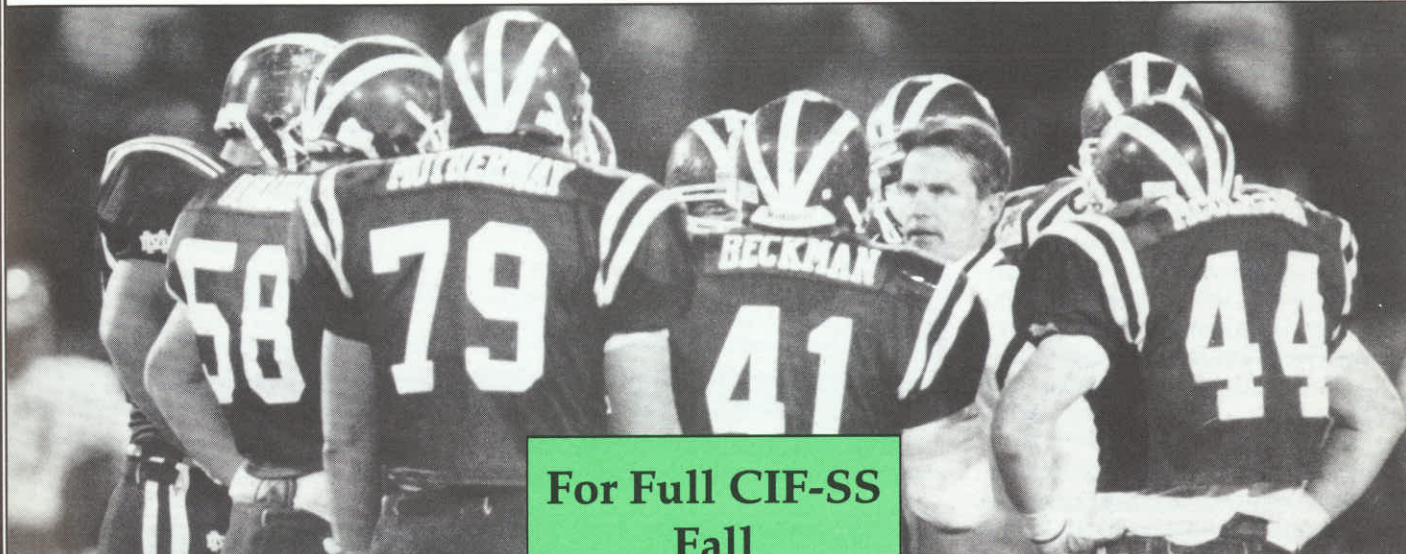

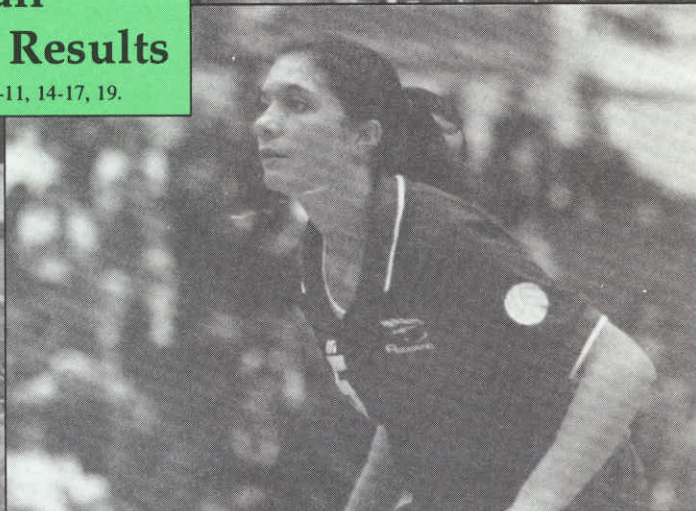

## PRESIDENT'S MESSAGE



**Weighted Voting  
Yes or No?**

Two of the most debated and discussed issues in recent months have been play-off regionalization and weighted voting. An Ad Hoc committee under the very capable leadership of Temple City Principal and former CIF Southern Section Commissioner, Ray Plutko, is actively involved in examining our play-off structure. At the last meeting of our Executive Committee, there was a lengthy discussion of weighted voting. Our past president, Gary Smidderks, agreed to chair a group to look at the pros and cons of this issue.

Weighted voting is an accepted but often resented practice at the State level. The Southern Section is by far the largest of the 10 state sections. As such, the state constitution guarantees us twice as many votes as the next largest section. Currently, this means that we have 26 votes while the smallest section has one vote. By no means does this give us the equivalent of one vote per one student, but it has been an accepted compromise.

When the districts in Orange County first began to look at the formation of a new section, weighted voting was one of the primary issues. Many of the proponents cited this a major weakness with the Southern Section.

Essentially, the issues are well delineated. Should the smallest league in the Southern Section, the Hi-Lo league, which currently has 125 students in total, have the same number of votes as the largest, the Moore league, which has an enrollment of 14,331? Because of the large number of small and private school leagues, 37, that have an enrollment of under 1,000 students, do they have the "power" to determine the fate of the larger areas and leagues? Proponents of weighted voting obviously say "Yes". There are also hints of hypocrisy as we benefit from being large at the State level but don't offer the same benefit within our section.

The other side of the argument centers around the history of our council. Over

## CIF-SS COUNCIL MEETING MINUTES October 20, 1994

The October meeting of the CIF Southern Section Council was called to order by President Dr. Ken Gunn at 9:06 a.m., Thursday, October 20, 1994, at the Sequoia Athletic Club in Buena Park. All leagues were present with the exception of the Foothill, Metro and Victory.

1. **MINUTES** -- It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of April 28, 1994 as mailed; minutes of the June 24, 1994, CIF-SS Executive Committee as mailed; minutes of the August 13, 1994 CIF-SS Executive Committee as mailed and minutes of the October 5, 1994 CIF-SS Executive Committee meeting as distributed to the Council.

2. **MOORE LEAGUE TRAVEL PROPOSAL** -- Dr. Larry Burnight, league representative, reviewed a proposal calling for an amendment to the CIF-SS By-Law 702.1. This proposal would change the out of state travel (excluding border states) to every other year, instead of every three years. This will be an action item at the January meeting of the Council.

3. **OCEAN LEAGUE SOCCER PLAYOFF TIE-BREAKER PROPOSAL** -- Roger Bryant reviewed a proposal to eliminate the tie-breaker for the final championship games. Teams tied at the end of regulation play would be declared co-champions. This will be an action item at the January meeting of the Council.

4. **CITRUS BELT BASKETBALL PROPOSAL** -- Bob Hahn, league representative, presented a

proposal to delete Blue Book Rule 1620 which no longer has application. Following discussion, a motion to approve the proposal was passed.

5. **EMPIRE LEAGUE R & R WEEK PROPOSAL** -- George Allen, Playoff Groupings Committee Chairperson, reviewed background criteria for the 1994-96 football playoff groups. Following discussion, a motion to approve the proposal was passed.

In Division IX an appeal by Jeff Chancer, principal of Oak Park and Jim Bashore, athletic director of Carpinteria HS, with reference to placement of the Tri-Valley League in Division IX was heard by the Council. Speaking in opposition to the appeal and in support of the Division IX Football Playoff Groupings was Max Friedman, principal of Twentynine Palms High School and Bruce Moffitt, principal of Serrano High School. Following discussion a motion to deny the appeal was approved.

In Division VI an appeal by Nick Salerno, principal of El Monte High School, with reference to placement of the Mission Valley League in Division VI was heard by the Council. Speaking in opposition to the appeal was Stu Reeder, principal of Wilson (HH) High School and Ray Dunne, principal of Servite High School. Following discussion a motion to deny the appeal was approved.

Jerry Walsh, principal of Righetti High School, reviewed with the Council the concerns of the Northern League regarding the process of com-

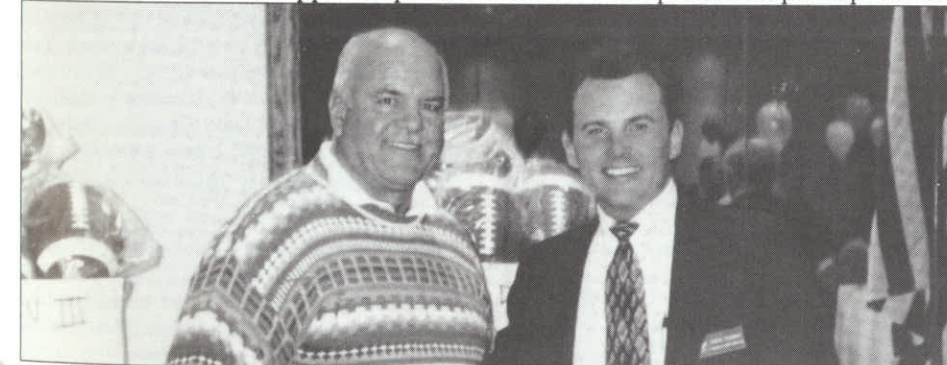

Here's a bit of good news for all of us involved in high school athletics.

Over the last few years, we have seen a resurgence in the interest and support of high school sports.

That has been true so far this year in particular. At last year's fall sports playoffs, record crowds were reported. Of course, the Southern Section CIF/Toyota Division I Football Championships at Anaheim Stadium was the most obvious indication of that as more than 26,000 attended the game on December 10, that was televised live on KCOP TV. A week earlier, a record crowd of more than 30,000 attended the Division I semifinal game between Los Alamitos and Mater Dei at Anaheim Stadium.

But in reality, all of the fall sports -- girls' volleyball, water polo, girls' tennis and cross country -- showed increased attendance over previous years. And that just wasn't for final games, but early-round playoff contests and preliminaries, as well.

We have noticed this trend of increased crowds and support of high school sports over the last few years. This can be attributed to many factors such as good matchups. It was no coincidence that the Mater Dei, Bishop Amat and Los Alamitos football teams were all ranked in the top 10 nationally this season. Also, the Newport Harbor girls' volleyball team was ranked No. 1 in the country last fall, Calvary Chapel/Santa Ana No. 1 in the state in wrestling and the Brea-Olinda girls and Mater Dei boys basketball teams have been nationally ranked during the last several years. That speaks highly of Southern Section athletics.

We know how outstanding our athletes and teams really are because attendance over recent years demonstrate that high school fans and community members appreciate the talented athletes they are seeing.

The professional sports strikes in baseball and hockey were not so much a factor in this upswing as you might think, given that the increase has been documented over the last few years, not just last fall.

The media has also shown increased in-

## MINUTES OF THE EXECUTIVE COMMITTEE MEETING August 13, 1994

The August meeting of the CIF-SS Executive Committee was called to order by President Dr. Ken Gunn at 1:15 on Saturday, August 13, 1994, at the Balboa Bay Club. All members were present with the exception of Margie Godfrey, Dr. James Fleming and Fr. Robert Gallagher.

**1. MINUTES** -- It was moved, seconded and passed to approve the minutes of the CIF-SS Executive Committee of June 24, 1994.

**2. PRESIDENT'S UPDATE** -- Dr. Ken Gunn commended the CIF-SS Office staff for last year's fiscal responsibility. Dr. Gunn also reviewed the minutes of the Administrative Committee and explained its roll and relationship to the Executive Committee. In addition, Dr. Gunn discussed the roll of the Executive Committee and the importance of attending Council meetings.

**3. COMMISSIONER'S UPDATE** -- Dean Crowley, Commissioner, reviewed with the committee the Blue Book update, the new CIF-SS Story format, the new CIF-SS Future Fund program, the hearing panel schedule and the new iron-on patch for Executive Committee and staff. In addition, he reviewed the job description for the Event Coordinator. Following discussion, it was moved, seconded and passed to approve the position of Event Coordinator. Also, Mr. Crowley reviewed the concerns of the USA Water Polo Association in regards to the Summer Dead Period, the Brea Olinda High School grade changing situation as it pertained to athletics and a concern regarding students restricted by the Transfer Eligibility Rule entering schools with no JV teams available for competition. Finally, Mr.

Crowley announced that he was forming a committee to look at regionalization for playoffs.

**4. ORANGE COUNTY SECTION/SOUTHERN SECTION DIRECTION** -- Dr. Ken Gunn reviewed with the committee the entire two-year process regarding the proposed Orange County Section and Strategic Planning. Following discussion, it was moved, seconded and passed to have the Administrative Committee in collaboration with the Orange County Steering Committee develop a commonly agreed upon White paper summarizing all facts regarding the formation of an Orange County Section to be sent to all leadership in the Southern Section. If this cannot be accomplished, the Council would be asked to postpone or have the issue tabled at the State Federated Council meeting in October.

**5. AUDITOR'S REPORT** -- Tom Triggs, President-Elect, introduced CIF-SS Auditor Gary Turner and Shirley Frazier, Director of Budget and Finance. Mr. Turner reviewed the process of budgeting for the current and future budgets. In addition, the audit of the 1993-94 years was passed out and reviewed by the Executive Committee.

**6. PROHIBITED USE OF PUBLIC FUND COMPLIANCE** -- Dr. Ken Gunn, President, reviewed with the committee Section 1, Article 13 (commencing with Section 32435) added to Chapter 3 of Part 19 of the Education Code, relating the use of public funds by local educational entities. Dr. Gary Smidderks reviewed the interpretations of Andy Patterson, CIF Attorney and Spencer Covert, Southern Section Attorney as it pertains to the Education Code statute. Following discus-

sion, it was moved, seconded and passed, requiring the CIF-SS to conform to the recent legislation.

**7. STATE FEDERATED COUNCIL ATTENDANCE -- EXECUTIVE COMMITTEE** -- Dr. Ken Gunn, President, reviewed the new process regarding CIF-SS Executive Committee members attending the State Federated Council meetings. In addition, it was moved, seconded and passed to approve Karen Hellyer, Assistant Commissioner to attend the Section 7 & 8 meeting in October.

**8. MONTCLAIR PREP REVIEW** -- Dean Crowley, Commissioner, reviewed with the committee the history of Montclair Prep violations of CIF-SS rules and their current compliance process as the results of soccer playoff violations.

**9. NEW SCHOOL MEMBERSHIP** -- It was moved, seconded and passed to approve the membership of Faith Christian and CEDU high schools on condition they attend an orientation meeting in the CIF-SS Office.

There being no further business to come before the Executive Committee, the meeting was adjourned at 4:25 p.m.

## MINUTES OF THE EXECUTIVE COMMITTEE MEETING October 5, 1994

The October meeting of the CIF-SS Executive Committee was called to order by President Dr. Ken Gunn at 1:03 p.m., October 5, 1994, at the CIF Southern Section Office. All members were present with the exception of Dr. James Fleming.

**1. MINUTES** -- It was moved, seconded and passed to approve the minutes of the August 13, 1994, Executive Committee Meeting.

**2. STATE CIF COMMISSIONER'S REPORT** -- Dr. Ken Gunn, President of the Southern Section introduced Tom Byrnes, State CIF Commissioner. Mr. Byrnes commended Dean Crowley, Southern Section Commissioner, on his work at the State level. In addition, State Commissioner Byrnes reviewed the state-wide CIF goals including renewal of AB1175, the State Strategic planning "action teams", the history of corporate support, the working paper on conflict of interest and financial protocols and the Brown Act as it applies to all CIF sections.

**3. COMMISSIONER'S UPDATE** -- Dean Crowley, Commissioner, reviewed the history of the CIF-AAF relationship, the process of required orientation for all new schools, the increased interest in roller hockey, the "fight" definition, the impact of the proposed Orange County Section on the Southern Section and the upcoming National Federation Section 7 & 8 meeting. In addition, he announced Toyota has come on board as the State CIF titled sponsor. Other state corporate sponsors include Vons, Herff Jones and Tombstone Pizza. Commissioner Crowley reviewed the numbers and type of hardships

being requested and the current plans for the January Executive Committee meeting.

**4. GIRLS' ATHLETIC DIRECTOR UPDATE** -- Donna Gunstream reviewed the Athletic Administrators meeting and their involvement at the CIF-SS Symposium scheduled for February 1, 1995.

**5. BOYS' ATHLETIC DIRECTOR SURVEY** -- Donn Clickard reviewed the new video that Liability Attorney Rick Ball is producing and the problem of cross gender coaching and the need to develop information in this area.

**6. TREASURER'S REPORT** -- Margie Godfrey reviewed with the committee the final 1993-94 budget and membership on the Budget Committee. This committee consists of Dale Mitchell, Tom Triggs, Donna Gunstream and Margie Godfrey.

**7. STATE STRATEGIC PLANNING IMPLEMENTATION** -- Dr. Ken Gunn reviewed the current status and work of the original committee. The next step is a report to the State Legislature.

**8. STATE MARKETING MANAGEMENT** -- Dr. Ken Gunn and Dr. Gary Smidderks reported that Toyota has been signed on as the titled state-wide sponsor. In addition, Vons, Herff Jones and Tombstone Pizza have signed on as state corporate sponsors.

B. Commissioner's Committee Recommendations: Commissioner Dean Crowley explained and reviewed State CIF action items from the State Commissioner's Committee with reference to the State Constitution By-Laws.

C. Section Relations Committee -- Orange County Section - Dr. Ken Gunn reviewed the meeting of the Orange County and Southern Section Representatives and the drafting of the Southern Section Executive Committee/Orange County Steering Committee Perspective.

D. Ethics, Expenses and Conflicts of Interest - Dr. Smidderks reviewed the State CIF working paper on ethics, expenses and conflicts of interest. 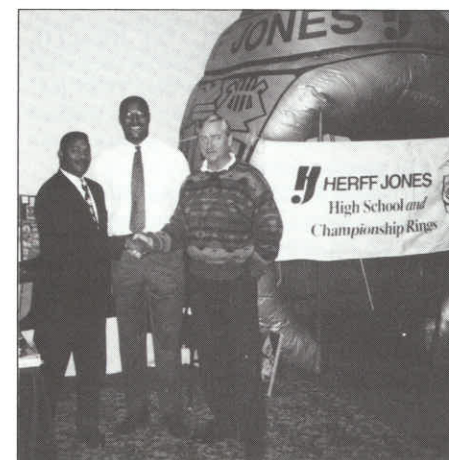

1. **MINUTES** -- It was moved, seconded and passed to approve the October 5, 1994 minutes of the CIF-SS Executive Committee Meeting.

2. **PRESIDENT'S UPDATE** -- Dr. Ken Gunn introduced Chris Thomas, Director of Sports Marketing who presented Tim Titus and Steve Forell from Herff-Jones. In addition, Dr. Gunn complemented the CIF-SS Office staff for the positive management of the playoffs. He commended Commissioner Crowley for his open communication with the Orange County representatives following the State Federated Council meeting.

3. **COMMISSIONER'S UPDATE** -- Dean Crowley, Commissioner, reviewed the new CIF-SS Executive Committee patches, the AAF Soccer Clinics and safety concerns regarding girls' pole vaulting. In addition, he updated the committee on the recent change in the R & R week with the Season of Sport Committee recommending no change in calendar dates. 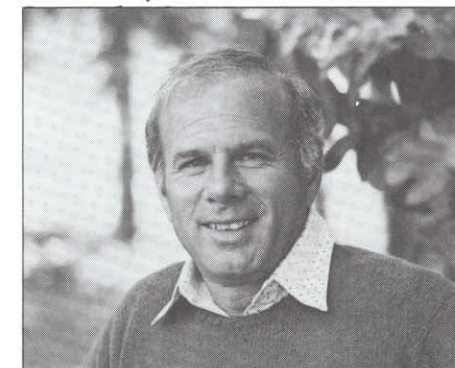
An athlete since his childhood days in Compton, Selleck excelled in basketball and

A Game Plan For  
Taking Control  
of the Crowd

With the basketball season upon us, it's an appropriate time to take a look at crowd control. Often times the phrase "crowd control" carries a negative connotation. The term seemingly relates to the prevention of undesirable incidents that seem likely to occur at athletic contests. This is true, in some cases.

But such precautionary measures should be taken at all athletic events, especially those involving a substantial number of spectators, regardless of the likelihood of unruly behavior.

Crowd control, or better yet, "crowd management," should be a positive subject. The management of crowds today is more important than ever in high school sports. The verbal and sometimes physical abuse of players and officials has worked its way from the professional level to the college ranks, and now, unfortunately, to the high school level. We in the CIF Southern Section must insure that our athletic programs will continue to operate under optimum conditions for the benefit and enjoyment of all those involved.

Every school fielding interscholastic athletic teams should assess its crowd management plans. What problems occurred at its interscholastic events last year? How could they most likely be prevented this year? What new problems might arise this year and what can be done to forestall them?

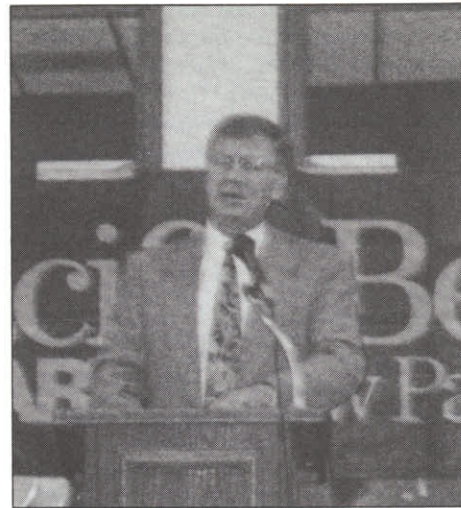
This is especially applicable for basketball, where large crowds are often assembled in small gymnasiums. When a significant number of spectators at a high school athletic contest feel free to express disapproval of a decision or the progress of their team by acting in a consistently unsportsmanlike manner, then it is obvious that the administration of at least one of the competing schools has not done its job in preparing for the contest. It matters not whether it is an indoors or outdoors activity, nor does it matter whether the objectionable behavior is that of students or adults or both. It is squarely up to the school administration to structure its crowd

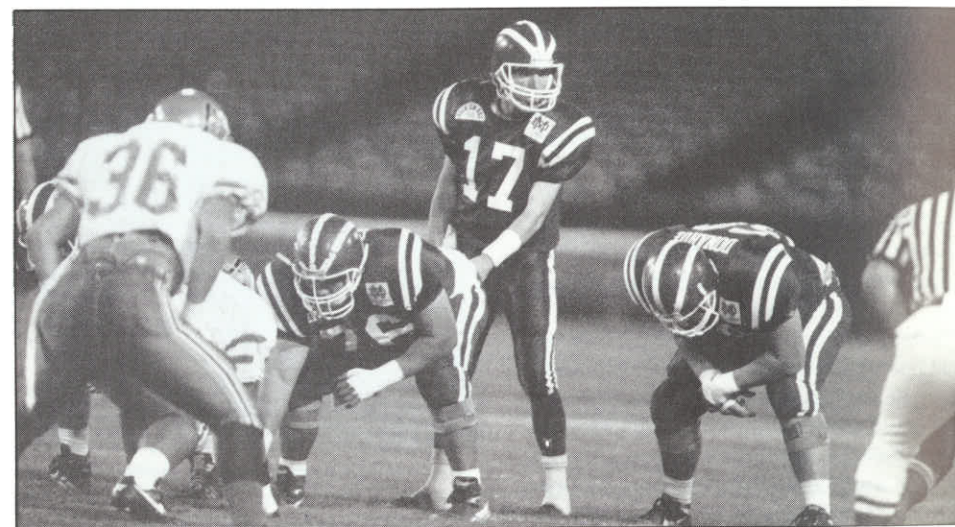
The Southern Section CIF/Toyota Division I Football Championship game was a highly-rated television success for KCOP-TV in its live telecast on Saturday night, December 10.

management policies so that such behavior is highly discouraged prior to the contest and acted upon swiftly should it occur at the site.

An important note: Faculty and staff supervision should be identified with some type of jacket or other identification.

It is relatively easy to display respect and a friendly spirit towards athletic opponents and game officials when things are going well. The test of sportsmanship and self-discipline comes when the decisions and "breaks" go the other way. If such positive attitudes are exhibited by participants and spectators alike, athletics are at their highest level.

The principal of the school, of course, is charged with the prime responsibility for the

health and safety of the student body. Assisting him or her with various aspects of crowd control management for interscholastic athletics will be, among others, assistant principals, athletic directors, coaches and other members of the faculty.

Every school has its own emotional climate and the crowd management problem-solving of individual schools should reflect this.

Interscholastic athletics are extra-curricular activities provided for the athletes' benefit, primarily -- not the student body or the community, and we all share a common responsibility to protect our athletes and our athletic programs. One of the means to this end is proper crowd management.

## MATER DEI FOOTBALL RANKED #1 IN NATION Monarch Boys Basketball Team Also Gets Top Ranking

It's well known that Mater Dei High School of Santa Ana has a tradition-rich athletic program. The Monarchs have been ranked at or near the top nationally in boys basketball for the past several years.

But when Mater Dei was named the No. 1 team in the nation in football this past year, it sent historians scurrying for the record books.

On Monday, December 19, two days after the nation's previous top-ranked team, Southridge High of Miami, lost in the Florida 6A state championship football game, Mater Dei (which a week earlier had defeated Bishop Amat to win the CIF-SS Division I title and finish 14-0), was named the best in the country by USA Today.

On that same day, the Mater Dei boys basketball team was ranked No. 1 in the nation after top-ranked DeMatha of Hyattsville, Maryland, lost the previous weekend in boys basketball.

Mater Dei was the nation's best in football and boys basketball.

Dave Krider, the USA Today high school

sports correspondent who devises the rankings, said he could not recall one school ever holding down the top ranking in two sports at the same time.

"It was a very unique thing," said Krider from his home office in Indiana. "I remember sweating out what might happen if Mater Dei got the football top ranking. And then the basketball team came along and I thought, wow, this is unbelievable. Because the seasons so rarely overlap, I didn't think it would ever happen."

Mater Dei and Krider himself were featured in a full-color feature in Sports Illustrated after Mater Dei defeated Bishop Amat in football.

Later in December, Mater Dei lost its first and only basketball game of the season, in a Las Vegas tournament game to Oak Hill High School, a game witnessed by Krider. That moved Mater Dei down to No. 6 nationally, but the Monarchs had ascended to No. 3 by mid-January.

"I think Mater Dei still has a shot to finish No. 1 (in basketball)," Krider said. "I'm sure

whoever wins it won't be undefeated. I've seen 15 of the top 20 teams in the country and Mater Dei is right on par with all of them."

To give a perspective on what an achievement it is to be ranked No. 1 in the nation in high school sports, the National Federation of State High School Associations reported this year that 16,451 schools participate in boys basketball nationally, and 13,029 schools compete in 11-man football.

Of course, since Mater Dei was ranked No. 1 in football in the final ranking of the football season, the dual rankings was a short-lived dream come true.

Nevertheless, the CIF Southern Section won't soon forget the day one of its schools was the country's king of two sports.

A lot of credit for the achievement must go to not only the athletes, parents, school administrators and supporters of Mater Dei athletics, but to all of the coaches, especially head boys basketball coach and athletic director Gary McKnight and head football coach Bruce Rollinson.

## GLENDORA RECEIVES ACCOLADES FOR SPORTSMANSHIP

Because of liability concerns, Rule 1923.3 does NOT allow schools to use their helmets and other personal protective equipment during the summer. This would include furnishing such to students for their attendance at school and/or non-school camps. It is not a violation for coaches to be with their student at these camps but schools may not furnish equipment.

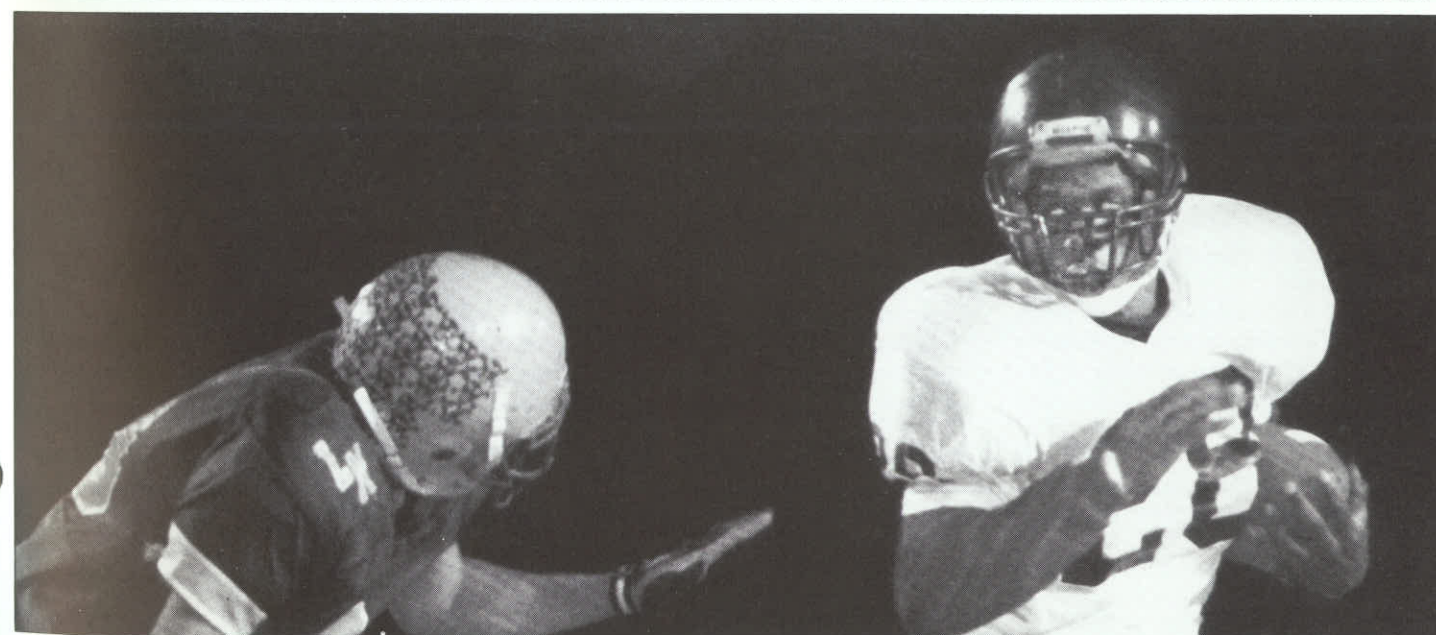

## IN THE NAME OF SPORTSMANSHIP: OFFICIALS ARE ONLY HUMAN

Barbara Maughan, a basketball and volleyball official from Los Angeles, expressed these feelings to *Referee Magazine*, "I wish," she said, "that coaches, players and spectators will some day realize that officials are human beings."

Perhaps this is a better wish: for the coaches, players and spectators to realize that officials are only human beings. For the problem seems to lie not in recognition, but in expectations. It's not who they are, but what is expected from them. Expectations which raise them to superhuman status.

Fans expect sports officials to meet a number of superhuman qualifications. First, in the area of their vision. They must possess a 360 degree peripheral vision so that they can see the whole field or court at all times. In addition, it must be X-ray vision in order to see through players, coaches, goals, and posts and eliminate all hidden violations.

Second, in the area of their judgment. Officials must be able to completely and accurately analyze every situation and make just that call which will please 100 percent of the crowd.

And, third, in the area of their discernment. This requires that officials be either mystics or psychologists, allowing them to render their decisions according to both the spirit and the letter of the law.

Exaggerations? Of course. But sometimes, they seem to be closer to the truth than what fans would like to admit. Officials have a difficult job, and most often do not get nearly the credit they deserve. One referee put it like this: "If you want a taste of what officials often receive from fans, the next time you see a traffic jam, jump out of your car and begin directing traffic. Then, keep track of all the compliments you get."\*

On the other hand, however, fans are quick to let the officials know when the call has gone against their team. They have coined short and cute, but subtle and cutting cliches (or jeers) to express their displeasure. Listen to some of them. They fit into three groups.

One group accuses the officials of being partial and playing favorites. "We're being homered" comes out loud and clear. "How much are they paying you?" "Call them both ways."

Another group suggests that the officials are inexperienced and incompetent. "Don't give up your day job" is often heard. A more recent one is "Go back to Foot Locker." "This is your first game, isn't it?"

Finally, there are those which communi-

cate that the officials are out of control and don't know what's going on. "Hey, ref, open your eyes, you're missing a good game," or "Where did you hide your dog?" "If you had a good eye, you'd be a cyclops."

What do officials think of verbal abuse, and how do they handle it? Verbal abuse from coaches and players involving profanity, or personal attacks on their integrity is usually not tolerated. Most are very sensitive to the "you" word and usually take appropriate action when they hear it.

But with verbal abuse from the fans, most officials probably take a "hear no evil" approach. Said one umpire, "You've just got to have the mentality where you don't hear the garbage and try to do your job the best you can. You've got to understand most of the vocal abuse comes either from people who don't know the game or from people who only focus on their kids."\*

Officials are not superhumans, are not perfect, and cannot see everything that's going on. And, they will continue to make mistakes. They know that their position gives them a certain power and authority, but most of them realize that they must not use this as a free ticket for an ego trip. Competent officials cause the game to progress smoothly with as little interference as possible. Preventive officiating is far superior to "whistle-happy" officiating, but in no way does it remove the responsibility for enforcing the rules. Officials know the importance of being definite, consistent, and impartial with their calls, and that nothing promotes negative fan reaction as quickly as the impression that the officials have "lost it." The official's power is there to ensure that the participants can enjoy competition in an environment of fairness and good sportsmanship.

The operative word is "sportsmanship." If sports are going to be what they are designed to be, all who are involved -- official, coaches, players, and fans -- must do their part to promote sportsmanship. Indeed, they must make an active effort to promote it. With this in mind, two vital suggestions are made.

**Be knowledgeable.** This is the number one complaint which officials express in discussing fan reaction. Fans often react to calls without knowing what the rules say about that situation. "It's amusing," John Bennett, a softball umpire from Anaheim said, "when a coach or spectator misinterprets a rule and insists he is right." Rules change regularly, are sometimes different between organizations, and carry different nuances of interpretation. A large part of

negative fan reaction is caused by fans not knowing the rules. This tongue-in-cheek remark expresses one opinion: "Too bad the Federation runs out of rulebooks before the fans get chances to buy them."\*

**Be objective.** The word "fan" is probably a shortened form of "Fanatic." And, to ask a fanatic to be objective may be comparable to asking the sun not to rise in the east. He/she is, by virtue of the case, highly involved both mentally and emotionally, and often is not able to see the forest for the trees. It is common to hear, after a losing effort, "the refs cost us the game." Bob Davis, a young baseball umpire from the Long Beach Association, found it hard to believe that fans could accuse him of favoring the home school when in fact, he had never been to, or even heard of, that school. Al Dean, a veteran official of nearly 30 years, says that there are fans who know the rules, but still refuse to be objective when the call goes against them.

The next time one is prone to accuse the official of bias or favoritism, he/she should stop for a minute and objectively ask the question, "Do I really believe that the refs caused us to lose this game because they wanted the other team to win?" If the question is answered honestly, it will have a sobering effect.

Nothing which has been said is designed to discourage the fans from being loyal and enthusiastic supporters of their teams. Get excited, yell your lungs out, let the coaches and players know that you are with them all the way. Hurt with them, bleed with them, die with them, but do it in a way that exhibits a class act. Never be satisfied with losing, but lose with dignity. The reputation of our actions will follow us long after the final bell has sounded. (\*quote taken from *Referee Magazine*)

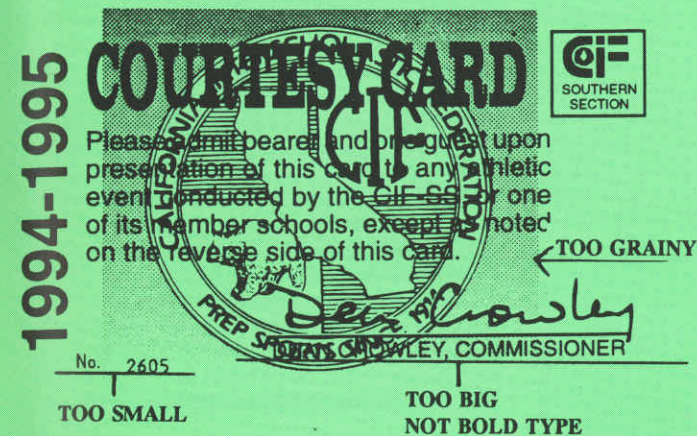

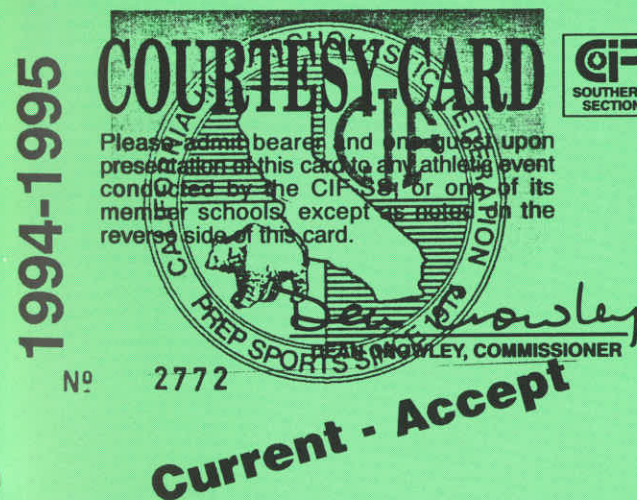

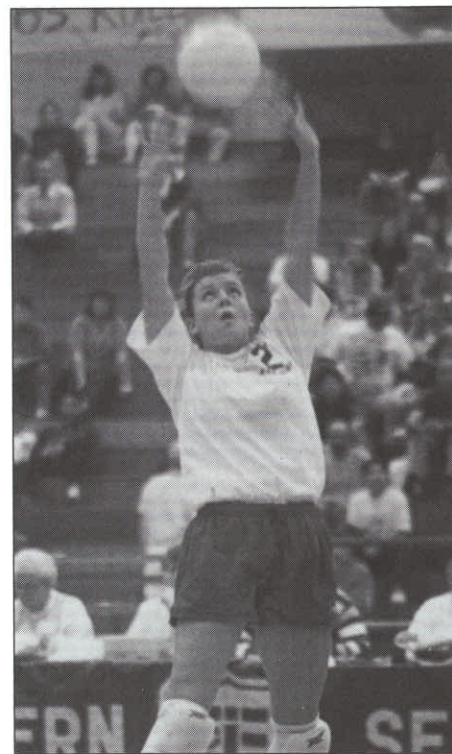

**7. STATE CIF OCTOBER ACTION ITEMS** -- Dr. Gary Smidderks, past president, presented the following agenda items for the October State Federated Council in order to give our delegates voting directions:

A. Implementation - Strategic Planning -- Vote to send delegates uninstructed.

B. Commissioner's Committee Recommendations:

(1) Revise Article 4, state CIF Amateur Standing Rule - Vote to support.

(2) Add one sentence to State CIF By-Law 204(B)(5) - Vote to support.

(3) Remove State CIF By-Law 211C and make it a separate By-Law 212 - Vote to support.

(4) Change term "regular school" to "school of residential eligibility" wherever it appears in State CIF By-Law 221B - Vote to support.

(5) Add a new category to State CIF By-Law 303 - Vote to deny.

(6) Add sentence to State CIF By-Law 600 to further define competition on outside teams - Vote to approve.

(7) Reword State CIF By-Law 601 - Vote to deny. Following further discussion, a motion to approve State CIF By-Law 601, if amended, was approved.

C. Section Relations Committee -- Orange County Region -- Dr. Gary Smidderks reviewed the CIF-SS Executive Committee Orange County Steering Committee voting options. Following discussion a motion to not support the formation of an Orange County Section was approved.

D. Ethics, Expenses and Conflicts of Interest -- Dr. Gary Smidderks reviewed the ethics, expenses, conflict of interest, disclosures and financial protocols. Following discussion, a motion to send our delegates uninstructed was approved.

**8. PRESIDENT'S UPDATE** -- Dr. Ken Gunn, president, reviewed the goals and standards of the Commissioner and Executive Committee developed for the 1994-95 year at the August Executive Committee meeting.

**9. 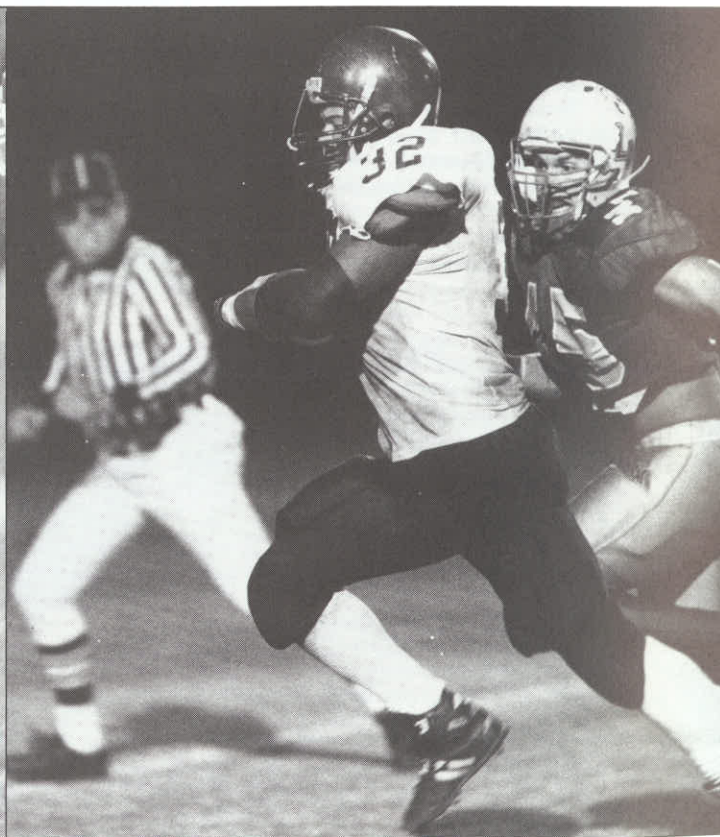
