

# PRESIDENT'S **MESSAGE**



Make the Grade Elusive **Scholarships**

On that rumor-filled grapevine that somehow connects high school athletic circles all over the country, one misconceived rumor which receives too much air play is that "the best way to obtain a university scholarship is to identify one sport in high school and concentrate religiously on it, to the exclusion of any and all other sports or activities." It is further said that year-round practice, including the thousands of dollars expended to participate in club teams, greatly improves one's changes, if not guarantees, that athletic scholarship. This premise of paying the athletic discipline today in exchange for the university paying the tuition tomorrowmay seem to make sense, be a good plan, and to a parent or coach, be reasonable.

Reality is different. Less than one percent (1%) of all high school athletes receive athletic scholarships to NCAA Division I schools, and these awards were made to students regardless of whether they concentrated on one, two, or even three sports. The reality is that the largest number of students receiving scholarships or financial aid is those students who were granted awards based on their good grades.

The National Federation of High School Associations regularly reports on studies regarding participation in sports. its recent findings indicate the following:

- \* Participants have "significantly higher" grade point averages and better attendance when compared to non-participants.
- \* Participants in more than one sport expcerience higher academic performance.

It should be noted that the typical high school athlete is in school every day, and, as a result of good attendance combined with classroom effort, that

- 1. MINUTES It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of May 1, 1997. Additionally, the minutes of the CIF-SS Executive Committee meeting of June 18, 1997, August 9, 1997 and October 1, 1997 were submitted as informational
- 2. DISTINGUISHED SERVICE AWARD Tom Triggs, President and Dr. Ken Gunn, Past-President, introduced those receiving the State CIF Distinguished Service Award. Recipients were retired superintendents, Dr. Robert Packer, Duarte Unified School District and Dr. Cynthia Grennan, Anaheim Union School District.
- 3. PUBLIC HEARING SESSION Dan Hay President of the Huntington Beach High School Football Booster Club, discussed concerns regarding Orange County releaguing. In addition, Thomas Wright, an Esperanza High School parent, reviewed concerns regarding the proposed fall season of sport for girls' golf.
- 4. STATE CIF OCTOBER ACTION ITEMS -Margie Godfrey, President-Elect, presented the

following agenda items for the October State Federated Council in order to give delegates voting direction:

We all know that parents want what is best for their students. When it comes to participation in high school athletics, parents are more than willing to let you know what they feel is best for their children. The only question is, in what form does that parents interest present itself to you, the administrator or coach? No matter how that interest comes to your attention, parental involvement can sometimes pose challenges for high school coaches and administrators.

It is not uncommon for many administrators to now spend more time dealing with parents than taking care of any other part of their day-to-day business. With students gaining more and more rights, today's administrators are dealing with parents more now than ever and that is not necessarily a bad thing. Parents that show a greater interest in their children's daily pursuits have a greater understanding of what it is that athletic administrators are up against. Keeping parents involved can go a long way in helping to reduce the friction that can occur when problems do arise.

The first thing that can be done to help this process along is to include parents in any preseason meetings. Let the parents know from the very beginning what there role is and any expectations that the school may have for them. Explain to them what their child will be going through during their athletic season like physicals, grade requirements, lettering policies, practice and playing-time information as well as interaction between coaches. Let the parents know what the kids will be learning and how it will be taught so there will be no surprises later on. Encourage their appearances at practices so they can watch that phase of the program. Schools can even put these policies in writing so that the athlete, parents, coaches and administrators alike will have a guide to refer to throughout the season as questions and concerns come up.

# NIKE AND CIF-SS TO DEVELOP LEADERSHIP ON AND OFF THE COURTS





# JOHN WOODEN CLASSIC INCLUDES ONE DAY OF HIGH SCHOOL BASKETBALL

For the first time ever in its four year history, the John R. Wooden Classic basketball tournament was expanded from a one-day college doubleheader to a two-day event that featured high school teams leading off the festivities.

The John R. Wooden Classic High School Invitational was held on December 4 at the Arrowhead Pond of Anaheim and featured five Southern California schools: Ayala, Crespi, Glendora, Los Alamitos and Mater Dei. It also included national high school power DeMatha Catholic out of Hyattsville, MD.

The first game featured a battle of two teams that combined for 50 wins last season in Glendora and Ayala. Glendora used a balanced offense to control all four quarters and post a 62-43 win to open the classic. Mater Dei and Crespi tangled in game two as a young Monarchs team flexed their muscles in taking a 61-39 victory from the Celts. Game three was the

featured game that pitted Los Alamitos vs. DeMatha. The Stags, led by legendary high school coach Morgan Wootten, jumped out to an eight-point lead at the half, but then had to hold-off the charging Griffins for a 67-59 win.

Established in 1994, the John R. Wooden Classic is an annual tribute to the legendary former UCLA coach and the excellence he personifies. The Wooden Classic is a celebration of the game of basketball and the activities benefit the Children's Miracle Network, Children's Hospital Los Angeles and Southern California High School athletics. This year's events included the annual showcase doubleheader featuring Stanford vs. Georgia and UCLA vs. New Mexico, December 6 at the Pond.

The classic also included a golf tournament at Newport's Pelican Hill Golf Club and the John R. Wooden Classic Banquet at the Anaheim Hilton & Towers.

# RULE REVIEW



Another Look For Open Enrollment

I'm sure all administrators by now should have the new open enrollment form 214.1. The rule, essentially, allows students new transfer options, provided that the transfer meets specific guidelines. Additionally, this new form must be filed with the Southern Section office for the transfer to be processed.

The rule designates that for students transferring from one school to another, certain criteria must be met in order for the student to gain athletic eligibility sooner. First, the intent to transfer must have made known by May 15 of the previous school year. Next, the transfer must be for non-athletic and non-disciplinary purposes and lastly, the transfer must take place during the first fifteen days of the school year.

For those transferring within a certain district, the May 15 date becomes inconsequential, but the student must transfer under the district's open enrollment policy. Again, the transfer must be non-athletic and non-disciplinary in nature. Like interdistrict transfers, enrollment must take place in the first fifteen days of the school year.

Further, the rule allows students only one open enrollment transfer during their career in order to retain unrestricted eligibility. Therefore, if the student has had one open enrollment transfer approved in his or her career, he or she can only gain unrestricted eligibility for subsequent transfers through a bona fide change of address or hardship (Rule 215).

Now, with the new provision, should the student transfer in after the first 15 days on or before May 15, that student will be restricted for the sports they competed in during the previous year, but starting the nextFall, that student would then be unrestricted.

For example, Johnny, on February 1, files the appropriate 214.1 transfer forms and is

# STATE-WIDE MARKETING UPDATE CIF ARCO am/pm SCHOLAR-ATHLETE OF THE YEAR PROGRAM EXPANDS

This year the CIF- ARCO am/pm Scholar-Athlete for the Year program has expanded with the number of scholarships awarded more than doubled from a year ago. ARCO, which gave \$50,000 to the program a year ago, has increased the total dollar amount for the scholarships to 98,000. In addition to selecting one statewide male and female scholar-athlete, 44 other scholarships will be awarded to student-athletes from among the 10 sections that comprise the CIF.

In past years the CIF has limited schools to nominations for one Scholarship Awards male and one female student-athlete. At the schools' request, this year the CIF will no longer limit the number of nominations from each school

"We are most grateful to ARCO and it am/pm stores for recognizing the importance of this highly-

acclaimed program," said Jack Hayes, CIF executive director. "Over the last two years, we have been able to expand the program significantly due to their generous contributions."

Said John Tarman, CIF marketing director: "ARCO and its am/pm mini-markets have clearly established themselves as preeminent corporate citizens as demonstrated by their increased support of this extraordinary scholarship program."

The criteria for qualification includes possessing a minimum (unweighted) grade point average of 3.70, demonstrating superior athletic ability in at least two years of varsity play within California and having a record of good citizenship.

In addition, each applicant must complete a student essay entitled "Catching the Spirit" which focuses on the significance of sportsmanship in athletics.



# TEACHING KIDS TO BE "GOOD SPORTS"

Youth Sports: The Last Vestige of Sportsmanship

We're living in an age where the preservation of traditional values can no longer be taken for granted. It seems we need to have reminders (books, movies, newspaper articles, etc.) to maintain our awareness of the importance of preserving the basic human values which are essential to the survival of a community.

It's no different in the world of sports. The traditional value of sportsmanship is being challenged from all sides: professional, college, high school and even in youth sports. There are some who say sportsmanship is becoming a lost art and that unless we remind ourselves of the essentials of sportsmanship and strive to maintain the basics of sportsmanship it will gradually fade as other values have done in our society.

In the midst of all this, it seems doubly important that we recommit ourselves to guiding our youth, reminding them what sportsmanship is all about, rewarding them for showing good sportsmanship and showing, by our example, that sportsmanship is still alive and valued in youth sports today.

Here's a 10-item checklist for kids to follow as they try to dvelop a habit of good sportsmanship.

### 1. I abide by the rules of the game.

Part of good sportsmanship is knowing the rules of the game and playing by them. If a player decides to play a given sport, it is the responsibility of that player to learn not only how to play but how to play according to the rules which have been established and standardized at allow competitive games to be played in an orderly fashion. The more a player knows the rules the more that player can enjoy th sport.

### 2. I try to avoid arguments.

Part of good sportsmanship is anger management. Arguing with officials, coaches or opponents is often simply a misguided effort at "letting off steam" in the heat of competition. A good sport knows that anger can get in the way of a good performance. A good sport knows how to walk away from an agurment and to stay focused on the game at hand.

### 3. I share in the responsibilities of the team.

Good sportsmanship implies that the player on a team is a team player. In other words, the player understnads that his or her behavoir reflects on the team in general. Moreover, a team player does not condone unsportsmanlike conduct from teammates and reminds players that they all share in the responsibility of promoting good sportsmanship.

### 4. I give everyone a chance to play according to the rules.

In youth recreational sports the more talented players, if they are good sports, will look out for and encourage the less talented players on the team, cooperating with coaching plans to let everybody play. Unfortunately, some coaches may become so pre-occupied with winning at all costs that they never play some players, regardless of the time and effort they put in at daily practices, even when the socre warrants clearing the bench.

### 5. I always play fair.

Honesty and integrity should be an integral part of sports. A player with good sportsmanship does not want a hollow victory which comes as a result of cheating ("dirty" fouls, ineligible players, performance enhancing drugs, etc.)

### 6. I follow the directions of the coach.

A player with good sportsmanship listens to and follows the directions of the coach, realizing that each player's decisions affect the rest of the team. If a player has disagreements with the coach, the player discusses the disagreements privately in a civil manner, away from the public eye.

### 7. I resprct the other team's effort.

Whether the other team plays better, or whether it plays worse, the player with good sportsmanship does not use the occasion to put the other team down. In the field of competition respect for opponents is central to good sportsmanship. If an opponent out-performs a player that player accepts it, learns from it, offers no excuses and moves on. If a player out-performs an opponent, that player enjoys the victory, but does not gloat, does not belittle, and does not minimize the opponent's effort.

### 8. I ffer encouragement to teammates.

A sign of good sportsmanship is a player who praises teammates when they do well and who comforts and encourages them when they make mistakes. Criticizing teammates in the heat of battle simply distracts from the focus of working together and gives the advantage to the opponent who develops a sense of confidence when seeing signs of weaknes or a lack of unity in the midst of the competition.

### 9. I accept the judgement calls of the game officials.

Part of the human condition is making mistakes. Arguing with an official over a judgement call simply wastes energy. The player with good sportsmanship knows that errors may be made, but the player also knows that a game is made up of all the plays and calls from the beginning to the end of the game, not just the call in dispute. The player with good sportsmanship may be upset, but that player also has learned to focus his/her energies back on the game and on doing the best he/she can do for the rest of the game.

# WHO DO WE BLAME FOR OUR LOSS?

I am writing this article in response to something I read in the paper from a coach, which I found very distributing, especially in light of our constant quest to improve sportsmanship among our athletes, students and fans. This is something I believe every coach, athletes, parent and spectator should consider and take a critical look at how they themselves handle these situations.

It concerns public criticism and blaming of official for a loss!

I want to start off by saying that I have yet to meet an official in the MSHSL that goes out to deliberately make one team or another lose. Keep in mind that most of the calls that officials are asked to make are JUDGMENT CALLS. We, as coaches, also make judgment calls: as to who to play, when to play them what play to do, etc. These are calls we have to make as coaches based on our best JUDGMENT of the situation, and sometimes they work, and sometimes they don't (in other words, sometimes we are right and sometimes we are wrong). It is our call to make, and we do the best we can based on our best professional judgment of the situation. The same I true for the calls made by the professional officials we hire for that purpose.

When we blame officials, or for that matter blame anyone, for our losses, we are degrading the effort of all individuals involved in the contest. Instead of blaming anyone for our losses, we should congratulate our opponents for out-playing us on that day. I feel this approach would be better for our relationship with our opponents, as well as better for our players, our spectators and the program and sport as a whole.

Let our athletes know that they played hard, but, on that particular day, our opponent played a little better. It wasn't luck or someone's fault we lost; it was because they played a good game. It is the very

winner and a loser. There is no shame in being the loser, especially if you gave your best effort. However, when we blame the officials or anyone in particular for our loss, everyone involved in the contest comes out losers. No one intentionally goes out to try and lose a contest, but everyone tries their best to win it, so the winner should be congratulated, and the loser need not look for anyone to blame, not even himself, for the loss.

It has been my experience in watching MSHSL contests of all kinds for more than twenty-five years, as a coach, an official. and a spectator, that officials do make bad call, but the bad calls for and against a team tend to even out throughout the course of a game or season. In that time I have never heard a coach give the official credit for the bad calls that went that coach's way. If we don't give credit for bad calls in our favor. then we should not criticize calls we don't agree with. Keep in mind that if the calls tend to even out then that means that there must have been some other reason for the loss. That reason for the loss would be that our opponent played better that particular night.

We, as coaches, should not be looking for the negatives in a contest or who to blame for the loss. This only leads to a negative and combative attitude in the players towards that opponent or official. This attitude then is carried over to the parents and fans. When we blame officials for the loss, we are sending the message to our athletes that the only way that opponent can beat us is by cheating. Instead, we should look for the positive things achieved in the contest and work to improve on those things as well as the areas where we did not perform up to expectations.

I understand the feeling of frustration, as a coach who has watched an athletes work

hard to win, when that athlete los4es a contest. It is not his fault or your fault or anyone's fault that the loss occurred; the other athletes or team just out-performed our athlete on that day, so give him credit for that effort.

Please keep in mind the difficulty the MSHSL is having getting new officials and the difficulty your athletic director has in getting officials for your contests; it is getting worse every year. One of the reasons for this is the verbal abuse officials receive from fans and players and, in some cases it is physical abuse, which is on the rise. When coaches openly criticize officials, you are only reinforcing and legitimizing this type of behavior from fans.

Officials are on the field, just like boundary lines are on the field, to keep the contest fair for both sides. All the officials I have talked with are involved because they want all the athletes to have as good an experience as possible. If you have a legitimate complaint about an official, there is a process established, through the MSHSL to file your complaint, voicing it in public is not the way to do it. Remember it is very hard to argue with a judgment call, you may not agree with it, but there is very little you can do to change it.

I feel that BLAMING people for our losses, whether it is officials, players, coaches or spectators, has become a big problem in high school athletics, and it really has no place there. I have offered some ideas in this article, that if we all work together on them and share them with our colleagues we can create a situation in our athletic programs where both sides can feel like winners in a contest, even if we are the team with the lower score on the scoreboard.

### 10. I end the game smoothly.

When the game is over, pouting, threatening, cajoling have no place in the life of the players with good sportsmanship, who emphasiz3e the joy of participating, regardless of outcome. They're not devoid of emotions but they know that their efforts eot end the competition smoothly, without antagonistic emotional display, will help ensure that the games will continue in the future.

On a final note, a word of cautin. We can't be so naive as to think that by teaching and valuing sportsmanship in our youth we will ensure that they will take these values with them into their

young adult and adult sports lives. However, if we don't expose them to the essentials of sportsmanship, and if we don't guide them in developing a sense of good sportsmanship, we can all but guarantee that they will fall prey to the young adult and adult world of sports and athleteics, with its continueed tendency to minimize sportsmanship, and maximize winning as the only real value in competitive athletics.
