The Council meeting was called to order by Earl Haugen, President, at 9:12 a.m. on Thursday, October 12, 2006. - **1. ADOPT AGENDA** It was moved, seconded and passed to adopt the agenda.

# SOUTHERN SECTION MARKETING UPDATE

## TV Contract Rule ... It's more than just football

Just a friendly reminder that the new TV rule for regional/national/web cast of games includes all CIF Southern Section home events. We have experienced some first year confusion where schools assumed this was a football only rule.

All TV and cable TV broadcasts that air regionally, nationally or via web cast (thus can be seen world wide) fall under the rule approved by Council in November 2005. These games must be contracted through the CIF Southern Section office. Rights fees received for regular season games will be returned to the host school (or both schools where Fox Sports is concerned) in the spring of each school year.

Your school does still have the right to allow local cable to do their non-commercial or school district channel broadcasts so long as 1) non of the above TV, regional cable or web casts have contracted to do the game and 2) the local cable broadcast is limited to your home city and those immediately contiguous to your home city.

Finally, each host school does have the right to say no to any regular season TV broadcast. The only stipulation is that if you say no to one entity, then you have said no to all other entities for that game also. It remains your school's choice whether to host a regular season TV broadcast or not.

## Playoff Requirement reminders:

PLEASE display the Toyota Championships banners at all boys and girls playoff events hosted by your school. It is a requirement and Toyota annual contributions have saved every member school \$3,000 each. You are reminded the PA Announcements must be read ahead of your home school announcements when hosting a CIF-SS playoff event and that Gatorade jugs are the only allowable sport drink advertiser (re: jug) at playoff events.

#### Team Academic Awards:

The CIF-SS/TOYOTA Academic Awards packages have been sent out and are due back by March 16<sup>th</sup>. Teams must have at least a 3.0 GPA to enter. Award winners will be announced in late March and the awards will be distributed prior to the Anaheim Angels-Detroit Tigers game on Tuesday, April 24<sup>th</sup>.

# COMMISSIONER'S CORNER

Ensuring our Financial Future

Two years ago, the Section office began discussions with the Executive Committee about our level of service and staff needed to provide that service. We have been busy digging out as much information as we can to demonstrate that, while the Section is financially sound, the time has come to add staff to keep pace with demand. This year the Section will present to Council a balanced budget along with a plan designed to allow for expansion within the office: first, a look back at our financial history.

For years, the Section survived on entry fees to playoffs. Then, in 1933, Seth Van Patten reported to Section schools that the baseball playoffs ran into the red. The semifinals between Inglewood High and Cathedral High had netted only \$24.00. He paid the umpires \$22.00 and four baseballs cost \$6.00, leaving a deficit of \$4.00. "A terrible state of affairs," he said. Shortly after that playoff, in September, 1933, Van Patton proposed a dues structure based on size of school. In addition, Mr. Van Patten was authorized clerical help. Thirty-five years ago, in 1972, dues were set at 8 cents per student. Two years later, a per-sport fee of \$10.00 was added. This plan was well suited for the 429 schools in the Section. Rent for the office was cheap, we were housed on the campus of Gahr High School. Office staff consisted of a Commissioner, his assistant, an information director, assignment secretary and four clerical helpers. They managed 12 sports.

Over the years, the dues structure has been incredibly stable. There was a dues increase in 1979, then one in 1985 to the twenty-three cents per pupil we presently charge. Imagine: in 35 years there has been two dues increases and one change in the per sport fee. It has been twenty-two years since the small school fee increased from \$50.00 to the present \$75.00. In that time the Section has expanded from 429 schools to 563. The number of sports

# OFFICIALS' WHISTLE



Recruit Train Retain

Nationwide surveys show a shortage of high school officials. As officials groups continue to age, it becomes more important to replace those veteran officials who will no longer service our member schools. To avoid the unwanted option of playing contests on multiple days to accommodate an officiating shortage, a plan of action that is in place needs a fresh look.

Six years ago the Southern Section embarked on an aggressive program titled "Recruit – Train – Retain". The focus of this effort remains threefold:

- 1. Target those who are athletes or involved in athletics to get involved in officiating once their playing days are over. This would include high school players and coaches and even parents who may to become involved in this different aspect of sports.
- 2. Work jointly with our officials organizations to partner in recruiting new officials and to make them feel welcome. A large part of the high level of attrition in officiating- over 60% of new officials do not return for the next season- is due in part to how new officials are treated. Our officiating Units made a commitment to offer scholarships, advancement opportunities and continuous training in areas that would increase the chance of success for new officials.
- 3. Mentor programs and the ability to advance in a structured manner for new officials was also a part of this effort. Both new and veteran officials would gain from such commitments, and a reduction in the turnover rate would positively impact member schools.

Working with our officiating groups becomes an even greater issue as we begin discussions on a new three year agreement beginning with the 2007-08 school year. Issues involving our officials groups ultimately influence school activities and day to day school operations.

# MINUTES OF THE EXECUTIVE COMMITTEE MEETING - August 14, 2006

This meeting of the CIF Southern Section Executive Committee was called to order at 8:30 a.m. by President Earl Haugen in the Eagles Nest Small Ballroom, Pechanga Casino and Resort, Temecula, California. All members were present with the exception of Stan Ford, Susan Rainey, Guy Roubian and Bill Thomason.

#### 1. OPENING BUSINESS

- E. Adopt Agenda It was moved, seconded and passed to adopt the agenda with the addition of Item 7, Closed Session.
- F. Approval of Minutes Minutes of the May 24, 2006 Executive Committee Meeting It was moved, seconded and approved.
- H. Introduction of New Executive Committee Members Jim Staunton introduced the new members of the Executive Committee Chris Bowles, Jerry Halpin, Barrett Luketic and Mark Rose. Bill Thomason was unable to attend the meeting.

#### 5. OLDBUSINESS

- A. Membership status of new schools admitted in 2005:
- 1. Nia Educational Center After discussion, it was moved, seconded and approved for full membership.
- 2. Pacifica Christian High School After discussion, it was moved, seconded and approved for full membership.
- B. Overview of Strategic Planning Committee Dr. Staunton, Karen Hellyer, Paul Castillo, Rob Wigod reported on the progress of each of their committees
- C. Reports on National Federated Summer Meeting Earl Haugen, Jim Staunton, Paul Castillo, John Dahlem and Janet Berardi each reported on the meetings they attended during the Summer Meeting.

#### 6. NEW BUSINESS

- A. Proposal for Restructuring Office Administrative Staff - Jim Staunton stated the staff is looking at the time when it will be best to expand the office staff. He proposed the time when office costs go down, most likely when we have some retirements, to incorporate new staff. But felt the time has passed for the addition of a new position. He explained the preliminary duties of this new position. Gary Smidderks suggested we advise Council of our desire to add a position. Earl Haugen suggested it be added soon in order to for this new person to learn from the expertise of the more experienced personnel. It was suggested that the office staff move forward with the planning for a new assistant commissioner.
- B. Recommendation of Larry Satterfield, Athletic Director, Mojave High School as Desert Area Representative After discussion, it was moved, seconded and approved for Larry Satterfield to become the Desert Area Representative.
- C. Report on Rule 214, Transfer Eligibility Jim Staunton explained that the CIF State Director was given orders to come up with a uniform transfer eligibility rule for the state of California. The state is split on what the transfer rule should be. The proposal of 30 days of no varsity eligibility was not looked at with favor by the Southern Section. Other Sections in the state do not have the restrictions of Southern Section. The Central Coast, Northern and San Francisco Sections have different issues and feelings.

The Sac Joaquin Section has implemented the 30 day restriction; some Sections do not have an issue with transfers. The conclusion of these committee meetings came to a restriction of 50% of the season.

Jim stated the Southern Section favors one year restricted eligibility. However, one possible solution is to concede anyone may go where they want the first year but to be fair to any family who decides they want to make a change, allow an unrestricted transfer after freshman year. At the end of ninth through the beginning of 10<sup>th</sup> grade and until the 15<sup>th</sup> day after the beginning of school, they may transfer with no restriction. Any subsequent transfer would have restriction.

7. CLOSED SESSION—The Executive Committee met in closed session from 1:15 p.m. until 2:10 p.m. Earl Haugen reported the Executive Committee reviewed the commissioner's evaluation.

#### 8. REPORT SESSION

A. Presidents' Report – Earl stated that John Dahlem has done an outstanding job as president. He has no plans to change the direction of CIF. His goal is to help the new people progress on the Executive Committee and feels the strength of this committee lies with those who stay on the committee. We need longevity. We have had people join the committee in the past couple of years who are bright stars. We want to keep this committee viable with leaders in the community. Earl also had the opportunity to play in the Champions for Character Golf

Tournament and hopes all of the Executive Committee will participate.

- B. Treasurer's Report Bill Dabbs read the treasurer's report. He stated the monies received in 2005-06 have been higher in every sport except softball. Bill reported the audit will be done in late August and will be presented at the November Executive Committee meeting.
- C. Commissioner's Report Jim Staunton stated he received a complaint from Gabrielino High School on football players going to San Gabriel High School. He brought in two investigators who found some irregularities; a parent reported an address for a student to go to Gabrielino and then reported another address to attend San Gabriel. Jim also stated he has been appointed to the Federated Council as the commissioners' representative to the State Executive Committee. John Costello has been negotiating with Fox and we now have a contract with them. Regarding the Champions for Character Golf Tournament, he asked all Executive Committee members to bring a foursome. We need these funds to support the Champions for Character luncheon on October 12 and the way to support this luncheon is to bring more people to the golf tournament.
- D. Executive Committee Member Reports Thom Simmons reviewed the Fox Sports contract and commended John Costello for his hard work in making sure the interests of the Southern Section were met. He gave an overview of the contract which is a three year deal. They receive 25 games per year and the Section will receive \$50,000, \$51,500 and \$53,045 for the three year term. Their main interest was football

# MINUTES OF THE EXECUTIVE COMMITTEE MEETING - September 27, 2006

This meeting of the CIF Southern Section Executive Committee was called to order at 1:00 a.m. by President Earl Haugen at the CIF Southern Section office, Los Alamitos, California. All members were present with the exception of Susan Rainey, and Larry Satterfield.

#### 1. OPENING BUSINESS

- E. Adopt Agenda It was moved, seconded and approved to adopt the agenda.
- F. Approval of Minutes Minutes of the August 14, 2006 Executive Committee Meeting It was moved, second and approved with the correction to Executive Committee Member Report, Terry Speir.

#### 5. OLD BUSINESS

A. Report on Bylaw 214 - Dr. Staunton reported on the progress of making Bylaw 214, Transfer Eligibility, uniform throughout all ten Sections of the state. Legislators have become involved asking why there are so many interpretations between the Sections. Dr. Staunton talked about the bills that were put before the legislature last year. Dr. Staunton presented a proposal which the Section Commissioners favored. It will allow eligibility at any school going into the ninth grade and at the end of the ninth grade would allow a free move. With this proposal remains the issue of hardships. The Commissioners have determined four kinds of hardships: court appointed change of guardianship, school safety issues, financial hardship circumstances and loss of educational

Mr. Haugen stated the next piece is the appeal process. Some Sections do not want an appeal process. Some Sections want everything appealed. The state office would like to have this rule in place for a first read in January.

B. Update on Strategic Plan – John Costello stated the Financial Planning Strategic Committee met to discuss opportunities for the Section and how to guide the Section in the future. Television brings high profile to schools yet small schools do not get any attention. This committee discussed tickets and sponsorships. Other topics raised were does the Section want to make money and should ticket prices be raised. Sue Kuwabara stated they also discussed publicizing what the Southern Section does and who it is. She feels we need to re-educate about who CIF Southern Section is.

Dr. Staunton convened the Sportsmanship Committee with Terry Speir and Sue Kuwabara. They had five recommendations: dealing with trash talking, profanity and taunting at events; Pursuing Victory with Honor training; improving communication with schools on positive efforts made by the Section in the area of sportsmanship; publishing positive information about schools who promote Pursuing Victory with Honor; and examining consequences to ejected athletes. The committee wants to bring the last item before Council and have it included in the Blue Book. (See attachment)

C. Television Rights Update – John Costello reported on the agreements with Fox and KDOC Channel 56. Time Warner is hoping to become a competitor of Fox.

#### 6. NEW BUSINESS

A. Hardships – What is and what is not a hardship – This item was previously discussed under the Report on Bylaw 214.

- B. Recommendation of Reginald Thompkins, Principal, Eisenhower High School, as Citrus Belt Area Representative After discussion, it was moved, seconded and approved to have Reginald Thompkins as the Citrus Belt Area Representative.
- C. Champions for Character Luncheon Dr. Staunton invited all Executive Committee members to attend the luncheon on October 12, 2006 at 11:30 a.m. to assist with the distribution of awards. Please advise Pat Chiappetta if you will be attending. Senator Alan Lowenthal will be our keynote speaker.
- D. Legislative Newsletter Mr. Haugen stated as part of our on going effort of communicating with principals, he asked all area representatives to come prepared for the November Executive Committee meeting, with a report on their communications with their membership.

Mr. Haugen also reminded the members to formulate nominations for the 2006-07 Hall of Fame and Distinguished Service awards.

#### 7. CLOSED SESSION

The closed session began at 2:30 p.m. and ended at 2:45 p.m. It was called to discuss a recommendation for staff insurance and personnel matters. He anticipated no action on these items.

#### 8. REPORTSESSION

A. Presidents' Report – Mr. Haugen stated the Section 7/8 Meeting went very well and there were several programs he wanted to inform the members about:

Jim Staunton – Reported on a presentation by the Oregon Schools Activities Association regarding practicing in the heat. Go to www.osaa.org for further information.

John Dahlem – Reported on the alcohol policy in Nevada and distributed his history of CIF Earl Haugen – Reported on the Coaching for Competence and Character program by Bruce Brown and his desire to bring this program to the Southern Section.

Treasurer's Report – Bill Dabbs reported that the dues have not gone up this year, they are \$0.23/student and \$25/sport and will be mailed this week of September 27, 2006. They will be delinquent on November 1. He also reported the audit is complete and will be presented at the November Executive Committee Meeting. John Dahlem asked Area Reps to remind their constituents of the different types of dues.

# NFHS LAUNCHES NEW COACH EDUCATION PROGRAM

INDIANAPOLIS, IN (February 1, 2007) — The National Federation of State High School Associations (NFHS) has launched its own online Coach Education Program with two courses — a Fundamentals of Coaching course and a First Aid for Coaches course.

The online version of the program began January 3 and is available through the NFHS Coach Education Web site at www.nfhslearn.com. This is the first and only education program designed exclusively for interscholastic coaches. The Fundamentals of Coaching course addresses the following subjects: educational athletics and the role of the coach, the coach as manager, the coach and interpersonal skills, the coach and physical conditioning, and the coach as teacher. The First Aid for Coaches course is a sports safety training program developed by the American Red Cross of greater Indianapolis and the U.S. Olympic Committee.

"We are pleased with the quality and depth of the courses we've launched," said Tim Flannery, NFHS assistant director and staff liaison to the NFHS Coach Education Program. "The NFHS Fundamentals of Coaching course provides a unique student-centered curriculum for interscholastic coaches, assisting them in creating a healthy and age-appropriate sport experience that supports the academic mission of the 18,500 schools from NFHS-member associations."

After 16 years with another company, the NFHS started its own Coach Education Program to keep the costs down and to provide a program that targets the role of the interscholastic coach in an educational setting. For the interscholastic coach, the primary goal is to promote learning.

"We view the sports experience as an extension of the classroom," Flannery said. "As such, winning must take a lesser role to learning. If winning is the primary goal, then it makes it impossible to achieve our purpose. Thus, the program was created in order for coaches to find the happy balance between winning and teaching. "The whole purpose of the fundamentals course is to train coaches regarding their

# HISTORY OF THE CALIFORNIA INTERSCHOLASTIC FEDERATION SOUTHERN SECTION

#### HORSE SHOES, FOOTBALL THROW, ONE YEAR RULE

Interesting items gleaned from the minutes of the State CIF and CIF Southern Section Council meetings:

"The use of the terms 'major and minor' sports should be eliminated and the proper emphasis placed on all sports according to their educational values to those who participate" (January, 1932).



- Official Horseshoe Rules were articulated in the January, 1932, minutes including weight of the shoes and the admonishment that, "No contestant shall make any remarks or utter any sound within hearing of the opponent, or make any movement that might interfere with opponent. Penalty is that both his shoes are declared foul."
- It was decided that the Football Throw be included in the 1932 State Track Meet in accordance with the following regulations: "Football pass for distance. Ball to be passed between parallel lines five yards apart. Javelin rules of throwing shall apply. If ball touches either parallel line the throw does not count. The football shall have regulation intercollegiate specifications. Medals will be awarded for this event, but points not be counted" (State minutes, November 28, 1932). "Nothing shall be used on the hands of the contestants which shall in anyway interfere with others who wish to use the ball" (State Minutes, December 1, 1934).



- "The eligibility of life guards as members of water polo teams is to be a matter of discussion for the next meeting" (February 16, 1920).
- "Mr. Barry then reported that the Bay League recommend that a 'letter' man, moving from one school to another, be not allowed to play on the new school team unless he has resided in that School district at least one year except of his parents move with him" (October 7, 1923).
- Unique schools not placed in a league by the CIF in 1923 (May 26, 1923):

San Luis Obispo State
Pasadena Military Academy
U.S.C. Preparatory Academy
George Junior of Chino (named for William Reuben
George of Boys Republic fame)

# USC ASSISTANT FOOTBALL COACH STEVE SARKISIAN SPEAKS AT 31ST ANNUAL FOOTBALL PRESS CONFERENCE AND LUNCHEON

University of Southern California Assistant Head Football Coach Steve Sarkisian was the keynote speaker at the 31st Annual CIF Southern Section- Toyota Football Championship Press Conference and Luncheon held on December 4, 2006 at the Grand in Long Beach.

Steve Sarkisian has been an assistant coach at USC since February 2005 and is at USC for the fourth separate time as an athlete or coach. He is currently an assistant coach and a quarterbacks coach. Under Sarkisian's guidance, USC quarterback Matt Leinart was a finalist for the Heisman Trophy and set 16 records at USC. For the 2004 season Sarkisian worked with the Oakland Raiders. Sarkisian originally joined the USC coaching staff in 2002 as an offensive assistant. After briefly spending time in San Diego Sarkisian returned to the Trojans as they went on to win national titles in 2003 and 2004.

Sarkisian starred at the quarterback position at the prep, college and professional levels. He played football and baseball at West Torrance before heading to El Camino Junior College. From there he went on to play at BYU, where he eventually would become a second-team All-American. He went on to play for the Saskatchewan Roughriders of the Canadian Football League before becoming a coach.

Sarisian talked about the importance of enjoying the moment of their involvement in the championship game. He encouraged the student-athletes to continue on their academic path with the same commitment they gave to football.

The luncheon was attended by the 26 11-Man Football finalists as well as the two 8-Man Football Championship Teams.

# TWO GENERATIONS HAVE TEAMED TO LEAD TEMECULA VALLEY

TEMECULA - It happens so often in high school sports — coaches stepping down to spend more time with their family. Rico Thompson doesn't have to struggle with such a choice because coaching boys basketball at Temecula Valley allows him the opportunity for additional time with family. Thompson, in his 11th season with the Golden Bears, is fortunate to be surrounded by family every time his team takes the floor. Thompson's younger brother Andy is his assistant coach, and among Thompson's players this season are his son, Ricky, and his nephews Billy and Johnny. At most games, another 40 members of the Thompson family are perched in the bleachers leading the cheers. "It's a very special experience," Thompson said. "I'm dad and uncle, so I'd be at the games anyway, but as their coach I can be there for them in two ways."

With the Thompsons leading the way, Temecula Valley has emerged as one of the top programs in Riverside County. The Golden Bears captured their second consecutive Southwestern League championship and fourth in five years. Thompson came to Temecula Valley in 1991 and took over the varsity program after the '96 season. He turned to those closest to him for help, choosing as assistants his brothers, Danny and Bill, the father of Billy and Johnny. Two years later, Andy Thompson left a coaching post at Los Alamitos, moved to Temecula and took over for his brothers as Rico's right-hand man. "We all followed big brother out here," he said. "Few things in life are perfect, but this is one of them. This is what I've always wanted to do." Thompson views his younger brother as more of a co-head coach than an assistant. The two complement each other and rarely have moments of heated debate. "We're like-minded, and that goes beyond basketball," Thompson said. "It's also about character and teaching the kids values. There are those times when we don't see eye to eye, but we can work things out quickly because we are family."

Thompson might be dad and uncle to the Thompson teens, but those titles get thrown out when they hit the court. During games and practices, Thompson is coach, nothing more. "We realize it has to stay professional," Billy said. Keeping those boundaries wasn't always easy for Thompson, especially during his son's freshman season. Whether Ricky would play varsity or junior varsity was a tough decision. "I wanted one thing as his father and another thing as his coach," Thompson said. "In that case, mom stepped in." Ricky played junior varsity as a freshman and moved up to varsity as a sophomore, when he was joined by Billy. Having family on the team led to another issue — whether Thompson was giving favorable treatment to his son and nephew. "It comes up constantly, but I think I've been blessed with a son and nephews who can play the game," Thompson said. "Of course there's an instinct to favor your family, but you have to put that aside for your own integrity."

Ricky has heard taunts of "daddy's boy" more than once. They were tough at first, but Ricky said he has learned to play through it. Billy and Ricky are two of the Bears' senior leaders. Billy, the starting center, is averaging 15.4 points and 10 rebounds, while Ricky, the starting point guard, is averaging 13.1 points and five assists. Johnny Thompson, who joined his brother and cousin on the varsity team this season, has had limited action as a sophomore but has learned valuable lessons. "It's special, being able to learn from Billy and Ricky as players and from Rico and Andy as coaches," he said. With the season winding down and Ricky and Billy set to graduate this year, the Thompsons are making sure to cherish this rare experience. "The one word I use to describe it is fun," Andy Thompson said. "Whether we're making a trip to Hawaii or just down the road to San Diego, we're always having fun."

# FOOTBALL RULES CHANGES FOCUS ON ILLEGAL HELMET CONTACT

INDIANAPOLIS, IN (February 12, 2007) — In its continuing emphasis on illegal helmet contact in high school football, the National Federation of State High School Associations (NFHS) Football Rules Committee reorganized and clarified several rules with the intention of further reducing the risk of injury in the sport. Rules revisions regarding illegal helmet contact were among 14 rules revisions made by the committee at its January 20-21 meeting in Indianapolis. The rules changes were subsequently approved by the NFHS Board of Directors.

In Rule 2, the committee placed butt blocking, face tackling and spearing under the heading of "Helmet Contact — Illegal" to place more emphasis on risk-minimization concerns. In Rule 9-4-3, the committee added a note that lists examples of some types of illegal helmet contact that could result in disqualification.

Examples of illegal helmet contact that could result in disqualification include, but are not limited to: a) illegal helmet contact against an opponent lying on the ground; b) illegal helmet contact against an opponent being held up by other players; and c) illegal helmet-to-helmet contact against a defenseless opponent. In addition, the committee formulated a definition of a flagrant foul, an often-used term in the rules book but which previously was not specifically defined. A flagrant foul will be defined as a foul that may or may not involve physical contact, but involves such acts as fighting, contacting a game official, fouls so severe as to place an opponent at risk, persistent or extreme abusive conduct and the use of vulgar language or gestures.

"While these changes mostly involve reorganization, the committee is confident that the rules now place a stronger emphasis on flagrant acts and illegal helmet contact," said Bob Colgate, NFHS assistant director and liaison to the Football Rules Committee. "These revisions continue our ongoing emphasis on risk minimization and good sportsmanship."

"Annually, the NFHS Football Rules Committee has sought ways to better promote the health and physical welfare of the participants and cultivate the high ideals of good sportsmanship," said Brad Cashman, executive director of the Pennsylvania Interscholastic Athletic Association and chair of the NFHS Football Rules Committee. "The rules committee has again raised the standard in regard to both areas of concern."

Changes in the football game jersey specifications that were approved last year for implementation in 2010 were revised slightly this year, and the implementation date was moved back to 2012. The revised rule will still require the visiting team's game jerseys to be white and contrast with the home team's jersey.

"The changes made this year by the committee will provide manufacturers and schools a clearer direction on the specifications," Colgate said. "The committee extended the implementation date to give schools an opportunity to make the necessary adjustments during the normal uniform rotation and replacement cycles during the next five seasons."

In Rule 8-2-2, an enforcement option has been added when there is a foul by the opponent of a team scoring a touchdown. In addition to its previous option of accepting the result of the play and having the penalty enforced on the try-for-point, the scoring team may choose to have the foul enforced on the ensuing kickoff.

Two changes were made in Rule 1-2-3 regarding "The Field and Markings." A 4-inch-wide broken restraining line is now required around the outside of the field, and the line must be at least two yards from the sidelines and end lines. The only exception to this rule will be in stadiums where the total field enclosure does not permit the line. In addition, a line, 4 inches wide by 12 inches long, that bisects the limit line at each 5-yard line extended, may be used. "These lines are used to assist line-to-gain crews, as well as providing additional safety features for players, officials and sideline media; helping game officials with an unobstructed sideline operating area; and providing coaches with an unobstructed view from the coaching box," Colgate said.

Rule 1-2-3 now will also provide rule support for the location and dimension of a three-yard line marking that appears on the field diagram. A line, 4 inches wide by a minimum of 24 inches in length, shall be centered and placed three yards from each goal line. The committee added two new articles to Rule 10-4 regarding basic spots for enforcement of penalties. The basic spot will be the 20-yard line for plays when the end of the related run is in the end zone followed by a loss of possession and the ball re-enters the playing field and then goes out of bounds.

Following are other changes approved by the Football Rules Committee:

- Added the word "legal" to the definition of a passer to help clarify Rule 2-31-11.
- Provided an opportunity for a coach who assumes the head coaching responsibility during a game (when the head coach has been disqualified) to call a time-out.
- Beginning with the 2008 season, required forearm pads to meet same specifications as gloves and hand pads as set forth by the Sporting Goods Manufacturers Association in 1994. The new rule will require forearm pads to have the NFHS/NCAA label attached beginning in 2008.
- In six-, eight- and nine-player football, reduced the free-blocking zone to a zone three yards on either side of the snap and three yards behind each line of scrimmage.

In terms of the number of participants, football is the most popular high school sport for boys. According to the 2005-06 NFHS High School Athletics Participation Survey, 1,071,775 boys played 11-player football, with another 25,000 involved in six-, eight- and nine-player football. In addition, 1,264 girls played high school football in 2005-06.

offered has increased exponentially. We now have 450 schools playing football, 445 playing soccer and 390 playing golf. Basketball is the biggest by far; 533 schools fielding teams. Lacrosse was just introduced and we continue to offer field hockey, gymnastics and badminton. We have gone from a boy's only institution to include both genders. Transfers, which were once unheard of, now happen regularly. Litigation and legal work takes up more time than ever before. Last year we processed over 500 hardship requests. 3.000 transfers as well as bona fide residence changes. And now, we have the time consuming wrestling weight management program to add to one commissioner's duties.

Changes in technology enhance our ability to communicate but computers and web site providers cost a great deal to purchase and maintain.

The Executive Committee agrees that the time has come to add another position to allow the office to serve our schools. The last Assistant Commissioner was added in 1975 with the arrival of girls' sports. Since 1975 the CIF has grown by over 100 schools and several sports. Every year the need to mentor and train athletic administrators increases. With new schools come new administrators.

Our goal is to provide a high level of service to our members. That means a highly qualified person available to answer questions and offer advice. It means effective communication not only to schools, but to legislators, principals and superintendents. We must help our schools investigate wrongdoing by some and assist families who legitimately seek help for their athletes. We have reached out to all of our nine areas to provide them with the fall packets and informational seminars on new rules.

This is a way of saying that, to ensure our financial future; we must identify a revenue stream to take us into the next five to ten years. We will offer our Council a plan that will have as little effect on their finances as possible as we move into a new era of service and support.
