

COMMISSIONER'S CORNER

AREA PLACEMENT/ RELEAGUING

One of the biggest issues and concerns that our member schools have involves Releaguing. Every four years, the task of configuring our leagues takes place. It is a subject that our member schools are extremely passionate about and take very seriously. The process involves having each of the nine designated areas of our section formulate a plan that places every school in that area into a league within that area for the next four years. However, before the formal Releaguing effort can begin, another important task must be accomplished that has a major effect on the ability of our areas to form viable leagues. That situation is called Area Placement.

Area Placement often gets ignored because of the much larger focus our schools put on Releaguing, but the decisions made regarding Area Placement can have a tremendous impact on how an area can arrive at a league configuration that works best for that area. We are currently involved in the Area Placement process for the 2014-2018 Releaguing Cycle. What that means is we are following the current CIF Southern Section Blue Book rules toward establishing the areas for our member schools so they may begin to develop their area's Releaguing Plan. To gain a better understanding of these Blue Book Rules, I suggest you visit our web-site, www.cifss.org, where the entire Blue Book is available for you to download.

This year, some new Blue Book Rules will be applied to Area Placement for the first time. Specifically, the CIF Southern Section Office now has the responsibility of developing the Area Placement plan for our section. Here is the process we are following...

1) We surveyed the principals of our member schools to ask if they wished to remain in their current area or wished to be placed into a different area. The surveys were mailed out on September 14, 2012 and were due back in our office by October 12, 2012. A key component of this survey is a requirement that schools are only allowed to address their own placement into an area, they cannot address issues involving other schools in their area.

2) The results of our survey indicated that approximately 95% of our schools requested to remain in the area they are currently in.

3) On October 24, 2012, our office staff met with the Releaguing Chairmen from the nine areas to review the survey requests and discuss issues and concerns in each area.

4) On November 26, 2012, the CIF South-

1. Proposal from Boys and Girls Water Polo Advisory Committee to create a 16-Team Playoff Bracket. Seeded 1-16 to be presented by Ethan Demato and Eric Henninger - Action/Exec. Cmte. Supports - There was a motion and a second to support SS446. The vote was tied, therefore the motion failed.

4. NON-ACTION SESSION

A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

1. Proposal for Statewide Football Tie-Breaker - Discuss - State championships will continue to follow NFHS rule which is 10 yards. Many sections would like to have the option of a "section" specific guideline. The Southern Section football advisory committee would like to keep the 25 yard rule. There are only two sections that have a tie breaker system in place currently. Many games (in other sections) will end in ties.

2. Proposal for Addition of Bylaw 300.D Gender Identity Participation - Discuss - There was no discussion on this topic.

3. State Commissioners' Proposal to Define Bylaw 510, Athletic Motivation - Discuss - This added language would provide more examples of "athletic motivation" (camps and clinics are added to the pre-enrollment contact component with other evidentiary pieces as well).

B. SOUTHERN SECTION NON-ACTION ITEMS

1. Proposal from Pacific Coast League for Addition of Bylaw 1903.1 to the Physical Conditioning Practice to be presented by Mark Cunningham - Discuss - With the change of the football start date, it was challenging for schools to get their required practices in before their first game. Labor Day. Many schools lost their scrimmaging opportunity. This adjustment would take care of early starts, number of practices, etc. It doesn't matter if the calendar ends up going back. This proposal will work regardless.

5. NEW BUSINESS

A. Marketing Report - John Costello - Big emphasis on the 2013, CIF-SS 100 year anniversary. FOX has been creating vignettes and informational pieces to help promote this milestone. Our supporting partners have been integral in promoting and funding the event. We will be presenting "100 Athletes for 100 Years"; a fantastic representation of the rich athletic history in our community. Your continued support in hanging banners to showcase our supporters is greatly appreciated.

B. Public/Private Report - Rob Wigod/Scott Raftery - Members from both public and private schools represent this committee exploring issues and misconceptions of one another. Most recently they talked about area placement, but also got some historical facts as the separation of public and private has been discussed in past. Public schools are frustrated with limitations on fund raising. Private schools are facing decreasing enrollment because of the economy. Public schools are eliminating transportation and starting games later, forcing students to find their own transportation to games. There is a feeling that the sport of basketball is driving many of the issues at hand.

Rob has formed a "Private School Leadership Committee" to expose the private school leadership to "the know" of high school sports. Private schools have a different administrative hierarchy; involving some of these leaders will help further bridge the understanding of challenges both groups face.

6. REPORT SESSION

A. President's Report - Jim Monico - The "Champions for Character" dinner took place honoring fantastic students, administrators, schools and leagues in our section. Thanks to the individuals putting that event together and FOX for their support and coverage. Staff was commended on their work as was the communication in the office. Twitter, Facebook, CIF-SS Home and the CIF-SS website has been an integral part.

B. Commissioner's Report - Rob Wigod - We are excited about the centennial and looking forward to the celebration of that event and the history of what this organization does. CIF-SS Home has been a great addition to the efficiency and ease of information exchange. San Diego has picked this up and it is anticipated that other sections within the state will too. The section is successfully implementing the new transfer rules.

This is the first year we were able to award scholarships at the "Champions for Character" dinner. We can do that with the support of our golf tournament. Please continue to nominate deserving individuals for those awards.

Be aware of the upcoming "area placement" and "re-leaguing" timeline. Pay special attention to the "area placement" timeline as the "re-leaguing" portion dates may be pushed back.

Please support the cause by "liking" the CIF-SS on Facebook. We are here to serve and we encourage open lines of communication to our office.

C. Treasurer's Report - Carter Paysinger - The annual audit was completed and accepted by the Executive Committee. The Southern Section had

a profit over \$111k with our net assets at \$3.2 million (cash, investments, inventory, property and equipment). \$188K in total liabilities. We are continuing the commitment to technological advancements to improve the efficiency of information exchange at no cost to the member schools. We will continue this practice evolving CIF-SS Home software and committing to on going refinements. The office is in the midst of network transition. The CIF building was recently painted and sport graphics added. 33% of budget has been spent YTD on the 100th year anniversary celebration. 554 schools have paid sports fees, \$452k in revenue (fees only account for 12% of total revenue), 25 schools outstanding as of 10-25-12.

5) There is an appeals process available to schools who believe they have been placed inappropriately and schools who appeal may only address the appeal to their own school's placement in that area, not the placement of other schools into their recommended area. The appeals process will be concluded by March 20, 2013. After that date, Area Placement will be complete and Releaguing can begin.

B. SOUTHERN SECTION ACTION ITEMS

1. Proposal from Boys and Girls Water Polo Advisory Committee to Create a 16-Team Playoff Bracket, Seeded 1-16 - Discuss/Recommend -Discussion: There was concern of this format being adopted by other sports. This is an opportunity to look at a different model and the other sports will be looking at this to see if it works. This process will only be used in the first round. Because the administrator over water polo was excused for this meeting, it was moved and seconded to bring this item back to the October 11, 2012 Executive Committee meeting for further discussion. The motion carried.

4. NON-ACTION ITEMS

There were no State Federated Council or Southern Section non-action items.

5. NEW BUSINESS

A. Undue Influence Sub Committee - Nancy Billinger stated the she and committee members Loren Kleinrock, Carter Paige, Reggie Thompkins and Rob Wigod will meet to further discuss this item.

B. NFHS Summer Meeting - The meeting was attended by Rob Wigod, Thom Simmons, John Costello, Jim Monico and Dan Burch.

Jim Monico attended the Board Members Reception. They discussed virtual schools, reducing the number of appeals and public private issues. He stated the State of Kansas got out in front of this item by going to their legislators and stating if you are a virtual school you will not be a member. It is defined as a school that operates only online. If a student is taking one course and is attending a regular school, he can participate. If it is strictly an online school, you may not be a member or participate. There is August 16, 2012

a lot of discussion on this topic and will come to California at some point.

Jim also attended a session on concussions. He learned that mouth guards do not play a role in concussions. He attended a Paralympics discussion where they talked about the athletes in this year's Olympics. He also attended a session on a cheerleading type of competition called Stunt. This discussion came about because it is a college sport even though cheerleading is not considered athletic. This will count in the Title IX points. They are looking to take some of the risks out of stunting at the high school level and to limit the number of championships. This is an alternative to competition stunting.

Dan Burch attended the concussion session and a session on how to use technology. He also attended round table discussions and the most popular topic of discussion was about students transferring schools. A solution from the State of Kentucky on stopping transfers was to win a very high profile court case.

Reggie Thompkins learned that legislators in Florida have taken over the Florida Athletic Association and give a lot of freedom to the transferring students. Dan feels that CIF has done a great job of avoiding the legislature coming in to govern us. Florida now has no control because the state legislature has taken over.

Financial Report - Mitch Carty - Mitch C. Carty distributed his report and discussed 2011-12 financial information. We are up 4% and kept our expenses to about \$6,000 over last year.

D.100th Anniversary Celebration - Thom Simmons discussed the timeline for the Centennial Celebration. We are finished with about 90% of the work required for the event. He showed the banners that were mailed to all schools and stated the original charter member schools received special banners naming them as Charter Members of CIF. At the culminating ceremonies, there will be interviews with famous athletes who went back to their high schools and were interviewed. Jim Staunton and John Dahlem are creating the yearbook. The final events will take place at the At&TUVerse Theatre. Lynsey Rhodes will be the Mistress of Ceremonies. They have reached out to CIF heroes who will go out to different sports games. They are in the process of finalizing the 100 Greatest Athletes and will not release this list until the night of April 13, 2013. These are not the 100 greatest athletes of the last 100 years they will be called the 100 Athletes for 100 Years.

Thom also discussed the inaugural CIFSS Football Media Day that will be held on August 22, 2012. This will be a kickoff for our Fox games and the football season and will be held in the commissary on the Fox Lot. There will be 16 teams coming as well as media representatives.

Rob thanked Thom for his work in making this a very special year for us. We feel honored to be celebrating this organization. The message we give to the schools is that this year is the time to celebrate what everyone committed to CIF does. He also stated there were 32 Olympians who received medals this year and they are from the Southern Section. Their pictures were placed on our website.

E. Eligibility Report - Scott Raftery reported some of the changes in the rules for 2012-13. Tennis will have a Southern California regional beginning this year. Football entries will no longer require a .500 overall record. All leagues are in the new playoff grouping for the next two years. Appeal Hearings may be granted for specific areas only per Bylaw 207B(5)c.

6. CLOSED SESSION

Closed Session began at 1:55 p.m. and ended at 2:40 p.m.

A. Commissioner's Goals - Rob Wigod - Jim Monico reported during the closed session, the Executive Committee took action and adopted the 2012-2013 Goals submitted by the Commissioner. 7. REPORT SESSION

A. President's Report - Jim Monico - Jim Monico stated he went to the 2011-12 Graduation Ceremony of Ayala High School and it was a top notch event. He thanked Mitch for the excellent budget report, the commissioners for the information on the transfer eligibility rule changes and he commended Thom for the preparations for the Centennial Celebration. He is looking forward to a good year and enjoying it with the other members of the Executive Committee and what it will bring to the organization.

B. Treasurer's Report - Carter Paysinger - The Treasurer's Report was discussed during Mitch's report.

C. Commissioner's Report - Rob Wigod - Rob Wigod reported that the CIFSSHome summer trainings had 40 people during each of the sessions. Many days there were two sessions held. We have been doing the Fall Workshops combining the new system information with the new rules. We have been to the Citrus Belt, Foothill-Citrus, Orange County, High Desert and Northern Areas and the turnout has been great. We had 80 people at yesterday's training. The Champions for Character Awards Dinner is scheduled for Monday, October 1, 2012 in the Grand Salon of The Queen Mary. The golf tournament on June 19th was the most successful ever. There were 145 players and the proceeds will allow us to give \$500 scholarships to the student Champion for Character awardees. We also have a new award, the Commissioner's Award, for schools doing specials things for another school, a student or their community. Rob also invited the Executive Committee members to attend the Distinguished Service/Hall of Fame Luncheon immediately following the Council meeting on October 25 and thanked everyone for the help and support given to him this past year. He is looking forward to a very special year.

Jim Perry - Jim is representing CAHPERD on the State Federated Council and is grateful to see the entire picture by participating on the Southern Section Executive Committee.

E. AdoptAgenda – Action - There was a motion and a second to bring item 6A, Legal Update, forward to the beginning of the meeting and to adopt the agenda as amended. The motion carried.

F. Approval of Minutes

1. Minutes of the August 16, 2012 Executive Committee Meeting–Action-There was a motion and a second to approve the minutes of the August 16, 2012 Executive Committee meeting. The motion carried.

2. PUBLIC HEARING SESSION

A. Recognition of anyone wishing to address the Executive Committee. Speakers must limit their remarks to three minutes. - There was no one present to address the Executive Committee. <u>3. ACTION ITEMS</u>

A. STATE FEDERATED COUNCIL ACTION ITEMS

1. Revision of CIF State Football Championship Bowl Format - Discuss/Recommend - Discussion: There is a problem with the revision language. Issues with the proposal were that some of the language violated Bylaw 511; it stated there was not a State Championship and the San Francisco and Oakland Sections play a bowl game against each other. The proposal stated they could continue with their bowl game. The author is aware of the changes needed and if the item is corrected in time, it will be brought forward to State Federated Council. - There was a motion and second to support with the changes to be made. The motion carried.

2. Remove All References to "Athletically Motivated" and "Transferring for Athletic Reasons" from the CIF Constitution and Bylaws – Discuss/ Recommend - It was moved and seconded to support. The motion carried.

B. SOUTHERN SECTION ACTION ITEMS

1. Proposal from Boys and Girls Water Polo Advisory Committee to Create a 16-Team Playoff Bracket, Seeded 1-16 – Discuss/Recommend -Discussion: Kristine Rach stated that this proposal would create a bracket seeded 1 – 16 to create a playoff tournament where qualifying teams will be ranked based on specific criteria and seeded within the playoff brackets accordingly. The Water Polo Committee ranks teams every year and justify seeds by records. Quantitative data places each team in the proper seed. Seeds 1 – 8 will play seeds 9 – 16 in the first round only. - It was moved and seconded to support. The motion carried.

4. NON-ACTION ITEMS

A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

1. Proposal for a Statewide Football Tie-Breaker - Discussion: Rob Wigod stated this item had been discussed at the State Commissioners' Meeting. The Southern Section prefers the 25yard procedure along with 3 other Sections. This item is a first read at State Federated Council. The Southern Section Football Advisory Committee prefers to keep what is in place and that is the 25-yard procedure but not force the other Sections to follow. Roger Blake stated he felt all Section should have the same qualifying criteria. The State Executive Committee would like a decision but there was no movement by any of the Sections at the last Commissioners' Meeting.

2. Proposal for addition of Bylaw 300.D Gender Identity Participation - Discussion: This item is language to use when processing a trans-gender athlete

3. Commissioners' Proposal to define Bylaw 510, Athletic Motivation - Discussion: The Section Commissioners are looking for clear language on athletic motivation. Nancy Blazer, Commissioner, Central Coast Section, is rewriting this item to make the definition of athletic motivation clearer. On page 3, items a, b and c define athletic motivation. On page 4, item 2 adds camp or clinic which is a significant addition that shows prior contact. In item 3, club coach is added. Item 4 adds the ability to use material from public websites. The entire state wants to define athletic motivation clearly and with this proposal they have tried to streamline and clearly define.

B.SOUTHERN SECTION NON-ACTION ITEMS

1. Proposal from Pacific Coast League for addition of Bylaw 1903.1 to the Physical Conditioning Practice - Discussion: This item was authored by a member of the Football Advisory Committee. It creates a formula to calculate the start date for football by adding item d, "the week of the first game..." solves the issue of the number of practices and allows for scrimmages before the first game.

5. NEW BUSINESS

A. Undue Influence Sub Committee - Nancy Billinger will meet with committee members and will report at the January meeting. They will address undue influence and how it limits the perception of the public and how we deal with it.

B. NFHS Section 7/8 Meeting - The meeting was attended by Rob Wigod, Jim Monico, Reggie Thompkins, Glenn Martinez and Nancy Billinger.

Jim Monico discussed the different sessions he attended. Weight levels in female wrestling are being addressed. Reggie Thompkins stated the meeting was well rounded and organized. He brought very good information back to his school. The State of Montana is having many difficulties with the Indian Tribes and the biases associated with them. Nancy Billinger appreciated the opportunity to attend.

C. Marketing Report - John Costello - John discussed the marketing and sponsor updates.

D. Area Placement - Rob Wigod - Rob Wigod stated a new process has been implemented. Requests for changes of areas will be due on October 12, 2012. On October 24, he will meet with the Releaguing Chairs. At the January Executive Committee, the Area Placement configuration will go to the Executive Committee for approval. Once that has been approved, releaguing will begin.

He also stated that every student received a \$500 scholarship check. He commended the staff for their work on the upcoming Centennial Celebration. He was also very pleased with the status of the SOP and how well it has been received by the public.

B. Treasurer's Report - Carter Paysinger - Carter Paysinger read the report.

Charlie Ricards – Complemented staff because he feels the new website is working well and appreciates how updates are done so quickly.

Thom Simmons – Next Wednesday is the annual golf equipment giveaway. He asked everyone to let as many people know as possible.

Rainer Wulf – The cifsshome.org web system was a huge challenge and the office staff was to be commended for the hard work in taking care of the glitches and errors found in the beginning. He also discussed his site visits to schools and seeing the organized, positive student activities.

Kristine Rach – She is looking for ways to expand the Student Council Committee. She is considering having leagues combine their student leadership with athletes to promote more involvement of students. She would like to go out to the schools in order to improve the outreach to students.

STEVE SARKISIAN SPEAKS AT 36TH ANNUAL FOOTBALL PRESS CONFERENCE AND LUNCHEON
