SIX CIF SOUTHERN SECTION-FORD DUAL MEET WRESTLING, PRESENTED BY FARMERS CHAMPIONSHIPS TO BE AWARDED THIS WEEKEND

LOS ALAMITOS — In the 21st year of the one-day tournament format, the six divisional championships of dual-meet wrestling will be held this Saturday, Feb. 6.

Saturday's tournaments are scheduled to start with first-round action beginning at 11 a.m., second-round action at 3 p.m., preliminary finals at 5 p.m. and the championship finals at 7:15 p.m. (All times approximate). Weigh-in is to begin at 9 a.m.
