SIX CIF SOUTHERN SECTION-FORD DUAL MEET WRESTLING, CHAMPIONSHIPS TO BE AWARDED THIS WEEKEND

LOS ALAMITOS — In the 22nd year of the one-day tournament format, the six divisional championships of dual-meet wrestling will be held this Saturday, Feb. 4.

Saturday's tournaments are scheduled to start with first-round action beginning at 11 a.m., second-round action at 3 p.m., preliminary finals at 5 p.m. and the championship finals at 7:15 p.m. (All times approximate). Weigh-in is to begin at 9 a.m.

Top seeds for each division include Northview (Central Division), St. John Bosco (Coastal Division), Sultana (Eastern Division), Righetti (Northern Division), Irvine (Southern Division), and Mayfair (Western Division).

Wrestling sites for the six divisions are as follows; Central Division – Alta Loma HS; Coastal Division – Marina HS; Eastern Division – Santiago/Corona HS; Northern Division – Dos Pueblos HS; Southern Division – Redondo Union HS; and Western Division – Lakewood HS.
