# CIF-SS COUNCIL MEETING MINUTES

## January 24, 2018

### 1. OPENING BUSINESS

A. Call to order by Carter Paysinger, President of the Council: - Call to order at 9:06 a.m.

B. Pledge of Allegiance

C. Roll Call

D. Introduction of Guests - Brian Seymour – CIF State Office - Steve Fryer – Orange County Register

E. Adopt Agenda - Motion and 2nd to approve the agenda as written. Motion passed 69-1-3

F. Approval of Minutes

1. Minutes of the October 3, 2017 Council Meeting - Motion and 2nd to approve the minutes as written. Motion passed 74-0-2

### 2. PUBLIC HEARING SESSION

A. Recognition of anyone wishing to address the Council. - -Speakers must limit their remarks to three minutes. - Tim Ballaret – Special Olympics and Unified Sports. His goal is to help bring Unified Sports to the high school campus. Tim gave a brief description on how the activity or event can look on the individual campus. Grant funding is available and he is simply here to make schools aware and offer his services. Gary Bohamed – Water Boy Sports – Proud sponsor of the CIF Southern Section. They are here today to promote their product and they brought with them today a sample of the product and how it works. The product is designed to provide a healthy way to fill water bottles during an athletic event without removing the lid.

### 3. ACTION ITEMS

A. STATE FEDERATED COUNCIL ACTION ITEMS

1. Proposed Revision to Bylaw 207 – Transfer Eligibility, International Students - Motion and 2nd to approve. Discussion: A question was asked about the additional language added in Bylaw 207.A(3) which reads, "Evidence that multiple students have transferred or changed schools to participate in a particular sports program at one school." (CIF Bylaw 510E)  
Motion passed 60-20-2

2. Proposed Elimination of Bylaw 1605 – Basketball Coaching Box - Motion and 2nd to approve. Discussion: None Motion passed 81-0-1

B. SOUTHERN SECTION ACTION ITEMS

1. Proposed Revision to 2018-2019 Sports Calendar – Baseball/Softball - Proposal was presented by Tom Fox,

Crestview League Representative, who gave the history on why this proposal was reintroduced after narrowly being defeated last April. Motion and 2nd to approve Discussion: None Motion passed 51-31-0

2. Proposed Revision to 21-Day Summer Dead Period - Proposal was presented by Jeff Williams, Golden League Representative. Motion and 2nd to approve. Discussion: None Motion passed 80-2-0

### 4. NON-ACTION ITEMS

A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

1. Proposed 2018-19 State Budget No CIF State Budget submitted at this time.

2. CIF President Elect and Executive Committee Nominations - Southern Section President-Elect, Dr. Monica Colunga, agreed to have her name forwarded for consideration for President-Elect of the CIF Executive Committee.

3. Proposed Bylaw 208.A(4) - Foreign Exchange Programs Host Famil - This proposal would allow for Limited Eligibility for a Foreign Exchange student who resides with a paid or volunteer coach-

ing staff member at the school of enrollment. Current policy prohibits athletic eligibility when the student is hosted by a coach either paid or voluntary.

4. Proposed Bylaw Revision 504.M – Day of Respite - Proposal requests a change in how an alternate day of respite would be determined. The schools that do submit paperwork for an alternate day of respite would identify an actual 24-hour time period, not simply a day, i.e. Saturday.

5. Proposed Bylaw 502 – Competition vs. Non-CIF Member School - The Commissioners Committee is proposing a revision to further clarify who a CIF member school is allowed to play. Schools outside of California must be members in good standing with their respective State Association and must also be eligible to compete in that State Association's Championships.

6. Proposed Bylaw 2001.B Revisions – Football Full Contact Allowance - Proposal calls for a reduction of full contact football practice from 180 minutes per week to 90 minutes per week broken into no more than 45 minutes per day, twice a week. The time limitation applies only to full contact. A possible

revision and clearer definition may be brought forward as to the definition of "full contact".

7. Proposed Bylaw Revisions 211 and 303 – Continuation School - The Commissioners Committee is proposing a revision to Bylaws 211, Continuation School Eligibility, and Bylaw 303, Multi-School Membership, that would revise the athletic eligibility of students who attend a Continuation High School. Students could not use this as an avenue toward eligibility if they were placed in the Continuation School due to a disciplinary issue. This proposal is an outcome and direction from the Federated Council Roundtable discussions held in January, 2017.

8. Proposed Bylaw Revision 201.A.4 - The proposed bylaw revision would allow coaches to communicate directly with incoming 9th grade students/parents beginning May 1st who have registered for classes at the CIF member school and, in the case of a private school, paid a non-refundable registration fee.

9. Proposed Bylaw 207.B(5).c(viii).e Move – Return to Previous School - Bylaw 207.B. (5).c. (viii). (e) Regarding Return to Previous School without participation is presently listed under Hardship Waivers in the Blue Book. The Commissioners Committee is recommending moving the bylaw to a more appropriate place in CIF Bylaw 207, Transfer Eligibility, Non-Participation.

### B. SOUTHERN SECTION NON-AC-TION ITEMS

1. Proposed 2018-2019 Southern Section Budget - Mitch Carty presented the proposed 2018-2019 Southern Section 18-19 Budget. Mitch explained that sports revenue continues to remain flat. We have seen increased revenues in Marketing. We have also made efforts to cut expenditures where possible and use outside partners to offset traditional costs, for items like tickets. Mitch submitted and recommended a 2% COLA increase for Southern Section staff. The proposed budget also includes a new staff position overseeing digital content, which encompasses the website and social media.

2. Proposed Revision to Bylaw 23.1(j) & 24.2 – New Member Application Due Date - This revision would change the application date for new member schools from May 1 to April 1.

3. Proposed Revision to Bylaw 70.8 – Number of Executive Committee Meetings - This revision would change the

number of required regular Executive Committee meetings from six to five. With the move from four Council meetings to three several years ago there is no longer a need for the Executive Committee to meet six times each year.

4. Proposed Revision to Bylaw 2003.3 - Use of Full Pads on First Day of Practice - This revision would allow the use of full pads on the first allowable day of fall practice provided that the requirement of three mandatory conditioning days is met prior to that day.

5. Proposed Revision to Bylaw 2021.3 and all sports sections - This revision would allow the required three weeks of the Summer Dead Period not to be taken consecutively.

6. Proposed Revision to Bylaw 3303 – Water Polo Host Teams - This revision would allow in the sport of Water Polo, Division 1 only, the higher overall seed will remain the home team for all rounds throughout the Southern Section play-offs.

7. CIF Southern Section Executive Committee Nominations - Mike West, Principal of ML King HS, and Dr. Nancy Kelly, Superintendent Upland USD, were introduced as President-Elect Candidates for the position of Southern Section President-Elect for 2018-2020.

### 5. REPORTS

A. Treasurer's Report - Jeff Jordan - Treasurer Jeff Jordan noted that as of this date the Southern Section shows a net income of \$692,000. Football revenue sharing is \$454,239 to member schools, while Volleyball revenue shares to schools is \$37,541.

B. President's Report - Carter Paysinger - President Carter Paysinger focused on the role of the athletic trainers and the need for a site action plan for each sport. He then reminded all member schools to make sure the emergency action plan that you have in place will work in all situations during school, after school, for students and parents. He asked the question, "Where are the AEDs located at your site." Finally, he applauded the work of the Commissioner and the Southern Section staff for continuing to demonstrate excellence.

C. Commissioner's Report - Rob Wigod - Commissioner Rob Wigod reminded everyone that the state of the CIF-SS is strong. Fall Playoffs saw several new schools win section championships and the margins of victory in numerous contests were much closer, especially during the opening rounds of the playoffs. Please continue to promote the #PacktheHouse program to help increase revenue back to member

schools. Ontario Christian High School and Moorpark High School were the two schools recognized for their efforts toward this program from the Fall season and each will be receiving \$1,000 grants from the Southern Section office. Rob announced that the Hall of Fame/Distinguished Service and Champions for Character Award nominations are both due by May 1. The Champions for Character Golf tournament held at Rio Hondo Golf Club that supports this program will be on June 19, 2018. Rob continued by lauding CFO Mitch Carty for his work on our behalf in the financial area. Finally, Mr. Wigod is very pleased with the active discussions that take place at Council Meetings on various agenda items. This feedback is critical in understanding particular proposals and shows that we are doing what is best for the membership and the student-athletes.

# MINUTES OF THE EXECUTIVE COMMITTEE MEETING

## January 13, 2018

### 1. OPENING BUSINESS

A. Call to order by Carter Paysinger, President of the Council

The meeting was called to order at 9:50 a.m. by President, Carter Paysinger. Carter welcomed everyone to Riverside.

B. Pledge of Allegiance

C. Roll Call

D. Introduction of Guests - There were no guests present.

E. Adopt Agenda - There was a motion and a second to approve the agenda. Motion carried 23-0-0.

F. Approval of Minutes There was a motion and a second to approve the minutes of the September 28, 2017, Executive Committee meeting. The motion carried 23-0-0.

### 2. PUBLIC COMMENT

A. Recognition of anyone wishing to address the Executive Committee. Speakers must limit their remarks to three minutes. There was no one present to address the Executive Committee.

### 3. ACTION ITEMS

#### A. STATE FEDERATED COUNCIL ACTION ITEMS

1. Proposed Revision to Bylaw 207 – Transfer Eligibility, International Students - Monica Colunga reviewed the proposal to revise CIF Bylaw 207 regarding the eligibility of International Students who are not in the United States as a result of a valid residence change, approved Foreign Exchange program or Hardship. There are a variety of companies promoting international students to come here and attend our schools. There was a motion and a second to approve the proposal. Dave Reid asked what the other sections are saying about this proposal. Rob Wigod explained that this was the rule five years ago and it was removed from Southern Section bylaws because of a conflict with State bylaws and the State bylaw has never been changed. Roger Blake is distributing information regarding how many students this change will impact. Loren Kleinrock asked what is this youth study that is in the agenda. Rob Wigod stated that these are companies working with school that are basically setting up their own foreign exchange programs and not randomly placing students. Chris Calderwood asked if this does not pass, can we reintroduce it at the section level to bring us back to where we were five years ago. Rob Wigod said that the CIF State is in support of it and if it does not pass, there should still be an effort to get this done. The motion carried 23-0-0.

2. Proposed Elimination of Bylaw 1605 – Basketball Coaching Box - Monica Colunga reviewed the proposal to eliminate CIF Bylaw 1605, the Basketball Coaching Box. This rule is redundant as it also appears in the National Federation Rule Book. There was a motion and a second to approve the proposal. There being no discussion, the motion carried 23-0-0.

#### B. SOUTHERN SECTION ACTION ITEMS

1. Proposed Revision to 2018-2019 Sports Calendar – Baseball/Softball - Carter Paysinger reviewed the proposal. It is asking to move the season of sports dates for Baseball, Softball, Girls Tennis, and Boys Volleyball to align with the CIF State and other sports. There was a motion and a second to approve the proposal. Terry Barnum asked if there is a sense that the Council is ready to say yes to this. Rob Wigod explained that the office has been attending league meetings in the effort to address any questions and issues the leagues may still have regarding these changes. We reached out to the leagues that voted yes with a statement that the proposal was being reintroduced and asking for their continued support. Mike Middlebrook stated that there are still a couple of holdout leagues that want to leave the calendar as it stands. Glenn Martinez added that the larger leagues are deferring to the smaller leagues and those that were in support are still in support. Thom Simmons stated that the leagues are positive where he has been in attendance. There are few questions and once you explain that they set their own schedules and do not have to start on the very first day, they become more positive about it. Dick Billingsley asked if there are leagues changing their positions. Chris Calderwood answered that there are Inland Empire schools that have gone from yes to no. Glenn Martinez echoed Thom Simmons' statement about the scheduling

and it is up to the school whether or not to start on the first day. Rob Wigod added that the Baseball Advisory Committee is in support, but the Softball Advisory Committee is not quite yet. Rainer Wulf stated that there are going to be scheduling challenges that have to be worked out but there already were challenges in the spring with AP testing and graduations. The motion carried 23-0-0.

2. Proposed Revision to 21-Day Summer Dead Period - Carter Paysinger reviewed the proposal. This is a request to move the available start date of the summer dead period up one week, from the first Friday in June to the last Friday in May, as Football is starting earlier next year. There was a motion and a second to approve the proposal. Terry Barnum asked if this stayed the same for all the other sports besides Football, giving them from the last Friday in May to the last Monday in August. Rob Wigod answered that this is no changing the ending date, just the first available starting date. Dead periods must still be completed by last Monday in August for all other sports, besides Football, which must complete their summer dead period prior to their first day of Fall Practice. The motion carried 23-0-0.

### 4. NON-ACTION ITEMS

#### A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

1. Proposed 2018-19 State Budget - (To Be Distributed at the CIF State Federated Council Meeting) - Monica Colunga stated that we have not received the proposed 2018-19 CIF State budget but added that the CIF State is solvent.

2. CIF President Elect and Executive Committee Nominations - Monica Colunga deferred to Carter Paysinger to review nominees. Carter Paysinger stated that we have always supported those nominees from our section and have gone uninstruced for all other positions. Monica Colunga is a candidate for CIF President-Elect.

3. Proposed Bylaw 208.A(4) - Non-Action - Foreign Exchange Programs Host Family - Monica Colunga reviewed the proposal that came from Southern Section. This proposal would allow for Limited Eligibility for students who live with a staff member at the high school. Mike West asked if this applies to any staff member and volunteers. Rob Wigod stated that it applies to members of the school's athletic staff and that students must be enrolled in an approved foreign exchange program.

4. Proposed Bylaw Revision 504.M – Day of Respite - Monica Colunga reviewed the proposal. This proposal is to change the Bylaw to a 24-hour period of respite. Those schools requesting this respite must submit paperwork and this proposal cleans up the language on that. Jill Matyuch asked what about playoffs? Rob Wigod stated that we have changed schedules to accommodate the sundown Friday to sundown Saturday period of respite. This would clarify that a school cannot play seven consecutive days or practice on Sunday after a playoff game on Saturday. This is for a 24-hour period and allows for more flexibility in scheduling. Terry Barnum asked what is the documentation for this? Rob Wigod answered that schools fill out the Alternate Day of Respite Form and send it to our office for approval. If someone played on Sunday, we would follow up on the information given to see if they were off on Saturday. The form covers the day off and is for all sports.

5. Proposed Bylaw 502 – Competition vs. Non-CIF Member School - Monica Colunga reviewed the proposal. This proposal clarifies who CIF schools are allowed to compete against from other states. The proposal states that only schools who are in good standing with their respective state associations and are eligible to compete for state championships in their states, are eligible to play against CIF member schools. Rob Wigod added that we have to approve our schools travelling to other sections and/or states through the sanctioning process and if the schools are not members in good standing in their state associations, we do not approve them.

6. Proposed Bylaw 2001.B Revisions – Football Full Contact Allowance - Monica Colunga reviewed the proposal to reduce the maximum number of minutes of full contact football practice allowed from 180 minutes per week, with no more than two days and 90 minutes each of those two

days, to 90 minutes per week, no more than two days and 45 minutes each day. Loren Kleinrock spoke to the idea that less contact practice time has shortened the body's ability to sustain that contact during a game. Monica Colunga added that more concussions occur at practice then during games and this is trying to minimize concussions. Mike West stated that less practice time has not indicated more injuries. Glenn Martinez said that the Football Advisory Committee has been ahead of this and that this is not changing what you can do, just the amount of time you can do it. Coaches are not hitting for 90 minutes twice a week now. Coaches are prepared for this even if they may not like it.

7. Proposed Bylaw Revisions 211 and 303 – Continuation School - Monica Colunga reviewed the proposal to allow for eligibility for Continuation School students, whose schools are part of a Multi-School Agreement with a CIF member school. Students in this situation would not be eligible if they have been placed at the Continuation School due to disciplinary reasons. Sometimes it is attendance and truancy that has brought a student to continuation school, not discipline. Mike West stated that he has worked at an alternate site and likes this option as it is good to give students the motivating factor to encourage them to excel. Chris Calderwood added that his district opposes Multi-Campus Agreements as it is difficult to govern students that are not on our campuses. Rob Wigod clarified that this would fall under a Multi-Campus Agreement between the Continuation School and a member school. Loren Kleinrock asked if this is permissive appears to be a lot of background work to be done with this. The definition of Continuation School is different between districts and alternative schools from the normal comprehensive school.

8. Proposed Bylaw Revision 201.A.4 - Monica Colunga reviewed the proposal which would allow coaches to directly communicate with incoming 9th graders after May 1 instead of after the school year is over. Terry Barnum asked why a financial component for private schools (as in a non-refundable registration fee) was part of the language because at some private schools, financial aid takes care of the registration fee. Rob Wigod stated that most parents know where they are going by May 1. Terry Barnum will ask at the CIF State meeting about the registration fee requirement.

9. Proposed Bylaw 207.B(5).c(viii).e Move – Return to Previous School - Monica Colunga reviewed the proposal which is a request to move this language from Hardship to a more appropriate place in Bylaw 207. This affects transfers when a student participates at School A, moves to School B and does not participate, then moves back School A, they are eligible at School A. This should be a Non-Participation transfer and has been under Hardship. Southern Section already processes these as Non-Participation.

#### B. SOUTHERN SECTION NON-ACTION ITEMS

1. Proposed 2018-19 Southern Section Budget - Mitch Carty distributed the budget and reviewed the document with the Executive Committee. See attachment at the end of the minutes. Mitch highlighted the savings in the cost of tickets, and of the underwriting of some of our events by sponsors obtained by Thom Simmons and Jackie Gibson. By eliminating printed programs and making them available online, we eliminated \$20,000 in costs. Other changes included changes in staff, the elimination of marketing commissions, and the lowering of our expenses thanks to the hard work of our great staff. The last page is a request to add a social media coordinator to the staff. This new position is added into the 2018-19 budget. Thom Simmons stated that we are losing sports media writers, and this would help to get the word out about our product that we are losing with the downsizing of print media. Nancy Kelly asked if it is time to do a study on staff salaries. Monica Colunga suggested that maybe it is time put a protocol in place to do this, maybe every three years. Mitch Carty agreed that every three years is a good time period for

review. It was decided to create a subcommittee to review protocols for a three-year salary review. Those members interested in being a part of this subcommittee will contact Mitch Carty to create this protocol.

2. Proposed Revision to Bylaw 23.1(j) & 24.2 – New Member Application Due Date - Carter Paysinger reviewed the proposal moving the new member application date from May 1 to April 1.

3. Proposed Revision to Bylaw 70.8 – Number of Executive Committee Meetings - Carter Paysinger reviewed the proposal to eliminate one meeting of the Executive Committee reducing the number from six to five each year. Since the change several years ago to three Council meetings instead of four, six meetings a year is not needed.

4. Proposed Revision to Bylaw 2003.3 - Use of Full Pads on First Day of Practice - Carter Paysinger reviewed the proposal to allow full pads on the first day of Fall practice for Football, provided a school has completed their summer dead period and three days of conditioning practices in helmets, t-shirts and shorts. Glenn Martinez stated that Football is trying to recoup a couple of practice days since they lost a full week due to the change in the 2018-2019 sports calendar. This is old language being reintroduced.

5. Proposed Revision to Bylaw 2021.3 and all sports sections - Carter Paysinger reviewed the proposal that would allow schools to pick three non-consecutive weeks for their summer dead period. Chris Calderwood stated that isn't the point to give students time for families. It is hard enough when athletes participate in different sports and take different weeks and now we are getting away from giving the families their time. Carter Paysinger added that the multi-sport athlete may not get a break and the Football player might only get one week with late planning.

6. Proposed Revision to Bylaw 3303 – Water Polo Host Teams - Carter Paysinger reviewed the proposal regarding Open Division playoffs and the home team designations. This proposal would have the highest seed having home games in all three rounds. This would be similar to what the CIF State does in their playoffs, with the team carrying the higher seeds always having home games. This division would have a pure seeding regardless of league finish and league membership. Chris Calderwood stated that we don't do this for other sports, why would we do this for Water Polo?

Carter Paysinger called for a lunch break at 11:52 a.m. Carter Paysinger reconvened the meeting at 12:52 p.m.
