

# CIF-SS COUNCIL MEETING MINUTES APRIL 9, 2019

#### 1. OPENING BUSINESS

- A. Call to order by Dr. Monica Colunga, President of the Council 9:02 am
- B. Pledge of Allegiance
- C. Roll Call
- D. Introduction of Guests Eric Sondheimer LA Times; Steve Fryer OC Register
- E. Adopt Agenda It was moved and seconded to adopt as written. Motion Passed: 73-0-7
- F. Approval of Minutes 1. Minutes of the January 23, 2019 Council Meeting. It was moved and seconded to adopt as written. Motion Passed: 78-0-3
- G. NFHS State Award for Outstanding Service to Dr. Keith Feder Roger Blake Roger Blake, State CIF Executive Director, presented Dr. Keith Feder with this award. Dr. Feder was honored for his contributions in support of the CIF and the Sports Medicine Foundation. He has helped more than 40-member schools over the past 21 years in the areas of student-athlete treatment, training of doctors and ATC's and supporting schools to bring these professionals onto high school campuses.

#### 2. PUBLIC HEARING SESSION

A. Recognition of anyone wishing to address the Council. Speakers must limit their remarks to three minutes. Tom White, Concordia University, discussed new programs on campus (Internship) and offered a reduced rate to member schools who participate in the California Coaches Conference to be held June 24-28 at the Irvine campus location. The cost of the program for an entire school staff would be \$149. Attendees can also earn up to four graduation credits.

#### 3. ACTION ITEMS

#### A. STATE FEDERATED COUNCIL ACTION ITEMS

- 1. Proposed 2019-2020 CIF State Budget It was moved and seconded to support the 2019-2020 CIF State Budget as written. Motion Passed: 79-0-8
- 2. CIF State Executive Committee Nominations It was moved and seconded to send our representatives uninstructed, based on the fact that no Southern Section candidates are seeking election at this time. Motion Passed: 86-0-4
- 3. Proposed Bylaw Revision 503.F Coaching Staff Payments It was moved and seconded to support the proposal as written. Motion Passed: 85-0-3
- 4. Proposed Bylaw Revisions 22.B.9 & 503.L Emergency Action Plans and A.E.D. It was moved and seconded to support the proposal as written. Motion Passed: 88-0-1
- 5. Proposed Bylaw Revision 2000.B Varsity football Age Requirement Medical Clearance -It was moved and seconded to support the proposal as written. Motion Passed: 76-7-6
- Proposed Bylaw Revisions 211 and 303 –
   Continuation School It was moved and seconded to support the proposal as written. Motion Failed: 10-73-7
   B. SOUTHERN SECTION ACTION ITEMS
- 1. Proposed 2019-2020 CIF Southern Section Budget It was moved and seconded to support the 2019-2020 CIF Southern Section Budget as written. Motion Passed: 85-4-1
- 2. CIF Southern Section Executive Committee Nominations - to Move Nominees Forward - The Citrus Belt Area (15 leagues) voted to elect Ed Kearby (14 votes) over Monty Owens (1 vote). The Desert Area (2 leagues) voted to elect Jeff Williams (1 vote). unopposed. One abstention. The Jeff Williams ran Foothill Area (9 leagues) Voted to elect Ann Fitzgerald (4 votes) over Robin Torres (2 votes). Three abstentions. The Northern Area (9 leagues) voted to elect Dave Hess (7 votes) over Dick Billingsley (2 votes). The Parochial Area (6 leagues) voted to elect Steve Miller (6 votes) over Brian Walsh (0 votes). The Small Schools Area (23 leagues) voted to elect David Parkes (20 votes). David Parkes ran unopposed. Three Abstentions. The Superintendent Area Representative is elected by the entire Council (96 votes). Reggie Thompkins (64 votes) was elected over Grant Bennet (17 votes) and John Garcia (9 votes). Six abstentions.
- 3. Officials Fees Proposal to Support 19-1-0 It was moved and seconded to support the proposal as written. Discussion: Officials still need to do a better job on working to recruit and retain officials. Bryce Sunderland,

Chair of the Officials Fees Committee, addressed the Council and stated that the committee did inform the individual officials groups that more steps had to be taken to provide greater opportunities for new officials to advance within each unit. These opportunities would focus on offering more assignments, higher level assignments and possible playoff assignments. Motion Passed: 77-10-3

4. Proposed Bylaw Revision 504.M - Sunday for Cheer Only - It was moved and seconded to support the proposal as written. Discussion: Bill Schloss, Principal of California High School, spoke to the Council in support of this bylaw. He said La Serna High School had informed him that the Sunday restriction has had a negative impact on their program and urged the Council to vote yes on this proposal. Motion Failed: 34-50-6

#### 4. NON-ACTION ITEMS

A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

- 1. Proposed Bylaw Additions 1501 and 2603 Baseball and Softball State Championships This proposal would allow for the adoption of a Regional Championship in the sports of baseball and softball. Once the event has been adopted, additional details will be addressed in regard to calendar, standardized number of contests, number of teams entered and format.
- B. SOUTHERN SECTION NON-ACTION ITEMS
  There are no Southern Section Non-Action Items at this time

#### 5. NEW BUSINESS

A. 2018-19 Southern Section Goals - Rob Wigod - Mr. Wigod discussed the progress that the Southern Section has made over the course of this year in reaching the stated goals that were established in August, 2018. This included: use of social media as advanced by Chelsea Heyward, Digital Media Coordinator; CIFSSHome mobile version; new championship events (Traditional Cheer, Unified Track and Field); rule changes (sport

calendar, number of allowable contests, SOP dates, international student bylaw revision); Administrator Summit Leadership Track; work with CIF Sports Properties; online ticketing; broadcast rights; CIF Transfer bylaws discussion; NFHS Network Pixellot program.

B. Transfer Rules Committee Update - Richard Shearer, Chairperson - Mr. Shearer gave an update on the committee's second meeting that took place earlier today. Items discussed were: current SOP Bylaw and any possible adjustments, VCR Check List and the plan to require schools to now upload all collected evidence of a fully executed valid change of residence. This will begin as of June 1, 2019. The committee also discussed current undue influence language and reviewed a new policy implemented by the Arizona Interscholastic Association that has clearly defined a person associated with a program. The question is could this definition be adopted into the current CIF-Southern Section Blue Book? The committee finished after having a brief conversation regarding participating in the same sport at two different schools in the same year and should students that transfer under the condition of a valid change of residence be limited as to how far in distance should the new school be in relation to the new home address. At the end of his report each area was permitted 15 minutes to meet and discuss with their representatives any additional topics and ask any follow up questions from the report.

#### 6. REPORTS

A. Treasurer's Report - Dr. Jeff Jordan - Dr. Jordan announced to the membership that our current profit/loss statement showed a positive of \$705,160. However, the Spring sport months generally are the lowest revenue generating and we should expect this profit balance to be reduced. Projections point to a break-even balance

# MINUTES OF THE EXECUTIVE COMMITTEE MEETING March 28, 2019

#### 1. OPENING BUSINESS

A. Call to order by Dr. Monica Colunga, President of the Council – called to order at 1:02 p.m.

B. Pledge of Allegiance

- C. Roll Call All members were present except for Todd Arrowsmith, Terry Barnum, Chris Calderwood, Chelsea Heyward and John Norman
- D. Introduction of Guests There were no guests present.
- E. Adopt Agenda There was a motion and a second to adopt the agenda. There being no discussion, the motion was approved to adopt the agenda.
- F. Approval of Minutes There was a motion and a second to approve the minutes of the January 19, 2019 Executive Committee meeting. The minutes were approved.

#### 2. PUBLIC COMMENT

A. Recognition of anyone wishing to address the Executive Committee. Speakers must limit their remarks to three minutes. Dion Lee, Head Coach, Bonanza High School in Las Vegas, Nevada made a presentation to the Executive Committee regarding the benefits of adding Girls Flag Football to CIF Southern Section sports. Florida, Nevada and Alaska sanction Girls Flag Football. San Francisco also fields Girls' Flag Football. It is a Winter sport in Nevada, a Fall sport in San Francisco and a Spring sport in Florida. It is his goal to uniform it throughout the country and would like to see it start out as a club sport on campuses to get started. Mr. Lee was involved in creating the playing rules and is now spending all his time promoting this sport.

#### 3. ACTION ITEMS

#### A. STATE FEDERATED COUNCIL ACTION ITEMS

- 1. Proposed 2019-2020 CIF State Budget Mike West reviewed the proposed budget. There is a 10% increase in PERS, steps plus 2% for staff. Overall balanced budget. There was a motion and a second to approve this proposal. There was no discussion. Motion carried 20-0-0.
- 2. CIF State Executive Committee Nominations Mike West reviewed the nominees. Traditionally, the vote is in support of candidates from our section and uninstructed for all others. There was a motion and a second to approve the proposal. There was no discussion. Motion carried 20-0-0.
- 3. Proposed Bylaw Revision 503.F Coaching Staff Payments Mike West reviewed the proposal. The Commissioner's Committee is recommending this change. This asks to penalize the coach and not the team for violations of this bylaw. There was a motion and a second to approve this proposal. There was no discussion. Motion carried 20-0-0.
- 4. Proposed Bylaw Revisions 22.B.9 & 503.L Emergency Action Plans and A.E.D Mike West reviewed the proposal. This bylaw is required due to passage of a State bill. There was a motion and a second to approve this proposal. Mike West reiterated a story regarding an incident at a baseball game with a baseball umpire. Jeff Williams asked if you have an A.E.D. is there more certification needed for use? Mike West stated anyone can operate an A.E.D. if they follow the instructions on the device but most have this certification. Motion carried 20-0-0.
- 5. Proposed Bylaw Revision 2000.B Varsity Football Age Requirement Medical Clearance Mike West reviewed the proposal. Sports Medicine Advisory Committee supports this update. There was a motion and a second to approve this proposal. Mike West continued that there was discussion at the State level, and this is only removing the one section of this bylaw. Loren Kleinrock asked if this puts the coach at a greater liability for the student. Mike West answered maybe, maybe not, as there is the same liability of any student. Paula Rodas clarified that students must get cleared to participate in athletics in general and the doctor needs to know it is for Football. Motion carried 20-0-0. —
- 6. Proposed Bylaw Revisions 211 and 303 Continuation School Mike West reviewed the proposal. The Commissioner's Committee recommended this proposal go forward for consideration. There was a motion and a second to approve this proposal. Rob Wigod clarified that the Commissioner's Committee is supportive of this concept being considered and moved forward. Mike West said it was sent back asking for clarification of a semester in good standing and other issues, which have now been covered in the Q&A's. Motion failed 1-19-0.

#### B. SOUTHERN SECTION ACTION ITEMS

- 1. Proposed 2019-2020 CIF Southern Section Budget --Monica Colunga reviewed the proposal. A balanced budget was presented with a sport fees increase, no price increases in tickets, or changes to revenue splits. There was a motion and a second to approve the proposal. There was no discussion. Motion carried 20-0-0.
- 2. CIF Southern Section Executive Committee Nominations Monica Colunga reviewed the nominations.

There was a motion and a second to forward the slate of candidates to the Southern Section Council. There was no discussion. Motion carried 19-0-1.

- 3. Officials Fees Proposal Monica Colunga reviewed the proposal. The request is to raise fees \$1 a year for the next three years plus additional changes which are in the proposal. There was a motion and a second to approve the proposal. There was no discussion. Motion carried 19-1-0.
- 4. Proposed Bylaw Revision 504.M Sunday for Cheer Only - Monica Colunga reviewed the proposal. There was a motion and a second to approve the proposal. Jill Matyuch is in full support of this proposal. Those who have written this proposal and are backing it are the only people it affects, and they will lose their most competitive events if they are unable to compete on Sundays. There is a claim that Cheer did not want to be part of this organization. Mike West clarified that as this is written, they can choose which event per year they will participate on a Sunday. Jill Matyuch reminded everyone that it included CIF Office approval. Monica Colunga added that it is unfortunate that Cheer did not ask to be a sport, but accommodations have already been made for them and that there is a larger audience that needs to be considered. Mike West commented that if the event was an NFHS approved event and this bylaw was just for that one event, he would be more likely to approve the change, but not if individual schools have the option to choose any event throughout the year, including events similar to the Sharps event that are not NFHS regulated. Jill Matyuch added that California is the only state that does not allow cheer on Sundays. This is for Traditional Competitive Cheer. Rob Wigod stated that these competitions do not allow teams to compete if they are not representing a high school. Dana Wilkerson asked if there are any other sports that want to play on Sunday? Rob Wigod answered that is has come up but mostly is the question of travel. Motion failed 2-18-0.

#### 4. NON-ACTION ITEMS

A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

1. Proposed Bylaw Additions 1501 and 2603 - Baseball and Softball State Championships - Mike West reviewed the proposal. This is a request to establish a State Regional Championship the week following the Section Championships. Not every section is on the same sports calendar. Rob Wigod mentioned this step needs to happen first in order to bring about the details of the events. This is a Central Section proposal. Dick Billingsley voiced concern as Volleyball Championships were after graduation and with schools moving their calendars earlier, it becomes a problem once students have graduated. Mike West agreed as his school's graduation is right after Memorial Day. Jim Perry stated that this proposal would be the same as Water Polo and Soccer with eight team brackets in multiple divisions. More details are needed to see what the Central Section is trying to work toward with this proposal. Carter Paysinger brought up the fact that with some schools being in session and some schools being out that this is an unlevel playing field

#### B. SOUTHERN SECTION NON-ACTION ITEMS

There are no Southern Section Non-Action Items at this

#### 5. NEW BUSINESS

- A. 2017-2018 CIF Southern Section Audit Monica Colunga stated that the Audit Committee met this morning and accepted the audit. Mitch Carty reviewed aspects of the audit which showed a \$115,000 profit from the 2017-2018 school year. It was a good year considering where we were with the decline in ticket sales. Staff did a good job in cutting costs. There was a motion and second to accept the audit. The motion carried 19-0-1.
- B. Financial Report Mitch Carty Mitch Carty distributed a handout that appears at the end of these minutes. He highlighted several items. Dick Billingsley stated that the Football Advisory Committee had a discussion regarding money coming in and may make changes to bring more in next year.
- C. Marketing Update Thom Simmons/Jackie Gibson Jackie Gibson reviewed a handout that was distributed to the Executive Committee and appears at the end of these minutes. Outfront Media Sports has committed \$1-9M which is close to the revenue share threshold at \$2.0M. Tik-a-Tap cost the state an opportunity at reaching revenue share when they filed bankruptcy. Thom Simmons commended Rob Wigod for leading the section into the OMS agreement and it is paying off.
- D. Communications Update Chelsea Heyward Thom Simmons gave the report as Chelsea Heyward was not present. The office is ahead of budget in rights fees this year. There was a deal for Basketball with KDOC and this relationship has now turned into a contract for the 2019-20

school year. Talking with Baller TV to be our number three network. In social media, Instagram is performing better than expected. The playoff brackets garnered 10,200 likes which is ahead of where we wanted to be. Soccer received twice as many views as all other Winter Sports.

E. 2018-19 Southern Section Goals - Rob Wigod - Rob Wigod distributed the section goals and they appear at the end of these minutes. He highlighted several accomplishments to the Executive Committee. Loren Kleinrock mentioned that he appreciated the tone that the Transfer Rules Committee is taking. Rob Wigod continued that it is time to see exactly what we are looking at, for example, the SOP dates at the end of the season instead of at the beginning, a type of first-time transfer rule in an environment where valid change of residence and hardships have been tightened up. Monica Colunga requested that at the Council Meeting, Council members sit in their geographic areas to allow members to meet with their area representative from the Transfer Rules Committee and ask for input.

Monica Colunga called for Closed Session at 2:20 p.m.

#### 8. REPORTS

A. President's Report - Dr. Monica Colunga - Monica Colunga discussed calls that she has received as President of the section. The principals and school administrators need to be educated on the process and procedures of the organization. There needs to be a way to get that message out. Rob Wigod did a great job in his message on loyalty. Changing clubs when they do not like what is going on is happening at the high school level and we need to send the message of loyalty. Attended Glenn Martinez' memorial and a thank you to Rob Wigod for the eulogy. Finally, thank you to the staff for your reliance through this difficult time.

B. Treasurer's Report - Dr. Jeff Jordan - The auditors were very complimentary of the organization. Please refer to the Treasurer's Report at the end of these minutes that Jeff Jordan reviewed with the Executive Committee. At Walnut Valley Unified, they are rolling out A.E.D.s throughout the district. It is fun to get to work with school sites.

- C. Commissioner's Report Rob Wigod This has been a difficult time and I appreciate everyone's support. The search for a new Assistant Commissioner will begin April 8, with applications closing on May 3. Interviews will be conducted in the middle of May, with a selection at the end of month and the new person starting on July 1. We will be asking for your involvement in the process. Dana Wilkerson will term out at the end of this school year, so we need a new At-Large Representative to be appointed. Would like to hear from you any nominations you might have for this position at our May meeting and the new person will be appointed at the August meeting. The new school's application deadline is Monday, April 1. Emails were sent to the Probationary schools for their evaluations of this school year and we will be asking you to revisit them. Along with staff, will be attending the CSADA Conference in San Diego next weekend with a session just for Southern Section Athletic Directors and then will be attending the CIF Federated Council Meeting the following Friday in Burlingame. Champions for Character, Hall of Fame, and Distinguished Service Award nominations are due May 1. The Champions for Character Golf Tournament is Monday, June 17, at Alta Vista Country Club in Placentia. Please be part of the day and we will have the In-N-Out truck on site for lunch.
- D. Executive Committee Member Reports President-Elect, Mike West – AB 1592 is in legislature. For this bill, we are going to ask the schools to send their logo to be placed on one letter to show support. Roger Blake will send out the request to all schools. Glenn Martinez' primary goal was to create the Athletic Trainers Committee and has helped the community to have a voice and be able to provide feedback. Mt. SAC Area Representative, Paul Lopez - Talked about the impact Glenn Martinez had on the section. His area is in the middle of Releaguing. Asked if 16 games are too many for high school football players. Girls' Athletic Directors Representative, Jill Matyuch - It was great to be at the Women in Sports conference with the CIF-SS Street Team. There were excellent speakers and Nancy Kelly was great and authentic. Foothill Area Representative, Loren Kleinrock - This is an amazing group and my time with it is coming to an end. I am grateful to have been able to a part of it and it has been a rewarding experience. Small Schools Area

at the end of the current school year. Dr. Jordan did note that \$630,445 in playoff revenue has been returned to member schools to this point. In addition, The Friends of Golf organization has donated \$47,000 to member schools that participate in its program. Finally, Dr. Jordan informed the Council that building maintenance over the next 1-3 years will begin at the section office and some of those items will be a new phone system, computer replacement, roof and HVAC repairs.

B. President's Report - Dr. Monica Colunga - Dr. Colunga reported to the membership that schools need to be aware of what outside programs are doing in your area and that how they operate is completely different from how our member schools operate in to student transfers. Students that participate in outside club teams can move from club to club with no penalty and when parents and students attempt this at the high school they are presented with our rules and bylaws. To alleviate this situation an outreach needs to begin at the elementary and middle schools, so parents are aware that the high school education-based athletics programs operate much differently than private outside athletic teams and groups.
