Century Conference


- Inequities of Football and Basketball compared to all our other sports

Century Conference


- Went to a seven-team league when Esperanza was provided relief

- Playoff guaranteed slots led to an investigation of a conference







Canyon CIF Champs 2015, El Modena CIF Champs 2017.

2018 and 2019 Seasons: All eight schools where ranked in their football perspective divisions at one point during the season.
