## SIX CIF SOUTHERN SECTION-FORD DUAL MEET WRESTLING, CHAMPIONSHIPS TO BE AWARDED THIS WEEKEND

LOS ALAMITOS — The six divisional, one-day tournament championships of dual-meet wrestling will be held this Saturday, February 1.

Saturday's tournaments are scheduled to start with first-round action beginning at 11 a.m., second-round action at 3 p.m., preliminary finals at 5 p.m. and the championship finals at 7:15 p.m. (All times approximate). Weigh-in is to begin at 9 a.m.

Top seeds for each division include St. John Bosco (Division 1), Victor Valley (Division 2), Fountain Valley (Division 3), Royal (Division 4), South Torrance (Division 5), and Glenn (Division 6).

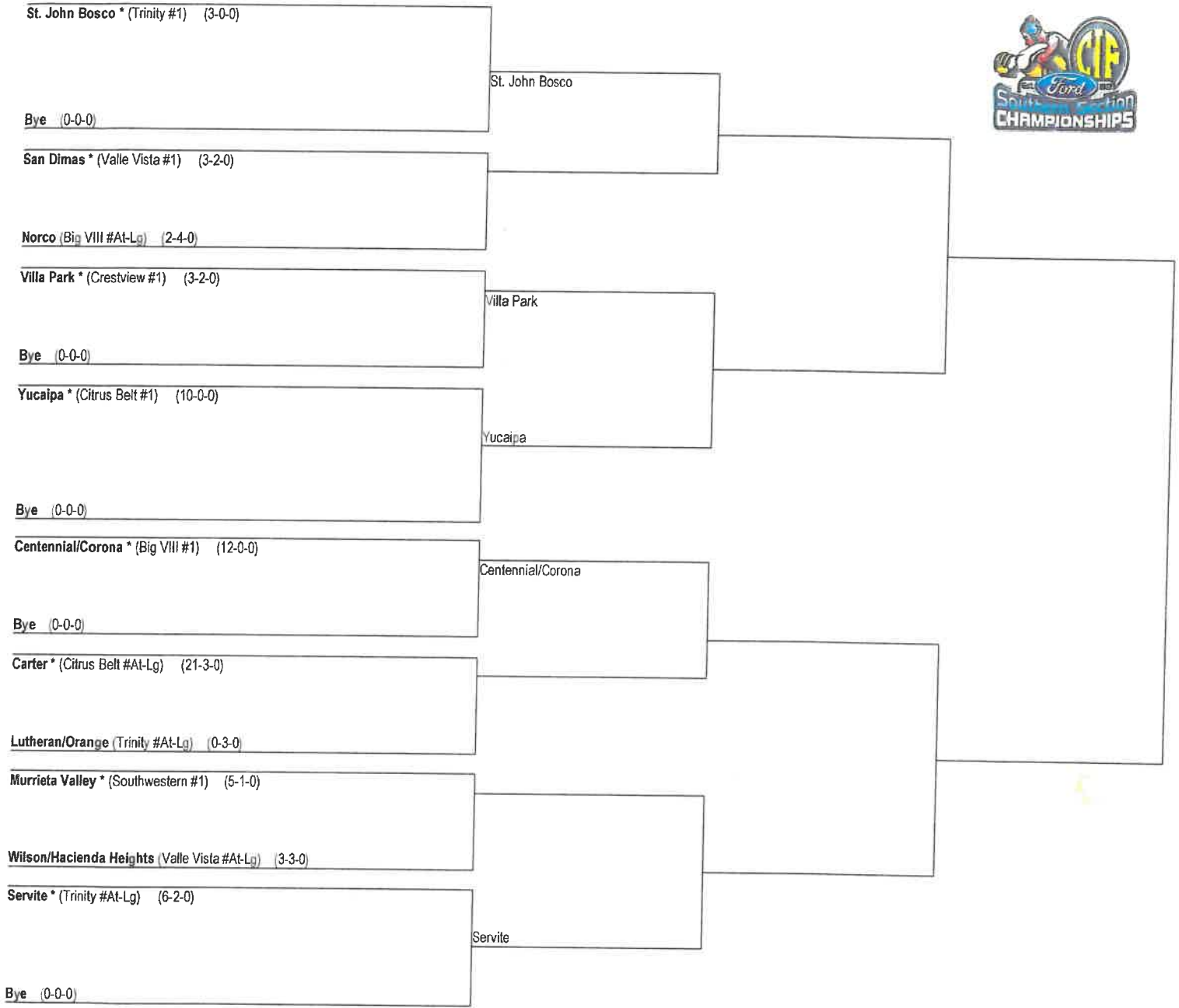
