Mr. Wigod and Carter Paysinger will be attending the CIF Football Summit to be held in Sacramento on February 6. The mission is to look at how we can best promote and improve football safety. Commissioner Wigod finished by asking the Council to promote and support the Champions for Character Golf Tournament that funds our student-athlete scholarships. Finally, May 1 is the deadline for nominations for the Hall of Fame and Distinguished Service awards.






## SPORTS REVENUE DROP (2015-16 to 2016-17)










#### **SPORTS REVENUE DROP (2016-17 to 2017-18)**





### TICKET SALES DROP (2016-17 to 2017-18)






## SPORTS REVENUE DROP (2017-18 to 2018-19)






