Sanctions and delays are recorded in the Sanctions box in the lower left corner of the scoresheet. The number of the player is placed in the Y column if given a yellow card or the R column if given a red card. The number is placed in both columns if given a red and yellow card together. Use 'C' for the head coach, 'A' for an assistant coach, and 'D' if the team is given a delay sanction.

Then record the team (A or B) and the score at the time of the sanction, with the score of the team receiving the sanction going first.


