- 1. Proposed 2020-2021 State Budget ¬ Mike West reviewed the proposal and updated the Council on the 2% COLA request. Mr. West stated that the funds would be held in abeyance until the final budget is complete and evidence shows that it can be funded. There was a motion by the River Valley League and a second by the Ambassador League to approve the proposal. There being no discussion. The motion carried 84-1-2.
- 2. CIF State Executive Committee Nominations There was a motion by the Sea View League and a second by the Pacific League to support the Southern Section candidates for CIF State Executive Committee positions: Terry Barnum, Carter Paysinger; and go Uninstructed on all others. There being no discussion. The motion carried 89-0-1.
- 3. Proposed Bylaw 503.M Revision Ejection Policy Mike West reviewed the proposal. There was a motion by the Sea View League and a second by the Big VIII League to approve the proposal. There was no discussion. The motion carried 79-

- 4. Proposed Bylaw 303.B.(6)a and b Revision Mike West reviewed the proposal. There was a motion by the Big VIII League and a second by the Mission League to approve the proposal. There was no discussion. The motion carried 86-1-0.

She reminded the Council that if the budget is approved the 2% COLA for Program Coordinators and the 1% COLA for Administrators would be held in abeyance until the final budget is complete and evidence shows that it can be funded. There was a motion by the Palomares League and a second by the Pacific View League to approve the proposal. There was no discussion. The motion carried 90-1-0.
- 2. CIF Southern Section Executive Committee Nominations - Dr. Colunga reviewed the proposal and the nominations to the Council. The following candidates were elected to Executive Committee positions: President-Elect - Jim Perry, District Athletic Director, Huntington Beach Union High School District Treasurer - Chris Calderwood, Vice-Principal/Athletic Director, Rancho Mirage High School Activities Director Representative - Todd Arrowsmith, Activities Director, West Ranch High School. Due to the retirement of Chuck Shore from Gladstone High School, his nomination for Boys' Athletic Director Representative was withdrawn. Nominations were accepted from the floor. The following were nominated: The Del Rey League nominated Eric Wood from Bishop Montgomery HS, second from Santa Fe League. The Crestview Conference nominated Ray Elliot from El Dorado HS, second from Del Rio League. The Montview League nominated Brett Proctor from Alta Loma HS, second from Suburban League. Brett Proctor declined the nomination. San Andreas League spoke on behalf of and in support of Rich Imbriani. Boys Athletic Director Representative - Rich Imbriani, Athletic Director, Cajon High School Girls Athletic Director Representative - Michelle Spencer Athletic Director, Marina High School Orange County Area Representative - Mary Jane Hibbard, Principal, Rancho Alamitos High School
- 3. Proposed Bylaw 1212 Revision Change of Due Date Dr. Colunga reviewed the proposal. There was a motion by the Southwestern League and a second by the Big VIII League to approve the proposal. There was no discussion. The motion carried 90-0-0.
- 4. Proposed Bylaws 3319, 3319.5, 3319.7 and 3314.1 Dr. Colunga reviewed the proposal. There was a motion by the Suburban League and a second by the Almont League to approve the proposal. There was no discussion. The motion carried 80-4-6
- 5. Proposed Bylaw 504.M Revision Dr. Colunga reviewed the proposal. There was a motion by the Del Rio League and a second by the Coastal League to approve the proposal. Discussion: Question from the Montview League as to why the Executive Committee voted to support the proposal. Jill Matyuch responded by saying that this is to help cheer get "out of the box" it was placed in. She then explained that this is a single event that is

supported by the NFHS. Brett Proctor, Palomares League, raised the concern over allowing Sunday exemptions. Tom Fox reminded the Council that this specific event and any that follow should be looked at individually so if other sports ask for an exemption the Council should discuss each request independently. Jim Perry reminded the Council that we should be very cautious and that when Cheer was accepted, they agreed to follow all rules of the constitution. Dr. Colunga reminded the Council that all members should be open minded to look at all new ideas and proposals as we evolve. Tom Fox again stated that Cheer is limited and that it does not operate like other sports do. David Hess spoke in support of the proposal and gave reason for his ves vote during the recent Executive Committee meeting. Jim Perry reminded the Council that if this proposal does pass it does not make it a bylaw immediately. It simply means that it will be moved to the CIF State Federated Council for first reading in October and to be voted on in January, 2021. The motion carried 46-39-5.

6. Proposed Bylaw 3320.4 Revision - Dr. Colunga reviewed the proposal. There was a motion by the Suburban League and a second by the Almont League to approve the proposal. Discussion: Question from the Western Athletic Conference about the what would happen if a yes vote was recorded for both this proposal and SS 612, would they conflict with each other? Assistant Commissioner Kristine Palle responded that they would not. If a yes vote was recorded, then the Council is stating that they would like to have swimming playoff divisions formulated based on competitive equity. With that, the higher placed gender would bring the lower placed gender from the same school into the same division for the playoffs. The Pacific View League spoke in support of this proposal and the need to keep the Girls' and Boys' teams together due to travel issues and the need to lessen the potential impact of taking coaches out of the classroom for multiple days. The motion failed 3-82-5.

7. Proposed Bylaw 3320.4 Revision - Dr. Colunga reviewed the proposal. There was a motion by the Suburban League and a second by the Almont League to approve the proposal. Discussion: The Golden West League asked for clarification on how competitive equity divisions would be formulated. Tim Walsh stated that in SS 611, the proposal detailed how teams would be placed and would SS 612 follow the same explanation. Assistant Commissioner Palle responded that the same system that was outlined in SS 611 would be used in SS 612. The motion carried 77-7-6.

Player Misconduct

First ejection: one subsequent game suspension, player MAY be in attendance in street clothes.

Second ejection: three subsequent game suspensions, player MAY be in attendance in street clothes.

Third ejection: out for the season, player may be in attendance in street clothes. The section office will make a determination on the number of subsequent game suspensions up to 6 games.

Player Fighting and Assaultive:

First offense for fighting: 3-6 game suspension as determined by the Section. Player MAY be in attendance in street clothes for the duration of the subsequent suspensions.

Second offense for fighting: player is ineligible for the remainder of the season. The section office will make a determination on the number of subsequent game suspensions, up to 6 games.

Coach Ejection and Coach Ejection for Fighting:

First ejection, one game suspension, coach must immediately vacate and MAY NOT be in attendance while serving. Second ejection, three to six game suspension, determined by the Section, coach MAY NOT be in attendance.

Third ejection, done for the remainder of the season, three to six game suspension, as determined by the Section, coach MAY NOT be in attendance. The section office will make a determination on the number of game suspensions up to 6 games.

A COACH EJECTED FOR FIGHTING MUST LEAVE THE PREMISES. THE SECTION OFFICE WILL MAKE A DETERMINATION ON THE NUMBER OF SUBSEQUENT GAMES SUSPENSIONS UP TO 6 GAMES.

503.M. Statewide Sportsmanship and Ejection Policy cont.

Spectator

If a spectator is ejected from a contest, it is the responsibility of the school to ensure that person does not attend that team's next contest. If the same spectator is ejected a second time, it is the responsibility of the school to ensure that person does not attend any of the remaining contests for that season.

Key Points to Statewide Sportsmanship and Ejection Policy

- 1) Any unserved portion of a suspension will carry over to the next season. If the athlete is a senior, it will carry over to their next sport.
- 2) Players may be in attendance during their suspensions, Coaches MAY NOT.
- 3) The administrative meeting/paperwork process (for athletes) will still be in effect and is required on all ejections for fighting. The Principal must still upload a letter reflecting the "corrective action" taken on all coach ejections.
- 4) Your school MAY have more stringent policies in place to these (i.e.: a rule indicating that the student may not be in attendance at the team's next contest).

Appeal Process for All Multi-Game Ejections:

The school principal may appeal the penalties listed above in writing to the League Commissioner/President (for a regular season contest not including the final contest prior to Section playoffs) or CIF Section Commissioner with jurisdiction in the matter (for the final contest prior to Section playoffs and all playoff contests). The appeal must be received by the Section within 48 hours of the date of the ejection. Reasons for the appeal may only include misidentification of the ejected player or a misapplication of the rule. There will be no appeal regarding the

The following Articles and Bylaws were adopted by the CIFSS Council

Bylaw 32.B.4.B – Releaguing Procedures

- a. Schools in a conference may releague each year.
- b. Report specific league participation in CIFSS Home

Bylaw Revision - All Sports Sections - Summer Dead Period

- a. 14-day dead period for the entire school (all sports, all levels at the same time).
- b. No contact or activity of any kind including weightlifting, virtual meetings etc. may take place.
 - i. No class may be offered to circumvent this rule
 - ii. Participation with your high school coach in a club setting IS a violation.

Bylaw 3320.2 - Playoff Divisions for Golf

a. Competitive equity system will now be used in CIF team golf for both boys and girls.

Bylaw 1212 - Change of Due Date for Winter Schedules

- a. Winter schedules are due to the assignor September 1st (moved from July 1st).
- b. This year, due to COVID, the schedule due dates are October 12 and December 14, 2020

Bylaws 3319, 3319.5, 3319.7 and 3314.1- Football Playoff Groupings

- a. Football will now create playoff divisions based entirely on the current year's data at the end of the regular season.
- b. Seeding in each bracket will follow the power rankings regardless of league finish or affiliation.
- c. The higher seeded team will be the automatic host for the first round of the playoffs.

Bylaw 3320.4 – Swimming and Diving Playoff Divisions

- a. League Finals results will be submitted to CIF allowing teams to be divisionally placed based on competitive equity
- b. Done by team and by gender (so you can be in a different Division than your league mates AND your boys and girls can be in different divisions as well)

Currently, the position only has one candidate and nominations will be accepted from the floor. There was a motion by Jill Matyuch and a second by Jim Perry to approve the proposal. There was no discussion. The motion carried 22-0-0.
- 3. Proposed Bylaw 1212 Revision Change of Due Date - Dr. Colunga reviewed the proposal. There was a motion by Jim Perry and a second by Paula Rodas to approve the proposal. There was no discussion. The motion carried 22-0-0.
- 4. Proposed Bylaws 3319, 3319.5, 3319.7 and 3314.1 -Revision - Football Playoff Groupings - Dr. Colunga reviewed the proposal. There was a motion by Chris Calderwood and a second by Jill Matyuch to approve the proposal. Dr. Colunga asked Assistant Commissioner Rich Shearer to provide some information and background for this proposal. Rich informed the Executive Committee that the Members of the Football Coaches Advisory Committee were strongly in favor of this proposal. The proposal would guarantee that all automatic playoff qualifying teams in the sport of football would make the playoffs. There was no discussion. The motion carried 22-0-0.
- 5. Proposed Bylaw 504.M Revision Sunday Cheer Competition - Dr. Colunga reviewed the proposal. There was a motion by Jill Matyuch and a second by Reggie Thompkins to approve the proposal. Ed Kearby raised a concern that if this were to pass that the significance and value to the other Cheer competitions would be devalued. Jill Matyuch expressed to the Executive Committee that this single event is the equivalent of the Super Bowl and that teams should be allowed to attend and compete on a Sunday. Reggie Thompkins pointed out to the Executive Committee that the Superintendents Advisory Committee approved the proposal. Chris Calderwood asked if the Cheer Advisory Committee supported the proposal and Rob Wigod confirmed that they did. Mike West asked for clarification on what was different between this proposal and one that was brought forward for a vote which failed during the 2018-2019 school year. Jill Matyuch explained that the failed proposal was asking for a Sunday exception for any Cheer competition whereas this proposal is asking for an exception for one specific event. Jim Perry raised a concern that if this were to pass, it would possibly open the door for other sports to ask for an exception and create a problem later. Jim also informed the Executive Committee that the organization running the event has allowed teams to submit a video of the teams' performance and have it evaluated. Ann Fitzgerald responded to Jim Perry's statement that video could be submitted in lieu of a live performance. The issue is that once the video is submitted it must be used at each interval and a new video cannot be submitted for each round of the competition. Ann also pointed out that this one event is the only one that is currently supported by the NFHS. After hearing the discussion, Nancy Kelly called for the vote. The motion carried 13-8-1.
- 6.Proposed Bylaw 3320.4 Revision Swim Playoff Divisions - Proposal A - Dr. Colunga reviewed the proposal. There was a motion by Terry Barnum and a second by Nancy Kelly to approve the proposal. Dr. Colunga asked Assistant Commissioner Kristine Palle to provide some information and background for this proposal. Kristine informed the Executive Committee that the Swimming Coaches Advisory Committee were in favor of this proposal. The proposal would place teams in playoff divisions based on competitive equity and not strength of league which is the current practice. This proposal would keep both the Girls' and Boys' teams together in a competitive playoff division based on which gender was higher ranked. Jim Perry commented that if this proposal were to pass then SS 612 could not be passed as they would contradict each other. Kristine confirmed and explained that the Committee could not vote to approve SS 611 and vote to approve SS 612. Motion failed 1-20-0.
- 7. Proposed Bylaw 3320.4 Revision Swim Playoff Divisions - Proposal B - Dr. Colunga reviewed the proposal. There was a motion by Terry Barnum and a second by Nancy Kelly to approve the proposal. Dr. Colunga asked Assistant Commissioner Kristine Palle to provide some information and background for this proposal. Kristine explained that this was a continuation of SS 611 which would place teams

in playoff divisions based on competitive equity and it would review Boys' performance and Girls' performance separately, allowing the two genders to be placed into different playoff divisions. Dave Hess expressed a concern for the schools in his area that if the Girls and Boys teams were placed in different playoff divisions that it could cause an excessive amount of travel and loss of class time for the coaching staffs. Dave Reid spoke in support of the proposal simply saying that he saw this as a fairness issue for the two swim programs at each school. The motion carried 20-1-0.
