Southern Section Boys/Girls Track and Field Championships Approved – We just received word that our Boys/Girls Track and Field Championships have been approved by the various county public health departments we are working with. Here are some important details as we prepare for this exciting event...

Prelims – Saturday June 5

- Locations - Division 1 – Trabuco Hills High School
 - Division 2 – Moorpark High School
 - Division 3 – Estancia High School
 - Division 4 – Carpinteria High School
- Format – Qualifying information is on our Track and Field page at www.cifss.org.
- Spectators – Will be allowed, per CDPH and local county health department guidelines.
- Ticketing – All tickets will need to be purchased through our online ticketing partner GoFan.
- Livestream – The entire event will be livestreamed and specific information on livestreaming will be forthcoming.

Divisional Finals – Saturday, June 12

- Locations - Division 1 – Trabuco Hills High School
 - Division 2 – Moorpark High School
 - Division 3 – Estancia High School
 - Division 4 – Carpinteria High School
- Format – Qualifiers from Prelims will advance to Divisional Finals.
- Spectators – Will be allowed, per CDPH and local county health department guidelines.
- Ticketing – All tickets will need to be purchased through our online ticketing partner GoFan.
- Livestream – The entire event will be livestreamed and specific information on livestreaming will be forthcoming.

With the recent announcement that there will not be a 2021 CIF State Track and Field Championship, we will not be conducting the Southern Section Masters Meet this year.

Season 2 Individual Sports Update – For the Season 2 Individual Sports listed below, here is the latest information as of today...

- **Boys/Girls Golf** – We have secured 17 of the 18 golf courses that we need to conduct our Boys and Girls Individual and Team Golf Championships. We have obtained some approvals from county health departments and are still awaiting approvals from others. Be aware that there will be various formats involved in these events based on specific golf course and county rules. For example, some will be shotgun starts, some will be done using tee times, some will allow spectators, some will not. Once everything is confirmed, we will officially announce that we are conducting our Boys and Girls Golf Championships and all necessary information will be made available in our Boys Golf Playoff Bulletin and Girls Golf Playoff Bulletin, which will be posted on our website when they are completed.
- **Boys/Girls Individual Tennis** – We have secured Seal Beach Tennis Center for the Girls Individual Tournament Round of 16 and Quarterfinals on Wednesday June 9, and Semifinals and Finals on Thursday, June 10, with the Boys Round of 16 and Quarterfinals on Wednesday, June 16 and Thursday, June 17. All of those dates have been approved by the Orange County Public Health Department, so they are ready to go. We are still trying to secure sites and gain approvals for our Individual Sectionals for Girls and Boys and will continue to do so, with the hope that we will be able to obtain the necessary approvals soon. Once we do, an official announcement will be forthcoming.
