The 2021-2022 Proposed Budget projects income of \$6.62 million and expenses at \$6.59 million. Additionally, the budget shows two unfilled staff positions in the burden of salary figures. Given that only one of these positions may be filled in the 2021-2022 school year, an additional surplus of \$80,000 may be realized. The proposed budget also shows a projected income of \$50,000 for State Regional Baseball and Softball events that have been added to the calendar. The Southern Section has already reviewed this proposal and voted in favor of the proposal. The proposal was brought back as a first read due to new information regarding other sections and states allowing Sunday competition. The sport of Skiing/Snowboarding has been allowed to practice and compete on Sundays given the unique nature of the sport and the fact that there is competition with Nevada schools which allow for Sunday competition in the sport. This provides some context to the concern that we would be allowing an exception for Cheer that has not been allowed for any other sport.

1. Proposed 2021-2022 CIF Southern Section Budget

Chief Financial Officer Mitch Carty presented to the Executive Committee Budget Option 1, best-case scenario, for the 2021-2022 school year. This best-case scenario is highlighted by taking a conservative approach toward sports revenue and special events revenue. In addition, sponsorship and broadcast contracts are at 100% fulfilled and sport fees to match the 2020-2021 school year with no increase in sport fees for 2021-2022. Overall, Mr. Carty presented a balanced budget trending to a normal operating year. The proposed budget indicates a return to a full staff of 17 employees, with step and column adjustments, along with the return of full benefits for office staff employees, if revenues support those actions.

There was a motion by Dr. Paula Rodas and a second by Chris Calderwood to approve the motion as written. There being no discussion, the motion was approved as written.

A. Financial Report Mitch Carty

1. 2019-2020 CIF Southern Section Audit

Chief Financial Officer Mitch Carty informed the Executive Committee that the Audit Committee had met, the 2019-2020 Audit was completed, no findings or adjustments were necessary and the Audit Committee accepted the 2019-2020 Audit as presented.

There was a motion by Chris Calderwood and a second by Dave Reid to approve the audit. There being no discussion, the motion was approved as written.

**Motion Carried: 22-0-0** 

Mr. Carty also informed the Executive Committee that as of today we have received 98% of membership dues along with investment interest income of \$218,000. Furthermore, the Section Office did receive \$456,000 from the Payroll Protection Loan and we have applied to have the loan repayment forgiven. We are awaiting a response to that application currently. Office Staff continues to take mandatory vacation and expenditures have been limited to necessary items only. Mr. Carty has also applied and been approved for the second Payroll Protection Loan. A decision as to when those funds will be applied will be made shortly. The funds could be applied to the remaining 2020-2021 budget or shifted to the 2021-2022 projected budget.

Season 2 sports have all returned and are currently playing. If Season 2 sports do have playoffs, this could potentially generate additional revenue for the section but also require additional expenses.

Finally, Mr. Carty announced that the CIF Southern Section Office will re-open on Monday, March 22, 2021, with normal operating hours of 7:30 am - 4:00 pm.

#### B. Marketing Report

Thom Simmons/Jackie Gibson

Marketing Manager Jackie Gibson informed the Executive Committee that three new ball contracts have been finalized with vendors and returned to our office. They are currently under legal review before they will be signed and presented to our member schools and to the public. The additional remaining contract has yet to be signed and returned to our office. The four new ball contract agreements are for five years, beginning in 2021-2022, with the mandatory playoff ball requirement beginning in 2022-2023.

Next, Mrs. Gibson shared her thoughts and experiences with the Executive Committee after attending a Southern Section football game on Friday, March 12, 2021. She was delighted and pleased that high school sports had returned after an over one-year absence.

#### C. Communications Report

Chelsea Heyward

Digital Media Coordinator Chelsea Heyward reported that CIFSS This Week has returned with Episode 14 highlighting the return to play for so many schools. The episode highlighted four member schools, Alemany, Warren, Bonita, and St. John Bosco. The video contains interviews with coaches and players as to how they have handled COVID, the off-season and the return to finally playing sports.

Assistant Commissioner Thom Simmons reported that the televised football contest on Fox Sports West between St. John Bosco and Sierra Canyon on March 13, 2021, earned a .24 rating share in the 25-54 prime age demographic. A normal rating share on Fox Sports West for high school football in that category is a .12 share.

#### D. CIF Southern Section 2020-2021 Goals

Commissioner of Athletics Rob Wigod presented and reviewed the 2020-2021 CIF Southern Section Goals. This document shows existing goals, new goals for the 2020-2021 school year and responses to those goals as of March 15, 2021. The goals achieved to this point included increased communication efforts made through social media platforms and Southern Section Updates, completion of the Area Placement process as a prelude to Releaguing, implementing three new rules changes, signing multi-year agreements with Fox Sports West and the NFHS Network and administering the revised 2020-2021 sports calendar completed in August, 2020.

The member schools have had to juggle and schedule and re-schedule numerous events and this has been no easy task.

#### B. Treasurer's Report

Treasurer Chris Calderwood reported that Friends of Golf has donated \$23,500 which will be Distributed to member school golf programs. As of today, 555 of the 559 member schools have created a sports fee invoice. 544 of these invoices have been paid. Mr. Calderwood suggested that if any Executive Committee members know of any schools that have not yet submitted membership dues that they contact them to assist in this collection. Mr. Calderwood also expressed to the Executive Committee that more schools should try and use GoFan as a ticketless/no contact entry system into athletic contests.

#### C. Commissioner's Report

Rob Wigod

Commissioner Rob Wigod stated that as of this coming Saturday, March 20, 2021, all Season 1 and Season 2 sports will have started play in some capacity. That was the goal of the Southern Section dating back to the announcement of the 2020-2021 sports calendar in July, 2020 and we are happy that schools are able to begin once again. Commissioner Wigod reminded the Executive Committee that we continue to advocate for a healthy return to play following the CDPH return to play guidelines. Commissioner Wigod thanked all member schools, principals, athletic directors and coaches for adapting to all of the changes that have been presented to them. Finally, Commissioner Wigod thanked the Executive Committee for their support of our staff and our entire organization.

#### D. Executive Committee Member Reports

Dr. Monica Colunga informed the Executive Committee that Commissioner Wigod received individual recognition from CIF State Executive Director Ron Nocetti for his leadership role in dealing with State and Section issues related to the COVID pandemic.

CADA Representative – Mrs. Geniel Moon reported that CADA just completed a successful online conference that was held on March 1-6.



We appreciate the trust that you have given in allowing us to give your child a distinctively Christian education. We realize that a Christian education is probably the greatest financial investment you will ever make in the life of your child. It is an investment that will yield eternal dividends.

To achieve giving your child a quality education academically, spiritually, emotionally, and physically, we will work closely together with the home. Realizing that the impact of the home is the strongest influence in a child's life, we wish to do all we can to help you prepare your child to do God's will in the future.

In order to acquaint you better with FBCS, we have prepared this handbook for you. We ask that you read it thoroughly. If you have any questions, please feel free to ask or call the school office. We desire that this would be a great year for you and your child at FBCS, and again, thank you for

the trust and faith you have placed in us.

Please note: FBCS is an unaccredited school, but is a member of the American Association of Christian Schools. For 9<sup>th</sup>-12<sup>th</sup> grade students there is an option at an additional cost for dual enrollment in Alpha Omega Academy for an accredited diploma.

### ABOUT OUR SCHOOL

### Our History

First Baptist Church School opened in 1987 and has grown from a one-room Learning Center to our present class structure providing our children with a distinctive Christian education through the ministry of FBC & School.

Even though unaccredited, almost 90% of all FBCS graduates have gone on to college and have been accepted by both Christian and secular colleges.

### The Purpose of First Baptist Church School

First Baptist Church School is an integral part of the ministry of the First Baptist Church of Long Beach, California. It is not in any way separate in belief or practice. The Pastor of the church is also the Pastor of the school. Parents should realize that in sending their child to First Baptist Church School, they are agreeing to the philosophy and direction of the First Baptist Church.

We have a two-fold purpose at First Baptist Church School. It is as follows:

- 1. Protect our youth
- 2. Build balanced Christians

### The Philosophy of First Baptist Church School

True education must recognize God as the Supreme Source of all knowledge and wisdom. All subjects taught will be consistent with this truth.

We are dedicated to the concept that truth is to be found in the Word of God, and that the Word of God, the Bible, is the Truth. Therefore, we interpret and integrate all subjects with the study of Biblical principles and ethics. Our goal is to mold an individual to be balanced spiritually, academically, and socially.

### Our Statement of Faith

- 1. We believe that there is one God, eternally existent in the Person of the Father, Son, and the Holy Spirit.
- 2. We believe the Bible to be the inspired, infallible, and only Word of God.
- 3. We believe in the virgin birth of the Lord Jesus Christ, in His vicarious and atoning death through His shed blood, in His bodily resurrection, in His ascension to the right hand of the Father, and His personal, pre-millennial return in power and glory.

### **ADMISSION**

### Acceptance Policies

FBCS exists to meet the needs of the membership of First Baptist Church and is open primarily to members of First Baptist Church. However, we will admit some children whose parents are in good standing with another church of like faith and practice. By enrolling, Parents are stating that they are in total cooperation with the purpose, philosophy, and doctrine of First Baptist Church and the standards set forth in this handbook.

Each applicant will be reviewed by the Administration for acceptance or rejection. Children are not denied enrollment to First Baptist Church School because of below-grade level achievement scores. However, if it is felt that a child requires additional specialized assistance, the parents will be given a referral to an appropriate service, or the student will be placed in the proper grade level. A child may be denied admission if the transcripts reveal that the student has a prior discipline problem.

First Baptist Church School, as a private institution, reserves the privilege of setting and maintaining its own standards of student conduct, dress, cleanliness, and scholarship. The school maintains the right to refuse admittance and terminate attendance of anyone who violates the standards set down in the rules and regulations for students, or rules of conduct as defined by the school administration.

### Steps for enrollment

- 1. Complete and return an Enrollment Application for each child to be enrolled, along with the appropriate fee. The application fee is non-refundable.
- 2. Parents and prospective students review the Handbook. This will answer most questions.
  - a. An interview with the parents is conducted.
  - b. An interview with the student (7th-12th grade) is conducted.
- 3. Read and sign the other various forms supplied by the school.
- 4. All curriculum/book fees MUST BE PAID IN FULL before the child will be issued any books.
- 5. All students must be immunized according to the California Department of Education Immunization Standards, and parents must supply the school with a copy of the immunization records.
- 6. All transcripts from previous schools must be requested by filling out the appropriate request form at the time of registration.

### Student Selection

Certain individuals will be given priority over other applicants. Returning students will be given priority over new applicants. New applicants transferring from Christian schools may be given priority over transferring applicants from public schools, and children of First Baptist Church members will be given priority over all.

### Non-Discriminatory Policy

First Baptist Church School has a racially non-discriminatory policy, and therefore does not discriminate against applicants based on race, color, national, or ethnic origin.

### Re-enrollment Procedures

Students who are re-enrolling must do so earlier than general registration in order to guarantee acceptance. No student has the right to re-enroll. Application for re-enrollment will be approved at the sole discretion of the administration.

### **Interview and Testing**

Students are enrolled at FBCS on the basis of an interview with each prospective student, his parents, and the administration.

Any new student will be tested by FBCS before placement in grade level.

The church's Statement of Faith and the School Handbook will be thoroughly reviewed to ensure that parents understand its provisions.

### Parental/Student Agreement

All parents and each 7th-12th grade student must sign The Student Handbook Agreement Form, pledging their support of the school's program, before the child is admitted to school. All parents of students from K4-6th grade must sign this form on behalf of their children. Any student who does not have this form on file in the school office, agreeing with the direction of the school, will not be admitted or will be asked to withdraw.

### **School Procedures**

### School Hours

Full Day 8:15 A.M.-3:00 P.M. Minimum Day 8:15 A.M.-12:00 P.M.

### Arrival and Departure

### Drop Off

- 1. 1 staff member will be on duty in the North Parking lot at 7:45 a.m. each morning. Students arriving after 7:45 a.m. are to go directly to the North parking lot and remain there until school begins.
- 2. FBCS is not responsible for students before 7:45 a.m.
- 3. Follow traffic instructions in the "dropping off" and the "picking up" of your child as directed.

### Pick Up

- 1. School is over at 3:00 p.m. Parents should make arrangements to have their children picked up at 3:00 p.m.
- 2. After school, all students will proceed directly to identified supervised areas, and <u>remain</u> there until picked-up. No loitering on school/church grounds will be allowed.

#### Late Pick Up:

- 1. All Students not picked up by <u>3:15 p.m.</u> will be escorted to Extended Care. (Extended Care charges apply.)
- 2. Only legitimate emergencies will be excused the Extended Care fee.
- 3. Students serving detention need to be picked up by 3:30pm.

<u>Minimum Day Schedule</u>– All students on minimum days <u>must</u> be picked up by <u>12:15 p.m.</u> **Extended care will not be provided on minimum days.** 

### **Tardiness**

School begins promptly at 8:15 a.m. Students are considered tardy if they <u>are not in their classroom</u> (or other designated area) by 8:15 a.m. Please note that a written note does not automatically excuse any tardiness. The tardy must be in accordance with the provisions set forth below in order to be excused. There will be no penalty for excused tardiness.

#### **Excused Tardiness:**

- 1. Doctor's appointments
- 2. Unknown car/transportation problems
- 3. Legitimate emergencies

### Unexcused Tardiness: (for example)

- 1. Oversleeping
- 2. Running errands/Running late
- 3. Working late the night before
- 4. Known car/transportation problems

### Penalties for Unexcused Tardiness: (Per Quarter)

10 occurrences of tardiness – Parental Conference with the Principal

20 occurrences of tardiness- Parental Conference with the School Board

### Attendance

#### **Absences - General**

All students who have been absent will need to present to the school office a written excuse signed by the parent or legal guardian, the morning they arrive back to school. Whether or not a student has a note, they must report to the main office to receive a pass to return to class. Excusable absences are listed below. Any absence involving three consecutive days in any one semester must have a written statement from a doctor to qualify for an excused absence due to illness. If there is not a written excuse on file within 48 hours of the absence, it is recorded as "Unexcused." Consecutive absences will be followed up by a phone call so as to discern the reason for the absence.

#### **Excused Absences are as follows:**

- 1. Illness with a doctor's note
- 2. Medical, dental appointments
- 3. Funeral Services for family members
- 4. Court Appearances
- 5. Family/Personal events with advanced written notification

#### **Unexcused Absences are as follows:**

- 1. Oversleeping
- 2. Staying home to study
- 3. Not feeling well
- 4. Student not "wanting" to attend
- 5. Family/Personal event without prior written notice

Parents who wish to take their children from school during the school day should send a note to the office. If a student is dismissed early, the parent is responsible for signing out the child in the school office. Parents should wait in the office. Office personnel will summon the student from class.

### **Unexcused Absence Penalty**

An unexcused absence means a student <u>may not make up missed work or tests</u>. Any student missing more than fifteen days per semester, for any reason, will find his grades for the semester's work in jeopardy. Parents will receive a letter from the school office when the student has reached his 10th and 15th absence.

### Make Up Work

Whenever a student misses class work and/or homework due to an excused absence, he will be given the number of days he was absent plus one day to make up this work without receiving a zero. (Ex.: two days excused absence = three days to get the missed work turned in.)

### **Policies**

### **Learning Disabled**

First Baptist Church School does not have a specialized program for learning disabled students. It is the administration's job to make sure that each child is having his individual needs met by the teacher; therefore, the administration may suggest that a student not enroll at FBCS but have his needs met elsewhere.

#### Residence

Students must reside with their parent(s) or legal guardian in order to be accepted and remain in the school. This remains true even if the student has reached the age of 18 years.

### **Elementary Specifics**

Age Requirements for Kindergartens

- 1. All prospective kindergarten students must be five years old on or before September 1 of the school year to enroll in K5.
- 2. All prospective kindergarten students must be 4 years old on or before September 1 of the school year to enroll in K4.

### Health Policy

The most appropriate person to administer medication to a child is the parent. This is best accomplished in the home setting. However, if it becomes necessary for medication to be administered at school, then <u>one</u> of the following two procedures must be followed:

- 1. The parent or guardian may come to the school with the medication and administer it personally to the child. Call the school to arrange the time when you will arrive to administer the medication.
- 2. The parent must fill out a *Request for Administration of Medication* form each time there is a need to give **prescription or non-prescription** medication. Also, a written statement from the Physician requesting that medication be administered must be given to the School Office. **All medication must be in its original labeled container.**

The administration of medication in this manner is in compliance with the California Education Code 49423, which is cited below. **Over the counter medications must follow the same procedure**.

Education Code 49423 states that, Notwithstanding the provisions of Section 49422—Any pupil who is required to take, during the regular school day, medication prescribed for him by a physician, may be assisted by the school nurse or other designated school personnel if the school receives (1) a written statement from such physician detailing the method, amount, and time schedules by which such medication is to be taken, and (2) a written statement from the parent or guardian of the pupil indicating the desire that the school assist the pupil in the matter set forth in the physician's statement.

### **Physical Examinations**

Students must have a physical examination by their family physician when entering the 1st grade.

#### **Immunizations**

All students must have the required immunization shots and a record of these must be in the student's file prior to the admission process being completed.

#### P.E. Exclusions

Students who are unable to participate in physical education must have a doctor's excuse.

#### **Head Lice**

Occasionally, the school staff will do a school-wide lice check. If your child has lice nits, eggs, or bugs (dead or alive) they will have to be sent home until their hair has been treated with lice shampoo, and every nit and egg has been picked out.

### Financial Policy

### **Our Financial Operations**

First Baptist Church School is a private, not-for-profit corporation. No state or federal funds are received by the school. Income from tuition is insufficient to fully cover the cost of operating the school. Interested individuals are invited to contribute to the operation of the school via gifts for general expenses or by providing scholarships for deserving students who would otherwise be unable to afford such training. A school fund raising project may be planned as the need arises. We reserve the right to use school income for any facet of the church ministry if deemed necessary.

### **Payment Schedule**

Payments are made directly to **First Baptist Church School,** and are due on the 1st of each month. FBCS automatically will charge a \$25.00 late fee for payments received after the 15th of the month.

All payments must be made by check, money order, cash, or credit card in the school office. Please make all checks payable to First Baptist Church School. There is a \$1 fee for every \$100 paid by credit card.

The yearly payment schedule is:

- 1. 12 month payments, beginning in July.
- 2. 10 month payments begin in August depending upon date of registration.

### **Delinquent Payments**

Payments are due on the 1st of each month, (or other date that is specifically identified) **and are late** after the 15th. A \$25.00 late fee will be charged automatically when your payment is late. Payments 30 days past due **will** result in immediate withdrawal of your child from school.

Any student whose account is not current will not be permitted to participate in any graduation/promotion ceremony.

### **Discounts/Credits**

- 1. There is a 5% discount on all accounts paid in full by September 1st.
- 2. No illness credits are given.
- 3. Request for Tuition Assistance for 2 or more children in a family will be considered, and the request must be submitted to the School Board prior to August 1st.
- 4. If a student is withdrawn prior to the end of the school year, any discounts are negated and full tuition will be charged.

#### **Special Fund Raising**

First Baptist Church School is endeavoring to keep low tuition rates for the benefit of each parent. For that reason we will offer fundraising opportunities. The school receives no federal assistance, neither is it endowed or supported by any other organization.

### Church Attendance

It is naturally assumed that each child will faithfully attend all respective church services. Although Church Service attendance will not be recorded, it will be kept under observation. When a problem in church attendance is noted, FBCS administration will address parents directly so as to bring about a mutually agreed upon solution.

### Grievances

It is the policy of the school that problems or suggestions are taken up first with the offending party. If satisfaction is not achieved, then the problem should be presented in writing to the Administration. All letters written in the proper spirit will be given careful consideration.

### **Student Drivers**

Students who drive to school must obtain a parking permit from the school office.

Students are not allowed to loiter in or around cars during school hours.

Students driving vehicles or riding in vehicles driven by other students must have written permission from their parents on file in the School Office. A copy of the student's driver's license, current car registration, and vehicle insurance must be on file in the School Office.

Any infraction of the rules governing the use of vehicles or improper driving conduct such as speeding, reckless driving, etc. will be sufficient grounds for revocation of the permit to park on school property.

### Soliciting

We request that there be no soliciting on school property among school parents other than official, school-approved fund raising activities.

### School Office

The School Office will be open Monday through Friday from 8:00 a.m. to 4:00 p.m. When a visit to the classroom is necessary, please come by the School Office first. **DO NOT GO DIRECTLY TO THE CLASSROOM**. If you wish to meet with your child's teacher, please arrange for a private conference by calling the School Office.

Lunches, homework, books, and other items may be left in the School Office to be delivered to your child.

Students are only allowed to use the school office phone for legitimate emergencies. Forgotten homework or PE clothes does not constitute an emergency.

### Closed Campus

FBCS is a closed campus. Students are to remain on school campus at all times during the school day. This includes going off campus for a quick errand or to purchase lunch. If a student is caught off campus, a call to the parents will be made and a detention will be issued. If this occurs a second time, the student will be automatically suspended for one day. All visitors must report to the school office to receive a visitor pass. No non-FBCS students are permitted in the classrooms during school hours.

### Off-Limits Areas

The following areas of the Church property have been designated as "off limits" to all students: main church hallway restrooms, elevator, foyer, and Main Auditorium. No student should be in these areas without permission at any time during or after school hours.

### Safety Drills

Drills for fire, earthquake, and lockdown preparedness are held periodically to ensure that, in an emergency, the student body will react accordingly with a minimum of delay. Cooperation is necessary and expected in order to conduct them in a serious, orderly manner. A specified exit route has been established for each classroom. Students are to follow procedures when the signal is given.

### Parent-Teacher Conferences

FBCS recognizes the importance of the home and school working together to obtain spiritual and academic growth for the child (Deuteronomy 6:6-9, Ephesians 6:4). Two afternoons, at the end of the first and third quarters, are set aside for parents to discuss their child's progress with each teacher. It is importance that at least one parent attend these conferences if needed. We urge each parent to arrange his personal schedule in such a way so as to make time for Parent-Teacher Conferences. Additionally, parents are encouraged to discuss problems and set an appointment with the teacher throughout the school year should a need arise.

### Progress Reports/Report Cards

The purpose of our reporting system is to give parents and students an accurate indication of the progress, or lack of progress, that is being made. Each student is evaluated in two areas: academics and conduct. The academic grade is based on the actual work done on homework, quizzes, tests, exams, etc. The conduct evaluations are based on the actions and attitude of the child in the school environment.

Academic grading is based on a percentile of 100%.

Progress Reports will be given every 3 weeks. It is the parent's responsibility to sign and return the Progress Report within two days of its distribution.

Report Cards will be sent out every 9 weeks, which constitutes a quarter. Report Cards must be signed and returned within two days of its distribution. The fourth quarter and final Report Card will be mailed after the close of school. **Final Report Cards will be held until ALL financial obligations are met.** 

### Early Dismissal

### 11th and 12th grade students whose class periods end before 3:00pm must sign out.

Requests to leave during the school day (8:15am - 3:00pm) must be approved through the school office.

Students who drive their cars to school may not check out during school hours unless parental permission has been secured (this should be rarely used). All other students must be picked up by their parent, guardian, or authorized adult.

### Alternative Transportation

Bicycles, skateboards, skates must be stored during the school day in a designated location. Students are not allowed to ride these during recess or lunch breaks, and are not to be in this area unless arriving or departing school.

FBCS is NOT responsible for the safety and protection of any alternative transportation stored on school property.

### Emergency Policy

If an emergency occurs, every effort will be made to contact parents. If parents cannot be reached, appropriate medical attention will be secured, if necessary, according to your instructions on the emergency form.

The emergency information in the student's file must be current at all times. Please notify the School Office immediately of any changes in your phone number or address. If information in the student's file is not kept current after being requested, the parents may be asked to withdraw the child.

### Text Books

The only Bible used at FBCS is the King James Version. No other version will be accepted. In the event in which a student may lose or damage a book it may be required that the parent or guardian purchase a replacement book.

No text books will be issued until the book fee has been paid in full.

### Field Trip Policy

Field trips are taken at various times during the school year to places of educational interest. A signed Field Trip Permission Form gives permission for the student to take part in school sponsored trips away from the school campus. The student is required to maintain the same level of self-discipline away from school as is required at school. These trips will be chaperoned by teachers and by parents when requested. Regular school dress code applies to field trips unless otherwise suggested by the teacher and approved by the administration. **Parents are asked to follow the same standards of dress and conduct as the students.** 

### <u>Testing Policy</u>

First Baptist Church School uses the Iowa Assessment to help the administration and faculty to work more effectively with each student and to make continual improvements to the curriculum. A fee is included in the registration payment for each student to take this test.

It is also highly recommended that seniors and juniors register for both the SAT (Scholastic Aptitude Test – commonly referred to as the ("College Boards") and the ACT (American College Test). It is also recommended that all freshmen and sophomores take PSAT and P-ACT which are given in the fall of each year. Students will be notified, in advance, concerning the times and places of these examinations.

### Homework Policy

Believing that homework is an integral part of the school program, each teacher is at liberty to give homework to aid each student to advance in his studies.

Each student is expected to complete his homework assignments at home.

Homework is given for several purposes:

- 1. For Drill: We believe that most students require solid drilling to master material essential to their educational progress.
- 2. For Practice: Following classroom explanation, illustration, and drilling on new work, homework is given so that the material will be mastered.
- 3. For Remedial Activity: As instruction progresses, various weak points in a student's grasp of a subject become evident. Homework following instruction is given to overcome such difficulties.
- 4. For Special Projects: Book reports, compositions, special research assignments, and projects are some of the activities that are frequently the subject of the homework attention.
- 5. For Completion of Class Work: To complete work introduced in class.

Parents are not to do the homework assignments for their children, but do have a responsibility to help their child by providing a time and place with an atmosphere that is conducive to study and concentration. Unfinished homework assignments will affect the student's grades.

### Awards and Honors Policies

FBCS believes that unusual efforts and achievements should be rewarded. It is Scriptural that we should "...press toward the mark for the prize of the high calling of God in Christ Jesus." Phil. 3:14

Grade averages will be computed by academic achievement grades only. A list of Honor Roll students will be published at the end of each quarter and semester.

### **Eligibility/High School Honors**

The GPA of the student will determine eligibility for High School Valedictorian and Salutatorian. To be eligible for consideration, a student must have attended FBCS for a minimum of three years.

### Academic Probation

Any student whose 3 week progress report GPA is below 2.0, (A=4; B=3; C=2; D=1), will be placed on academic probation.

Academic probation is defined as follows:

- 1. Student may not participate in field trips.
- 2. Student may not participate in extracurricular activities. Example: Sports, Bible Quiz, Senior Trip

At the end of the following grading period, the student will be allowed to participate in school activities as usual if he has a 2.0 GPA. Academic probation will not carry over from one school year to the next.

### **Internet Policy**

The internet is an increasingly difficult area for parents to monitor in the home. In it there are so many avenues that the devil uses to pull Christians down. While our handbook covers many of the issues that can be found on the internet and through social networking, we institute the following policy. Any student who is a member or user of a social networking site or blog will be subject to the same standards of this handbook. Any use of profane language, or use of inappropriate pictures/graphics will be subject to the same discipline outlined in this handbook.

### Searches for Suspicion of Illegal or Unauthorized Materials

FBCS reserves the right to search all student's person and belongings in the event the school suspects any student may possess an unapproved or stolen item. Such a search may be conducted without the student's or parent's permission. Enrollment in FBCS constitutes parental consent for such searches.

The following items may be included in the search, but is not limited to this list:

- 1. Backpacks, purses, pockets, etc.
- 2. Lockers, desks, etc.
- 3. Automobiles on school property

### Electronic Device Policy

No student is permitted to use electronic devices on school property during school hours without prior approval. Secondary students may store such devices in their lockers. Any phone or device found in class or found in use during school hours will be held for 30 days or a \$25.00 recovery fee. Note: The administration reserves the right to check the device's contents while it is on school property. Enrollment in FBCS constitutes parental consent for such searches.

### **Prohibited Articles Policy**

Cigarettes, alcohol, narcotics, knives, guns, explosives of any kind, unapproved music, and anything depicting scenes or insignias associated with gangs are not permitted on school property. Violations will result in Detention to Expulsion. This list may be added to at anytime by the administration.

### Lost and Found

The school operates the Lost and Found from which articles may be retrieved from the school office. We urge you to mark all jackets, book bags, PE clothes, etc. with indelible ink for clear identification. The Lost and Found is accessible during office hours only. It is the student's responsibility to claim all lost articles, whether marked or not.

Students who find lost articles are asked to take them to the School Office. Any and all articles that are left in Lost and Found for more than 20 school days may become the property of the school and may be disposed of as deemed necessary.

### **Programs**

### Extended Care

Extended care is available from 3:15-5:30 p.m. The charge for extended care is \$5.00 per hour, \$3.00 first 20 min., \$4.00 first 40 min. after which the full hour will be charged. There is no grace period after 6:00 p.m. Any student not picked up by 5:30 p.m. will be assessed by \$1.00 per minute late charge. Extended care will not be provided on Minimum Schedule days.

### Lunch Program

- 1. FBCS is not a food service provider and does not prepare lunch for its students.
- 2. Parents should prepare a "bag lunch" for their children and provide all necessary extras, such as napkins, plastic spoons, forks, etc.
- 3. Children normally will eat in the school lunchroom with their entire class at scheduled times under the supervision of assigned school teachers.

### **Athletics**

### **Eligibility for Athletics**

Only eligible students may participate in interscholastic athletics.

- 1. Every athlete must meet the academic requirements as stated: a 2.0 GPA with no incompletes and no "F" in any subject.
- 2. The grades of all athletes will be checked every three weeks. If the student falls below the required standard, they will be ineligible for the next three weeks.
- 3. If a student is academically ineligible, he is still required to be at practices and must be at all home games in school attire on the team bench. He will not be allowed to travel with the team to any away games.

Parents will be charged an extra fee for participation in interscholastic sports which are as follows:

Mandatory liability insurance fee (all sports): \$55

Basketball Fee: \$25 Volleyball Fee: \$25

All other Athletic specifics are stated in the Athletic Handbook.

### **Proper Behavior**

#### **Code of Conduct**

FBCS expects its students to live above reproach in all aspects of their daily life. Students must exhibit respect for God, country, family, teachers, and fellow students as a way of life, not just on campus. Therefore, the dress code, code of conduct, and all other FBCS rules and regulations are in effect at all functions which are school related, such as sport games, etc.

### **Disciplinary Action**

### The Philosophy

"Discipline" is defined as... "To instruct or educate, to inform the mind, to prepare by instruction in correct principles and habits, as to discipline youth for a profession or future usefulness."

At FBCS we believe that education should be more than learning and retaining a mass of facts and figures. It should be a process of growth that develops the whole person spiritually, mentally and physically. Christian discipline is essentially a character building tool; it is concerned with the development of Christ's character into an individual's life. Biblical discipline involves deliberately guiding and directing the child in such a way as to change the child's will, attitude, and behavior, ultimately resulting in joy and success.

Various forms of correction may be used, depending upon the nature and severity of the problem. Students shall be treated fairly and equally. Disciplinary action shall be based upon a careful assessment of the circumstances, the seriousness of the offense, the student's attitude, and the potential effect of the misconduct upon the school and social environment.

Students who violate the school's rules and guidelines are subject to:

- 1. Privileges withheld
- 2. Parent-teacher conference
- 3. Parent-principal conference
- 4. After-School detention
- 5. Suspension
- 6. Expulsion

#### **Detention Procedure**

Detentions begin daily at 3:00 P.M. and end at 3:30 P.M. Any student arriving after 3:00 will be considered tardy and will receive one extra day of detention to serve, in addition to the original one. Each service of detention is for 30 minutes. Detention will be served mandatorily on the day after issue. Detention cannot be served unless the signed slip is turned in to the supervising faculty.

### There will be no excuse for missed detention. If a student misses or skips detention an additional detention is issued.

Upon accumulation of 5 detentions the student will be called into the principal's office.

Upon accumulation of 15 detentions the student will be suspended for one day.

Upon accumulation of 25 detentions the student will be suspended for two days.

Upon accumulation of 35 detentions the student will be expelled.

These accumulation totals are based on semester time periods. At the start of the second semester the totals will begin anew.

### **Suspensions**

Students whose deportment has been shown to be unacceptable may be subject to suspension. This means the student would not be allowed to attend class or be on school premises for the duration of the period of suspension.

The suspended student is not allowed to make up any missed work.

Upon accumulation of 4 suspensions within the school year, the student will be expelled. The suspension totals do not reset upon semesters.

### **Expulsion**

It is the goal of FBCS to work with and through any student disciplinary issues. FBCS is greatly honored and privileged by every student's admittance into the school and will work together with the parent toward a successful promotion/graduation. Nevertheless, the school administration reserves the right to expel any student at any time when, in the administration's estimation, the student's extremely aberrant behavior/attitude is found out of harmony with the rules and policies of the school. Expelled students may not be considered for re-enrollment until the next school year. Re-enrollment will then only be allowed if the student returns on probation. Expelled students may not return to school campus before, during, or after school without prior written permission from the school administration. Decisions in these matters are the full responsibility of the administration working together with the Pastor and further reviews or appeals will not be considered.

- Illegal Drug use, distribution, paraphernalia, or possession- Expulsion
- Gambling-Suspension/Expulsion
- Involvement in crimes- Expulsion
- Immorality (language, lifestyle)- Expulsion
- Pornography- Suspension/Expulsion
- Possession of knives, firearms, or any other fighting instrument on school property-Expulsion
- Striking a Teacher- Expulsion
- Tobacco use or possession- Expulsion
- Possession of explosive material of any kind on school property (including fireworks and firecrackers)- Expulsion
- Possession of contraceptives- Expulsion
- Truancy- Suspension/repeat occurrence Expulsion

**Note:** Any student who threatens verbally, through writing, or graphically to shoot or harm the school property, employees, or other students in the school, will be subject to immediate expulsion and criminal prosecution.

Any arrest for any crime will constitute immediate expulsion.

### **Dress Code and Grooming**

Our dress standard is based on these Biblical principles:

- 1. Modesty
- 2. Distinction of gender

The students are expected to dress modestly and appropriately. It is expected that the parents make sure that their child conforms to the dress standard of FBCS.

FBCS students are to be dressed according to school regulations when arriving at school and departing from school. Students must also be dressed properly after gym or recess breaks.

The Administration is the final authority in interpretation of any standard that may come into question on an individual basis. This dress code can be subject to change based upon the administration of FBCS discretion.

#### **DRESS CODE**

All students are to be neatly and appropriately dressed during school hours and for all school sponsored activities. It is required that students dress according to school guidelines when attending church services.

While the dress code is intended to be inclusive, a fad or a style may not be specifically mentioned.

#### **Parent Dress Code**

We ask that all parents dress according to the stated dress code when they come to school classes, field trips, class birthday parties, etc. It is preferred that parents also observe the dress code at ball games and any school-related function.

#### P.E. Uniforms

Students are required to dress in the school's specified gym uniform for P.E. class.

### GIRLS DRESS CODE

Non-denim, below-the-knee length, loose fitting skirt; Slit must not be higher than the back of the knee. Skirts must be navy blue, khaki or plaid (only available from Land's End). Our goal is that the skirt length be sufficient to ensure modesty while standing, walking, bending, or sitting. We strongly recommend that undershorts (i.e. bike shorts), of any color be worn under skirts.

Loose fitting Polo style shirt buttoned up except for top button. Shirt must be light blue, royal blue, navy blue, gray, or white. Only FBS logo will be permitted. An undershirt is recommended for modesty.

#### Hair/Make-up

Hair should be neat and attractively maintained. Hair is not to be shaved or shaped in extreme style. Hair color may only be changed to a natural tone.

Make-up, if used, must be used modestly.

### Jewelry/Accessories

Earrings should be worn only on the earlobe. No other piercings are acceptable. Only one bracelet may be worn on either wrist.

### **BOYS DRESS CODE**

Navy blue or khaki non-denim, non-form fitting pants, straight leg: belt must be worn.

Polo style collared shirt buttoned except for top button, and tucked in. Polo shirt must be light blue, royal blue, navy blue, gray, or white. Only FBS logo will be permitted. An undershirt is recommended for appropriateness.

#### Hair

All boys are to wear their hair so that it is neat, attractively maintained and groomed. **All hair styles** are subject to administrative approval.

- 1. Not covering eyes
- 2. Boys' hair not to cover ears, eyebrows, or extend past shirt collar
- 3. No facial hair
- 4. Sideburns may extend down to bottom of ear

### Jewelry/Accessories

No jewelry besides a wristwatch and ring are allowed to be worn. No bracelets or wristbands (excluding medical bands) may be worn at any time.

### Shoes

No flip flops or open toed shoes allowed. Socks must be worn with shoes.

### Field Trip Dress

Regular uniform dress is required for all field trips unless notified differently by the administration.

### Jackets/Sweaters

Sweaters: Only navy or gray sweaters will be permitted.

Jackets: Defender hoodies or Defender jackets will be permitted.

No other jackets or hoodies will be permitted.

### Parent's Code

Our parents play a vital part in the total program of FBCS. Emphasis again and again has been placed upon the importance of parents cooperating with the school for the education of the child. We like to believe that the following code, when subscribed to by all our parents, would make FBCS a school that would truly honor the Lord and produce the finest education possible.

- 1. I will pray regularly for the teachers and administration.
- 2. I will cooperate fully in the educational function of FBCS, doing my best to make Christian education effective in the life of each of my children, that they may love and serve the Lord Jesus Christ for all their lives.
- 3. I will pay all my financial obligations to the school before the date they are due. If I am ever unable to pay on time, I will notify the school in advance, giving a reasonable explanation for the delay and stating when the payment can be made.
- 4. I will assume volunteer duties and responsibilities as opportunities arise and as God provides the strength and time.
- 5. I will attend periodic meetings and parent's functions of the school.
- 6. If I become dissatisfied with FBCS in any respect, I will try to resolve the matter with the person or persons involved, rather than seeking to spread criticism or hold a negative attitude in my heart. I will not criticize the school before my children. I will follow the Biblical information found in Matthew 18:15.
- 7. I will seek the advancement of FBCS in all areas: spiritually, academically, and physically.
- 8. I will attempt to visit/observe my child's classroom sometime throughout the school year.

### **High School Specifics**

#### Make Up Work

It is the student's responsibility to talk with his teacher regarding making up work when he is absent with an excuse. Whenever a student misses class work or homework due to absence, he will be given the amount of days he was absent plus one to make up this work without receiving a zero. (Ex.: two days absence = three days to get the missed work turned in.)

### **Make Up Tests**

Whenever a student misses a scheduled test or quiz due to absence, he must make up that test according to the individual teacher's schedule.

If a student is tardy for class during the taking of a test or quiz and that tardy is unexcused, he will have the amount of test or quiz time left in class to finish it. If it is an excused tardy, he may be required to take that test or quiz if the teacher feels there is adequate time. If not, he is to make up that test or quiz according to the teacher's schedule.

### **Homework/Grades 7-12**

A percentage of your child's grade will be determined by the completion of assigned homework, therefore it is most important that homework is completed.

### **High School (Grades 9 - 12)**

Depending upon the course of curriculum, 230 to 275 semester units are required in grades 9-12, including Bible courses. Each major subject will receive 10 units.

Parents of high school students, and the students themselves, must understand that graduation from FBS is not "automatic" upon completion of 12 years of school. No diploma is granted until the student has completed all the requirements of the particular curriculum course of study. This may require attendance beyond the student's 12<sup>th</sup> grade year.

### **Physical Education:**

As part of the requirements for high school graduation, each student is required to successfully complete four semesters of P.E. No student is exempt from P.E. unless he has a written excuse from a physician. All Junior High students will be required to take P.E.

Please note: FBCS is an unaccredited school, but is a member of the American Association of Christian Schools. There is an option for accreditation if dual enrolled in Alpha Omega Academy which comes at an additional cost.

### Promotion/Retention

Seventh and Eighth graders do not accumulate credits toward high school graduation. Failure of three or more subjects (yearly average) automatically requires retention for seventh and eighth graders.

The following are the conditions which require a junior high student to attend summer school:

- 1. Those who fail the year in Mathematics or English.
- 2. Those who fail three academic subjects for the year.

Junior high school students (in one of the categories above) may be retained to repeat the grade instead of going to summer school.

At the high school level (grades 9-12), a student will only advance to the next grade according to the credits which they have earned.

Those who fail either semester of any course required for graduation must attend summer school.

<sup>\*</sup>Bible is a required subject for each year a student attends FBS.

### Ignitia Program

Any misuse of school equipment will result in suspension and reparation of damages.

Any misuse of Ignitia account will result in a two day suspension. A second offense will result in a 5 day suspension. A third offense will result in expulsion. Misuse of account could include any of the following but not limited to: stealing passwords of another user, giving your password away, letting another person do your assigned worked, logging on at inappropriate times (during church), doing someone else's assigned work.

### **Elementary Specifics**

### Four-Year-Old Kindergarten

Since much of our knowledge is acquired during the first six years of our lives, a four-year-old student is of prime importance. We endeavor to teach the children in the areas of Bible, Alphabet/Phonics, Manuscript Writing, Numbers, Art, and Music.

### Five-Year-Old Kindergarten

The five-year-old child is ready both mentally and physically to participate in an active educational program. The child is given an opportunity to advance in many areas of learning such as: Bible, Cursive Writing, Comprehensive Reading, Art, Music, Phonics, and Mathematics.

### Elementary Discipline

Each teacher will have their discipline procedure given out with their classroom management plan. In the event that a student is sent to the office, the parent might be called to help take care of the problem.

K4-6th grade students are expected to live a life honoring to our Lord Jesus Christ and it is naturally assumed that parents will keep their children from obviously sinful or worldly activities.

Elementary Discipline can include any of the following methods: detention (before, during, or after school), suspension, or expulsion.

### General

We count it a privilege to work together with parents in training your children. Our goals for each child include achieving *self-control* and *good Christian character* in addition to being academically prepared.

Proper Discipline is firm, consistent, fair, and tempered with love. Our teaching staff attempts to maintain standards of behavior through kindness, love, and a genuine regard for the student.

If your child is having a problem with his behavior, your child's teacher will be in contact with you to help correct behavior patterns in the classroom.

### **School Classroom Rules**

- 1. Sit up straight and stay in your seat at all times
- 2. Be prepared for class

- 3. No talking without permission
- 4. Obey all instructions the first time they are given.

### Dismissal/Expulsion

Dismissal occurs when a student is not performing within the boundaries of Christian attitude or conduct. Students who are dismissed may not be considered for re-enrollment until the next school year.

### Good Behavior

Each teacher will have good behavior incentives. Merits, privileges, notes (praising positive behavior), stickers, and small rewards will be given on a consistent basis.

Each teacher will choose a "Student of the Month." These children will be given special recognition in chapel.

### Playground Rules:

- 1. Fighting, play fighting, or rough housing is not permitted.
- 2. Students are not to climb on any fences, light poles, or walls on the school campus.
- 3. Students must wear shoes at all times.
- 4. Students are responsible for keeping the playground neat and clean.
- 5. Students are to remain fully dressed at all times while on campus.
- 6. Parents will be responsible for any equipment that is damaged or destroyed by their child.
- 7. Balls must not be bounced against facility walls.

FBCS reserves the right to make, amend, or prescribe the rules and policies for behavior, dress, appearance, or any and all other unforeseen problems that may arise at any time during the year. The school expects full cooperation from both the student and parents in the education of the student and in adherence to all school plans, policies, and regulations.

Initial incoming class in fall of 2021 will be all freshman, and with a varsity level only it will prove difficult to field varsity level teams, without at least two grade levels on campus.
Continuing to introduce gymnasium/stadium phase on campus to support athletics programs is advised
Understanding that a probationary level membership gives them time to solidify possible league inclusion (Heritage), during 2022 school year when at least two levels are on campus and Varsity level participation is feasible. Since they only plan on 1 level of competition (varsity) this is a concern. With no staffing in place until July, probationary membership will allow for Athletic Administration, Athletic Director, Coaches and support staff a year to get programs, procedures, and inter-district agreements in place.



Accreditation: PWS is a full member of the Association of Waldorf Schools of North America (AWSNA) and the Western Association of Schools and Colleges (WASC)

Curriculum: A Waldorf high school provides a comprehensive, cohesive, and rigorously challenging college and life preparatory curriculum that balances academic, artistic and social-community development work. In addition to its preparatory nature, the purpose of all curricular subjects is to encourage students to operate regularly outside their comfort zones, thereby developing confidence and the willingness to accept challenges and to see work through to its end. Because Waldorf Education works with a curriculum designed to meet the developmental needs of students, all students take the core curriculum and are asked to stretch themselves daily. Much of the core curricular subjects, particularly history and science courses, are taken all four years, to meet the students developmentally, so that students are learning about each subject in a way that relates to them as adolescents. Because of the high-degree of internal rigor in our Waldorf Educational program, AP and other second-party proprietary courses are not offered.



## Music

Music is a core element of the Waldorf curriculum, and plays a central social and artistic role in the high school. The music program allows every student, from novice to accomplished musician, to participate fully in the study and performance of choral and instrumental music. The program's goal is to empower students through a deep understanding of music as a language that they can perform, interpret, and create.







Obviously, the past year has presented unprecedented challenges regarding the athletic program at TREE Academy. While we have kept an eye on building for the future, we have been able to accomplish a number of significant upgrades during the 2020-2021 school year to bolster our case for inclusion as a full member of CIF.

Although we do not have a gymnasium on our campus, we have spent a good deal of time and energy to upgrade our facilities at the TREE Academy campus. Since last May, UCSA has expanded its weight room through the purchase of additional training equipment, and has improved its practice field [approximately 70 yards x 30 yards, with a 1/8 th of a mile dirt track around it]. These improvements will enable the existing athletics teams at UCSA to practice on campus, and they provide a location to train the student athletes involved in the athletics programs we are developing. Additionally, UCSA has become an Accredited High School, and is a member in good standing in the Agape/Cross Valley league. Both of these have further helped bring consistency to the academic and athletic programs we are able to provide.

Even though this has been an incomplete year with respect to athletic competition, it will be a complete calendar year of probationary status for UCSA. Therefore, the administration at the University Careers & Sports Academy, requests that the CIF Executive Committee grant full membership beginning in the fall of 2021 to UCSA.
