#### Mandatory Playoff Use Requirement:

The mandatory "official" ball rule for all playoff rounds, excluding golf. The rule applies throughout the conduct of <u>all</u> CIF-SS <u>playoff</u> contests.

\*Items in red are used in the final game for the CIF-SS Championships. Any model listed is approved for play in CIF-SS post season play.

#### Playoff Ball Use Rule Enforcement:

Should a school fail to provide the correct game ball, the game will always be played. Teams/schools failing to utilize the correct official ball in CIF-SS playoffs will be reported by officials to CIF-SS and will not be allowed to host their next available home playoff game. Penalty will carry over to the next season if not enforceable this season due to elimination.

Note: NFHS stamp is required in all sports except in golf, tennis and beach volleyball.

#### PLAYOFF INFORMATION

#### A. TEAM PLAYOFF ENTRY FORMAT

The CIF Southern Section is pleased to conduct the 2024-2025 CIF Southern Section Ford Girls Team Beach Volleyball Championships.

The 2025 Girls Team Beach Volleyball Playoff brackets will be established based on submissions from the respective leagues. There will be three (3) divisions of Girls Beach Volleyball. Should the number of automatic playoff entries fail to complete the full bracket, the inclusion of AT-LARGE teams will be added to the draw.

All recognized leagues will be guaranteed team entries based on the size of the league. All 4 team leagues will be guaranteed 2 entries; 5 and 6 team leagues will be guaranteed 3 entries; 7 and 8 team leagues will be guaranteed 4 entries; 9 or more team leagues will be guaranteed 5 entries. Under the playoff format, in all sports, leagues have the responsibility of developing and identifying the priority for their representatives into the playoffs as so noted under Article 350 (Playoffs) of the CIF Southern Section Blue Book. Please note, leagues may not conduct additional contests beyond the prescribed limits unless said contests are to determine AUTOMATIC ENTRY and not representative priority (leagues must have this as part of their constitution and must secure permission from the CIF-SS office before conducting such playoffs for entry).

#### AT-LARGE ENTRIES / Must Have Overall Record of .500 or Better AND Played a Minimum of 12 Matches

AT-LARGE entries can only be considered when the number of automatic entries does not fill the size of the playoff bracket. For example, 30 teams earned an automatic entry therefore two (2) AT-LARGE entries are to be selected to fill the bracket to 32 teams.

#### **BYLAW 3500 PLAYOFFS**

For additional information on bracket construction, filling of "byes", wild card entries, AT-LARGE entries, and determination of sites after the first round please review Bylaw 3500 in the CIF Southern Section Blue Book.

#### LEAGUE CHANGE OF ENTRY

A League Automatic Qualifier Reconciliation document will be posted to the cifss.org public website by Thursday, April 17 at 11:00am. Leagues/ Schools will have the ability to correct a leagues automatic entries until 2:00pm Thursday, April 17, 2025. After 2:00pm Thursday, April 17, no new information will be accepted or corrected. The entries will be locked, and brackets created. Due to the complexity of this system no adjustments will be considered or made after this deadline.

#### **END OF COMPETITION**

All non-league/league competition for entries must end on Wednesday, April 16, 2025.

Note: A leagues individual qualifying tournament make take place after the Team Entry deadline. League Individual Entries must be reported by Friday, April 25 at 12:00 noon.

#### B. CIF SOUTHERN SECTION BEACH VOLLEYBALL TEAM QUALIFICATIONS

#### PLAYOFF BRACKET CONSTRUCTION

With the passage of the new competitive equity playoff system (CIFSS Council, January 2024), and changes to Bylaws 3519 and 3520, the way we group playoff divisions has changed. To summarize, playoff divisions will be created at the end of the regular season based on a team's current win/loss data. It is imperative that coaches/athletic directors enter their full schedule, and results consistently throughout the season. Member schools who fail to accurately enter complete regular season results into the CIFSSHome system will not be placed into a playoff division and will be ineligible to participate in the Southern Section Championship Playoff Tournament. Schools (via the coach and/or AD email) have been getting updates of missing scores throughout the season. The missing results must be filled or deleted. Schools frequently use "TBA" as opponent names in tournament situations as placeholders. Please review your results carefully, entering actual tournament opponents played, the correct date the contest was played on, and the game scores. Please look through your schedule and scores on CIFSSHome (no other platform) as all data retrieval will be from CIFSSHome. The Massey Ratings, the same power ranking system the CIFSS has used in various sports since 2014 will be used. Previously, the overall strength of the league would determine pre-season divisional placement. Now, only the current year will be used for in-season divisional placement. The benefit of this is being placed in a division based on the accolades of the team a school currently has, rather than the success or the strength of the league.

PLEASE MAKE SURE ALL SCHEDULES AND SCORES ARE COMPLETED BY WEDNESDAY, APRIL 16th (end of the day) or sooner!

Last League and Contest Date: Wednesday, April 16th (NO TEAM MATCHES MAY BE PLAYED AFTER THIS DATE, AT ANY LEVEL).

Score Reconciliation: Thursday, April 17th (NO GAMES ARE BEING PLAYED, THE SEASON HAS ENDED FOR ALL LEVELS) Playoff Bracket Release: Friday, April 18th.

The CIF Southern Section Girls Beach Volleyball Playoffs shall be conducted in three (3) playoff divisions. Bracket size for all divisions will be determined based on the number of automatic entries and team power rankings after the regular season has been completed.

It will be the responsibility of the Commissioner, and his staff to establish the pairings in each first round game for all divisions. Playoff groupings will be created using an average of the total number of automatic qualifiers across all divisions. A **playoff division will start with an automatic qualifier** and include all teams until the automatic qualifier which begins the division below it. Once Automatic Qualifiers have been placed into a division, any remaining spots will go to the highest ranked, .500 or better At-large / Freelance team(s) in that grouping. The ranking of each team will be determined by a schools rating at the designated time Thursday afternoon, April 17, 2025.

All playoff brackets will use a single elimination format regardless of size. Each playoff bracket will rank the teams #1 - #16 or #1 - #32. In this format the #1 ranked team will play the #32 ranked team, the #2 ranked team will play the #31 ranked team, etc. until the all the first-round matchups are set. The higher ranked team will be the host team for the first round of the playoffs. After the first-round playoff Bylaw 3504 will be followed to determine who will host the second round and beyond. Matchups will be set based on a team's ranking and does not consider league affiliation or league place. The

higher seeded team, regardless of league finish, shall be the host school in the first round. It is possible that two teams from the same league will meet in the first round of the playoffs.

Important information to be considered regarding the formation of the 2025 playoff divisions:

- Rankings for all teams will be determined at a designated time Thursday afternoon, April 17, 2025. Rankings will be taken using the Massey Reporting system. As the rankings are dynamic, only these rankings, from that moment will be used. Massey rounds to the nearest 10<sup>th</sup> in posting their rankings, however teams that are tied in ranking, will have their strength of schedule used to break an exact matching power ranking value.
- 2. After all teams have been placed into division one, the next available automatic qualifier and all remaining teams after that will make up 16 to 32 team brackets to form divisions 2 & 3.
- 3. An average of automatic qualifiers will be used to place teams into division. It is an average, with some divisions having more, and some less than the average depending on the order of automatic qualifiers and number of at-large teams in a grouping of teams. There are currently 73 automatic qualifiers from 23 established leagues for the 2025 season. (This number is subject to change based on participation of all teams during the league portion of our season.)
- Once automatic qualifiers have been placed into a division, and pending space, any remaining spots will go to the highest ranked, .500 overall record or better at-large teams in that grouping. A team MUST be .500 or better to qualify for the playoffs regardless of their power ranking.
- 5. Team schedules and results will be locked, and brackets created after 2:00pm, Thursday, April 17, 2025. Due to the complexity of this system no adjustments will be considered or made after this deadline.

AT-LARGE PETITION / APPLICATION – MUST HAVE .500 RECORD OR BETTER AND PLAYED A MINIMUM OF 12 MATCHES FOR CONSIDERATION (see Blue Book for clarification): Please follow the instructions below to enter your school as an AT-LARGE Entry for Girls Beach Volleyball. The AT-LARGE Application is to be submitted by your school no later than Wednesday, April 16, 2025, by 9:00 p.m.

Log in @ <u>www.cifsshome.org</u> (If you do not have a log in & password as a coach, check with your Athletic Director). Once you are logged in:

- Please be sure that your Schedule is updated in CIFSSHome as this is where the information for the At-Large Petition will be created.
- On the left panel, click on AT-LARGE Petition
- Select "Girls Beach Volleyball" then click "Add"

#### AT-LARGE SELECTION CRITERIA

The team(s) selected to fill any open positions in either a 16-team or 32-team playoff backets will be based on the school's individual power ranking number. The highest ranked team in each respective division that was not an automatic qualifier will be selected to fill any open positions until that bracket is complete.

An At-Large entry may be seeded in any position on the bracket based on their team's power ranking except for #1 as no playoff division will start with a non-automatic qualifier.

#### FREELANCE PLAYOFF ENTRY QUALIFICATION

All freelance schools desiring entry into the playoffs must submit their "Freelance Petition" and schedule with updated results into CIFSSHome. **Schedules must be input into CIFSSHome prior to the start** 

**of each season for evaluation.** (Rule 3510.1) Match scores must be regularly updated in CIFSSHome and final season results submitted to the CIF-SS office by April 16, 2025 @ 9:00 p.m. Freelance schools must also submit an "At Large" petition through CIFSSHome prior to 9:00 p.m. on April 16, 2025.

#### C. PLAYOFF TOURNAMENT RULES/HOSTING INFORMATION

#### 1. SPORTSMANSHIP

To maintain a high standard, we urge every player and coach to review the essentials of good behavior while on the court. You are reminded that this is a Southern Section activity which should be conducted in the highest tradition of good sportsmanship.

Coaches are expected to submit their playoff line-up for each match by placing players in rank order based on ability. A team's top pair must be entered as 1's the next best pair entered as 2's, etc.

#### 2. <u>RULES</u>

All playoff matches will be conducted following the CIF-SS Beach Volleyball Rules 2024-2025. https://cifss.org/wp-content/uploads/2021/06/CIF-SS-Beach-Volleyball-Rules-2024-2025.pdf

Teams must consist of 5 pairs to participate. A school may not enter a match with less than 5 pairs. During the regular season a match may have been conducted with less than 5 pairs to grow the sport however at this time for the playoffs that is not allowed.

All matches (5 pairs) must be played to conclusion. Truncating (ending a contest when one team has secured 3 points) is not allowed.

#### 3. ELIGIBILITY LIST

An eligibility list must be completed and submitted to the CIF-SS Office **prior** to your first playoff contest. This list will suffice for all remaining contests. This list is generated through the CIFSSHOME.org site when your roster information is input into the system.

#### 4. OFFICIALS

A beach rules "monitor" is required for each team playoff event. The host school is responsible to pay the beach monitor as this is a non-revenue sport. The host school must also communicate the location and time of the contest with the beach volleyball assignor.

Playoff officials "monitor" fee: Minimum 2 hours - \$80 Each additional ½ hour or portion of - \$20

#### 5. TIME OF MATCHES / LOCATION

All matches are scheduled to begin at 2:00 p.m. Schools may play at another time if it is mutually agreeable to both competing schools. The location of each contest must be communicated to the CIF Southern Section office.

6. <u>PRE-GAME/HOSTING ARRANGEMENTS</u> The host school is responsible for:

- Securing an adequate site for use in all team playoff matches. Our Office is recommending a minimum of three (3) courts for team competition.
- Contacting the visitors immediately after learning opponents name and prior to the contest to confirm location, number of courts, warm-up time and contest time.
- Providing information to the visitors regarding directions to the match site, special parking regulations and any other special circumstances relative to the match.

The CIF-SS Office is not presently equipped to survey all sites during the coming post-season competition. We depend upon the good judgment of the home school management to notify this office and all opponents if a given site does not meet minimum standards.

#### 7. MATCH RESULTS

You must post your match results on CIFSSHOME.org immediately following the <u>match</u>. This is for score reporting only. Information regarding the next round will be updated on the CIFSS website after 9:00 a.m. the next day.

#### 8. PROTESTS

By action of the CIF-SS Council at its March 1983 meeting, protests of playoff contests involving rules will no longer be entertained following the conclusion of the contest. No protest may be carried forth once the contest is completed.

Coaches are encouraged to carry a copy of the CIF Southern Section Beach Volleyball rules and this bulletin with them for all playoff contests.

Schools will still have the opportunity to protest a contest in accordance with Southern Section Rule 1112, as it pertains to use of ineligible players.

#### 9. SUSPENDED or POSTPONED CONTEST

If a match must be postponed because of inclement weather, that match will be rescheduled for the next available date. However, the re-scheduled date must take place prior to the next scheduled round. If a contest must be suspended all points previously played will stand. For example, if Pairs #1 and #2 have completed play and the match is tied 1 - 1 at the point of suspension the remaining pairs would resume the contest from that point forward. If a set is suspended before its completion the score would be noted and resume from that point forward.

#### 10. MEDICAL TIMEOUT (MTO)

During a match, a Medical Timeout (MTO) of up to 5 minutes may be taken by a player for injury or illness. Each player is allowed one MTO per match. A medical timeout does not count as a team timeout. If the injured player requests a trainer, the five minutes begins when the trainer arrives at the court. If no trainer is requested or one is not present, the five minutes begins as soon as the MTO is requested. If a player cannot continue playing after the conclusion of the five-minute timeout, that match shall be forfeited.

#### D. PLAYOFF/CHAMPIONSHIP WARM-UP PROCEDURES (PRE-MATCH)

- 1. One hour before the competition, the official with the assistance of the home team, must confirm that the dimensions as well as the quality and safety of the boundary lines and all other sport equipment, meet the requirements.
- 2. Before the start of the Referee must check: The net is perpendicular to the court and the dimensions of the boundary lines and free zone are accurate.
  - a. Note: In a square court (8m x 8m for one side), the length of the short diagonals (11.31 meters) must be equal.
- 3. The playing area, sand condition and sport equipment are safe for the players and officials.
  - Note: Boundary lines must be properly secured and present no danger to players. Exposed hooks, metal fastening devices or spikes to hold the lines in place are not acceptable.
- 4. Prior to each match officiated, before the warmup time, inspect the court and free zone area checking its symmetry, safety, and general condition.
  - a. Note: Before/during the match, the Referee must pay attention to the fact, that the free zone must always be free from any obstacle which can cause an injury to a team member (drinking bottles, TV camera tripods, sand rakes, etc.).
- 5. The playing court is maintained by the sand rakes who are responsible for raking it before, during the game, between sets, and between matches.
  - a. Note: The referee is responsible to check that this is done properly and together with the host school, and they should continuously monitor during the match the condition of the lines and the playing court, ensuring that both courts are in equal condition.
- 6. The height of the net must be as per Rule.
  - a. Note: Before each match, after the sand has been rake, the referee must check the height of the net before the coin toss.
- 7. The net, posts and referee's stand (if applicable) are properly padded so that a player is not a risk of injury from exposed hard or sharp surfaces.
  - a. Notes: Before/during the game (and especially at the beginning of each set), must check whether the side bands are exactly perpendicular to the playing surface and placed directly above each sideline and whether the antennae are just at the outer edge of each side band. If this is not the case, they should be readjusted immediately.
- 8. The referee takes possession of the match balls before the match and checks that all of them have identical characteristics (color, circumference, weight, and pressure).
- 9. Educating and training players on the proper completion of AVP scoresheets.

- 10. Ten minutes are allowed for formal warm-ups. This period includes one minute to conduct the coin toss with a player representative from each competing pairs team and eight minutes of formal timed warm-up.
  - 10 min. Coin toss
  - 9 min. Start eight-minute formal timed warm-up (coaches must leave the playing court)
  - 1 min. End warm-up, teams to pre-determined team area, referee(s) to designated location
  - 0 min. Teams to end-lines, first serve
