A. Recognition of anyone wishing to address the Council. Speakers must limit their remarks to three minutes. None.

3. ACTION ITEMS

A. STATE FEDERATED COUNCIL ACTION ITEMS - There are no State Federated Council Action items at this time.

B. SOUTHERN SECTION ACTION ITEMS

1. Proposed Bylaw 2513 and 2516 Revision - Soccer Player Ejection - There was a motion from the Suburban League and a second from the San Andreas League to support the proposal from the Raincross Conference. Ryan Sharpe, from the Raincross Conference, briefly explained the idea behind the proposal. Dennis Guerra, Suburban League, and a member of the CIF Southern Section Soccer Advisory Committee, spoke in support of the proposal. The motion carried 83-7-1.

4. NON-ACTION ITEMS

A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

1. Proposed Sport Addition – Beach Volleyball - President-Elect Jim Perry reviewed the proposal to add Beach Volleyball to the list of CIF-approved sports. This proposal would be for girls only

and would take place in the Spring sport season. The format would call for pairs to compete as a school team. No discussion or questions.

2. Proposed Bylaw 504.M Revision – Sunday Cheer Competition - President-Elect Jim Perry reviewed the proposal which requests an exception to CIF Bylaw 504.M. to allow Traditional Competitive Cheer teams to compete on a Sunday at the NHSCC event. This exception may be used one-time per school year for the above-named event only. Question was asked by Jill Matyuch from Brea Olinda High School: "Would all members of the Southern Section vote to support the proposal?" President Mike West confirmed that the Southern Section would be voting in favor of this proposal as the Southern Section has already passed it and is forwarding it to the CIF Federated Council for first reading.

3. Proposed Bylaw 1206 Revision - Allowable Contacts Baseball/Softball - President-Elect Jim Perry reviewed the proposal which sets the number of allowable contacts for these two sports at 28 and states that tournament games will be counted as one (1) contact for each

tournament game. Implementation would be for the 2021-2022 school year. This proposal brings softball and baseball into alignment with other CIF Regional and CIF State Championship sports regarding the maximum number of allowable contacts. No discussion or questions.

4. Review of 2020-21 Weighted Voting - President-Elect Jim Perry reviewed the information regarding CIF Federated Council Weighted Voting numbers for the 2020-2021 school year. The number of votes for the Southern Section remains unchanged from the 2019-2020 school year and remains at a total of 34 votes. No discussion or questions.

B. SOUTHERN SECTION NON-ACTION ITEMS

1. Proposed Bylaw 166.1 and 166.3 Revision - Hall of Fame/Distinguished Service Award - President Mike West reviewed the proposal. President-Elect Jim Perry, as a member of the Hall of Fame Selection Committee, spoke in favor of the proposal. He believes this will help clarify the qualifications and criteria required for coaches to be selected to the CIF Southern Section Hall of Fame.

2. Proposed Bylaw 126 – Altercation Plan - President Mike West reviewed the proposal for the implementation of a mandatory Altercation Plan that would be for all sports at all levels. This Altercation Plan would be placed into the Blue Book as a new bylaw if adopted. The plan calls for the training of coaches and athletes to listen for key or code words if an altercation were to happen with the intent that an automatic response would de-escalate the situation. The Rio Hondo League asked for clarification regarding the proposal and that this language would be added into the Blue Book as a new bylaw.

5. REPORTS

A. Treasurer's Report - Chris Calderwood - Mr. Calderwood announced that the 2019-2020 Southern Section audit has been completed. As of today, 369 schools have paid their membership dues and a total of 531 member schools have created an invoice to show they are in the process of payment. Membership dues are due today, October 1st.

B. President's Report - Mike West - Mr. West spoke to the roles that each of us have at their respective schools and he wanted to remind the Council that it is important to keep in contact with each other, not just via e-mail, but to also pick up the phone to have a conversation or simply to check-in on each other. The role of the Principal or the Athletic Director is an important one on each campus and that personal interaction is very important during this unique time.

C. Commissioner's Report - Rob Wigod

- Commissioner Wigod will continue to send out periodic updates to schools as needed and if you have missed any they may be found on our web site at www.CIFSS.org. Commissioner Wigod reminded the Council that we have begun the Area Placement process this year in advance of Releaguings. Area Placement Requests Forms from each member school are due by October 9, 2020. Commissioner Wigod reminded everyone that our sports calendars are in place and will not be changed. The thought process was that it was set up for a December start so schools could have the maximum amount of time possible to schedule and get organized. Commissioner Wigod concluded by thanking the members of the Council, the Executive Committee members for their service and the Southern Section Office Staff for their continued support.

There was a motion by Chris Calderwood and a second by Dave Reid to adopt the revised agenda. There being no discussion, the motion was approved to adopt the revised agenda. Motion Carried: 20-0-0

2. PUBLIC COMMENT

A. Recognition of anyone wishing to address the Executive Committee. Speakers must limit their remarks to three minutes. Dick Billingsley – Addressed the Executive Committee and requested that member schools develop an Altercation Plan for teams/schools to use and follow. This plan would guide coaches and student-athletes on what to do in case a fight was to occur during a contest. Coaches and schools would then train students on how to act, what to do and how to deescalate a situation like a school emergency plan.

3. ACTION ITEMS

B. SOUTHERN SECTION ACTION ITEMS

1. Proposed Revision to the 2020-2021 Sports Calendar - Mike West reviewed the contents of the CIF Southern Section Blue Book and specifically Article 5, Bylaw 54.8 which allows for the Executive Committee to act on behalf of the Southern Section Council when emergency situations arise. In this case, a new 2020-2021 Sports Calendar was created and presented for approval by Commissioner Rob Wigod due to the COVID-19 pandemic. There was a motion by Chris Calderwood and a second by Rich Imbriani to approve the revised 2020-2021 Sports Calendar. Discussion: David Parkes asked why the soccer season was set to begin approximately two weeks earlier than most of the other Spring Season sports. Mr. Wigod responded by saying that the soccer season had traditionally been one of the longest seasons and in order to keep the season length similar to past years, it required this earlier start date. Motion Carried: 21-0-0

2. Proposed Revision to Bylaw 1213.1 - Official Schedule Due Dates - Southern Section Blue Book Article 5, Bylaw 54.8 was necessary for the Executive Committee to act on behalf of the Southern Section Council due to the COVID-19 pandemic. This emergency action allows for the change in the required due dates for schools to submit their sports schedules to the Area Liaisons, officials' groups and into CIFSSHome with the following new dates: Fall Sports – Monday, October 12, 2020
Spring Sports – Monday, December 14, 2020. There was a motion by David Parkes and a second by Mary Jane Hibbard to approve the revised due dates. Motion Carried: 20-0-0

3. Proposed Bylaw 2513 and 2516 Revision - Soccer Player Ejection - Before a

motion and a second to approve, Dr. Colunga asked the Executive Committee members if they had an opportunity to discuss this proposed bylaw change with their member schools. The majority response was that the Executive Committee members had not had the chance to do so and as a result, Dr. Colunga requested that the motion be tabled until September 24, 2020.

B. 2020-2021 CIF Southern Section Goals – Rob Wigod - Commissioner Wigod reviewed the 2020-2021 CIF Southern Section Goals that are attached to these minutes. Some of the key highlights are:

Area Placement will take place this year in anticipation of a new Releaguering Cycle for 2022-2026. Girls and Boys Lacrosse Championships will take place in June, 2021.

The Football Playoffs will launch a new system using current year results to establish playoff divisions. Swimming & Diving Championships will have a new format allowing for girls and boys teams to be placed into different playoff divisions. Finally, Commissioner Wigod announced that the NFHS Network is offering to each school two Pixelot cameras free of charge for the broadcasting of its athletic events.

C. Financial Report - Mitch Carty - Chief Financial Officer Mitch Carty presented a finalized profit and loss statement for the 2019-2020 school year. He highlighted how much money was lost when the Spring Sport playoffs and championships were canceled. On March 18, 2020, the potential loss was estimated at \$250,000. Mr. Carty then presented a slide of how much money the office saved in order to recoup some of the lost revenue. The highlights of the recovered money came from a Payroll Protection Plan, work from home strategy, implementation of mandatory vacation by the office staff and the finalized collection of all receivables. Based on the measures taken, the final pre-audit actuals and projections for the 2019-2020 school year showed a profit of \$118,246.45.

5. NEW BUSINESS

A. Financial Report - Mitch Carty - Chief Financial Officer Mitch Carty shared an overview of our current quarterly budget rather than a yearly budget to show our current profit and loss vs. actuals for Quarter 3. Please see the attached budget for review.

B. Marketing Report - Jackie Gibson - Marketing Manager Jackie Gibson reported that she is currently working on new ball contracts and that schools were sent surveys asking what ball or balls they currently use for each sport. She is contacting possible new partners and requesting RFP's from each of the companies. A plan has not been determined as of now to use one company for all our official championship balls or go with individual ball contracts for each sport. Assistant Commissioner Thom Simmons reported that we have agreed in principle on terms with Fox Sports West for an additional three years. That full agreement will be available shortly and will begin with the current 2020-2021 school year. In addition, an agreement with the NFHS Network will be finalized soon.

C. Communications Report - Chelsea Heyward - Digital Media Coordinator Chelsea Heyward reported that CIF Southern Section This Week launched on September 9, and they have aired three episodes as of today. Social media numbers are continuing to increase with each episode being accessible on our YouTube channel.

6. REPORTS

A. President's Report - Mike West - Mr. West has been invited to Team Up for Sports Safety in California. The goal of the program is to focus in on 4 or 5 key areas which include trainers, air

quality, strength and conditioning and cold-water immersion for student athletes. Mr. West also attended the NFHS 7/8 Section meeting that was held online September 2nd and 22nd. He was pleased to be a part of the discussion and gained valuable feedback from the other states involved.

B. Treasurer's Report - Chris Calderwood - Mr. Calderwood announced that the annual audit had been completed for 2019-2020 school year. As of the date of this meeting, 298 member schools have paid their membership dues. At this time last year, 473 members had paid. Currently 94% of the member schools have created an invoice for this year so additional membership dues payments should be arriving over the next few weeks. The deadline for payment is October 1, 2020.

C. Commissioner's Report - Rob Wigod - Commissioner Wigod will continue to send out periodic updates to schools as needed and if you have missed any they may be found on our web site at www.CIFSS.org. Commissioner Wigod reminded the Executive Committee that we have begun the Area Placement process this year in advance of Releaguings. Area Placement Requests Forms from each member school are due by October 9, 2020. Commissioner Wigod reminded everyone that our sports calendars are in place and will not be changed. Heyward - Dr. Heyward updated the Executive Committee on our current social media numbers highlighted by Commissioner Wigod's live press conference in July to announce the revised 2020-2021 Sports Calendars. The press conference had over 200,000 viewers and impressions making this one of our largest events on record.

6. REPORTS

A. President's Report - Mike West - Mr. West began by thanking Dr. Monica Colunga, Carter Paysinger and Dr. Jeff Jordan for their past guidance and leadership prior to taking over the presidency. Mr. West presented his vision for the next two years, highlighting that he is working on the physical and mental protection of the student-athlete. Mr. West would like to carry on what Carter Paysinger started by pushing to make strides in getting full-time athletic trainers at each school site. Finally, Mr. West reminded the Executive Committee that schools should still commit to paying their membership fees by October 1, 2020 due date.

B. Treasurer's Report - Chris Calderwood - Treasurer Chris Calderwood began by thanking his predecessor, Dr. Jeff Jordan, for his leadership and guidance as the Southern Section Treasurer the past two years. Mr. Calderwood gave a brief update on membership dues collected thus far and that the total is currently behinds last year's pace as of today. Mr. Calderwood then updated the Executive Committee on the plans to convert more schools to electronic finances (ticketing, membership dues collection, GoFan) and he encouraged all schools who are potentially looking for this transition to discuss it with Mitch Carty.

C. Commissioner's Report - Rob Wigod - Mr. Wigod announced that he is going to send out his Commissioner and Section Goals to the member schools in the coming days. He reminded the Executive Committee that two Athletic Director/Administrator workshops have taken place with one more to go on August 19, 2020. So far, over 250 member schools have already attended a workshop online. Commissioner Wigod announced that in general the member schools have had a positive reaction to the sports calendar that was presented in July. Mr. Wigod finally announced that the Executive Committee retreat will not take place this year as it traditionally does in January. The meeting will still take place on January 14, 2021, with the agenda and materials to be sent at a later date.

D. Executive Committee Member Reports - CADA Representative – Mrs. Geniel Moon announced that a statewide CADA Student Conference will take place instead

of an area conference in September. Mrs. Moon updated the Executive Committee that they have had weekly Zoom calls in order to help CADA members on the opening of schools for the 2020-2021 school year. Attendance has been very positive, and they will continue to do these as needed. Superintendent Representative – Mr. Reggie Thompkins wanted to thank Commissioner Wigod on behalf of the Superintendents Committee and his willingness to attend and be available for meetings, questions and guidance.
