## SIX BOYS/ONE GIRLS CIF SOUTHERN SECTION-FORD DUAL MEET WRESTLING, CHAMPIONSHIPS TO BE AWARDED

LOS ALAMITOS — The six boys and one girls divisional, two-day tournament championships of dual-meet wrestling will be held this Saturday, January 29 and Wednesday, February 2.

The girls tournaments is scheduled to start with first-round action beginning at 11 a.m., second-round at 3 p.m., quarterfinals at 5 p.m. and the semifinals at 7:00 p.m. (All times approximate). Weigh-in is to begin at 9 a.m. The final rounds will be held on Wednesday, February 2 at the site of the school ranked highest in the final poll. Weigh-in is to begin at 6:00 p.m. and championship matches to start at 7:00 p.m. (All times approximate).

The boys tournaments is scheduled to start with first-round action beginning at 11 a.m., second-round at 3 p.m., and the semifinals at 5:00 p.m. (All times approximate). Weigh-in is to begin at 9 a.m. The final rounds will be held on Wednesday, February 2 at the site of the school ranked highest in the final poll. Weigh-in is to begin at 6:00 p.m. and championship matches to start at 7:00 p.m. (All times approximate).

Top seeds for each division in the boys tournament include Temecula Valley (Division 1), Centennial/Corona (Division 2), San Clemente (Division 3), Millikan (Division 4), Mayfair (Division 5), and Western (Division 6). Top seed on the girls side is Northview (Division 1).

Wrestling sites for the six divisions of boys wrestling are as follows; Division 1 – Temecula Valley HS; Division 2 – Villa Park HS; Division 3 – Victor Valley HS; Division 4 – South Torrance HS; Division 5 – Mayfair HS; and Division 6 – Western HS. Wrestling for the girls rounds will be at Bonita HS and Northview HS.

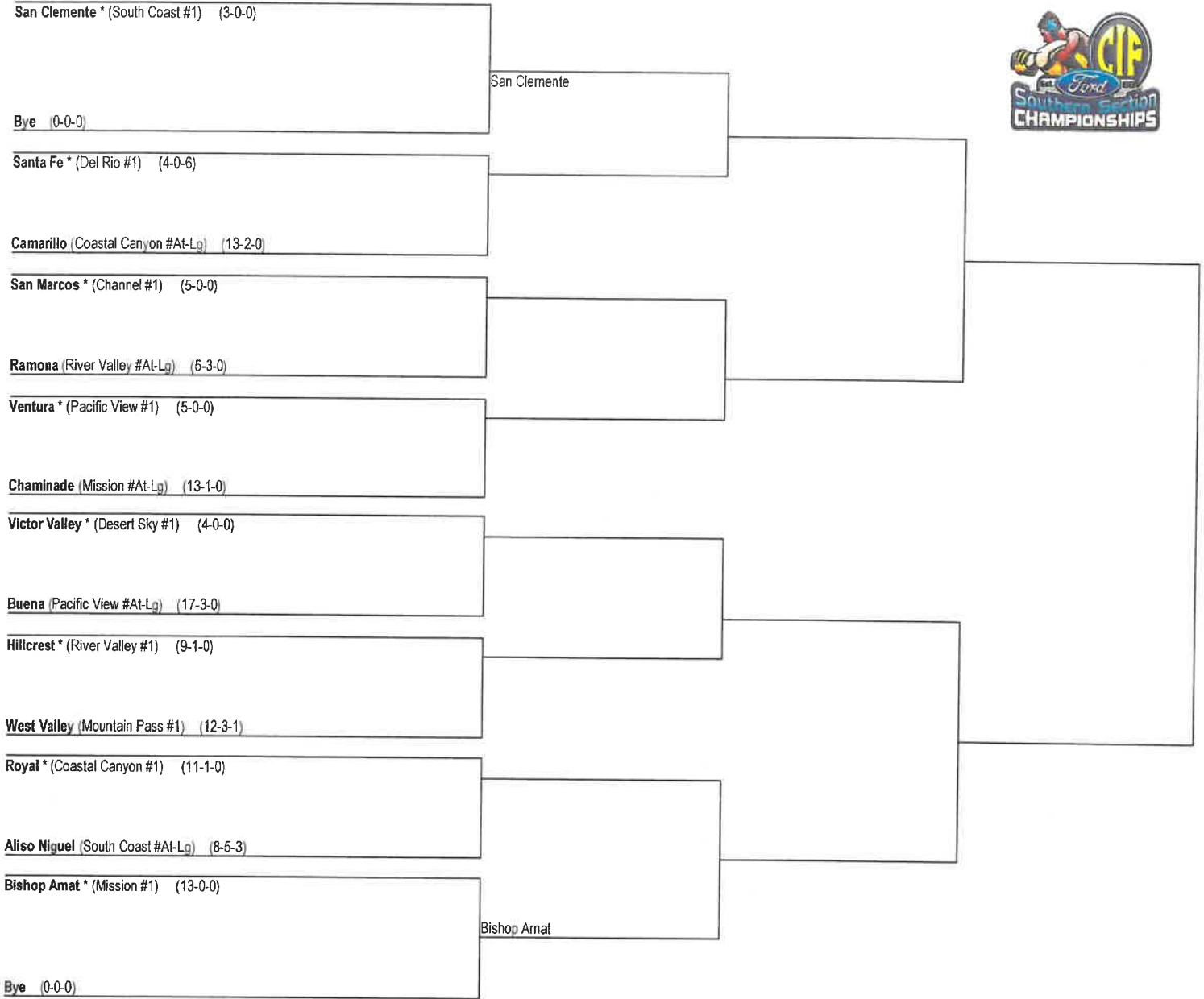

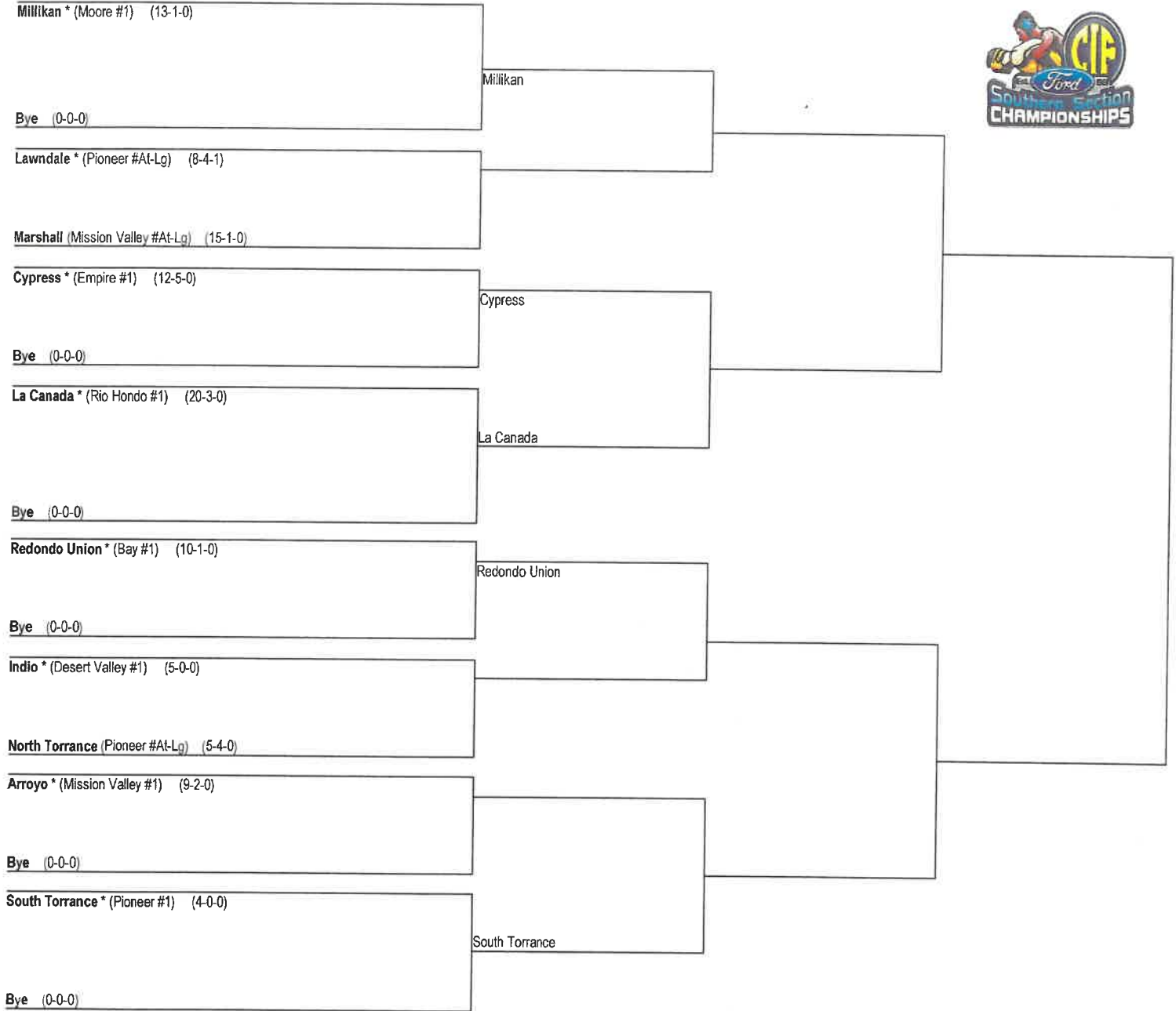

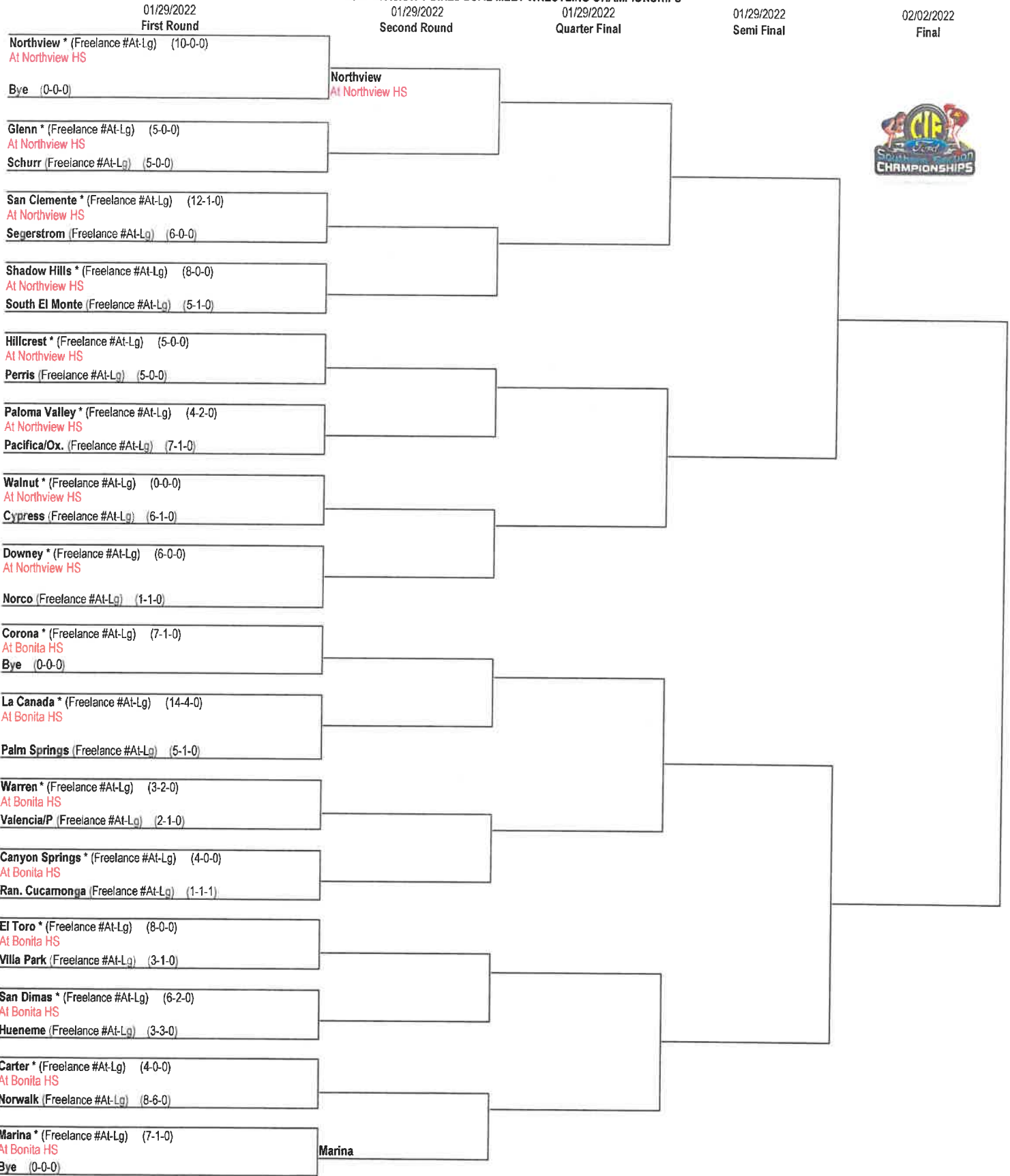
