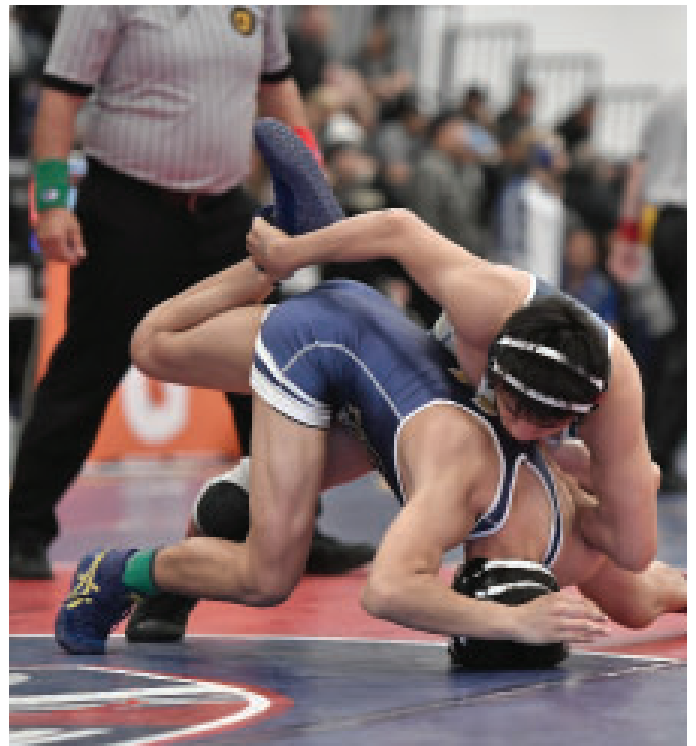

April 13, 2021

E. Adopt Agenda - There was a motion by the Palomares League and a second by North Hills League to adopt the agenda. There being no discussion, the motion was approved to adopt the agenda as written.

Motion Carried: 87-0-0

F. Approval of Minutes

1. Minutes of the February 2, 2021 Council Meeting - There was a motion by the North Hills League and a second by the Empire League to approve the minutes of the February 2, 2021 Council Meeting. There being no discussion, the minutes were approved as written. Motion Carried: 91-0-0

2. PUBLIC HEARING SESSION

A. Recognition of anyone wishing to address the Council. Speakers must limit their remarks to three minutes. Ms. Cami Stein from the California Officials Swim and Dive Association presented a request to change Southern Section Bylaw 1203.1. This bylaw pertains to the Southern Section only recognizing the governing authority for each sports officials' association.

3. ACTION ITEMS

A. STATE FEDERATED COUNCIL ACTION ITEMS

1. Proposed 2021-2022 CIF State Budget - President-Elect Jim Perry presented the CIF State Budget for review. The 2021-2022 Proposed Budget projects a surplus of \$30,000. The budget is highlighted by projected CIF Regional Baseball and Softball revenues and changes in Marketing revenue due to the fulfillment of contracts. The full proposed budget can be viewed at www.cifstate.org. There was a motion by the Big VIII League and a second by the Freeway League to approve the proposal as written. There being no discussion, the motion carried. Motion Carried: 92-0-0

2. CIF State Executive Committee Nominations - President-Elect Jim Perry presented the CIF State Executive Committee nominations and stated that two positions will be elected from the seven total candidates. These openings will begin with the 2021-2022 school year. President West requested the Council to allow the Southern Section delegates to go uninstructed to the April 23, 2021 Federated Council meeting. There was a motion by the Mission League and a second by the Southwestern League to approve the proposal as written. There being no discussion, the motion carried. Motion Carried: 91-0-1

3. Proposed Bylaw 504.M Revision - Sunday Cheer Competition - This proposal will allow Traditional Competitive Cheer teams to compete on Sunday at the National High School Cheerleading Championship (NHSCC) event. This exception may be used one time per school year for the above-named event only. There was a motion by the Coastal League and a second by the North Hills League to approve the proposal as written. There being no discussion, the motion carried. Motion Carried: 63-25-4

B. SOUTHERN SECTION ACTION ITEMS

1. Proposed 2021-2022 CIF Southern Section Budget - Chief Financial Officer Mitch Carty presented the Council with Option 2, Best Case Scenario for the 2021-2022 school year. This is highlighted with sports revenue projections set toward conservative goals, sponsorship and broadcast contracts being fulfilled at 100% and sport fees to match the 2020-2021 school year. This proposal also includes the return of the full 17-member office staff, longevity steps and COLA increases, when revenue can support it, and the full return of employee benefits. The complete Proposed Budget can be viewed at www.cifss.org. There was a motion by the Big VIII League and a second by the Majestic League to approve the proposal as written. There being no discussion, the motion carried. Motion Carried: 91-0-0

2. CIF Southern Section Executive Committee Nominations - The Coast Area and the Mt. SAC Area currently will have vacancies for the 2021-2022 school year. The candidates for Coast Area are Dr. Paula Hart Rodas, Principal, Lawndale High School and Dr. Allan Tyner, Principal, Palos Verdes High School. For the Mt. SAC Area, the candidates are Paul Lopez, Director, Special Education/Health, Glendora Unified School District and Monica

Principe, Director of Secondary Education, Pomona Unified School District. President West reminded the Council that only leagues in the affected areas will be voting for these nominees. Paula Rodas was elected by a vote of 3-0-1 to represent the Coast Area for a four-year term beginning in the 2021-2022 school year. Paul Lopez was elected by a vote of 5-2-0 to represent the Mr. SAC Area for a four-year term beginning in the 2021-2022 school year.

4. NON-ACTION ITEMS

A. STATE FEDERATED COUNCIL NON-ACTION ITEMS - There are no CIF State Federated Council non-action items at this time.

B. SOUTHERN SECTION NON-ACTION ITEMS - There are no CIF Southern Section Council non-action items at this time.

5. REPORTS

A. Financial Report - Mitch Carty - Chief Financial Officer Mitch Carty reported to the Council that 99% (\$716,000) of the sport fees have been received as of today. Current investment revenue over Quarter 3, Quarter 4 and Quarter 1 has been very strong totaling \$210,000 in revenue. In addition, we have received 79% of the marketing and broadcast payments for the 2020-2021 budget year, however \$0 in sport playoff revenue has been received. PPP Loan #1 in the amount of \$456,000 was utilized in July and August of 2020, vacation accrual usage by office staff continues and employee furloughs and benefit reductions are ongoing. Season 2 playoffs are currently being planned and some additional revenue is possible. The full office staff will be returning as of Monday, April 19, 2021. Based on the current projections and expenses Mr. Carty projected an expected loss of \$168,687 for the 2020-2021 school year. PPP Loan #2 in the amount of \$388,000 has been received and this amount will go to offset the projected loss. This would leave \$219,000 to cover playoff

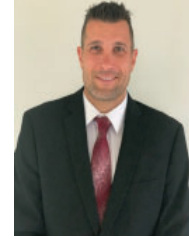

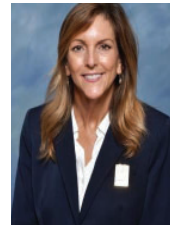

GoFan use will allow for capacity management, private links to accommodate desired patrons, financial reporting labor to the Southern Section dramatically reduced and event management will be streamlined. D. Marketing Report - Thom Simmons/Jackie Gibson - Marketing Manager Jackie Gibson reviewed the new ball partnership agreements with Wilson, Rawlings and Mikasa for the Executive Committee. She also updated the Executive Committee with the soon to be filled marketing agreements at playoff and championship sites. Finally, she showed a streamlined method to find all the social media and section updates that have been sent over the past 15 months.

E. Communications Report - Thom Simmons - Assistant Commissioner Thom Simmons updated the Executive Committee with how the Southern Section has been constantly communicating to our membership since March, 2020 when the COVID pandemic began. This has been done with 42 COVID-related updates, three live YouTube press conferences, one live YouTube question and answer just for student-athletes, 1,683 Tweets, 419 Facebook posts and 271 Instagram shares.

Next, he announced that the Fall Workshops have been set up and the dates and schedules are posted on our Southern Section web site. Commissioner Wigod thanked President West for his leadership as President and the Executive Committee members who helped push and encourage our member schools to be positive and patient over the past 15 months. Last, Commissioner Wigod thanked the Section Office Staff for their loyalty and support over the past 15 months. Many sacrifices, both professionally and personally by staff members, have taken place to get to this point in time.

D. Executive Committee Member Reports - Girls Athletic Director Representative - Michelle Spencer as a first-year member thanked the Executive Committee for their leadership and guidance. Boys Athletic Director Representative - Rich Imbriani thanked Ed Kearby for his mentorship and leadership in the Citrus Belt Area. He has been a driving force for a lot of Athletic Directors and coaches. CAPSO Representative - Terry Barnum thanked Commissioner Wigod, the Southern Section Staff and all Executive Committee members for their guidance, leadership and the opportunity to serve the Southern Section. At-Large Representative - Dr. Alexis Barile thanked the Executive Committee for their leadership and guidance in her first year on the committee. President-Elect - Jim Perry thank Ed Kearby for his guidance and years of service to the Southern Section, followed by a thank you to Terry Barnum who has helped the Section tremendously over the years.

F. Approval of Minutes

1. Minutes of the January 14, 2021, Executive Committee Meeting - There was a motion by Dave Reid and a second by Michelle Spencer to approve the minutes of the January 14, 2021 Executive Committee meeting. The minutes were approved as written. Motion Carried: 18-0-0

2. PUBLIC COMMENT

A. Recognition of anyone wishing to address the Executive Committee. Speakers must limit their remarks three minutes. None.

3. ACTION ITEMS

A. STATE FEDERATED COUNCIL ACTION ITEMS

1. Proposed 2021-2022 CIF State Budget - The 2021-2022 Proposed Budget projects income of \$6.62 million and expenses at \$6.59 million. Additionally, the budget shows two unfilled staff positions in the burden of salary figures. Given that only one of these positions may be filled in the 2021-2022 school year, an additional surplus of \$80,000 may be realized. The proposed budget also shows a projected income of \$50,000 for State Regional Baseball and Softball events that have been added to the calendar. Additional information can be found on the CIF State web site at www.cifstate.org. There was a motion by Chris Calderwood and a second by Dr. Paula Rodas to approve the motion as written. There being no discussion, the motion was approved as written. Motion Carried: 20-0-0

2. CIF State Executive Committee Nominations - As per CIF Constitution Bylaw 70.F., the following Federated Council members have volunteered to be candidates to serve a two-year term on the CIF Executive Committee for the 2021-2022 and 2022-2023 school years. The CIF Federated Council will need to elect two candidates from the list of seven candidates below. Catherine Arenson, San Francisco Section; Natalie Ayres, Central Coast Section; John Becker, Sac-Joaquin Section; Neezer McNab, LA City Section; Diana Nalbandian-Hatton, Central Section; Marybeth Ortiz, California Association of Private School Organization (CAPSO) A motion was made by Dave Reid and seconded by Ed Kearby to send the Southern Section delegates to the Federated Council meeting uninstructed on State 622. Motion Carried: 22-0-0

3. Proposed Bylaw 504.M Revision - Sunday Cheer Competition - The Southern Section has already reviewed this proposal and voted in favor of the proposal. The proposal was brought back as a first read due to new information regarding other sections and states allowing Sunday competition. The sport of Skiing/Snowboarding has been allowed to practice and compete on Sundays given the unique nature of the sport and the fact that there is competition with Nevada schools which allow for Sunday competition in the sport. This provides some context to the concern that we would be allowing an exception for Cheer that has not been allowed for any other sport. There was a motion by Dave Hess and a second by Geniel Moon to approve the motion as written. There being no discussion, the motion was approved as written. Motion Carried: 21-1-0

B. SOUTHERN SECTION ACTION ITEMS

1. Proposed 2021-2022 CIF Southern Section Budget - Chief Financial Officer Mitch Carty presented to the Executive Committee Budget Option 1, best-case scenario, for the 2021-2022 school year. This best-case scenario is highlighted by taking a conservative approach toward sports revenue and special events revenue. In addition, sponsorship and broadcast contracts are at 100% fulfilled and sport fees to match the 2020-2021 school year with no increase in sport fees for 2021-2022. Overall, Mr. Carty presented a balanced budget trending to a normal operating year. The proposed budget indicates a return to a full staff of 17 employees, with step and column adjustments, along with the return of full benefits for office staff employees, if revenues support those actions. There was a motion by Dr. Paula Rodas and a second by Chris Calderwood to approve the motion as written. There being no discussion, the motion was approved as written. Motion Carried: 22-0-0

2. CIF Southern Section Executive Committee Nominations - President Mike West reviewed the nominations submitted to the Executive Committee. The Coast Area and Mt. SAC Area will be electing representatives to fill vacancies for four-year terms that will be voted on by the leagues in those areas at the Southern Section Council meeting on April 13, 2021. The nominations for the Coast Area are Dr. Paula Hart Rodas, Principal, Lawndale High School and Dr. Allan Tyner, Principal, Palos Verdes High School. The nominations for the Mt. SAC Area are Mr. Paul Lopez, Director, Special Education/Health, Glendora Unified School District and Monica Principe, Director of Secondary Education, Pomona Unified School District.

4. NON-ACTION ITEMS

A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

There are no CIF State Federated Council non-action items at this time.

B. SOUTHERN SECTION NON-ACTION ITEMS

There are no CIF Southern Section Council non-action items at this time.

5. NEW BUSINESS

A. Financial Report - Mitch Carty

1. 2019-2020 CIF Southern Section Audit - Chief Financial Officer Mitch Carty informed the Executive Committee that the Audit Committee had met, the 2019-2020 Audit was completed, no findings or adjustments were necessary and the Audit Committee accepted the 2019-2020 Audit as presented. There was a motion by Chris Calderwood and a second by Dave Reid to approve the audit. There being no discussion, the motion was approved as written. Motion Carried: 22-0-0 Mr. Carty also informed the Executive Committee that as of today we have received 98% of membership dues along with investment interest income of \$218,000. Furthermore, the Section Office did receive \$456,000 from the Payroll Protection Loan and we have applied to have the loan repayment forgiven. We are awaiting a response to that application currently. Office Staff continues to take mandatory vacation and expenditures have been limited to necessary items only. Mr. Carty has also applied and been approved for the second Payroll Protection Loan. A decision as to when those funds will be applied will be made shortly. The funds could be applied to the remaining 2020-2021 budget or shifted to the 2021-2022 projected budget. Season 2 sports have all returned and are currently playing. If Season 2 sports do have playoffs, this could potentially generate additional revenue for the section but also require additional expenses. Finally, Mr. Carty announced that the CIF Southern Section Office will re-open on Monday, March 22, 2021, with normal operating hours of 7:30 am - 4:00 pm.

B. Marketing Report - Thom Simmons/Jackie Gibson - Marketing Manager Jackie Gibson informed the Executive Committee that three new ball contracts have been finalized with vendors and returned to our office. They are currently under legal review before they will be signed and presented to our member schools and to the public. The additional remaining contract has yet to be signed and returned to our office. The four new ball contract agreements are for five years, beginning in 2021-2022, with the mandatory playoff ball requirement beginning in 2022-2023. Next, Mrs. Gibson shared her thoughts and experiences with the Executive Committee after attending a Southern Section football game on Friday, March 12, 2021. She was delighted and pleased that high school sports had returned after an over one-year absence.

C. Communications Report - Chelsea Heyward - Digital Media Coordinator Chelsea Heyward reported that CIFSS This Week has returned with Episode 14 highlighting the return to play for so many schools. The episode highlighted four member schools, Alemany, Warren, Bonita, and St. John Bosco. The video contains interviews with coaches and players as to how they have handled COVID, the off-season and the return to finally playing sports. Assistant Commissioner Thom Simmons reported that the televised

football contest on Fox Sports West between St. John Bosco and Sierra Canyon on March 13, 2021, earned a .24 rating share in the 25-54 prime age demographic. A normal rating share on Fox Sports West for high school football in that category is a .12 share.

D. CIF Southern Section 2020-2021 Goals - Rob Wigod - Commissioner of Athletics Rob Wigod presented and reviewed the 2020-2021 CIF Southern Section Goals. This document shows existing goals, new goals for the 2020-2021 school year and responses to those goals as of March 15, 2021. The goals achieved to this point included increased communication efforts made through social media platforms and Southern Section Updates, completion of the Area Placement process as a prelude to Releaguage, implementing three new rules changes, signing multi-year agreements with Fox Sports West and the NFHS Network and administering the revised 2020-2021 sports calendar completed in August, 2020.

7. REPORT OF ACTION(S) TAKEN IN CLOSED SESSION

8. REPORTS

A. President's Report - Mike West - President Mike West thanked member schools for all their work during the COVID pandemic and pointed out that the Section Office Staff has done a great job in providing services to the member schools under very difficult and unusual circumstances. The member schools have had to juggle and schedule and re-schedule numerous events and this has been no easy task.

B. Treasurer's Report - Chris Calderwood - Treasurer Chris Calderwood reported that Friends of Golf has donated \$23,500 which will be Distributed to member school golf programs. As of today, 555 of the 559 member schools have created a sports fee invoice. 544 of these invoices have been paid. Mr. Calderwood suggested that if any Executive Committee members know of any schools that have not yet submitted membership dues that they contact them to assist in this collection. Mr. Calderwood also expressed to the Executive Committee that more schools should try and use GoFan as a ticketless/no contact entry system into athletic contests.

C. Commissioner's Report - Rob Wigod - Commissioner Rob Wigod stated that as of this coming Saturday, March 20, 2021, all Season 1 and Season 2 sports will have started play in some capacity. That was the goal of the Southern Section dating back to the announcement of the 2020-2021 sports calendar in July, 2020 and we are happy that schools are able to begin once again. Commissioner Wigod reminded the Executive Committee that we continue to advocate for a healthy return to play following the CDPH return to play guidelines. Commissioner Wigod thanked all member schools, principals, athletic directors and coaches for adapting to all of the changes that have been presented to them. Finally, Commissioner Wigod thanked the Executive Committee for their support of our staff and our entire organization.

D. Executive Committee Member Reports - Dr. Monica Colunga informed the Executive Committee that Commissioner Wigod received individual recognition from CIF State Executive Director Ron Nocetti for his leadership role in dealing with State and Section issues related to the COVID pandemic. CADA Representative - Mrs. Geniel Moon reported that CADA just completed a successful on-line conference that was held on March 1-6.
