CIF-SS COUNCIL MEETING MINUTES

April 5, 2022

1. OPENING BUSINESS

A. Call to order by Mike West, President of the Council at 9:03 am

B. Pledge of Allegiance

C. Roll Call

D. Introduction of Guests - Ron Nocetti, CIF State Executive Director; Chase Hartman, Los Angeles Chargers; Paul Caldera, Orange County Officials Liaison

E. Adopt Agenda- There was a motion by the Big VIII League and a second by the Southwestern League to adopt the agenda. There being no discussion, the motion was approved to adopt the agenda as written. Motion Carried: 85-0-2

F. Approval of Minutes

1. Minutes of the February 1, 2022 Council Meeting - There was a motion by the Surf League and a second by the Mulholland League to approve the minutes of the February 1, 2022 Council meeting. There being no discussion, the minutes were approved as written. Motion Carried: 86-0-1

2. PUBLIC HEARING SESSION

A. Recognition of anyone wishing to address the Council. Speakers must limit their remarks to three minutes. Jack Bautista, San Fernando Valley Soccer Officials assignor. Mr. Bautista spoke against the official's fees proposal and asked the Council to vote "no" on SS 636. Mr. Bautista stated that the proposal is not enough money for the lower-level soccer officials, nor does it provide enough of an increase for a center official working in a three-person crew.

3. ACTION ITEMS

A. STATE FEDERATED COUNCIL ACTION ITEMS

1. Proposed 2022-23 CIF State Budget - President-Elect Jim Perry presented the CIF State Budget for review. The 2022-2023 Proposed Budget projects an income of \$6.68 million and expenses at \$6.61 million. Income sources for the State CIF office are: State championships, corporate and marketing sponsorship, and membership dues. The expected expenditures for the CIF State Office are marketing fulfillment agreements and the CIF Home partnership. The full proposed budget can be viewed at www.cifstate.org. There was a motion by the Southwestern League and a second by the Mulholland League to approve the proposal as written. There being no discussion, the motion carried. Motion Carried: 86-0-1

2. CIF State Executive Committee Nominations - President-Elect Jim Perry presented the CIF State Executive Committee nominations. Mr. John Becker, Sac Joaquin Section and Ms. Natalie Thorne, Central Coast Section are in consideration for the position of President-Elect. President-Elect Jim Perry also announced that the following candidates have been nominated and have agreed to place their name for consideration to serve a two-year term on the CIF State Executive Committee: Catherine Arenson, San Francisco Section, Scott Giusti, San Diego Section, Marybeth Ortiz, CAPSO, Cris Oseguera, Northern Section, Louie Rocha, North Coast Section, Natalie Thorne, Central Coast Section and Mike West, Southern Section. These openings will begin with the 2022-2023 school year. President-Elect Perry requested the Council allow the Southern Section delegates to the CIF Federated Council to support Southern Section candidate Mike West and go uninstructed on the other positions. There was a motion by the Desert Empire League and a second by the Desert Valley League to support Mike West, Southern Section, and direct the Southern Section delegates to the CIF State Federated Council to go uninstructed on the other positions. There being no discussion, the motion carried. Motion Carried: 87-0-0

B. SOUTHERN SECTION ACTION ITEMS

1. Proposed 2022-23 CIF Southern Section Budget - Chief Financial Officer Mitch Carty presented the Council with the 2022-2023 budget. The complete Proposed Budget can be viewed at www.cifss.org. There was a motion by the Surf League and a second by the Mulholland League to approve the proposal as written. There being no discussion, the motion carried. Motion Carried: 87-0-0

2. CIF Southern Section Executive Committee Nominations - President Mike West reviewed the CIF Southern Section Nominating Committees slate of candidates for the 2022-2023 CIF Southern Section Executive Committee. Candidates included: President-Elect - Dr. Paula Rodas, Principal, Lawndale High School and Mr. Jeff Williams, District Athletic Director, Antelope Valley Union High School District. Dr. Paula Rodas received 57 votes, Mr. Jeff Williams received 24 votes. Citrus Belt Area Representative nominees are Mr. Darel Hanson, Principal, Riverside Poly High School and Mr. Kai Lyles, Athletic Director, Desert Hot Springs High School. Only members of the Citrus Belt Area are allowed to cast a vote for this position. Mr. Darel Hanson received 5 votes, Mr. Kai Lyles received 10 votes. Mt. SAC Area Representative nominees are Mr. Mitch Brunyer, Principal, Rowland High School and Monica Principe, Director of Secondary Education, Pomona Unified School District. Only members of the Mt. SAC Area are allowed to cast a vote for this position. Mr. Mitch Brunyer received 5 votes, Mrs. Monica Principe received 2 votes.

3. Proposed Revision to Bylaw 510.1 - President Mike West reviewed Action item SS 632 which was authored by the Private / Public Committee. This

proposal would remove the bylaw limiting incoming 9th grade students who have participated in club/travel programs coached by high school coaches to enrollment in the public-school attendance area they live in. The proposal will allow students and families to freely choose a youth program, club, etc. they wish to participate in regardless of the coaching staffs' affiliation with a high school. There was a motion by the Skyline League and a second by the Southwestern League to approve the motion as written. There being no discussion, the motion passed as written. Motion Passed: 77-9-1

4. Officials Fees Proposal

The Marmonte League asked the question: "When was the full proposal and supporting documents released so the leagues could review the information?" Commissioner Wigod explained that the proposal was sent out to all Council League Representatives on January 26, 2022 prior to the February 1, 2022 CIF Southern Section Council meeting. During the February 1, 2022 CIF Southern Section Council meeting, held electronically via Microsoft Teams, there were small group breakout sessions so Council members could ask questions or get clarifications on SS 636 and report that information back to their respective leagues. Motion Passed: 68-18-1

5. Proposed Revisions to Bylaws 3419.7 & 3420.3 - President Mike West presented and reviewed the details of SS 637. This proposal would align 8-Man Football with the current competitive equity-based system of 11-Man Football playoff divisions. 8-Man Football playoff divisions are currently based on school enrollment and this proposal would now place

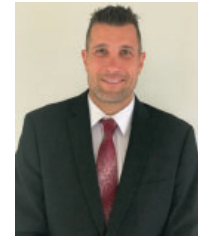

SYNOPSIS OF CHANGES TO 2022-23 BLUE BOOK

The following is designed for the benefit and convenience of athletic administrators and coaches in an effort to provide a capsule summary of the changes in the State CIF and Southern Section Constitution and Bylaws. These changes have been enacted by the State CIF Federated Council and the Southern Section Council throughout the course of the 2022-23 school year.

CIF STATE ARTICLE/BYLAWS CHANGES FOR 2022-2023

The following Articles and Bylaws were either adopted or revised by the Federated Council or Executive Committee

Bylaw Bylaw Name

Terms of Office

- 70.D 7. If in the second year of their term, an Executive Committee member ceases to be a representative of their Section to the Federated Council, that Executive Committee member may remain as an additional representative of their Section until the end of that representative's prescribed term.
(Approved February 2022 Federated Council)

Nominations

- 70.B 6. The nominating committee will name at least five (5) candidates for two (2)-year terms for the Executive Committee and at least two candidates for President-Elect.

Constitutions/Article Name

501 M. Statewide Sportsmanship and Ejection Policy cont.

Spectator

If a spectator is ejected from a contest, it is the responsibility of the school to ensure that person does not attend that team's next contest. If the same spectator is ejected a second time, it is the responsibility of the school to ensure that person does not attend any of the remaining contests for that season.

Key Points to Statewide Sportsmanship and Ejection Policy

- 1) Any unserved portion of a suspension will carry over to the next season. If the athlete is a senior, it will carry over to their next sport.
- 2) Players may be in attendance during their suspensions, Coaches MAY NOT.
- 3) The administrative meeting/paperwork process (for athletes) will still be in effect and is required on all ejections for fighting. The Principal must still upload a letter reflecting the "corrective action" taken on all coach ejections.
- 4) Your school MAY have more stringent policies in place to those (i.e.: a rule indicating that the student may not be in attendance at the team's next contest).

Appeal Process for All Multi-Game Ejections:

The school principal may appeal the penalties listed above in writing to the League Commissioner/President (for a regular season contest not including the final contest prior to Section playoffs) or CIF Section Commissioner with jurisdiction in the matter (for the final contest prior to Section playoffs and all playoff contests). The appeal must be received by the Section within 48 hours of the date of the ejection. Reasons for the appeal may only include misidentification of the ejected player or a misapplication of the rule. There will be no appeal regarding the judgement of an official.

Note: There is no appeal process for single game ejections.

Bylaw 510L1 **Eliminated**

This rule applies equally to any actions by any person or persons to enroll a student who is a graduate of the eighth or ninth grade of a junior high school in any member high school other than the public high school in the attendance area in which the student's parents or legal guardian reside.

Bylaw 3419.7 – B Man Football Playoffs

In the sport of B-Man and 11-Man Football, individual schools will be evaluated and placed into divisions on a yearly basis utilizing a formula based entirely on current regular season results.

Final power rankings, and divisional placements, will be determined and released at the end of the current regular season. Seeding of all playoff brackets in each division will follow the final power rankings in that division, regardless of league affiliation or league finish.

For example, in the First Round, the #1 seed, determined by the final power rankings for that division, will play #16, the #2 seed will play #15, etc. The higher seeded team will host the First-Round contest and then CIF Southern Section Bylaw 3404, Host Team After the First Round, will be followed for all subsequent contests.

MINUTES OF THE EXECUTIVE COMMITTEE MEETING

March 31, 2022

1. OPENING BUSINESS

A. Call to order by Mike West, President of the Council Meeting was called to order by President Mike West at 1:00 p.m. Kristine Palle introduced newest CIF Southern Section employee, Program Coordinator Tamara Towgood, to the Executive Committee.

B. Pledge of Allegiance

C. Roll Call

All members were present, except for Dr. Alexis Barile, Rich Imbriani, Cleveland Johnson, Monica Principe, and Steve Miller.

D. Introduction of Guests

There were no guests present.

E. Adopt Agenda

There was a motion and a second to adopt the agenda. There being no discussion, the motion was approved to adopt the agenda 16-0-0.

F. Approval of Minutes

There was a motion and a second to approve the minutes of the January 25, 2022 Executive Committee meeting. There being no discussion, the minutes were approved 16-0-0.

G. NFHS State Award for Outstanding Service - Ron Nocetti/Rob Wigod. Rob Wigod announced that Dr. Jim Staunton will be receiving the NFHS State Award for Outstanding Service at our next Southern Section Council meeting on April 5, 2022.

2. PUBLIC COMMENT

A. Recognition of anyone wishing to address the Executive Committee. Speakers must limit their remarks to three minutes. There was no one present to address the Executive Committee.

3. ACTION ITEMS

A. STATE FEDERATED COUNCIL ACTION ITEMS

1. Proposed 2022-23 CIF State Budget - President-Elect Jim Perry introduced the 2022-2023 CIF Proposed Budget highlighting various items including a line item for a new staff position and a balanced budget. There was a motion and second to approve the CIF Proposed Budget. The motion carried 16-0-0.

2. CIF State Executive Committee Nominations - President-Elect Jim Perry introduced the nominations for CIF Executive Committee positions. There was a motion and second to support the candidate from the Southern Section and go unopposed for all other positions. The motion carried 16-0-0.

B. SOUTHERN SECTION ACTION ITEMS

1. Proposed 2022-23 CIF Southern Section Budget - Chief Financial Officer Mitch Carty reintroduced the budget. There have been no changes since publication in the last agenda. There was a motion and a second to approve the 2022-2023 Southern Section Proposed Budget. The motion carried 16-0-0.

2. CIF Southern Section Executive Committee Nominations - President Mike West introduced the nominations. There was a motion and a second to approve moving the nominees for Southern Section Executive Committee positions forward to the Southern Section Council for action. The motion carried 16-0-0.

3. Proposed Revision to Bylaw 510.1 - President Mike West read the proposal to remove Southern Section Bylaw 510.1, related to incoming 9th graders who have played for high school coaches prior to initial enrollment in high school. There was a motion and a second to approve the elimination of this bylaw. The motion carried 16-0-0.

4. Officials Fees Proposal - There was a motion and a second to approve the proposal. President Mike West reviewed the proposal and the process that was followed to arrive at this finished product. Thom Simmons was asked to review the process and he began by stating that the Officials Fees/Relations Committee and President's Council initially met to begin the process. On October 19, 2021, the Officials Fees/Relations Committee met, as did the President's Council, and went over different scenarios. On December 16, 2021, officials' groups made presentations to the Officials Fees/Relations Committee. Once the Officials Fees/Relations Committee heard from those wishing to make a presentation, the Official Fees/Relations Committee met and developed the idea of an hourly fee structure for officials' fees across all sports. The Officials Fees/Relations Committee met again on January 18, 2022, and the proposal was finalized for a per sport hourly basis. This proposal was sent electronically to the Southern Section Council on January 26, 2022. First reading took place at the February 1, 2022 Southern Section Council meeting where breakout sessions were held to facilitate open discussions regarding all Non-Action items at that meeting. There were four different opportunities for groups to come forward and plead their cases. After further discussion, the motion carried 16-

0-0.

5. Proposed Revisions to Bylaws 3419.7 & 3420.3 - President Mike West reviewed the proposal to move 8-Man Football into a competitive equity model for playoffs identical to the process used for 11-Man Football. There was a motion and a second to approve the proposal. The motion carried 16-0-0.

6. Proposed Revisions to Bylaw 2415 - President Mike West reviewed the proposal for Girls Lacrosse allowing two yellow cards to be a dismissal from the contest but not an ejection requiring a subsequent missed game. There was a motion and a second to approve the proposal. Dave Hess asked why this is only for Girls Lacrosse and not Boys Lacrosse. Mike West said it was because the proposal only stated Girls Lacrosse and Boys and Girls Lacrosse are similar but very different sports. Thom Simmons added that the Girls Lacrosse community has been asking for this change for many years. The motion carried 16-0-0.

4. NON-ACTION ITEMS

STATE FEDERATED COUNCIL NON-ACTION ITEMS

There are no CIF State Federated Council non-action items at this time.

1. Proposed Addition of Girls Flag Football - President Mike West stated that this item was moved back to a non-action item because of a request to change the season of sport from Spring to Fall. Dr. Paula Rodas stated there was more support state-wide for the sport if it was a Fall sport rather than a Spring sport. This item will be read at the Southern Section Council meeting on April 5, 2022 and will be voted on at the first Southern Section Council meeting of the 2022-2023 school year, keeping to the original start time for implementation, if passed by the CIF Southern Section Council and the CIF Federated Council, in the 2023-2024 school year. Chris Calderwood asked about safety equipment and Dr. Paula Rodas stated there is no required safety equipment, but her team wore mouth guards as the safety level resembles that of soccer. The length of the season of sport would be similar to tackle football and be determined once approved by the CIF State Federated Council. The Executive Committee was informed that there is a different set of rules from tackle football and Girls Flag Football will use a different set of officials. There were several questions regarding safety and rules similarities to tackle football. The Los Angeles Chargers, Los Angeles Rams and Nike are big supporters and Nike is helping provide equipment to get programs started.

5. NEW BUSINESS

A. Financial Report - Mitch Carty - Chief Financial Officer Mitch Carty reviewed the budget handouts that were given out and appear at the end of these minutes. He commended Assistant Commissioner Rich Shearer for all the hard work that goes into all the sites and managing all the moving pieces of Boys and Girls Wrestling Championships. With the move to GoFan, we are down to two basketball reports and one soccer report missing. That has never happened before.

1. 2020-2021 CIF Southern Section Audit - President Mike West listed those that are on the Southern Section Audit Committee, which met before this meeting. Chris Calderwood reviewed the results of the meeting and the Southern Section Audit Committee accepted the 2020-2021 school year audit. Congratulations to Mitch Carty from the auditor. Mitch received an A+ report from the auditor regarding reports being provided thoroughly, completely, and professionally. It is incredible where we are right now compared to what we have been through. Chris continued that it is comforting to know there is a third-party group with the same trust in our processes as we hold. There was a motion and a second to accept the audit. Motion carried 16-0-0.

2. Marketing Report - Jackie Gibson - Marketing Director Jackie Gibson shared a PowerPoint presentation that appears at the end of these minutes, highlighting various items along the way.

C. CIF Southern Section 2021-2022 Goals - Responses - Rob Wigod - Commissioner Rob Wigod reviewed the published responses to the CIF Southern Section 2021-2022 goals, highlighting various items. Past President Monica Colunga commended the staff for getting us to where we are today.

6. CLOSED SESSION

A. Public Employee Evaluation of Performance - (Government Code 54957):

1. Commissioner's Evaluation

Closed Session began at 2:33 p.m. and ended at 2:41 p.m.

7. REPORT OF ACTION(S) TAKEN IN CLOSED SESSION

No action was taken during Closed Session. Discussion included the Commissioner Evaluation timelines and items

regarding the evaluation.

8. REPORTS

A. President's Report - Mike West - Mike West attended the Team Up for Sports Safety meeting. They are taking an evaluation of athletes in the state, looking at sports safety and how are we handling and improving sport safety. Heat illness and cold-water immersion were discussed along with the idea of having cold water tubs onsite, if possible. Another session talked about the effects of smoke on student-athletes in light of all the wildfires.

B. Treasurer's Report - hris Calderwood - Chris Calderwood presented the Treasurer's Report as a trivia game and the report appears at the end of these minutes. He mentioned how GoFan has cleaned up the entire ticketing and reporting process. The first PPP loan was forgiven and the application for forgiveness of the second PPP loan has been submitted. Sports fees have been paid by 561 member schools.

C. Commissioner's Report - Rob Wigod - Rob Wigod reminded the Committee that all award nominations for Champions for Character and Hall of Fame/Distinguished Service are due through cifsshome.org by May 1st. Spring sports are under way. Thank you for helping us cover all the different host site games through the Winter season. Unified Sports will have two divisional championships this year along with a Masters Meet that will qualify student-athletes to the CIF State Track and Field Championships. The site for our next Executive Committee meeting will be Parker's Lighthouse in Long Beach.

D. Executive Committee Member Reports

Activities Directors Representative - Todd Arrowsmith announced that Geniel Moon was sworn in as CADA President in Reno. CADA Representative - Geniel Moon reported that attendees at the CADA Convention were able to come with or without masks. It was a great event and hoping to bring our numbers back as we recover from COVID. Assistant Commissioner Rainer Wulf - There was a quick time frame in basketball from semifinals to finals. A big thank you to the Executive Committee for jumping in and helping out with awards presentations. The Ojai Valley Tennis Tournament is back for the first time since 2019. These are the best tennis players in Southern California. Track and Field Championships will be at Moorpark High School for Divisional Finals and the Masters Meet this year. Assistant Commissioner Thom Simmons - Thank you for your help with the SoCal Regional Basketball awards ceremonies. CSADA Representative - Dave Reid reminded the Executive Committee that the CSADA Conference is in San Diego this year and starts on April 20. Northern Area Representative - Dave Hess asked about probationary status of schools in his area and if they will need to be re-evaluated for future status. Rob Wigod answered that the Executive Committee will review the information submitted by the schools and will proceed accordingly. Desert Area Representative - Jeff Williams stated that everything this office has accomplished is inspiring and due to this group here, so congratulations to you all. President-Elect - Jim Perry stated he is amazed by the level of athleticism in our student-athletes. Grace and class displayed day in and day out. Assistant Commissioner Kristine Palle - There are Concordia University Masters Degree students in her class that may need resources for a Risk Management project, if you are available to help.

6. Proposed Revisions to Bylaw 2415 - President Mike West reviewed the details of SS 639. The proposal calls to align Girls Lacrosse with Boys and Girls Soccer regarding the issuing of two yellow cards during a contest. Currently in the sport of Girls Lacrosse, two yellow cards received by the same player warrants removal (ejection) from the current contest. CIF Southern Section Bylaw 1224 calls for the player to receive a subsequent game suspension due to the ejection from the last contest. The Girls Lacrosse Advisory Committee is proposing that when a player receives two yellow cards during a contest they are simply "fouling out" of that contest and they are not ejected. If they are not ejected, then they are not required to serve a subsequent game suspension. No Ejection Report would be filed by the game officials. The USA Lacrosse/NFHS Rule Book has two clear definitions for what is a suspension penalty (yellow card) and what is an ejection (red card) so officials can clearly decide what needs to be reported and what does not. There was a motion by the San Gabriel League and a second by the Suburban League to approve the motion as written. There being no discussion, the motion passed as written.

A. Financial Report - Mitch Carty - Mr. Mitch Carty reviewed and highlighted the Fall and Winter Sports playoff revenue. During the Fall Season the CIF Southern Section had a ticket sales revenue of \$1,143,265.85. This was an increase of \$256,975.00 compared to the 2019-2020 school year. During the Winter Season the CIF Southern Section had a ticket sales revenue of \$480,519.79. This was an increase of \$62,255.03 compared to the 2019-2020 school year. Other highlights mentioned was the 100% use of digital tickets via GoFan. The digital ticketing process now allows for a much more streamlined financial completion for each season that takes less than 1 month. Mr. Carty also reviewed that over \$1,000,000 has been sent back to schools in profit splits and honorariums to host schools in non-revenue sports. Finally, as of today, the net income in ticket revenue was \$1,371,274.00. This income revenue is similar to the 2014-2015 school year which resulted in a membership dues refund.

B. Treasurer's Report - Chris Calderwood - Mr. Calderwood reminded the Council that PPP loan #1 was submitted for forgiveness and approved. Currently PPP loan #2 has submitted for forgiveness as of March, 2022 and we are awaiting that decision.

C. President's Report - Mike West - President West gave his final address as Southern Section Council President and expressed his tremendous amount of pride by the member schools and support they have shown him during his presidency. President West has been very honored to serve as Southern Section President, especially during the COVID pandemic, and he takes pride in knowing that as he steps down the Southern Section is in great hands going forward.

D. Commissioner's Report - Rob Wigod -

1. CIF Southern Section 2021-2022 Goals - Responses - Commissioner Rob Wigod reviewed the 2021-2022 Southern Section Goals and updated responses to those goals. These goals and responses can be viewed in full within the complete agenda packet. Commissioner Wigod highlighted our continued increase in the social media platforms of Facebook, Twitter and Instagram along with promoting and participation in the Title IX at 50 celebration in cooperation with the National Federation of State High School Associations and the CIF State Office. Commissioner Wigod reminded the Council of the May 1st deadline for Distinguished Service/ Hall of Fame nominations and Champions for Character nominations is quickly approaching and to please submit those names for consideration. Next, Commissioner Wigod thanked the Council for disseminating information to member schools, supporting the Official's Fees Committee, thanked the Executive Committee and the Southern Section Office staff.
