# CIF-SS COUNCIL MEETING MINUTES

## January 31, 2023

### 1. OPENING BUSINESS

A. Call to order by Jim Perry, President of the Council. The meeting was called to order at 9:10 am.

B. Pledge of Allegiance

C. Roll Call

D. Introduction of Guests - Mr. Brian Seymour, Associate Executive Director, CIF State Office

E. Adopt Agenda - There was a motion by the Citrus Belt League and a second by the Southwestern League to adopt the agenda. There being no discussion, the motion was approved to adopt the agenda as written. Motion Carried: 77-0-5

F. Approval of Minutes

1. Minutes of the September 29, 2022 Council Meeting. There was a motion by the Orange Coast League and a second by the San Andreas League to approve the minutes of the September 29, 2022 Council meeting. There being no discussion, the minutes were approved as written. Motion Carried: 78-0-4

### 2. PUBLIC HEARING SESSION

A. Recognition of anyone wishing to address the Council. Speakers must limit their remarks to three minutes. The first speaker was Mr. David Hinshaw, President of Unit G (South Bay) of the Southern California Soccer Officials Association. Mr. Hinshaw addressed the Council regarding the current official's fee agreement that was passed for the 2022-2023, 2023-2024 and 2024-2025 school years. Mr. Hinshaw expressed a dissatisfaction by the soccer officials regarding game fees, alluded that soccer was a more difficult sport to officiate than others and should be paid at a higher rate. Mr. Hinshaw also addressed the Council stating that the number of soccer officials is declining due to a lack of pay and the public abuse officials receive during a contest.

The second speaker was Mr. Ruben Spilkin. Mr. Spilkin addressed the Council regarding the addition of Girls Rugby as a potential CIF sport. Mr. Spilkin outlined the many potential benefits for the student-athletes and the member schools should Girls Rugby be adopted as an official CIF sport.

The third speaker was Ms. Michelle Mendoza. Ms. Mendoza presented information regarding Name, Image and Likeness (NIL) and expressed a need for member schools to protect their student-athletes.

Ms. Rebecca Stewart, Regional Sales Manager, GoFan Digital Ticketing, addressed the Council. Ms. Stewart thanked the Council and the member schools that have utilized the GoFan ticketing service. Ms. Stewart also encouraged more schools to please contact her about the possibility of using GoFan for all ticket needs on campus.

### 3. NON-ACTION ITEMS

A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

1. Proposed 2023-2024 CIF State Budget - President-Elect Paula Hart Rodas reviewed the proposal for the Council. The CIF State is looking for a balanced budget. There have been increases in revenue across the state but also increases in operating costs. The full budget can be found at [www.cifstate.org](http://www.cifstate.org). The proposed budget will show the addition of four at-large members to the Executive Committee, which will add \$8,500 to the CIF Executive Committee expenses.

2. CIF State Executive Committee Nominations - President-Elect Paula Hart Rodas reviewed the list of nominations to the CIF State Executive Committee.

3. Proposed Amendment to Bylaws 212/510 - Amateur Status/Undue Influence - President-Elect Paula Hart Rodas reviewed the

proposal. The proposal is asking for revised language regarding Name, Image, Likeness (NIL) contracts and payments to student-athletes. The proposal outlines penalties based on infractions committed in violation of CIF Bylaws 212 and 510. The proposal adds clarifying language related to situations involving students and commercial endorsements being utilized to recruit and/or retain students at a member school. There was a discussion about how this proposal would affect a potential CIF Bylaw 510 violation. The Ocean League requested that the Southern Section office hold trainings and workshops with member schools on how to navigate NIL situations. Mr. Randy Bell from the Rio Hondo League stated that the NFHS Learn portal currently has a free course posted on its web site that member schools should view.

4. Proposed Amendment to Bylaws 207/504 - Transfer Eligibility/Season of Sport - President-Elect Paula Hart Rodas reviewed the proposal regarding academy programs and the eligibility of students upon transfer from an academy program. The CIF State and Section Offices have engaged in discussions regarding CIF Bylaws when a student transfers from an academy program to a CIF member school. This proposal defines what an academy program is and how a student participating in that program could affect the student's transfer eligibility. For the purposes of this bylaw, an "Academy" is defined as a non-school organization located in or outside of the State of California that contains a sports development and/or training program and consists of athletic team(s) that compete against other high schools or non-

school organization's athletic programs.

5. Proposed Addition of Bylaw 2901 - CIF State Tennis Championships - President-Elect Paula Hart Rodas introduced the proposal. This proposal would add CIF State Championships in the sport of Girls and Boys Team Tennis, effective with the 2023-2024 school year. Cost projections are currently minimal thanks to financial support from the USTA. This proposal follows the approved CIF State Championships Master Schedule timeline for implementation of new events for consideration. The event would allow the CIF Northern Regional and CIF Southern Regional Tennis Team Champions an opportunity to compete for a CIF State Championship.

6. Proposed Amendment to Article 70 - Executive Committee - President-Elect Paula Hart Rodas presented the proposal to amend Article 70 - Executive Committee which would expand the CIF Executive Committee from nine (9) to thirteen (13) members. The additional four (4) at-large members would reflect both gender and ethnic representation of the state's student population. This proposal would be for immediate implementation. Two (2) of the new members would serve for two-year terms and two (2) would serve for one-year terms to establish a cycle where the positions are replaced every two years.

B. SOUTHERN SECTION NON-ACTION ITEMS

1. Proposed 2023-2024 CIF Southern Section Budget - Chief Financial Officer Mitch Carty presented the proposed budget which can be found at the end of the Council packet. Mr. Carty highlighted the current actual budget and showed the trend from the past five years (2017-2022) to create the proposed 2023-2024 budget. Mr. Carty showed the increased projections in sports revenue at 3.6% over the previous year along with a Sports

Fees target projecting an increase of 6.8% due to new sports coming on board. Mr. Carty projected a 6% increase in expenditures over the previous year due to inflation and officials' fees. Mr. Carty presented a balanced budget for the 2023-2024 school year. Mr. Carty also announced that the Sport Fee waiver that occurred during the 2022-2023 school year will also continue in the 2023-2024 school year.

2. CIF Southern Section Executive Committee Nominations - -President Jim Perry reviewed the list of nominations and outlined which leagues will vote for each position. The Desert Area Representative currently has one candidate and President Perry announced that nominations from the floor will be accepted during the April 18, 2023 Council meeting.

3. Proposed Revision of Bylaw 1223.3 – Summertime Rules - Ms. Lisa Ulmer, Moore League Secretary, presented the proposal. The proposal allows for all schools to establish a 14 consecutive day Summer Dead Period for each sport on its campus rather than having one universal Summer Dead Period for all sports at the same time. Ms. Ulmer highlighted the benefits of the proposal and reasons why this proposal should be adopted. This proposal will still allow a school to select a universal Summer Dead Period for all sports on its campus but simply gives the school the flexibility to meet the needs of its school community.

### 4. ACTION ITEMS

#### A. STATE FEDERATED COUNCIL ACTION ITEMS

1. Proposed Addition of Girls Flag Football - September 29, 2022. President-Elect Paula Hart Rodas presented the proposal. This proposal has already been voted on and passed by the Southern Section at the Council meeting on September 29, 2022.

2. Proposed Amendment to Article 22 – Approved - Membership/Conditions of Membership 19-0-0 - President-Elect Paula Hart Rodas presented the proposal. This proposal identifies sanctions to be placed on member schools who do not complete the required annual CIF Participation Census. If a school fails to submit its census by May 15, the school will be immediately notified that its CIF membership will be suspended effective June 15. Reinstatement of membership will be made upon receipt of the completed CIF Participation Census. Reinstated schools will not be allowed to host any CIF Regional or CIF State playoff contest in any sport for a period of one year from the time of sanction. There was a motion by the Liberty League and a second by the Crestview League to support State 644. There being no discussion, the motion was approved.

Motion Carried: 83-0-1

#### B. SOUTHERN SECTION ACTION ITEMS

1. Proposed Revision Bylaw 1222 – Boys Lacrosse Officials Fees - There was a motion by the Big VIII League and a second by the Bay League to support Southern Section action item 641. The proposal allows for an increase in the time allotment listed by the Boys Lacrosse Official Fees document. There being no discussion, the motion was approved. Motion Carried: 71-1-13

2. Proposed Revision Bylaw – Approved - Beach Volleyball Official Fees - There was a motion by the Big VIII League and a second by the Southwestern League to establish a fee structure for a "monitor" (official) in the sport of Girls Beach Volleyball. The fee structure follows the same approved plan for all officials that was recently adopted by the Council. After a short discussion regarding if a monitor was required or not to conduct a contest the proposal passed as written. Motion Carried: 62-6-18

### 5. REPORTS

A. Treasurer's Report – Chris Calderwood -Treasurer Chris Calderwood reported to the Council that the audit by the Harrington Group for the 2021-2022 school year is almost complete, and it will be ready for the 2022 tax filing year. Mr. Calderwood announced to the Council that for the 2021-2022 school year our net income was a surplus of \$245,015. Finally, Mr. Calderwood stated that our financial investment balance as of December 31, 2022, was \$2,409,744. In addition, we are showing a modest gain of \$18,078 in investment income for the 2022-2023 fiscal year.

#### B. President's Report - -Jim Perry

President Jim Perry thanked the Council for their service. President Perry reported on his experiences attending the Girls Team Tennis Championships, the 8-Man Football Championships, The Division 1 Football Championship at The Rose Bowl and the Southern Section Cheer Championships. President Perry also announced that the Boys and Girls Open Division and Division 1 Championship Basketball games will be held at the Honda Center this season. Finally, President Perry announced that the position of Commissioner of Athletics for the CIF Southern Section will be posted on February 1, 2023. The new Commissioner will be announced at the next Council meeting in April.

#### C. Commissioner's Report - Rob Wigod -

Commissioner Wigod re-introduced Brian Seymour from the CIF State Office and thanked him for his attendance at today's meeting. Commissioner Wigod reminded the Council that the completion of the Winter Sports regular seasons for Boys/Girls Basketball, Boys/Girls Soccer and Girls Water Polo conclude this week and he emphasized that it is very important to have league playoff entries submitted by the required deadlines. Commissioner Wigod announced that the deadline to submit student teams for Academic Awards recognition is March 13. Commissioner Wigod reminded the Council that the Champions for Character, Hall of Fame and Distinguished Service Award nominations are now open and will close on May 1. Finally, Commissioner Wigod announced that the Champions for Character Golf Tournament is scheduled June 19 at Alta Vista Country Club in Placentia. Please register four-somes early, as this tournament sells out every year, and leagues should renew tee sign sponsorships to support the event.

# MINUTES OF THE EXECUTIVE COMMITTEE MEETING

## January 14, 2023

### 1. OPENING BUSINESS

A. Call to order by Jim Perry, President of the Council. The meeting was called to order at 9:33 a.m. Jim Perry welcomed everyone and thanked them for their attendance at the retreat and their enjoyment of the reception the evening before.

B. Pledge of Allegiance

C. Roll Call

All members were present except for Patrick Bendzick, Cleveland Johnson and Steve Miller.

D. Introduction of Guests

There were no guests present.

E. Adopt Agenda - There was a motion and a second to adopt the agenda. The motion carried 19-0-0.

F. Approval of Minutes - There was a motion and second to approve the minutes of the September 22, 2022 Executive Committee Meeting. The motion carried 19-0-0.

### 2. PUBLIC COMMENT

There was no one present for Public Comment.

### 3. NON-ACTION ITEMS

#### A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

1. Proposed 2023-24 CIF State Budget - President-Elect Paula Hart Rodas reviewed the proposal for the Executive Committee. The CIF State is looking for a balanced budget. There have been increases in revenue across the state but also increases in operating costs. Details can be found in the budget proposal in the agenda. President Perry added that the State has a proposal to add four at-large members to their Executive Committee, which will add \$8,500 to the CIF Executive Committee expenses.

2. CIF State Executive Committee Nominations - President-Elect Paula Hart Rodas read the list of nominations to the CIF State Executive Committee.

3. Proposed Amendment to Bylaws 212/510 - Amateur Status/Undue Influence - President-Elect Paula Hart Rodas reviewed the proposal. The proposal is asking for consequences regarding NIL contracts and payments to student-athletes. The proposal lists penalties based on the number of infractions of CIF Bylaws 212 and 510. If a student is promoting a product, wearing a school uniform and being paid, that is a violation? What if the athlete is just wearing a uniform and is on TikTok but not promoting anything, is that a violation? Are they getting paid? Did they monetize their account? These are items that need to be addressed. What about using the NIL money to entice students to attend a school? One way a school district is getting ahead of these items is to have a question on their athletic clearance paperwork asking if the student has social media accounts, if those accounts are monetized or are they receiving any money on an NIL agreement, asking those questions before they participate. Basically, students should not be wearing their school uniforms for anything they are making money on. After much discussion, we need to be sure we do not make a rule that cannot be enforced or make a rule we are not willing to enforce. There will be much more discussion

on this issue to see what can reasonably be done in the future.

4. Proposed Amendment to Bylaws 207/504 - Transfer Eligibility/Season of Sport - President-Elect Paula Hart Rodas reviewed the proposal regarding academy programs and eligibility of those students. This defines what they were participating in before entering the high school. Academy participation will count as participation and defines what an academy is.

5. Proposed Addition of Bylaw 2901 - CIF State Tennis Championships - President-Elect Paula Hart Rodas introduced the proposal. This would add CIF State Championships for Boys and Girls Team Tennis, effective with the 2023-2024 school year. Cost is minimal thanks to the USTA. The proposal lists the schedule for these championships. Passage of this proposal would complete the schedule established 10 years ago regarding the addition of championships at the CIF State level and a committee is being formed to see what sports are going to be potential CIF State Championship sports in the future.

6. Proposed Amendment to Article 70 - Executive Committee - President-Elect Paula Hart Rodas reviewed the proposal to expand the CIF State Executive Committee from the current 9 members to 13 members, adding 4 at-large positions, in order to better represent the Sections, ethnicity, and gender equality across the state. This would be for immediate implantation and nominations will be coming from all Sections. The CIF State Executive Committee will be asking for nominations from anywhere across the state. Two of the new members would serve for two-year terms and two would serve for one-year terms to establish a cycle where the positions are replaced every two years. The CIF State Executive Committee will vote on the nominations and elect the new positions at their June, 2023 meeting. At 10:24 a.m., President Jim Perry gave the Committee a 10-minute break. Meeting resumed at 10:36 a.m.

#### B. SOUTHERN SECTION NON-ACTION ITEMS

1. Proposed 2023-24 CIF Southern Section Budget - President Jim Perry asked Chief Financial Officer Mitch Carty to present the proposed budget. The budget was distributed to the members of the Executive Committee and Mr. Carty reviewed the packet. The packet will be sent out to all parties next week. Immediate Past President Mike West stated that schools have had increases in the public school budgets and the Southern Section Office is trying to align with those budgets. For the 2023-2024 school year, school Sport Fees will once again be waived. Schools need to remember this is a one-time item and for the 2024-2025 school year, it is anticipated that Sports Fees will be collected from member schools. President Perry applauded Jackie Gibson's efforts in negotiating the new apparel contract.

2. CIF Southern Section Executive Committee Nominations - President Jim Perry presented the nominations for the positions needing to be replaced starting in the 2023-2024 school year. Nominations can be found

in both the Executive Committee and Council agendas. These will be voted on at the April 18 Southern Section Council meeting.

3. Proposed Revision of Bylaw 1223.3 - President Jim Perry presented the proposal. The proposal requests that all schools can establish a 14-day Summer Dead Period for each sport rather than having all sports at the same time. It was mentioned that this past summer was the best two weeks since everything was closed and there was the knowledge of knowing exactly what can and cannot be done. A couple of sports at one school have the problem where the other 20 sports are good with a common dead period, but a couple are not. It was also emphasized that it is supposed to be a break for students and their families and having the same dead period allows the multi-sport athlete a complete rest. It was stated the current rule that is now in place has not been given enough time to see it work and should be given more time to see the true benefits of one common dead period.

### 4. ACTION ITEMS

#### A. STATE FEDERATED COUNCIL ACTION ITEMS

1. Proposed Addition of Girls Flag Football - September 29, 2022 - President-Elect Paula Hart Rodas reviewed the proposal that is now at the CIF State level and will be voted on at the February CIF State Federated Council meeting. This sport would be implemented in the Fall, 2023, if passed, and bylaws need to be established regarding total number of contests, allowable contests each day and each week, start date and end of season date, etc. One thought is to play as a "Monday Night Football" event, with maybe six teams playing at one place and rotating sites throughout the season. Schools have maximum flexibility to do whatever works best for their school community.

2. Proposed Amendment to Article 22 - Membership/Conditions of Membership - President-Elect Paula Hart Rodas reviewed the proposal, for immediate implementation, regarding the necessity to complete the annual CIF State Participation Census, including penalties for schools who do not complete this requirement by April 1. Only 10-12% of schools state-wide do not complete this very important survey. There was a motion and a second to send our delegates instructed to approve this proposal. The motion passed 19-0-0.

#### B. SOUTHERN SECTION ACTION ITEMS

1. Proposed Revision Bylaw 1222 - Boys Lacrosse Officials Fees - President Jim Perry reviewed the proposal for an increase in the time allotment listed in the Boys Lacrosse Official Fees. There was a motion and a second to approve this proposal. There being no discussion, the motion passed 19-0-0.

2. Proposed Revision Bylaw 1222 - Beach Volleyball Official Fees - President Jim Perry reviewed the proposal for the establishment of Girls Beach Volleyball Officials Fees. There was a motion and a second to approve this proposal. After a short discussion, the motion passed 19-0-0.

### 8. REPORTS

A. President's Report - Jim Perry - It was a very busy Fall. President Perry had the opportunity to attend more games than the average person given his district position. The CIF Southern Section Team Tennis Finals in Claremont were extraordinary. President Perry once again made his annual pilgrimage to the 8-Person Football Championships and was able to attend both contests this year. CSDR almost filled the stands at Birmingham High School for their game and Grace Brethren was a great host of the event. The Football Press Conference Luncheon and the Division 1 Football Championship Game at the Rose Bowl were amazing events. Thank you to the CIF Southern Section staff for all you do and how you do it. You are a class act!

B. Treasurer's Report - Chris Calderwood - Thank you to Chief Financial Officer Mitch Carty for all that you do for the organization. The annual audit is underway and currently, the Profit and Loss statement for the 2021-2022 school year stands at \$245,000.

C. Commissioner's Report - Rob Wigod - Thank you to all who were able to attend our Fall Championships, presenting awards and representing the Executive Committee.
