A motion and second were made for probationary status for Orange County Classical Academy. After discussion, which included a review of the New Member School Application, noting they do not have facilities at this time and understand they should be further along toward membership, the motion failed 3-17-0.

10. The SEED School of Los Angeles Approved Probationary 5A10
Presented by Steve Miller

Steve Miller presented The SEED School of Los Angeles for consideration and recommended probationary membership. A motion and second were made for probationary status for The SEED School of Los Angeles. After discussion, which included a review of the New Member School Application, the question was asked about joining the Los Angeles City Section but since they are not part of the Los Angeles Unified School District, but rather a Los Angeles County school, they would belong to the Southern Section, the motion carried 20-0-0.

B. Membership Status of New and Probationary Schools Admitted in 2022-2023

1. Aveson Global Leadership Academy Denied Membership 5B1

Rob Wigod pointed out that Aveson Global Leadership Academy did not send in an evaluation letter after numerous requests to the school. It is up to the Executive Committee to grant full or probationary membership or to drop the school from membership. There was a motion to approve another year of probation and a second. Motion failed 1-19-0 and Aveson Global Leadership Academy will be dropped from membership starting with the 2023-2024 school year.

2. Entrepreneur/Fontana Approved Probationary 5B2

Rob Wigod presented the evaluation and pointed out that they played only baseball and softball this year and missed the boys and girls sport in each season of sport minimum requirement. It is up to the Executive Committee to grant full or probationary membership. There was a motion to approve another year of probation and a second. Motion was approved 20-0-0.

3. First Baptist/Long Beach Denied Membership 5B3

Rob Wigod presented the evaluation and pointed out that this school joined the organization in 2021-22 and have been members for two years. They were unable to field a boys sport in the fall or a girls sport in the spring. It is up to the Executive Committee to grant full or probationary membership. There was a motion to approve another year of probation and a second. Motion was failed 0-20-0 and First Baptist/Long Beach will be dropped from membership starting with the 2023-24 school year.

4. Gorman Learning Center/Antelope Valley Approved Probationary 5B4

Rob Wigod presented the evaluation and pointed out that they were unable to field a boys sport in the fall, a girls sport in the winter and either a boys or girls sport in the spring, missing the minimum requirement of a boys and girls sport in each season of sport. It is up to the Executive Committee to grant full or probationary membership. There was a motion to approve another year of probation and a second. Motion was approved 20-0-0.

5. Lakeview Leadership Academy Approved Full Membership 5B5

Rob Wigod presented the evaluation and pointed out that they were able to field the required number of sports. It is up to the Executive Committee to grant full or probationary membership. There was a motion and a second to approve full membership. Motion was approved 20-0-0.

6. Magnolia Science Academy/Santa Ana Approved Full Membership 5B6

Rob Wigod presented the evaluation and pointed out that they were able to field the required number of sports. It is up to the Executive Committee to grant full or probationary membership. There was a motion and a second to approve full membership. Motion was approved 20-0-0.

7. Orange Crescent Denied Membership 5B7

Rob Wigod pointed out that Orange Crescent did not send in an evaluation letter after numerous requests to the school. It is up to the Executive Committee to grant full or probationary membership or to drop the school from membership. There was a motion to approve another year of probation and a second. Motion failed 4-16-0 and Orange Crescent will be dropped from membership starting with the 2023-2024 school year.

8. Pasadena Waldorf Denied Membership 5B8

Rob Wigod pointed out that Pasadena Waldorf did not send in an evaluation letter after numerous requests to the school. It is up to the Executive Committee to grant full or probationary membership or to drop the school from membership. There was a motion to approve another year of probation and a second. Motion failed 0-20-0 and Pasadena Waldorf will be dropped from membership starting with the 2023-2024 school year.

9. Palmdale Academy Charter Approved Full Membership 5B9

Rob Wigod presented the evaluation and pointed out that they were able to field the required number of sports and completed the addition of new facilities throughout the year. It is up to the Executive Committee to grant full or probationary membership. There was a motion and a second to approve full membership. Motion was approved 20-0-0.

10. TREE Academy Denied Membership 5B10

Rob Wigod presented the evaluation and pointed out that this school joined the organization in 2019-20 and were granted probationary status for 2020-21 as all on probation were given grace due to COVID. In the last two years, they fielded no boys sports in the fall and no girls sports in the winter and spring. It is up to the Executive Committee to grant full or probationary membership. There was a motion to approve another year of probation and a second. Motion was failed 0-20-0 and TREE Academy will be dropped from membership starting with the 2023-24 school year.

Lastly, he congratulated Assistant Commissioner Rainer Wulf on his upcoming retirement.



- e. Facilitate the distribution of grant monies received from the California Department of Education in support of the organization's mission and member schools.
- f. Continue to promote and onboard member schools to receive all payments from the CIF Southern Section electronically via Automated Clearing House (ACH) network instead of mailing checks.

9. Examine and Explore Issues Involving Public and Private Schools

- a. Continue to work with the CIF Southern Section Public/Private Committee on an ongoing basis.
- b. Continue to work with the Private School Leadership Advisory Committee on an ongoing basis.
- c. Continue to engage in a constructive dialogue with member schools, both public and private, on public/private issues.
- d. Serve as a resource for member schools, leagues, and areas of the CIF Southern Section by attending league meetings, area meetings and athletic director association meetings.
- e. Continue to emphasize adherence to the current CIF State Constitution and Bylaws and CIF Southern Section Blue Book rules that apply to all schools.
- f. Implement and evaluate amendments to CIF Bylaws 212 & 510 related to NIL and recommend edits to the 510 Chart.

10. Work Cooperatively with the CIF State Office and the Other 9 Sections

- a. Generate a sectional identity that provides leadership, along with being cooperative and sensitive to the needs of the CIF and the other sectional organizations.
- b. Develop strategies that recognize and support the needs of the CIF and the other sections without sacrificing the strengths and interests of the CIF Southern Section.
- c. Serve as a resource, along with members of the CIF Southern Section Staff, to the CIF State Office in the management and conducting of CIF State Regional and CIF State Championship events and other State Committees.
