A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

1. Proposed 2024-25 CIF State Budget

Non-Action

STATE 659

The 24-25 proposed budget projects income of \$7.55 million and expenses at \$7.4 million. Details can be found in the proposed budget notes accompanying this item. Most championships are budgeted for increased expenses based upon the three-year trend and rising cost of championship operations. The CIF is anticipating increased income revenue in several sports based upon three-year trend. There are increased expenses for insurance premiums, step and column increases for qualified staff and increased benefit/PERS contributions. There is anticipation of increased income from marketing partnerships, broadcast rights and championship merchandise based on three-year trend.

2. State CIF Executive Committee Nominations

Candidates for President Elect of the State CIF State Executive Committee are Paula Hart Rodas, Southern Section and Alton Nelson, North Coast Section. There are three "at large" positions open. These are two-year terms on the CIF State Executive Committee. Paula Hart Rodas is also being considered for "at large" if she is not in succession for President Elect. Our representatives will go "uninstructed" in their vote for these positions but will support Southern Section Candidates when in contention.

3. Proposed Bylaw Revision – 503.K.(1) –

Heat Illness Protocol

Heat Illness Protocol will require schools to determine the safety of fall outdoor practices and mandatory adjustments to practices using WetBulb Globe Temperature (WBGT). WBGT is different from Heat Index in that WBGT takes into consideration temperature, humidity, wind speed, sun angle and cloud cover. Heat Index takes temperature and humidity calculated for shady areas into consideration. Another factor involved in these readings is where your school is located. Ocean proximate locations are likely Category-1 while desert areas are likely Category-3 where each category has specific guidelines. Practice modifications will vary depending on the WBGT temperature in your school's area. Resources will be made available to determine the "Category" in which your school falls as well as guidelines for that area. Best practice will be to have a WGBT unit at your campus and your fields during hot months in the summer and early fall. There will be acclimatization accommodations necessary at the beginning of the fall season.

4. Proposed Bylaw Revision – 503.K.(2) –

Air Quality Index Protocol

Air Quality Index Protocol will establish a rule stating schools must refrain from outdoor practices and contests when the AQI is 151 or higher. This has been a standard for schools but has not been codified in the Blue Book.

5. Proposed Bylaw Revision – 503.L – Emergency Action Plan/Non-Action STATE 663
AED Protocols

This proposal will require emergency action plans to exist for every athletic field on a school campus (pool, gym, stadium, etc.) as opposed to only requiring a school EAP. These venue specific EAPs must be rehearsed at least once per season as dictated by recent passage of California State law (AB 245-McKinnor). AEDs must be "accessible", meaning they can be obtained for use in under 3 minutes of a possible sudden cardiac arrest. Schools may be required to purchase additional AEDs for their site to be placed in reasonably accessible locations for quick access in emergency situations.

6. Proposed Bylaw Revision – 1803 – State Traditional Non-Action STATE 664

Competitive Cheer Championship Event

The state regional championship will be replaced by a state championship starting in the 2024-2025 season. This is a proposed 2-day event. Teams will be required to participate in their section championships to be eligible.

7. Proposed Bylaw Revision – 3204 – State Boys Volleyball Non-Action STATE 665
Championship Event

Support of this proposal will create a state championship in the sport of boys' volleyball. Currently there is a regional tournament only. This will be a one-day event the weekend after regionals in the spring.

8. Proposed Bylaw Revision – 303.B.(6) a. and b. – Non-Action STATE 666

Multi-School New and Renewal Applications

This bylaw would put a hard deadline on the processing of multi-school applications. Schools must apply for or renew by the end of September to take affect the current school year. Applications or renewals received after September will be for the following school year.

B. SOUTHERN SECTION NON-ACTION ITEMS

1. CIF Southern Section Proposed 2024-25 Budget Non-Action SS 667

In preparing the budget for this year, changes are needed in respect to revenue. Please see the one-page synopsis contained in SS667 supporting documents which cover increases in detail. There is a proposed sport fee increases from \$75 to \$100 and a proposed revenue sport (basketball, football, and volleyball) ticket price increase. In preliminary rounds of the playoffs (in revenue sports), student tickets will go from \$5 to \$6 and adult tickets will go from \$10 to \$12. Student tickets have not seen an increase since 2007 while adult tickets haven't had an increase in over 10 years. In some individual sports there are entry fee increases due to increased costs for golf courses, tennis arenas etc.

3. Proposed Bylaw Revision – 3520.5 & 3520.6 Wrestling Playoff Divisions

Non-Action

SS 669

Supported unanimously by the girls and boys wrestling committees, this proposal will change the scope of results used to place teams in competitive divisions from using the last 4 years of data to using only the most recent two years. For Dual Meet Wrestling, divisions will be formulated every two years using Masters Meet qualifiers by school (over a two-year period). For individual wrestling, divisions will be formulated every two years using Masters Meet qualifiers by league (over a two-year period).

CIFSS annual audit by the Harrington Group was completed. There will be a proposal for audit acceptance at the next Executive Committee meeting. The section had a net income of approximately \$461k. Investment reserves in the fiscal 23-24 are strong thus far with November and December being good months. The California Department of Education Grant supported \$1.5 million in membership fees being waived, \$120k on golf entry fees being waived, \$111k on Athletic Admin Summit fees being waived, \$80k in Athletic/Activities Association donations, \$50k on the CIFSS history project, \$24k spent on wrestling coaches' association fees being waived, and \$30k spent on track officials' fees being waived. There is about \$735k left to spend.

Mr. Perry enjoyed the cheer championships in January hosted by Martin Luther King High School, their staff and especially the efforts of Coach Jennifer Brinkle and her parent volunteer groups. It was a huge competition this year with over 130 teams, largest thus far. Former football player Trevin Adams from CIFSS California School for the Deaf, is featured in the AT&T 5G helmet campaign. Mr. Perry enjoyed an athletic event where the crowd in attendance was asked by the announcer to sing the National Anthem.

D. Commissioner's Report

Unified Sports Advisory Committee has been formed under the leadership of Commissioner West. This will be a resource for schools interested in creating more opportunities for Unified Athletes. Track and Field will continue its offerings. Swimming has increased opportunities from 1 to 4 events at the Southern Section Swimming Championships in all four divisions. Area placement will start next fall. Re-leaguing chairpersons from the specific areas will have a round table in April to share procedures and best practices. The first meeting exploring officials' fees for the next three-year structure will take place on May 22, 2024. Championships for winter sports are upon us. Basketball will be hosted at Azusa Pacific University and Toyota Arena in Ontario. CIFSS is working to establish multi-year contracts for championship events to eliminate the need of finding facilities year to year. Cheer was a success with tremendous growth this year. The Commissioner is hopeful "STUNT" will be offered as a championship event next. "Friends of Golf" has been kind with donations. If your golf program has any need for equipment/gear, please look for information that will be coming to school emails shortly as equipment and resources will be distributed shortly.
