# MESSAGE FROM THE COMMISSIONER

### Competitive Equity Playoffs... What's Next?

On January 30, 2024, the CIF Southern Section Council voted 79-8 to amend Bylaw 3519 which addresses playoff groupings and how individual sports and teams within a sport are placed into divisions. The current, soon to be former, competitive equity playoff model has used data from the previous two years to establish playoff divisions prior to the season starting. Though this has been a progressive model compared to other areas of the state and the country, this method did not take into consideration how competitive a team might be in the current year. The new system established by January's vote will only evaluate how competitive a team is in the current season and then place teams into divisions based upon their ranking for that year.

Currently, the Assistant Commissioners in each sport are looking into and assessing ranking systems that can be applied properly to a given sport. There are a variety of options available to us through companies such as Massey, MaxPreps, SBLive, and others. Football currently uses a system developed by CalPreps which provides football rankings not just for California but for all states across the country. Each year, these groups make minor adjustments to their algorithms in order to maintain or enhance their accuracy. As we adopt our systems and establish the parameters for the algorithms we will be using, we too will continue to make adjustments yearly to ensure the most accurate outcome possible.

Regardless of what is adopted, it will only be as good as the data that is included. Accurate and timely schedules and scores for every team at every school will be imperative to the success of our new system. To that end, the CIF Southern Section is working to develop a "Data Hub" whereby schedules and scores input on various websites will come to a centralized location and be shared by all those who participate in the program. Though our bylaws state that schools must enter their scores into CIF Home, this could be accomplished by entering a score on another platform which would end up on our

system. It is imperative that athletic departments throughout the Southern Section ensure that the systems they have in place to update schedules and scores are effective, accurate and timely. If we collectively accomplish these tasks, the CIF Southern Section will have the most precise and relevant way to establish playoff divisions and seeding of any high school athletic association in the country.

#### More Observations from the Commish
