PAIRINGS ANNOUNCED FOR 2024 CIF SOUTHERN SECTION-FORD 8-PERSON FOOTBALL PLAYOFFS

LOS ALAMITOS, CA - CIF Southern Section Playoff pairings for the fall sport of eight-person football were announced at CIF Southern Section headquarters today.

This marks the third year of the competitive equity format in 8-person championships.

The CIF Southern Section Eight-Person Football Playoffs kickoff this week with 24 teams battling for two divisional titles (1 and 2). First round contests are scheduled for Friday, Nov. 8—unless competing teams mutually agree on a change. The CIF-Southern Section-Ford Eight-Person Division 1 championships are to be held November 22 or 23 and Division 2 will be held November 29 or 30 at host sites yet to be determined.
