SIX BOYS/THREE GIRLS CIF SOUTHERN SECTION-FORD DUAL MEET WRESTLING, CHAMPIONSHIPS TO BE AWARDED

LOS ALAMITOS, CA - The six boys and three girls divisional, two-day tournament championships of dual-meet wrestling will start this Saturday, February 1 with preliminary rounds in all divisions. Finals-round matches commence on Wednesday, February 5 in Boys Division 1 and Thursday, February 6 in all other divisions for both boys and girls.

The girls' tournaments are scheduled to start with first-round action beginning at 11 a.m., second round at 3 p.m., and the semifinals at 5 p.m. (All times approximate). Weigh-in is to begin at 9 a.m. The final rounds will be held on Thursday, February 6 at the site of the school ranked highest in the final poll. Weigh-in is to begin at 6:00 p.m. and championship matches to start at 7:00 p.m. (All times approximate).

The boys' tournaments are scheduled to start with first-round action beginning at 11 a.m., second round at 3 p.m., and the semifinals at 5:00 p.m. (All times approximate). Weigh-in is to begin at 9 a.m. The final rounds will be held on Wednesday, February 5 in Boys Division 1 and Thursday, February 6 in all other divisions at the site of the school ranked highest in the final poll. Weigh-in is to begin at 6:00 p.m. and championship matches to start at 7:00 p.m. (All times approximate).

Top seeds for each division in the boy's tournament include St. John Bosco (Division 1), Esperanza (Division 2), Sultana (Division 3), South Torrance (Division 4), Simi Valley (Division 5), and Santa Ana (Division 6). Top seed on the girl's side is Northview (Division 1), Santa Ana (Division 2), and Roosevelt (Division3).

Wrestling sites for the six divisions of boys wrestling are as follows; St. John Bosco HS (Division 1); Centennial/Corona HS (Division 2); Murrieta Valley HS (Division 3); Aliso Niguel HS (Division 4); La Canada HS; and Division 5; Upland HS (Division 6). Wrestling for the girls' rounds will be at Hillcrest HS (Division 1), Paloma Valley HS (Division 2), and Valencia/Valencia HS (Division 3).
