PAIRINGS ANNOUNCED FOR 2024-25 CIF SOUTHERN SECTION-FORD CHAMPIONSHIPS IN BOYS AND GIRLS SOCCER

LOS ALAMITOS, CA – Pairings for the 2024-2025 CIF Southern Section-Ford Championship Playoffs in the sports of boys' and girls' soccer were announced today. This is the first year of using current regular season data in determining playoff groupings.

BOYS SOCCER

A total of 263 boys soccer teams were paired into nine tournament brackets, with competition scheduled to get underway with first-round contests to be played in all divisions on Thursday, February 13, with single-elimination competition leading to the CIF Southern Section-Ford Boys Soccer Championships at Veterans Stadium at Long Beach City College (Saturday, March 1) or Fred Kelly Stadium in Orange (Friday, February 28 and Saturday, March 1). Divisions at each site to be determined.

GIRLS SOCCER

Nine divisional champions will be determined out of 263 entrants into the CIF Southern Section-Ford Girls Soccer Championship Playoffs, scheduled to open with first-round contests scheduled in all divisions for Wednesday, February 12. The single-elimination tournaments will conclude with championship finals matches at Veterans Stadium at Long Beach City College (Saturday, March 1) or Fred Kelly Stadium in Orange (Friday, February 28 & Saturday, March 1). 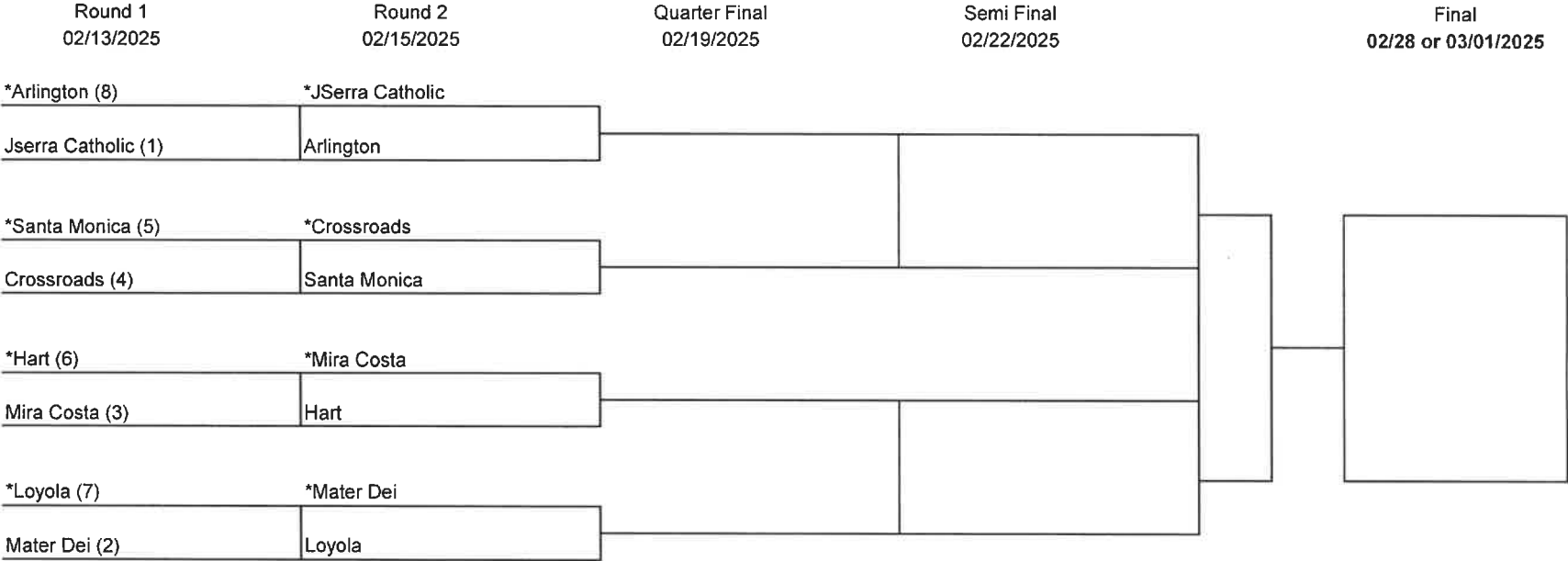
